





# An Outstanding Chapter-Without a House!

A House is an asset to any Chapter if operated efficiently. It is important—but the story behind the success of any Chapter is the spirit and leadership of the Brothers. This is a story prepared by Bob Hawk, H.A.E. of Beta Chi Chapter, American University of their success without a House.—Ed.

Tradition again repeats itself with Beta Chi at American University securing twenty-four topnotch pledges who added to our size and prominence on the campus.

Of the fourteen men selected at American University, the Sigs put three men in the Who's Who in American Colleges and Universities: Jack Jones, Bill Petrini and Burt Stephens.

#### Life In a Quonset Hut

Unique? Yes, and to our knowledge, Beta Chi Chapter of Alpha Sigma Phi at the American University has the distinction of having the only fraternity quonset hut House in the United States. But is it really a distinction? We think it is and here's why:

We of Beta Chi do not have living quarters, but the AU campus is small enough so that both pledge and Brothers are in constant touch with each other.

As with other chapters of Alpha Sig, the house is a meeting place, among other things. There is a "Sig Social Hour" each evening during the week from six to eight . . . the juke box really gets warmed up. But that isn't the end of it.

The seasons of the year have nothing on our hut. Fall, spring, winter and summer, the atmosphere bustles with activity. In the fall and the beginning of first semester, many parties are scheduled, the most outstanding of which are our annual hay parties in the house.

After rush and fall pledging, the Brothers get an opportunity to observe the pledges at work. The house improves each year, but all is not work . . . the patio immediately in front of the house is the scene of many dances and other activities.

Hot dog and marshmallow roasts usually

top off the fall session. Our fireplace, built last year during Pinnacle Week, is the point of activity.

Spring usually sees many improvements in the house . . . new furniture, paint jobs, etc. Ended with Saturday night parties, the spring session makes way for the summer cleanup which is handled mostly by Brothers who live in and around the Washington area.


During the year, there are several fraternity and sorority open houses. The doors of the Fraternity are thrown open and a good time is had by all. Object of much attention is our half-ton torpedo warhead bell. When rang, the bell can be heard all over campus.

We have very few problems in the house transportation-wise. The house is only 18 feet wide and sixty feet long with no stairs to climb. From floor to ceiling, the height is a mere ten feet. But by compactly furnishing the house, one would think it to be much larger—in our 1080 square feet, we have a "coke" machine, a cigarette and candy machine, a large trophy case, a bookcase that covers half of the rear wall and a kitchen complete with refrigerator and bar. Part of the house is partitioned into two rooms, a TV lounge and an office.

Outwardly, the house looks like a great sheet of metal shaped into a half-circle. On the street side is a large crest of the Fraternity. Passing by in a car, one can hardly miss it.

The patio of the house is based in concrete. An overhead speaker conveys jukebox music to the outside while it plays in the inside of the house.

A great transition is expected in the summer of 1959 as we get the first spade into the ground to start work on our

new house. But, in the meantime, life and spirit will remain in our quonset hut and our eyes will be looking to the future. When the new house is completed, many Brothers of the "old school" will look back to the hut with fond memories of brotherhood and the ideals that make Alpha Sigma Phi.

#### Beta Chi's Bell Borrowed Again

In the 1955 *Tomahawk* winter issue, there appeared an article entitled "Who Stole the Ding Dong?" After the article was published, Beta Chi Chapter recaptured the bell. Now, three years later, the half-ton torpedo warhead has again been "borrowed."


The news spread like fire around campus... "The Alpha Sig Bell is missing!" And so it went, from Thanksgiving, 1957 to January, 1958.

The bell had been loosened from its moorings of solid steel and cement. A hook holding the warhead was bent and the bell was lifted from its base. Hollow, the thick steel comes to a point at the top.

In the ensuing events, a regular "who dun it" developed. Many people on the American University campus were led to believe that the three other fraternities combined forces and relieved us of the bell. This was found to be untrue, however, as pledges and Brothers continued the search.

The mystery led to many places throughout Virginia, Maryland and the campus. Various "tips" led us to believe the bell was where it really wasn't. The mystery tagged on until about three months from the time the bell was taken, a certain fraternity on the campus found their charter missing.

Shortly after an impromptu negotiation,

we learned that our bell was buried under dirt in the rear of the athletic field. With shovels and rakes in hand and a cart trailing behind, twenty pledges and Brothers dug up the bell and rolled it back to the House.

A joyful Beta Chi and many students turned out to witness the proceedings. When the bell was rung to indicate that it had been returned, a tulmultous shout rang out from the crowd.

On the far side of the campus, another shout was heard . . . the return of the birth certificate of another fraternity.

#### Class Presidents

Beta Chi Chapter has in its ranks two class presidents.

Brother Dave Pattison, president of the Junior Class, is active in various campus activities. He is co-chairman of the Orientation Board, vice-president of the Debate Team, his dormitory, McDowell Hall, and Pan Athnon. He is presently serving as National Student Association co-ordinator for the American University College Council.

Brother Gerard holds the distinction of being class president twice in a row— Freshman class president and now Sophomore president.


#### Radio Station








You're going to need a "break" along about Labor Day. Why not combine the regular holiday with an unforgettable attendance at the Convention on September 3, 4, 5, and 6? Come for all four days if you can—or come just for the weekend. But don't miss at least part of the fun and inspiration of an Alpha Sig Convention. You will have a wonderful association with your Brothers, undergraduates and alumni. Alumni are especially urged to bring their wives. Excellent recreational facilities at the Inn and nearby will make for a total vacation and an enjoyable change for alumnus and wife.

You're making your reservation? Fine, now how do you get there—well—

The Manor is serviced by the Delaware Lackawana and Western Railroad. Those

traveling from the West can make connections from Chicago to Buffalo, or go into New York and make connections in Hoboken, New Jersey. The Pennsylvania Railroad serves Philadelphia, middle and western Pennsylvania, and southern points with transfer at Newark to the Lackawana Railroad for Pocono Summit. The Manor limousine meets trains at Pocono Summit. From Scranton connections can be made via the D.L. & W. Railroad to Pocono Summit, or by Martz or Greyhound Bus to Mount Pocono. Bus service includes via Greyhound or Martz Bus Lines to Mount Pocono or Swiftwater. Guests will be met by calling 3611 on arrival or by making prior request.

Flight tips—From Pittsburgh via TWA or Allegheny Airlines, from Harrisburg via Allegheny Airlines; from Washington or Baltimore via Colonial Airlines to the Scranton-Wilkes-Barre Airport; from Cleveland via United Airlines to Allentown-Bethlehem Airport. Guests are met at the Scranton-Wilkes-Barre Airport, Avoca, Pennsylvania or at the Allentown-Bethlehem Airport. Private planes will find air-

port facilities at Mount Pocono.

If you drive, consult your map—from then on, you're on your own.

Just a few notes regarding the mundane details of the reservations—

Alumni and undergraduates—other than official delegates—should make their reservations direct with the hotel. The rates are \$18.25 per person daily, including tax and gratuity, American Plan, for a twinbedded room with private bath and \$21.35 for a single room.

The Pocono Manor has made it possible for us to arrange to accommodate 35-45 non-delegates who may wish to stay in the Manor Lodge, which is adjacent to the Inn, at a rate of \$12.60 per day. This cost is on an American plan basis, including room, meals, tax and gratuity, and is a dormitory-type set up. Those Brothers staying in the Manor Lodge would take their meals with the others attending the Convention in Pocono Manor Inn. All brothers interested in this arrangement should make their reservations as soon as possible.

Just sit down now and make that reservation—please mention that you will be attending the Alpha Sigma Phi Convention, indicate which accommodations you desire, and address your envelope to: Pocono Manor Inn, Pocono Manor, Pennsylvania.

the General Chairman of the 1958 National Convention. The name of Campbell is not new to Alpha Sigs from coast to coast.

Lu is the son of L. Roy Campbell, Sr., Omicron '15, Delta Beta Xi, Past Grand Treasurer of the Fraternity and auditor of the General Fund books of the Fraternity and present auditor of the Tomahawk Trust Fund. Roy, Sr. also served as General Chairman of the 1952 Convention held at Pocono Manor Inn.

Brother Lu Campbell graduated from the Wharton School of Finance in 1950, served in the Navy from '50 until '54, when he was released with the rank of Lieutenant. He is a partner of the firm of Campbell & McCollom, Certified Public Accountants of Allentown, Pennsylvania. Lu has been active in business, civic and service organizations in the Lehigh Valley. He is a member of the Chamber of Commerce, Kiwanis, Lehigh Chapter of C.P.A.'s, National Association of Accountants and the American Institute of C.P.A.'s.

Lu's vice-chairman is Ellwood A Smith, Omicron '48, former Assistant Executive Secretary of the Fraternity and now Assistant Executive Secretary of the General Alumni Society of the University of Pennsylvania. An active Committee representing several Chapters are assisting the chairmen to plan an outstanding National Convention.



# IN THE ARMED FORCES

Ceremonies marking the promotion of Major George W. Baccus of Secane Pennsylvania to Lieutenant Colonel were held at the Military Clothing and Textile Supply Agency, Philadelphia Quartermaster Depot. Brother Baccus, Mu Chapter, University of Washington '38, received the insignia fo his new rank from Major General Webster Anderson, USA, Executive Director. Attending the ceremonies was Colonel Baccus wife, Mrs. Elma G. Baccus.

Colonel Baccus is presently assigned as Assistant to the Chief of the Quartermaster Inspector General Field Office at the Depot. He has been in this post since October, 1955.

A veteran of 16 years military service, Colonel Baccus entered the Army in 1942. From January, 1944 to September, 1945, he served in the European Theater of Operations. During this period he was assigned to the First and Ninth Armies and participated in the Normandy and Ardennes campaigns.

During the Korean War, Colonel Baccus served as Deputy Quartermaster of the 45th Infantry Division in Korea and later as Chief of the Special Projects Branch of the Eighth Army Quartermaster Section.

Colonel Baccus has been awarded the Bronze Star Medal with Oak Leaf Cluster for service in Europe and Korea, the Commendation Ribbon with Metal Pendant, and seven campaign and service ribbons with five battle stars.

Colonel Baccus is married to the former Elma Scheuer of McKeesport, Pennsylvania. They reside at 1023 Edgerton Road, Secane, Pennsylvania.

Captain James R. Collins recently was assigned as a resident physician in the radiology department of the Brooke Army Hospital, Fort Sam Houston, Texas.

Brother Collins is a 1952 graduate of Tufts University.

Second Lt. Arnold A. Kappeler recently was graduated from the 15-week basic officer course at The Infantry School, Fort Benning, Georgia.

Brother Kappeler is a 1957 graduate of Michigan State University.

Army Private Richard S. Dobson, University of Washington '54, recently was graduated from the 82d Airborne Division Jump School at Fort Bragg, North Carolina.

Brother Dobson received his parachutist wings after having completed a course which included five training jumps.

Second Lt. Robert G. Gabriel, University of Cincinnati '53, recently completed the field artillery officer basic course at The Artillery and Missile School, Fort Sill, Oklahoma.

Brother Gabriel was an engineer with the Cincinnati Milling Machine Company before entering the Army.


