# **U.C.L.A.** is back! Stockton State charters!!

Within one four-week period during the fall term, Alpha Sigma Phi added two more chapters to the active roll! Alpha Zeta Chapter at the University of California at Los Angeles was reactivated at ceremonies on November 10, 1984, and Delta Lambda Chapter at Stockton State College, Pomona, NJ, was installed on December 8, 1984

The original Alpha Zeta Chapter was founded on June 26, 1926, at U.C.L.A. and went inactive during the early 1970s. Since that time local alumni have hoped and planned for the chapter's return. Alpha Zeta alumni have been meeting at regular yearly events with alumni from other chapters living in the Los Angeles area. Events have included football tailgate parties, courtesy of Jack Horger, U.C.L.A. '53 and an annual Founder's Day Dinner every summer. Finally, in the Summer of 1982, inspiration to make the chapter's reactivation a reality was given to the group by young alumnus William Tyler, Wagner '76. Tyler made the alumni believe that a

reactivation effort would succeed.

By the Spring of 1983, with the help of the National Headquarters Staff, the Alpha Zeta Alumni Corporation had a plan set for reactivation. The corporation recruited recently graduated **Brian King, Washington '79** to be their full-time "colony recruiter" on the U.C.L.A. campus. King's room, board, and expenses were paid by the alumni corporation while he spent four weeks recruiting new colony members. By the end of his stay, King had pledged twelve men to Alpha Sigma Phi.

Area alumni served as volunteer advisors for the young group. Notable contributions of time have been given by Don Durward, U.C.L.A. '62, Jim Cordi, U.C.L.A. '64, and Robert Kutz, California '67. The group was officially colonized in October, 1983, and has grown to its current size of 30 men under the guidance of these advisors and Chapter Leadership Consultant, Tom M. Welsh, Westminster '79.

Initiation of the new chapter was held on

November 9th. A large delegation of brothers from Nu Chapter, University of California, Berkeley, and many Alpha Zeta alumni were on hand for the proceedings

The unquestionable highlight of the weekend was the attendance of two original charter members at the Chartering Banquet. Mac Ulrich, U.C.L.A. '26 and Wilmer M. Binford, U.C.L.A. '26, roster numbers #2 and #3, respectively said they wouldn't have missed the event for the world. Both

# Fraternity awards Delta Beta Xi to seven brothers

The Grand Council has announced that seven alumni who have dedicated themselves to volunteer service in Alpha Sigma Phi were given the Delta Beta Xi Award by Founder's Day, December 6th. Delta Beta Xi was the sub rosa organization formed by Alpha Sigma Phi at Yale from 1864-75 when the Fraternity was suppressed by the faculty. In 1938, the Fraternity revived Delta Beta Xi as an award to alumni who have given outstanding service to the Fraternity. No more than ten men per year may receive the award. Only 350 men have ever received the award. Here are the seven recipients this year.

Brian W. Jump, Indiana '79 has served Province III as Grand Province Chief since 1982. Following his graduation from Indiana he served the National Headquarters as Chapter Consultant, and then as Director of Alumni Development Brother Jump has also served on his chapter's alumni corporation board since 1982 and was its President in 1983-84. Delta Beta Xi was awarded to Brother Jump at Indiana's Homecoming

Stanley W. Kotulka, Penn State '70 has, for the past ten years, given hours of dedicated service to Upsilon Chapter at Penn State that have resulted in the chapter's elevation from a three-man chapter in 1973-74 to a powerhouse of 60 men today, considered tops on campus. Brother Kotulka has served as an officer on the Alumni Corporation

board for the past ten years as Vice-President and Treasurer. He spent endless evenings working with chapter treasurers, budgets, fire code provisions, debt financing, rush, and every other area of chapter operation. Brother Kotulka was awarded the Delta Beta Xi at Penn State's Homecomina

David Leasure, Ohio State '65 has served as Grand Chapter Advisor for Zeta Chapter, Ohio State, since 1982. He served as President of the Alumni Corporation Board from 1981-83, and since then as President and Editor of the Zeta Chapter Alumni Association. Brother Leasure has devoted much time to improving the housing conditions, undergraduate operations, and alumni operations of Zeta Chapter. He organized the chapter's very successful 75th Anniversary Sig Bust and has organized numerous other alumni events. Brother Leasure received the Delta Beta Xi Award at special ceremonies at the Zeta Chapter house on December 1st.

James R. Maher, American '68 has served his Beta Chi Chapter as Grand Chapter Advisor, Alumni Corporation President, and Alumni Corporation Treasurer through the past 15 years. Brother Maher was instrumental in keeping the chapter alive during the tough times in the early 1970s. His help in rushing new members and assisting in chapter financial matters during that period is a tribute to the strength that Beta Chi has retained. Brother Maher was awarded the Delta Beta Xi at a special dinner at the Beta Chi Chapter house on December 7th





Gordon L. Beeman James S. Reid, Tulane '68 has been

instrumental in the re-establishment of Alpha Theta Chapter at the University of Missouri, Brother Reid has served as the chapter's Grand Chapter Advisor and as the editor of the alumni newsletter since 1980. He, along with his father James I. Reid, Missouri '36, Delta Beta Xi '81, arranged for the purchase of a beautiful new chapter house in 1982 by forming the Alpha Theta Partnership. The Partnership has encouraged alumni to invest in the chapter house and provided the means to propel the chapter quickly into a leadership role on campus. Brother Reid has spent many weekends and evenings personally making repairs to the house and advising the young chapter. Brother Reid was given the Delta Beta Xi Award at the Alpha Theta Chapter Sig Bust.

offered words of wisdom and encouraged the new founders to "carry on their work with persistence." Grand Junior President Donald R. Morgan, Purdue '57 was the featured speaker of the evening, and Grand Secretary Edmund A. Hamburger, N.Y. Polytechnic '45 officially conferred the charter upon the chapter. Executive Director Robert M. Sheehan, Jr., Westminster '76 presented the traditional "Alpha Badge" and "Baby Blanket" on behalf of Eta Chapter, the previous newest installed chapter.

Delta Lambda at Stockton State was started as a local fraternity. Stockton's Greek System is very new (the college's first graduating class was in 1973). A small group of friends decided that they wanted something different from and better than the existing fraternities offered. This group of fifteen men began researching the different national fraternities and decided upon contacting Alpha Sigma Phi. The Assistant Dean of Students at Stockton State, Robert Cabello, Michigan '70 helped the leaders with their initial organization and has since served as a steadfast advisor to the group.

Delta Lambda was colonized in September, 1983, and by chartering time grew to 28 members. The new Stockton State Alpha Sigs have already taken leadership roles on campus and in the IFC. They have participated in fundraisers for the American Cancer Society and performed other community service projects.

Car loads of brothers from Beta Epsilon Chapter, Lehigh University, drove to Stockton State to participate in the initiation of the new brothers on December 7th. The Beta Epsilon brothers, led by HSP Andrew Bergdoll, Lehigh '82 and HM Richard Mansfield, Lehigh '82 set up and carried out the full initiation, Silent Dinner, and Black Lantern Processional with help from Patrick H. Madanba, Jr., Widener '81, Cabello, and the Headquarters Staff.

Grand Treasurer, Robert A. Sandercox,
Bethany '51, presented the charter and was the featured speaker at the Chartering Banquet the next evening. Sandercox encouraged the new brothers to "enjoy your successes this evening, but put them behind tomorrow as you set even higher goals." The Stockton State Dean of Students, Peter N. Mercado, welcomed the new chapter to campus enthusiastically and led a round of applause for Cabello, "who has helped the IFC and Alpha Sigma Phi so very much by his dedicated service." Hoyt's portrait will soon be displayed in the National Headquarters as a never ending tribute to his generosity.

Alpha Sigma Phi's mission and ideals are unsurpassed within our brotherhood," says **Stan N. Miller, Purdue** '64, Chairman of The Third Founding Campaign and Immediate Past Grand Senior President. "We are all indebted to Brother Hoyt for his generosity and support of the "Old Gal's" future. His gift, and all the gifts to The Third Founding Endowment, will preserve the benefits of our brotherhood for generations of future Alpha Sigs. John R. Hoyt was initiated into Alpha Sigma Phi on December 8, 1929, at Alpha Zeta Chapter, U.C.L.A. After receiving his B.A. degree he was commissioned as a Naval Aviator and ordered to the U.S.S. Lexington as a fighter pilot. When World War II was declared, he was transferred to the Bureau of Naval Personnel, in charge of five Flight Instructor Schools. In 1946, he was released to inactive duty as a Commander. In 1954, Brother Hoyt received the Delta Beta Xi Award for service to the Fraternity. This was at the time that he served as President of the Alpha Zeta Chapter Alumni Corporation.

During the years, he has published over 200 magazine articles and three books, the last of which was entitled *As The Pro Flies*; it is still selling well in 1985.

Brother Hoyt and his wife, Mary N. Hoyt, a member of Delta Delta Delta, reside on their three acre estate in Solvang, CA.
