Washington Celebrates 75 Years

*"Congratulations to each and every one of you for the achievements you have forged here in the last seventy-five years. All of us at Alpha Sigma Phi know your collective achievements came about with a great deal of hard work and struggle—but isn't that what our brotherhood has been about since its founding more than 140 years ago? It takes a great deal of hard work and struggle to make a Chapter as great as Mu. The hard work and enduring interest of our Brothers have contributed to the greatness of Alpha Sigma Phi and to the fulfillment of its goal—to exemplify and implement the time-honored principles summarized on the cover of our pledge manual **"TO BETTER THE MAN."**"*

It was in this eloquent manner that Grand Junior President **Edmund A. Hamburger, N.Y. Polytechnic '45**, expressed the congratulatory remarks of our 50,000 member Fraternity to Mu Chapter on the occasion of its 75th Anniversary Celebration on May 16. Accompanying Brother Hamburger was a delegation including Executive Director **Robert M. Sheehan, Jr.**,

Westminster '76, Executive Secretary Emeritus **Ralph F. Burns, Ohio Wesleyan '32**, and Grand Province Chief **Robert W. Kutz, California '67**.

Over 200 alumni and undergraduate brothers gathered at 4554 19th Avenue in Seattle, where the chapter house has been located since the 1920's, for the gala celebration. Alumni traveled from as far as Florida to attend. Following a two-hour reception, the gathering was treated to a sumptuous meal prepared by the house cook. Master of Ceremonies **Mark Still, Washington '75**, welcomed the brotherhood and coordinated a program filled with awards and congratulatory remarks.

Perhaps the most exciting moments were the surprise announcements of the Delta Beta Xi Award given to Grand Chapter Advisor **Jack Merrill, Washington '39**, and the Distinguished Merit Award given to **Dr. William B. Hutchinson, Washington '29**. Brother Merrill's award honors his years of dedicated volunteer service to the undergraduate chapter. He also served as co-chairman of the anniversary celebration. This issue of *The Tomahawk* is dedicated to Mu Chapter and its proud brotherhood. Photos from the anniversary celebration appear throughout this issue. Penn State Dances to Record Fund-Raiser

Five years ago Upsilon Chapter at Penn State finished second in the university IFC's charity dance marathon. They decided that second best was not good enough—and they have finished first in every year since.

For the fourth year in a row the Penn State Alpha Sigs teamed up with Alpha Sigma Alpha Sorority to capture the fund-raising championship. The team raised over **\$87,000** for the charity benefactor—The Four Diamonds Children's Cancer Fund at Penn State's Hershey Medical Center. The total raised by the combined 250 Interfraternity Council dance teams raised \$300,000. The event is the largest collegiate charity fund-raiser in the nation.

How do they raise so much money? "We work very hard and are very organized," says **John Moore, Penn State '84**, the 1987 Dance Chairman. Organized is right. All of the dollars are raised before the dancing ever begins. For the past three years the chapter has needed the full time use of a personal computer for their effort. The computer maintains records of gifts given in the past by local businesses and individuals. The computer data-base then helps produce personalized letters to both the individuals and businesses. The brothers try to encourage renewals and increases in donations every year.

But computer technology cannot replace good old fashioned hard work. "We send teams

of brothers to every major city in a four-hour radius to go 'canning'," says Moore. "Most people are very helpful. Nobody likes the idea of kids having cancer, and the Four Diamonds Fund helps children from all over the northeast—all over the country, really." Teams of brothers and their sorority teammates travel to Pittsburgh, Philadelphia, Rockville, Harrisburg, Erie, Washington, D.C. and many cities in between. "We just try to find areas where there will be a lot of people. We carry our signs and our cans and ask people to help," he says.

After weeks of "canning" and 48 hours of dancing, is it all worth it? "Well it does take a lot of time, but for those kids—just to know that it will help them—it's definitely worth it. We're going for our fifth first place finish in a row."

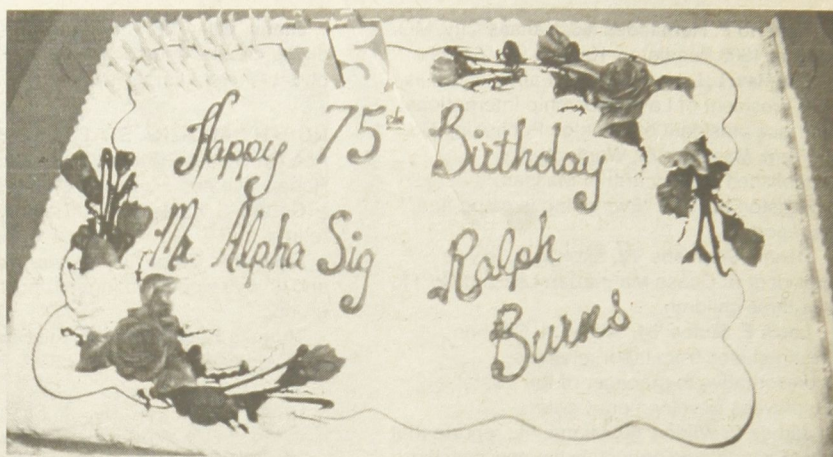

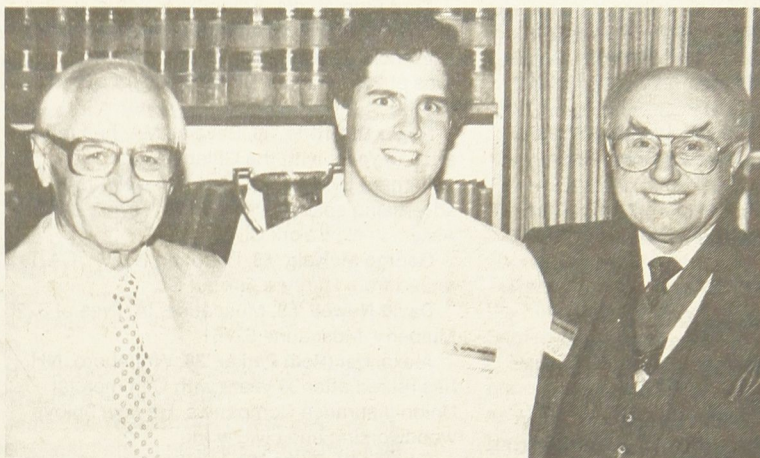

Hutchinson Receives Merit Award

In 1931, Alpha Sig **Dr. William B. Hutchinson, Washington '29**, decided, after starring in baseball at Washington and playing a summer of pro ball, to enter Medical School. However, his younger brother, also an Alpha Sig, **Fred Hutchinson, Washington '39**, decided that a pro baseball career was for him. He went on to have a very successful career as a player and manager. He managed the Cincinnati Reds when a rookie named Pete Rose joined the team.

Sadly, Fred Hutchinson's life was cut short by cancer at age 45. But his struggle with the disease further inspired his brother to continue pursuit of his chosen specialty—control and cure of cancer, the very disease that claimed his brother's life.

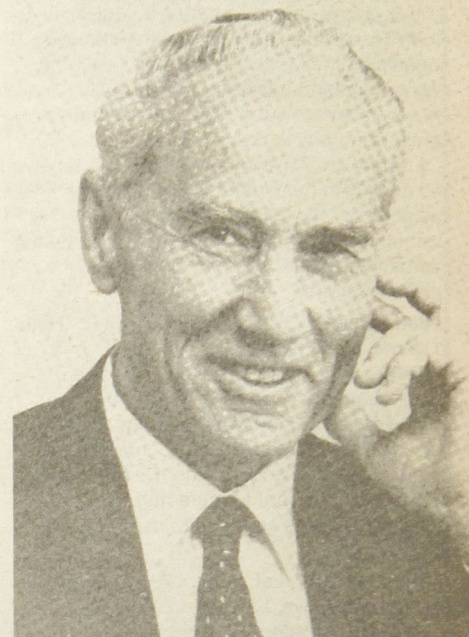
"Dr. Bill," as he is affectionately known around Mu Chapter, is one of the world's leading cancer researchers and surgeons. In 1956, after twenty-five years of surgical practice in Seattle, he became President and Founding Director of the Pacific Northwest Research Foundation. His noted expertise led to his appointment to the U.S. Senate Committee which drafted the National Cancer Act of 1971. Funding from that act allowed Brother Hutchinson to found one of only eighteen comprehensive cancer clinics in the country. In 1972, he became President and Founding Director of the Fred Hutchinson Cancer Research Center—named in tribute to his deceased brother.

Today, the research budget for the Fred Hutchinson Cancer Research Center exceeds

\$22 million. The center specializes in treatment of leukemia patients with bone marrow transplants. More bone marrow transplants have been performed at the Hutchinson Center than in the rest of the world put together. The waiting list of patients has stood at over 100 for several years. The success and world renown of the center is a tribute to Brother Hutchinson's perseverance and dedication.

In 1978 Brother Hutchinson was elected President of The XIII International Cancer Congress, and his honors have continued since, including being named First Citizen of Seattle and Alumnus Summa Laude Dignatus by the University of Washington.

The Grand Council of Alpha Sigma Phi voted unanimously that the 1987 Distinguished Merit Award—given only once annually to an alumnus who has distinguished himself in his professional career—should be made to **Dr. William B. Hutchinson, Washington '29**, based upon his remarkable record in cancer research and treatment. Grand Junior President **Edmund A. Hamburger, N.Y. Polytechnic '45**, made the award at Mu Chapter's 75th Anniversary Banquet to the thrill of over 200 Alumni and undergraduate brothers. He was the first Mu brother to ever receive the award and joins a long list of distinguished recipients including actor **Vincent Price, Yale '30**, industrialist **Joseph B. Lanterman, Illinois '34**, U.S. Senator **James B. Allen, Alabama '30**, theologian **Reinhold Niebuhr, Yale '13**, among many others.
