

In the spotlight: Surgeon General Dr. C. Everett Koop

Dr. C. Everett Koop, Dartmouth '34 is a man with a great deal of name recognition. As the Surgeon General of the U.S. Public Health Service, Brother Koop's name has become synonymous with the crusade against the number one public health enemy: smoking, as well as for the cigarette labels that bear his imprimatur. The crusade for a smoke free society by the year 2000 has generated enough interest and support to arouse the fear and resentment of the tobacco industry. A June 1986 Gallup poll showed that cigarette smoking dropped to its lowest point in 42 years—31% of adults questioned who smoked was down from a high of 45% in the mid-1950's. For men, it stood at 35%; women, 28%. The biggest drop came in the 18-29 age group, which fell 11 points to 27%. Nevertheless, the Surgeon General's opposition is formidable, and as he has said, the tobacco industry tells "flat-footed lies, like 'We don't really know what causes cancer.'"

Tobacco's place in society dates back to the 1700's when as the colonies' top cash crop, it bankrolled the revolution. Since then, its privileged place has held strong thanks, in part, to advertising. But that was before C. Everett Koop became U.S. General Surgeon.

The industry swears it uses ads only to persuade smokers to switch brands. Koop views cigarette advertising as deadly enticement for the young.

This past summer the fur flew over a Congressional bill that would ban all tobacco advertising in this country—an emotionally charged topic that wraps the concept of free speech around the threatened loss of billions of advertising dollars.

The Surgeon General endorses the idea; the White House, still enjoying a honeymoon with American big business, doesn't. So just before Koop hiked up Capitol Hill to testify before a House subcommittee, President Reagan's then Chief of Staff, Donald Regan, told the doctor to tow the administration line. The resulting publicity later forced Regan to relent, but not before he made it clear Koop was speaking only as an informed citizen, not as a presidential emissary.

Brother Koop told the House Energy and Commerce Subcommittee on Health and Environment that "cigarette ads have an insidious effect on the population as a whole by maintaining and encouraging use and undermining health education efforts." With the odds seemingly stacked in favor of the tobacco industry one wonders where this controversial public figure acquired the fortitude to surmount the seemingly impossible.

Becoming Surgeon General was in and of itself seemingly impossible six years ago. Brother Koop's nomination was one of President Reagan's most bitterly contested, with detractors calling him a right wing, religious, anti-abortion zealot with no public health experience. Opponents charged that he would use the position to preach his own conservative social agenda. The ensuing debate resulted in confirmation hearings that took nearly a year.

During that time he would return home at night to the cramped Washington apartment he and his wife had rented and say, "I can't take any more—I don't know what we're doing here. Let's go home to Philadelphia." To which Betty, his wife of 48 years would reply: "Let me remind you—you're unemployed in

Philadelphia. Let's stick it out." Koop stubbornly refused to retreat, and reflecting back has said, "If I were going to leave Washington, as ignominious a defeat it was going to be, I was going to be nonconfirmed. I was not going to leave because there were people trying to get me to leave."

That "stick it out" ingredient in his character has made it nearly impossible for the imposing 6-foot-1, 206 pound figure with the booming voice, an intimidating demeanor and the same kind of neatly trimmed, square cut beard favored by his Dutch ancestors, to ever abandon anything he has set out to accomplish. He is the first Surgeon General in years to actively encourage the wearing of uniforms at the Public Health Service, an act he has described as "a real morale booster." And on Wednesdays, which he has dubbed "uniform day," he looks very much the modern day Captain Ahab, ready to put out to sea, resplendent in his gold buttons, braids and ribbons and ready for the task at hand.

The office of the Surgeon General has traditionally not been viewed as a bureaucratic fortress, and in many ways the position is symbolic. Nevertheless, Dr. Koop is required to report to Congress annually on smoking and health. In 1986, the report focused on the suspected effects of "sidestream" or second hand smoke on the non-smoker. His other responsibilities are to advise the public on diet and nutrition, environmental health hazards, the importance of immunization and disease prevention along with warnings concerning the dangers of smoking. The Surgeon General also oversees federal hospitals and research facilities.

Today, well into his second four-year term as the nation's Surgeon General, he has established a brilliant public service career and as a result has received much respect and admiration. Nevertheless, six years as a team player in the Reagan administration hasn't made Brother Koop afraid to air his views on controversial subjects that others might find easy to side step: Pornography is a moral cancer. Abortion is wrong. Television violence promotes aggressive behavior. Video games addict youngsters. Too many Americans kill

themselves with sugary, fatty diets.

Despite earlier concerns, however, he has not used his public platform to wage a campaign against abortion. "I don't have any authority to change the law," he says. "I haven't changed my position—I've always been hard line on abortion—but, I have extraordinary compassion for those who have to make those decisions." Prior to entering the Public Health Service, Dr. Koop had a reputation as one of the leading pediatric surgeons in the nation.

The only child of a banker who was reared in Brooklyn, NY, Koop decided to become a doctor at the age of five. "I saw a movie about a surgeon," he says. "When I saw what he could do—remaking lives—I never wavered from it. I've been dedicated to it ever since."

His debut as a surgeon came unexpectedly. He was a pre-med student at Dartmouth and had landed a summer job at a Long Island hospital, where the Chief of Surgery became his mentor. One day, as Koop stood in the operating room watching the Chief Surgeon getting ready to amputate a leg, he was startled when the doctor said to him:

"Koop, why don't you do it?" Without hesitation, the 19 year old Koop took over. The operation was a success and the patient lived to later thank Koop for saving his life.

It was also while he was a student at Dartmouth and an undergraduate member of Alpha Eta Chapter that Koop first met his wife Elizabeth. They met at the Dartmouth Winter Carnival in 1936. She had come from Vassar College for the weekend. "She was the date of someone else—and I swiped her." Koop graduated from Dartmouth in 1937, married Elizabeth in 1938 and graduated from Cornell Medical College in 1941.

Seven years later he became the Surgeon-in-Chief at Children's Hospital in Philadelphia. He was one of only six pediatric surgeons in the country, now there are over 430. Surgeons were reluctant in those days to operate on children. "There was no basic science," he says. "It all had to be worked out." It was considered too dangerous to put an infant under anesthesia.

Doctors insisted that surgery be postponed until children were older. "Some poor kid would come into my office in a truss and I'd say to his doctor 'Why is he wearing that thing?' The doctor would say, 'I can't operate on him until he's 6.' I'd say, 'I'll do it tomorrow.'" He faced immediate and widespread skepticism from general surgeons who were unhappy over the growing specialization of their field.

At one point, Brother Koop operated on his 2 year old son, Norman for a hernia. "Anybody I know would have made a four-inch incision and laced him up like a 39 cent football and told him to stay in the hospital for a week and then not to cough, sneeze or look cross-eyed for six more. I said, 'This can't happen to my child!'"

"My lifelong ambition," Koop says, "was to have the most competent group of pediatric surgeons in the country under one roof. It took me 33 years to do it." Among his accomplishments at Children's Hospital were the development of safe pediatric anesthesia procedures, a drastic lowering of the infant-surgery mortality rate, the establishment of the country's first neonatal intensive care unit, and numerous advances in pre- and post-operative care including the use of intravenous nutrition. With these facts in mind it becomes even clearer why Dr. Koop is one of the "Right to Life" movement's most eloquent supporters.

In 1957, he successfully separated a set of Siamese twins, but one sister died from a cardiac defect when she was nine. The other one reached adulthood, married and is still in touch with him.

Years later in 1974, Koop made worldwide headlines when he separated Siamese twins from the Dominican Republic who had been joined at the abdomen and the pelvis. Though the operation was not one of his most difficult, it captured the public imagination and made him a hero in the girls' country. Then one night in 1976 he received a frantic phone call from the twins' village priest. One of the twins had choked on a kidney bean. Koop delivered the eulogy at the funeral and later said, "It's almost as if you're fated not to be successful."

Brother Koop is well-known as a caring and compassionate surgeon. It has been his philosophy to deal not only with the patient, but to treat the whole family. He would skillfully deal with a family's anxieties and help them cope with the grief of losing a child simply by following up with a letter, a phone call, or often a personal visit.

It was this reputation for helping families deal with the loss of a child that ultimately has had a significant effect on his life. In early 1968, he realized that four members of his staff had become specialists in each of four pediatric problems "and each had a child born to his wife with that very same problem."

He asked himself: "What am I famous for?"

With horror the answer came: "Dying children."

A premonition, which he shared with no one began to gnaw at him. "I was convinced I was going to lose one of my children," he says.

Later that year his son David, a twenty year old junior at Dartmouth College, was killed in a rock avalanche in the White Mountains of New Hampshire. Koop refers to the loss of his son as the most profound event in his life.

The loss of his son seriously affected his professional detachment and it was quite awhile before he regained the strength to help another family who had experienced a loss. Koop remembers, "The first time I had to sit down with a family I couldn't even talk to them."

Ten weeks after the accident, Koop and his wife found their son's Bible opened to the second-to-last verse of Jude, the final passage David had read before he died: "And now unto him who is able to keep you from falling . . ." Years later the Koops wrote a short book about their son's death called *Sometimes Mountains Move*. It details how their religious faith enabled them to endure the tragedy. Koop is proud to know that many people have told him and his wife how much it has helped them deal with grief.

The Koop's surviving children are Allen, 42, a history professor at Colby-Sawyer College in New Hampshire; Norman, 40, a Presbyterian minister in New Jersey, and Elizabeth Thompson, 35, known as Betsy, a homemaker in Georgia. Brother Koop also has seven grandchildren.

The Surgeon General is also busy keeping a diary of his days on the banks of the Potomac with the hopes of turning it into a book after leaving the Public Health Service. But for now Koop is content to begin his day at 5 a.m., arriving in his office by 7:15 a.m., and not returning home until twelve hours later.

Brother Koop turned seventy in October, but certainly doesn't look or act like it. He always says, "It takes an old man like me to keep the schedule the younger men set."

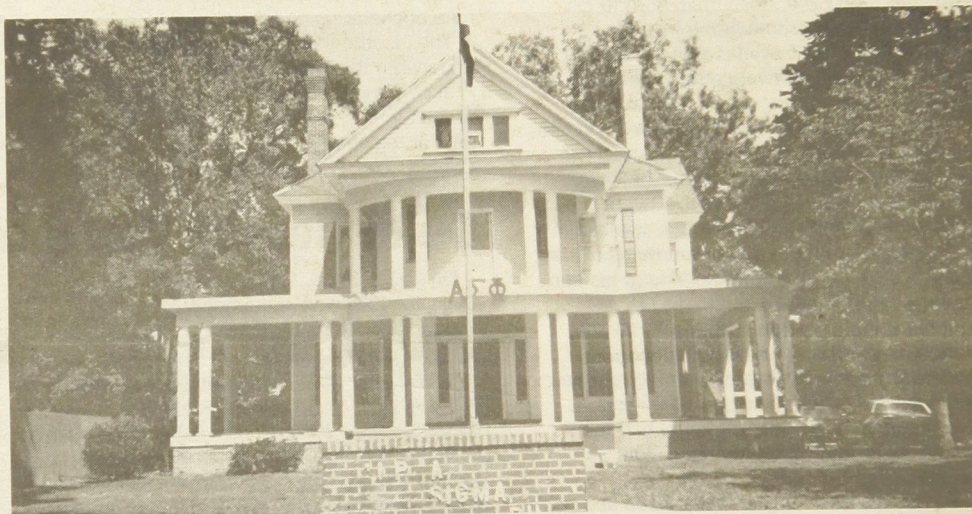
Province I

This fall the brothers were once again very successful in our intramural sports efforts and have really built a name around campus as a truly competitive opponent.

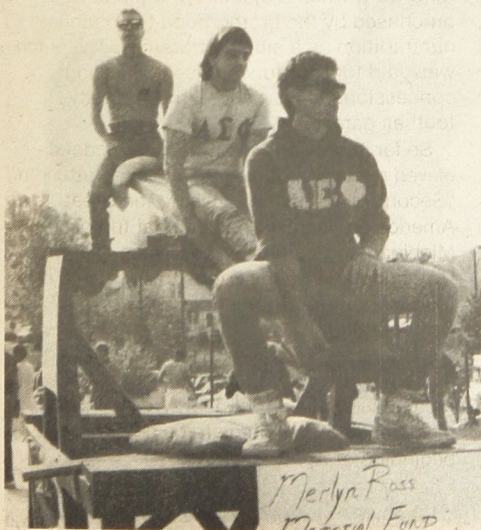

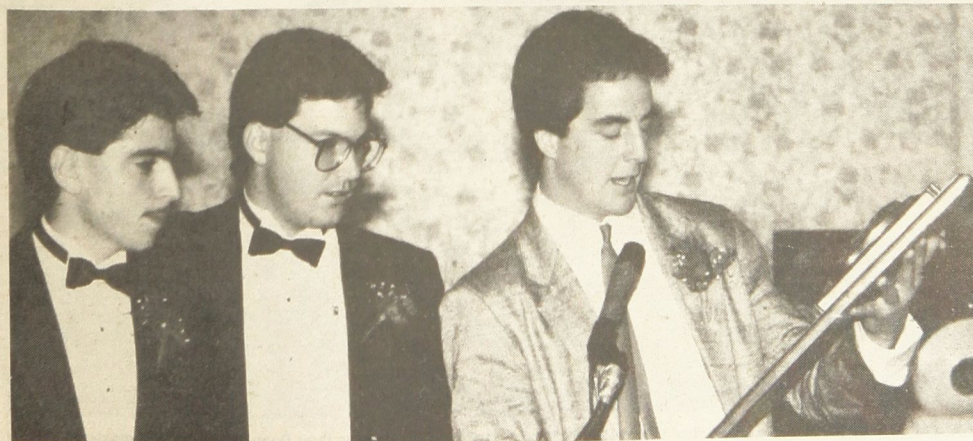

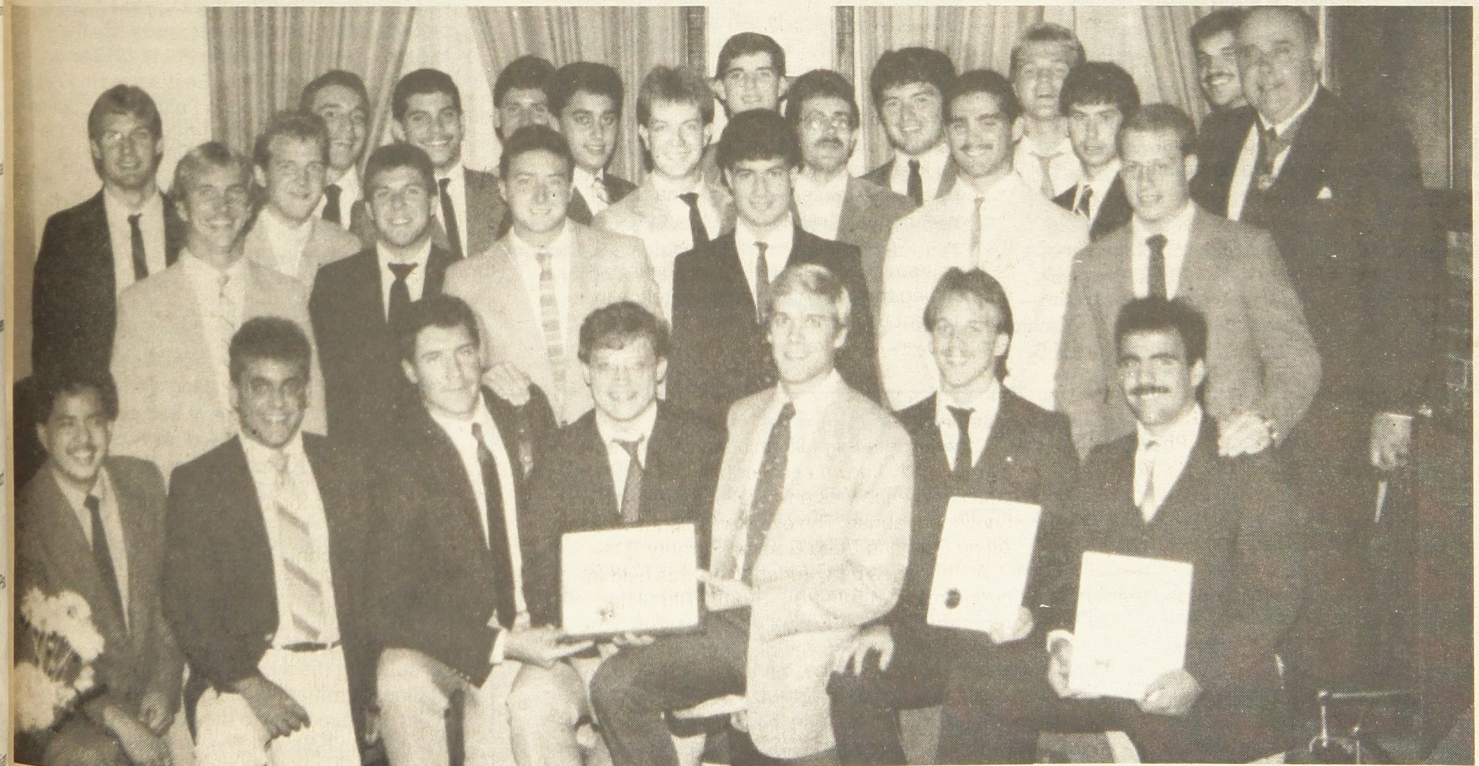
Lock Haven University

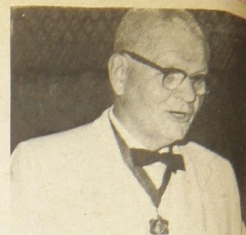

Former Grand Senior President **Donald J. Hornberger, Ohio Wesleyan '25** passed away at the age of eight-nine in Delaware, Ohio on November 17, 1986. Brother Hornberger had been retired since 1962 prior to which he served as Vice President and Treasurer of Ohio Wesleyan University. Brother Hornberger received the Delta Beta Xi Award in 1946 and was again recognized for his outstanding leadership and dedication in 1964 by receiving the Evin C. Varner Distinguished Service Award. He served on the Grand Council of the Fraternity for eighteen years; ten years as Grand Junior President and two years as Grand Senior President.

Six weeks shy of his 100th birthday, **Dr. Elbridge "Jack" Best, California-Berkeley '13** passed on, to the Omega Chapter. 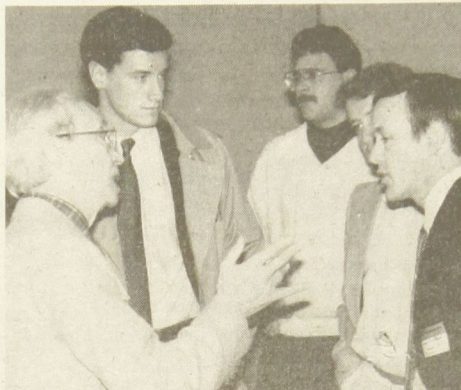

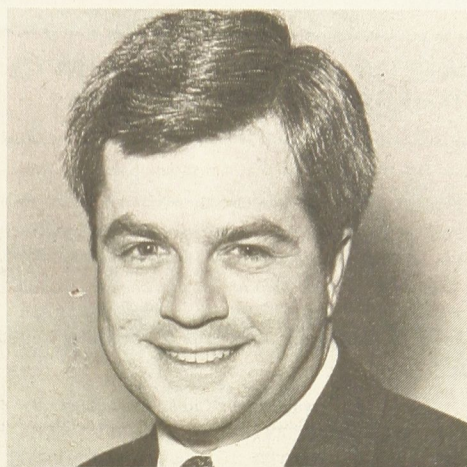
