#### LITTLE SISTER GROUPS

Discussed at the February 6, 1988 Grand Council meeting was "little sister" groups. Although the groups have never been recognized by the fraternity, some chapters still have them. The Grand Council voted to abolish the "Little Sister" pin and to support the National Interfraternity Conference's statement on "little sister" groups which states:

#### RESOLUTION REGARDING "LITTLE SISTER" GROUPS

Whereas, the National Interfraternity Conference believes sororities and women's fraternities offer excellent opportunities for women to share a fraternal experience, and

Whereas, auxiliary women's groups organized by men's fraternity chapters, commonly referred to as "little sisters" are inconsistent with the concept and philospohy of separate and equal women's fraternities, and

Whereas, the National Interfraternity Conference believes that these groups inhibit the accomplishment of chapter goals by:

\*Diverting resources of time, effort and money, which are needed for chapter operations and programming;

\*Distracting chapter members in the performance of essential duties...e.g., membership recruitment and membership education.

\*Inviting disharmony within the chapter by usurping the roles and responsibilities of initiated members;

\*Weakening the bonds of brotherhood by adversely affecting interpersonal relationships within the chapter; and

Whereas, the Fraternity Executives Association and several member fraternities have taken a position against these auxiliary groups,

Be it resolved, That the National Interfraternity Conference and the Presidents of its member fraternities believe that "little sister" groups are not desirable adjuncts to the collegiate chapters of men's fraternities and urges and recommends that member fraternities work with their chapters to eliminate these programs at the earliest possible time.

There will no longer be any "little sister" pins available for purchase. Reproduction of the pin will not be allowed in any shape or form. This pin may be reintroduced at a later date as a form of special recognition to our brothers and is the property of the National Fraternity.



#### REVOCATION OF THREE CHARTERS BEGUN

Also, at the February 6 meeting, the Grand Council voted to begin revocation procedures on three chapters. They are: Beta Zeta - N.C. State, Gamma Delta - Davis & Elkins, and Gamma Mu - Charleston. The chapters have received written notice of this procedure as will the alumni. They then have the opportunity to present a case for why the charter should not be revoked at the summer Grand Council meeting during the National Leadership Conference and Convention.

The reasons for revocation procedures to begin include but are not limited to the following:

- 1. No development programs act more like a social club than a fraternity
- 2. Continued low membership
- 3. Financial irresponsibility
- 4. Lack of following our "Reasons for Being" or "Code of Conduct"
- 5. General poor performance/attitude of membership

#### RUTGERS MAN DIES

James Callahan, 19, died February 12, 1988 due to pulmonary edema, a filling of the lungs with fluid. Sources say that he was at a prospective member party at Lambda Chi Alpha in which it is alleged he was encouraged to drink large quantities of alcohol. The death of this young man is a tragedy for the society of America, especially the fraternity system.

The chapter was "closed" by Dr. Edward Bloustein, the President of Rutgers, while encouraging the Alumni Corporation of Lambda Chi Alpha to close it permanently. The university is also requesting that the International Headquarters of Lambda Chi Alpha remove the charter of the local chapter. The president is also investigating the possibility of not recognizing the entire Fraternity system.

Our Beta Theta Chapter is being very smart in their operations and are being supportive to the system. They are very concerned with their system and what will happen to it. The brothers took 14 pledges the night of the incident and feel very positive about their operations.

Past Grand Senior President, **Richard Dexter, Oregon State '60** makes the following observation about the Rutger's incident:

"This is a real tragedy—counter to everything we have been trying to promote. A graphic example to our chapters and chapter officers of their responsibilities and the risks they run personally for not enforcing a responsible drinking policy."

It is important for us to remember that every member, pledge, rushee, guest, etc., is our responsibility. It is imperative that we strive to make our existing environment a positive one that eliminates peer pressure that destructs or has the potential to destruct one's physical or mental well-being.





#### PHI ETA AND BETA IOTA COLONIES TO CHARTER

The Grand Council voted February 6th to grant a charter to Phi Eta - Illinois State University and Beta lota Colony - Tufts University.

Illinois State will charter on April 9, 1988 and take the chapter designation of Delta Omicron. Tufts' chartering date will be announced later. They will be reinstated as Beta lota Chapter.

Initiations will be held on the preceding Friday as all of the pledges will then become a part of the Mystic Circle of Alpha Sigma Phi. Their long awaited journey of becoming a fully initiated brother comes to an end as an even more challenging road toward a successful chapter begins.
