Alpha Sigma Phi adopts Canine Companions for Independence as national charity

It took years of planning.

It will give years of value.

Last fall, Alpha Sigma Phi voted to adopt Canine Companions for Independence (CCI) as our national philanthropy.

In a vote taken among undergraduate chapters, alumni councils, and past Grand Senior Presidents, and present members of the Grand Council, CCI was selected from an initial field of 24 national charitable organizations.

"This is like a dream come true for many Fraternity members," says **Alan M. Breedlove, Penn State '77**, chairman of the national advisory committee on service. "It's something that's been talked about for years. Our constitution supports the adoption of a national charity, and even our Reasons For Being command that we 'maintain charity.'"

Canine Companions matches specially trained dogs to physically impaired people to assist them with the chores of daily living. Each dog responds to some 70 to 80 commands for tasks ranging from something as simple as assisting a hearing impaired person across the street, to more complex tasks like retrieving goods from grocery shelves for people who are wheelchair mobile.

"Our goal in selecting a national charity was not to mandate to our Brotherhood which charity we would support," Breedlove says. "We wanted a process that sought affirmation from the undergraduate chapters. I'm excited about the resounding acceptance of Canine Companions."

Charity is not new to Alpha Sigma Phi.

In fact, every year thousands of undergraduate and alumni Brothers take time to remember the welfare of others. Funds are raised for all manner of charities. Thousands of hours are donated for projects ranging from stuffing envelopes to upgrading substandard housing.

And lives are positively affected by Alpha Sigma Phi living up to the purposes for which our Society was formed.

Breedlove says adoption of CCI should not be considered as a replacement for local charitable activities.

"Many of our chapters have active, on-going philanthropic projects. We want that to continue. But by having CCI as our national charity, we want to focus chapter efforts once or twice a year to support this as our primary cause," he says.

The advisory committee on service spent countless hours researching possible national charities with the objective of determining on which one Alpha Sigma Phi could have the greatest impact.

Canine Companions proved ideal. Based in Santa Rosa, California, the organization has local



chapters operating near each undergraduate Alpha Sigma Phi chapter. And it is small enough that Alpha Sigma Phi's efforts can be felt.

"We didn't want to get lost as just another contributor to a large charity," Breedlove says. "We believe CCI is the perfect fit for Alpha Sigma Phi."

Perhaps the two biggest keys to making CCI Alpha Sigma Phi's charity are the organization's commitment to helping young people and its openness to allow members to interact with the people we help.

"The synergy between our two organizations is terrific," says Breedlove. "CCI is committed to

introducing recipients of Alpha Sigma Phi's largess to our undergraduate chapters. Chances are there will be people living in the same communities as our chapters who benefit from Alpha Sigma Phi's involvement with CCI. We'll be able to meet the people we help, make friends and stay in contact.

"That's much more appealing—and has a bigger impact—than just donating money, though fund-raising opportunities to support CCI are possible."

CCI is launching an effort to place more dogs with physically impaired young people, especially those in the 16 to 25 age range.

Each recipient attends an intensive residential training program in one of CCI's five centers scattered across the country. After initial training, each recipient receives follow-up instruction and adjustment to make sure that the dog and master are suited to each other.

The cost? Ten thousand dollars or more for training and placement of one dog.

Presently, the waiting list for a dog is more than 660 long.

To help chapters conduct successful charitable projects, Breedlove and his committee are presently working on a Service Manual which provides step-by-step explanation of how to conduct projects.

The Service Manual details how to identify a charitable cause, how to organize a project and how to motivate the chapter to become involved. Canine Companions is used as an example throughout the manual.

"We see the manual as a way to enhance the efforts of our chapters presently engaged in charities and as a way to encourage others to get involved," Breedlove says. "The idea is to have fun, build our sense of Brotherhood and sharpen



our organizational skills—all while we're helping other people.

"We want every Brother to experience how rewarding and much fun it is to open up and give of ourselves."

Breedlove indicates the adoption of Canine Companions for Independence will be formally kicked off at next August's National Leadership Conference as a start to a long-term association between the two organizations. But he hopes that chapters will undertake projects to benefit CCI this spring and summer.

As charitable work receives more emphasis on a national level, there will undoubtedly be increased attention given to the Chapter Service Awards presented at Convention.

But the enduring personal awards are what excites Breedlove most.

"We are the Fraternity 'To Better The Man,'" he says. "I can't think of a better way to ensure that we are creating experiences for our Brothers to be good citizens for life."

What is risk management and why do we need it?

Assume the following facts: You are the president of your chapter. Last Friday evening, your chapter sponsored a party with one of the sororities on your campus. Alcohol was served and you and the president of the sorority agreed that each would be responsible for monitoring the members of both chapters to ensure that nobody under the age of 21 drank alcohol. The party was held at your chapter's house and began at 9:00 p.m. and ended at midnight. At the party, Sue, a member of the sorority, celebrated her 21st birthday, although Saturday was actually her birthday. Neither you nor any member of your chapter had personal knowledge that Sue was not 21 at the time of the party. At about 1:00 a.m. on Saturday, Sue, apparently intoxicated, backed out of your chapter house's dimly-lit parking lot and hit Joe, also intoxicated at the time, who was returning to the chapter house from a party with the other mem-

bers of your chapter who were under 21.

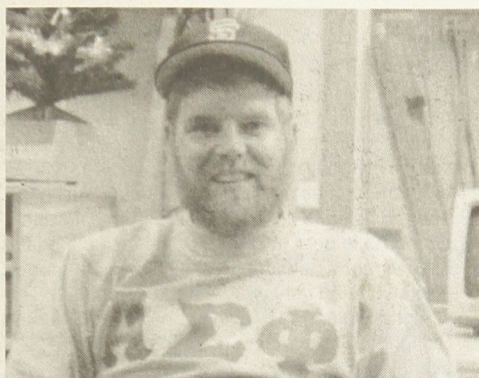
Although Joe's injuries were not life-threatening, Joe did require hospitalization for a broken leg and arm. Joe's parents, outraged at the incident, hired an attorney who sued many parties including your chapter, your national organization, your alumni association and house corporation, your chapter advisor, you (the chapter president) and each of the other chapter officers. What do you do now?

Unfortunately, the scenario described above could happen to any chapter of any Greek organization. Although the chapter only wanted to have "fun," the chapter and many other groups and individuals wound up defending themselves against a lawsuit. The whole event actually became a financial and emotional drain to many, whether or not they were directly or indirectly

involved. How could this have been prevented? Through **RISK MANAGEMENT**.

But what is risk management? Risk management involves a three-stop process. To begin with, the chapter must always identify potential risks associated with each chapter activity. In the above scenario, the potential risks were: 1) chapter sponsoring event where alcohol is served, 2) underage drinking, 3) poor monitoring of party attendees, 4) inadequate check of valid identification, 5) lack of alternative beverages for minors, 6) too much emphasis on alcohol and not enough emphasis on creative programming at party, 7) inadequate lighting in chapter house parking lot, and 8) lack of alternative transportation. Identifying risks is the first step in proper risk management.

The second step is to educate chapter members about the risks involved in chapter-sponsored events. Each brother must understand how his actions (i.e. underage drinking, not fulfilling monitoring duties, allowing or overlooking underage drinking) could lead to legal liability. By educating chapter members, the chapter will be able to take appropriate precautions in order to minimize and manage the risks. Upon occasion, a chapter will encounter undergraduates or alumni who believe that their actions will have no legal impact. These individuals usually will condone or encourage underage drinking. These people are wrong. If the chapter cannot educate these individuals regarding the risks associated with their actions, their attendance at high-risk events should be prohibited.

Finally, the chapter must manage the risks in order to decrease or eliminate the risks. No event can be risk-free. Chapters, however, should do what is necessary to reduce the risks and to act responsibly and in compliance with the law. In the above scenario, the chapter could have done the following acts to reduce the risks at the party: 1) if the chapter decides not to sponsor an alcohol-free party, then the chapter cannot purchase the alcohol, but either allow the attendees to bring their own or hire a professional bartender and

have a cash bar, 2) have *sober* monitors at the party who will ensure that no alcohol abuse and no underage drinking is occurring, 3) have sober monitors at each entrance checking picture identifications and marking each individual (i.e., hand stamps or wrist bands) as to whether they are of legal age to consume alcohol, 4) provide alternative beverages and nonsalty food, 5) provide some type of entertainment to take the emphasis away from alcohol, 6) ensure that all areas of the house are clean, safe and well-lit, and 7) provide safe transportation home for those requiring it. All of the above would have reduced the risks associated with the party in the above scenario.

Risk management can be summarized as follows: 1) *identify* the potential risks involved with each activity of the chapter, 2) *educate* all regarding the risks, and 3) *eliminate* the risk. Does risk management mean that the members of our Fraternity will no longer be able to have fun? Definitely not. Risk management only means that we must all recognize potential risks and attempt to decrease or eliminate those risks.

Because of Alpha Sigma Phi's continuous commitment to risk management, *The Tomahawk* will now regularly publish articles regarding this issue and suggest ways of reducing potential liability. This column will address issues facing each chapter such as alcohol and drug use and abuse, hazing, date-rape, warrantless searches and discrimination. Each article will discuss and analyze a specific issue and propose possible solutions to manage the risk involved.

As the author of this column, I welcome and encourage any questions or suggestions from brothers that might be incorporated into the subject of future articles. I hope that this column will be a helpful tool when implementing and enforcing risk management policies and procedures within Alpha Sigma Phi. □

Alpha Sigma Phi goes to the ends of the Earth!

During the months of October 1991 through February of 1992, I had the incredible experience of living and working at the bottom of the world. As Information Systems Coordinator for Amundsen-Scott South Pole Station, a U.S. scientific base, my responsibilities included managing all computing and communications from the most remote place on Earth. Located just 300 meters from the geographic South Pole, the station is manned by a civilian staff, supporting numerous science projects. South Pole is one of three United States Antarctic research stations which are staffed year-round.

When offered the position, it immediately came to mind that the Alpha Sigma Phi flag should be flown at the South Pole. In late September, on a visit to the N.J.I.T. campus in Newark, and with the help of Ken Nevola and Lou Russo, we retrieved the very same flag presented to the Alpha Rho Chapter during our re-chartering of 1982.

The following message was transmitted from Antarctica by computer email, just minutes after the flag was raised at exactly 90 degrees South latitude:

At 03:10 GMT, 15:10 Local time, on Sunday, 27 October 1991, the Alpha Rho Chapter Flag of Alpha Sigma Phi Fraternity was raised over the geographic South Pole, Antarctica. Pictures were taken. Readings at the time of the raising of the colors were as follows: Temperature: -60.2 F/-51.2 C, Wind: 360 Degrees at 12 Knots, Pressure: 667.2 Mb, Visibility: 6 Miles in Ice and Fog, Windchill: -101.5 F/-74.2 C, Physiological Altitude: 11115 Feet/3388 Meters.

After speaking to some Antarctic program veterans with considerable "ice time," it is believed that Alpha Sigma Phi was the first fraternity to ever fly its colors at the South Pole! The flag was returned to the Alpha Rho Chapter at a house meeting on March 11, to the cheers of all in attendance.

The next adventure for the Alpha Rho Chapter flag is an expedition to the North Pole, which is currently in the planning stages. Alpha Sigma Phi truly will extend to the ends of the Earth! □

Beta Omicron Tri-State University

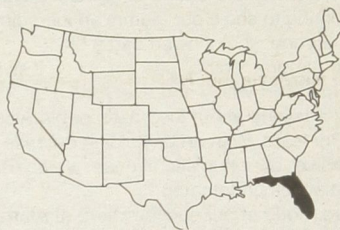

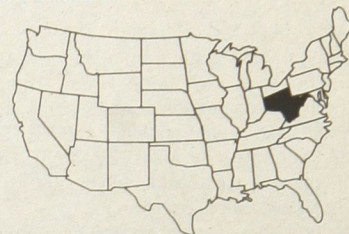
Gamma Theta University of Miami

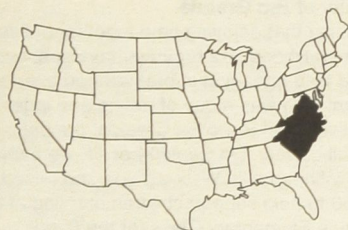

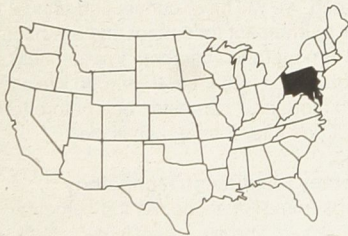
Beta Mu Wake Forest University

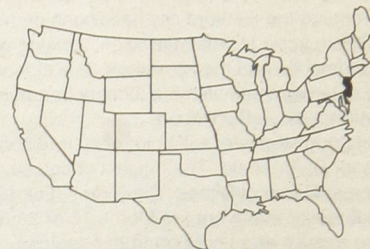

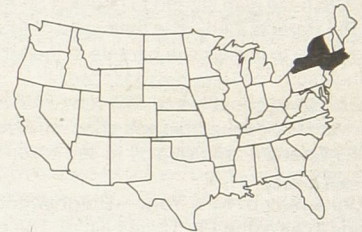

Book Review: His-Story

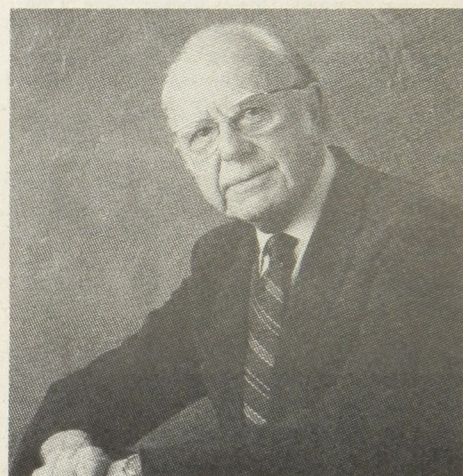

The following is a book review of *His-Story*, by **Robert Sheen, Lehigh '30**. Bob Sheen is Director Emeritus of the Milton Roy Company, St. Petersburg, Florida. He received the Delta Beta Xi Award in the class of 1955 and was Alpha Sigma Phi's Distinguished Merit Award winner in 1982. *His-Story* may be ordered directly from the author at 672 Boca Ciega Point Boulevard North, St. Petersburg, FL 33708. Robert T. Sheen's *His-Story* is far more than a fascinating, personal narrative of one of the nation's most successful industrial leaders—though certainly *it is* that. It is a highly readable guide for aspiring entrepreneurs of all ages on how to create and "grow" a service-oriented and prosperous business in a very competitive field. And it is an eloquent, though subtle, plea to leaders at all levels to seriously consider their obligations to their employees and to their communities so as to enhance the quality of life for all.

Throughout this attractively presented volume "Bob" Sheen illustrates vividly how a well thought out personal and management philosophy is urgently needed by anyone seeking higher responsibilities in organizational life. He tells us of his own discovery of that truth when, as a young engineer starting his own company, he suddenly realized that his excellent technical training had not necessarily prepared him to either manage or to lead.

A major value of this book for managers at all levels is to be found in Bob Sheen's stress on non-technical dimensions of management and leadership—in the espousal of a corporate culture that strongly encourages community involvement as inspired by the concerned and creative commitment of the organization's top

managers. An example, *par excellence*, is Bob Sheen whose gifts of time to various local, state and national conferences and commissions were immense and whose leadership and financial support to hospitals and Eckerd College were absolutely critical to the very existence of several of these institutions.

In a warm and candid recitation of the key, formative factors in his life, the author recalls the importance of family contributions to his religious faith, the crucial role scouting played in the development of his ethical values, and the extraordinary impact of dedicated and competent teachers at all levels of his education. It is clear that from these early underpinnings were spun the warp of innovative, technical competence and the weft of a management philosophy centered in the Golden Rule.

Although the book is a pure pleasure to read as an exciting true-life adventure story, it is in the careful re-reading for the lessons of life, of living, and of leading that it will provide endless, helpful examples for those thoughtful managers who aspire to true leadership. □
