### Letter to the Coastal Carolina HSP:

At some point, you and your chapter members should take some time to go into Charleston and take a look at the house at 6 Gibbs Street — it was a gift from the mother of the man we consider our principal founder, Louis Manigault.

At the time his parents moved into the house that was originally a gift from Louis' maternal grandfather to his mother, an arm of the Ashley River came up from where Battery Place is to the grounds of the 6 Gibbs Street house.

The house known in Charleston as the Manigault Mansion, 350 Meeting Street, was designed by Louis' grandfather, Gabriel Manigault, for his brother, Joseph Manigault. A painting in the dining room shows the Manigaults in Italy — Louis is the child in the red outfit.

Thomas Heyward, a great-uncle of Louis, was a signer of the Declaration of Independence, and two of his homes are preserved in Charleston.

Louis Manigault, his wife and one of his sons are buried in Magnolia Cemetery just off Meeting Street, about three miles from the intersection of Meeting and Broad.

Well, enough ancient history. My guess is the alumni of the Francis Marion Chapter that was active from 1983 to 1986 are your most likely prospects for some alumni support. At this stage of your chapter's development, however, the best thing it can do for its alumni program is to grow — initiate 25 to 30 men or more per year. By this means, Delta Sigma is most

likely to resist the troubles that frequently come to a new chapter when the founders graduate. It will have more alumni in the local area and will have a broader base on which to spread requests for support when a down-payment needs to be raised for a chapter house.

Best wishes for the long success of **Delta Sigma Chapter!** You have Alpha Sigma Phi heritage in South Carolina that few other fraternities can challenge.

### To the editor:

A comment on the "Alcohol Use, Abuse and Management" article in the summer 1993 Tomahawk. At the risk of being labeled reactionary, I feel that a National and Chapter "no alcohol" policy should apply, — at least in the case of house rules. I realize that such a policy would be pretty much unenforceable when functions are held at hotels, country clubs, or similar public facilities with bars. But even there, patronage at the bars should be discouraged, and alcohol should not be permitted in the Fraternity function. I hasten to add that I am not opposed to alcohol per se — I do use it myself. This, I think, is just a matter of social responsibility — financial considerations aside. While perhaps prehistoric, this was our chapter policy (in conformance with school policy) and, in my opinion, not only worked well, but certainly avoided many potential problems.

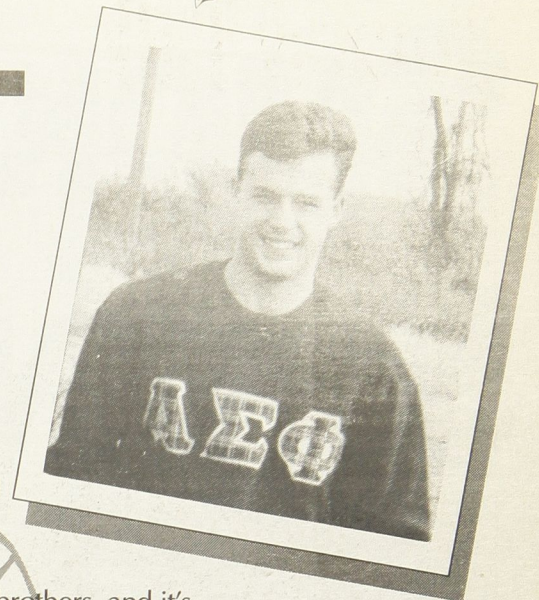

YOU BETTER KNOW WHAT TO DO

**A** major catastrophe happens: your chapter house burns down; a person connected with your chapter or with a chapter-sponsored event is injured or dies; the police raid your house in search of illegal drugs; an intruder breaks into your house and holds your chapter hostage or injures your members.

All of the above incidents have happened to various fraternities and sororities. They can happen again — to your chapter. The key to handling such a crisis is to develop an emergency procedure for your chapter.

The most important part of an effective emergency procedure is an appropriate chain of command. One person should be in charge and all others should follow his lead. If more than one person attempts to give directions, the chapter will be in a state of chaos. This person should be the president of the chapter, and if he is unavailable, the vice president.

It is advisable for your Prudential Committee to discuss emergency procedures for various catastrophes.

For example, all chapter members should be trained on how to exit the chapter house in an orderly manner should a fire break out. As part of your plan, assign one chapter member to each floor to ensure everyone gets out. Once all members are out of the chapter house, they should congregate in a predetermined spot so the president can see that all members are safe.

In any catastrophe, the chapter should obviously contact local emergency personnel: fire, rescue, police, etc. Next, chapter members should attend to any person who has an immediate need. The president should be aware of those members in the chapter that have specialized training or general first aid skills. All of these actions should be directed by the president who should remain calm and decisive. Calm and decisive leadership are important ingredients in a crisis situation.

After immediate needs are fulfilled, others must be contacted: the chapter advisor, designated university officials, Alpha Sigma Phi Fraternity Headquarters and the chapter alumni corporation/association officers.

As with any catastrophe affecting a local fraternity, news media will be seeking a story. Members of the chapter should be instructed not to respond directly to the media, but refer reporters to the president or other designated spokesmen such as the Grand Chapter Advisor or another local alumni member. When the president speaks with reporters, he should not draw conclusions or speculate blame. Further, it is unwise to point fingers at specific individuals or groups. The president, however, can use the media as a sounding board to show

that the Fraternity acted responsibly. For example, if fire destroys the chapter house, the president could state that he is not sure how the fire started, but that the chapter did have an effective escape plan to ensure the safety of its members. Obviously, every crisis should be carefully analyzed to determine what comments, if any, should be made. Only positive remarks should be addressed to the media.

The chapter house should be treated as a command station after a catastrophe. The president should assign certain individuals to i) man the phones so that a consistent message is disseminated, ii) provide security at the chapter house to prevent strangers from coming in, iii) relieve any individuals who may have assisted the injured party to the hospital, and iv) notify both the Fraternity Headquarters and the insurance company.

It may also be prudent for the president to contact a lawyer for advice as to how to deal with the particular situation. In the case of an injury or death, quite often a lawyer will advise not to have contact with the injured party or his family. However, this is not always the best way to proceed. We are all human, and we must deal with our emotions and express concern and condolences to the injured parties. Even though the chapter may wish to extend their sympathy or support, it is not advisable to discuss the cause of the injury. Therefore, Fraternity members should be encouraged to extend their condolences and assist the injured party but not to discuss who is liable or responsible for the injury.

Throughout the entire ordeal, it is the president's responsibility to lead the chapter back to a state of normalcy. At the beginning of the year, emergency numbers should be posted and emergency plans should be discussed with each member. Only by discussing possible emergency situations and establishing a proper chain of command, can a chapter be expected to deal successfully with catastrophic events both on a legal and emotional level.

By Emerson's definition and in the spirit of Pro Humanitae, Ron Niland, Wake Forest '77 has succeeded. Recently, his friend Greg Jones wrote a letter to the Wake Forest Office of Alumni Activities in which he described, with a special sense of candor and compassion, the difference his fellow Wake Forester has made in the lives of the people around him.

Ron came to Wake Forest in 1974 from Rockville, Maryland. He had been raised, as he puts it, "in the capitals of the world," where his father, a career foreign service officer, had been posted.

Ron's strong sense of social consciousness was broadened in his freshman year—Greg would say "liberalized"—through discussions with his friends. Those late-night debates in Kitchin House, it turned out, would have a lasting effect on Ron and his career in city government.

Ron made his first impact while serving as city manager in Hamlet, North Carolina. Besides serving as a deacon in his church and coaching a Little League baseball team, he secured a large federal grant to build a badly needed city hall.

In his first year of coaching, Ron met Len

Artis, a fatherless 11 year-old who was living with his grandmother. "If Ron hadn't taken a personal interest in Len," says Greg, "he'd be in jail by now." Ron became a surrogate father for the boy, taking him places with his own family, making him study, helping him get a part-time job, even co-signing for Len to get his first car. With Ron's support and constant encouragement, Len graduated from high school and entered the military. Today, Len is enrolled in a community college, studying to be a policeman.

Ron left city government for several years to take a higher-paying job as a sales representative. Hamlet's citizens, however, missed Ron's leadership so much that they asked him to return. Ron said yes, even though it meant a substantial cut in pay. Later, he and his family moved to Mt. Airy, but in the aftermath of the tragic industrial fire in Hamlet, Ron returned

again to console so many of the people he knew there.

Ron and his wife Maria and their two daughters have become an active part of the Mt. Airy community. They stay in touch with their Wake Forest friends, returning to campus often for Homecoming and other events. Ron fondly remembers his years as an undergraduate. He was a history major (or, rather, a "Smiley major," having taken all five of the courses David Smiley offered). Ron also recalls with great respect profes-

sors Robert Snyder in English, Robert Helm in philosophy, and Wake Forest friend Charles Talbert in religion.

As a classmate, a brother in Alpha Sigma Phi Fraternity, and a friend, Ron has made a significant impression on Greg and the many others with whom he has come into contact. We at Wake Forest are proud to recognize him as one of our own.

# Energizing Brotherhood:

OUR MISSION IS ENHANCED



Quick,

what's Alpha Sigma Phi's mission statement? Many brothers think it's "To Better the Man." Or is it the "Reason for Being?"

Actually, it's neither. The mission statement reads:

***"To Create and Perpetuate Brotherhood."***



**T**he mission statement was created out of a need to recharge the chapters with the spirit of the Fraternity. The theme of brotherhood is central to what Alpha Sigma Phi men stand for. A few observant brothers saw the need for a strengthening of the experience of brotherhood among the chapter members.

"The vision of the Fraternity, if we could capture it, comes from our founders," said Brother **Chuck Vohs, Penn State '75**, Chair of the Mission Statement Committee. "As an organization, what we need to do to fulfill that vision change depending on the socio-economic situation of the era."

### Back to Basics

Vohs believes certain Fraternity behaviors such as hazing, and alcohol abuse, indicate that the Fraternity had gotten away from its original meaning.

"If you asked our founders if that was what they intended, I don't think they'd say it was," said Vohs.

Vohs said there are trends that started after World War II that make it difficult for fraternities to do what they were created to do. The "excessive" behavior was not in agreement with what the Fraternity envisioned itself to be, he said.

He knew what the Fraternity envisioned and expected because Alpha Sigma Phi had taken on a strategic planning project in 1990. Many brothers were polled as to their impression of the Fraternity as it was and as it should be. The purpose was to help the national office better understand the needs of the members.

The project pointed to a need to redefine Alpha Sig's mission, and the way it would be accomplished. So in July 1993, the mission statement committee was organized, with Brother Vohs as the chairman.

### Mission: Brotherhood

The statement the committee came up with: "*To Create and Perpetuate Brotherhood*," means the Fraternity should be teaching and creating brotherhood — defined as the development of lifelong human relationships based on mutual love and support.

"Initiates don't come into the Fraternity already having this sense of brotherhood. It's the fraternity's responsibility to steward brotherhood — to set up those situations in which a sense of brotherhood automatically comes."

Brother **Jeffrey Hoffman, N.C. State '76**, said to him, "the intent of the new mission statement is to embody what's good about the Fraternity — to define how it should be perceived, and how it should progress.

"The purpose of Fraternity in general is to give young men a chance to participate beyond clubs. To give them an organization that lasts a lifetime, provides spiritual meaning and values, and gives them the opportunity to share that with other brothers," said Brother Hoffman.

### The Individual Experience

For the past three decades or so, most fraternities, including Alpha Sigma Phi, focused on achievement as it applied to the fraternity as a whole. There were team-type activities and pursuits, all designed to show "my fraternity is the best fraternity."

Alpha Sigma Phi sees a change toward the group supporting individual accomplishment, much like you would find in a functional family, explained Vohs.

"We want to enable the individual to grow and develop. The brothers said in a focus group that they want a fraternity that is like family — that support network," said Vohs. "What we're talking about is a pretty deep kind of friendship. We want there to be a group of young

men that will challenge you, support you, direct you, help you build your self-confidence, help you see your own biases and prejudices... to become free as an individual."

### Where Do We Go From Here?

As brothers in one Fraternity family, Alpha Sigs can turn this mission statement into action in many ways, including the following goals of the mission statement committee:

- **Service to Others and Philanthropy.** Through the national charity, Canine Companions for Independence, and through projects taken on by individual chapters, Alpha Sig can reach out into the community.
- **Scholarship.** The pursuit of knowledge was an intent of the Fraternity's founders. Alpha Sig still encourages academic excellence, and supports that goal with scholarships and grants to worthy and needy brothers.
- **Alumni Involvement.** Identify and create opportunities for alumni to work with undergraduates, sharing their knowledge and experience. Some outlets would be seminars, classes, advising, retreats, and the National Leadership and Alumni Conferences.
- **Keeping Alumni In Touch.** The Fraternity Headquarters is working on programs and services for alumni that will keep them in touch with each other and exemplify the goal of brotherhood for life.
- **Expansion.** Founding and chartering new chapters will widen the circle of Alpha Sigma Phi, enabling more young men on campuses to experience America's Premier Fraternity.

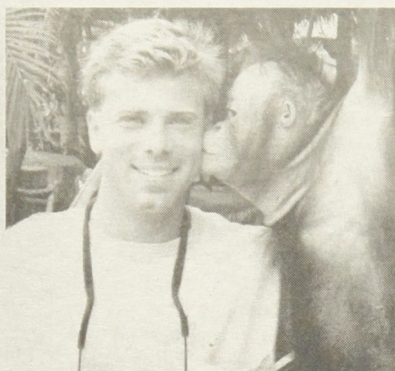
# Alumni Newsnotes

**Howard J. Barney '34**, Orcas, WA, retired in 1984. He "would like to hear from old timers."

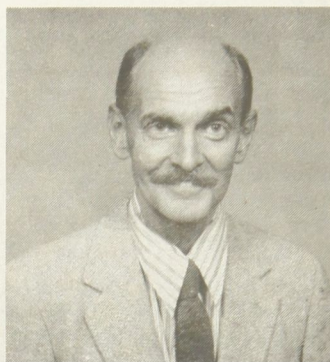

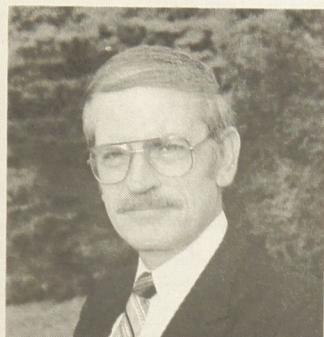

## A FINAL FAREWELL FOR VINCENT PRICE

One of our most famous brothers entered Omega Chapter last October. Vincent Price, dramatic, comedic, but most of all, horror actor of stage and screen passed into Omega at age 82. He succumbed after a five year battle with lung cancer.

Brother Price was initiated into the Yale Chapter of Alpha Sigma Phi in 1930. An art major, he planned to become a professor and art collector — and indeed, he was well on his way to becoming just that. Then, in 1935, on a dare, he

tried out for an acting role in a London production of "Broadway." He got the part, and decided acting was his destiny.

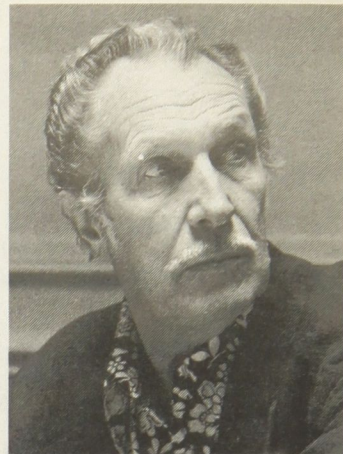
Known for his portrayals of evil characters in such horror classics as "The House of Wax," "The Pit and The Pendulum," and "The Raven," Price's list of acting credits ran the gamut from the British and American productions of "Victoria Regina" in 1935-37, to the "Three Musketeers" in 1948 to a voice characterization in

Disney's "The Great Mouse Detective" in 1986.

An obituary noted a quote from 1985, "I'm not the least bit disappointed that I'm remembered for my horror roles."

A true Renaissance man, Price was also an art collector, critic, and lecturer; a gourmet; the author of several cookbooks; and an art consultant and buyer for Sears.

We are proud to call Vincent Price a brother. His talent and his taste brought joy to many people. We will miss him.
