POSITION STATEMENT ON ACADEMICS

- WHEREAS Alpha Sigma Phi is the Fraternity "TO BETTER THE MAN" and all of its functions and actions should exemplify our Code of Conduct, and
- WHEREAS Alpha Sigma Phi was founded as a secret literary society, and our founders' vision was based on superior scholastic standards, and
- WHEREAS every Alpha Sigma Phi member was and is first a student, then a brother; no higher mission exists within the context of the undergraduate experience than academic excellence,
- BE IT RESOLVED that Alpha Sigma Phi regards scholarship as vital to the continuation of the traditions and values of the Fraternity, and
- BE IT RESOLVED that all chapters work pro-actively to foster the priority of academic excellence within the context of Fraternity activities, and
- BE IT FURTHER RESOLVED that it is the position of Alpha Sigma Phi Fraternity that every brother should focus on academic excellence for personal benefit in order that they may be a contributing member of our brotherhood.

NEW MEMBER GRANT PACKAGE

Each new member will receive a Grant in Aid based on the following criteria established and recommended.

- The term a man pledges will count as the term where grades are being considered.
- Their term grades will be compared to the All Greek Male Campus G.P.A.
 The HA will submit the proper paperwork to qualify.
 Grants will be awarded based on the following grading scale as it shows achievement over the All Greek Male Campus G.P.A. The scale is:

.25 over equals \$25 grant

.50 over equals \$50 grant

.75 over equals \$75 grant

1.0 over equals \$100 grant and cap on grant program

CHAPTER SCHOLARSHIP PROGRAM AWARD

We are recommending the following for an award to be developed similar to the current Gary A. Anderson Award.

The new award will be for chapters to submit their scholarship programs for recognition.

The National Scholarship Committee will have the responsibility to construct the program.

ACADEMY OF LEADERSHIP

We recommend that the HA, Scholarship Chairman, be an additional representative to the Academy of Leadership.

When this is accomplished a major tract of the AL will deal with procedures to improve scholastic performance of our brothers.

This is justified by our proposed Position Statement on Academics and by the fraternity Mission.

- WHEREAS the 1946 National Convention of Alpha Sigma Phi Fraternity and of Alpha Kappa Pi Fraternity approved the consolidation of the two fraternities under the name of the former, and
- WHEREAS the consolidation enabled the Old Gal to flourish through the ensuing half century, reaching 54 active chapters in 1951, and 61 active chapters in 1968, and
- WHEREAS 14 of the former chapters of Alpha Kappa Pi remain as active chapters of Alpha Sigma Phi,
- BE IT THEREFORE RESOLVED that the 1996 National Leadership Conference and Convention recognize the wisdom and foresight of those brothers who brought about the consolidation and express our thanks on this half century milestone.
- 27. The Report and Recommendations of the Committee on Ritual were presented to the Convention by committee chairman Robert Blaisdell, the delegate from Delta Tau Chapter at Murray State University.
- 28. The chairman of the committee on Ritual discussed the committee's work, but brought no resolutions to the floor.
- 29. The Report and Recommendations of the Committee on Constitution and By-Laws were presented to the Convention by committee chairman Dan Manning, the delegate from Alpha Rho Chapter at New Jersey Institute of Technology.
- 30. It was moved by the Committee on Constitution and By-Laws:
- WHEREAS The 1994 National Convention's constitution committee required the Grand Council to establish a committee to update, revise, and modify the existing Constitution of Alpha Sigma Phi,
- WHEREAS A committee, headed by Robert Wade, Bowling Green, worked with the Grand Council to accomplish such a revision, And Whereas, the 1996 Constitution and By-Laws Committee has reviewed the Grand Council's recommendations and made revisions and corrections,

THEREFORE The Constitution and By-Laws Committee moves that the revised Constitution and By-Laws of Alpha Sigma Phi be adopted by this convention one minute after the adjournment of this convention and that the Grand Council be given the authority to make grammatical changes to the document, provided such changes do not change the intent or meaning of the Constitution and By-Laws.

DISCUSSION AND PROPOSED CHANGES FOLLOWED

- 33. It was moved by the Oklahoma Alumni Council, seconded by the Beta Delta Alumni Council and PASSED BY HAND VOTE to amend Article III, Section 12 of the Constitution to read:
- ". . . ritual equipment and paraphernalia of the Chapter or alumni group shall become the property of the Fraternity."
- 34. It was moved by R.P.I, seconded by the Beta Delta Alumni Council and NOT PASSED BY A HAND VOTE OF 16-27 that Article XIII B, Section 7 of the By-Laws be amended to strike the following sentence:

The Grand Council may increase fees and dues an amount not to exceed the consumer price index at the end of the fiscal year.

- 35. It was moved by the Beta Delta Alumni Council, seconded by the Oklahoma Alumni Council and PASSED BY A HAND VOTE that Article IV, Section 8 of the Constitution be amended to read:
- "...all records, and archives of the council shall become property of the Fraternity."
- 36. It was moved by the Oklahoma Alumni Council, seconded by the Central Ohio Alumni Council and PASSED BY A HAND VOTE that Article VI, Section 5B of the Constitution be amended to read:

"In matters concerning <u>undergraduate</u> fees and dues, each Chapter, each Grand Council Member, and the undergraduate representatives to the Grand Council shall have one vote collectively."

37. It was moved by Stevens Tech, seconded by the Oklahoma Alumni Council and PASSED BY A HAND VOTE that Article XXVIII, Section 9, of the By-Laws be amended to read:

<u>The Pledge Ceremony:</u> As prescribed by the Ritual it can only be performed by members of a recognized colony of Alpha Sigma Phi only if administered by at least two <u>duly initiated brothers-undergraduate</u>, <u>alumnus</u>, or <u>staff members of Alpha Sigma Phi</u>. No colony shall be issued photo copies, printed copies or any portion of the Alpha Sigma Phi Ritual for any reason.

- 38. It was moved by the Oklahoma Alumni Council, seconded by the Beta Delta Alumni council and NOT PASSED BY A HAND VOTE that Article IX, Section 10 of the Constitution be amended to read:
- . . . suspended by a member, upon suspension, revocation of Charter, or expulsion, shall be delivered by the subject of discipline to the Fraternity Headquarters.
- 39. It was moved by the Oklahoma Alumni Council, seconded by the Beta Delta Alumni Council and PASSED BY A HAND VOTE that Article X, Section 1 of the By-Laws be amended to read:

"Expansion Chief: The Grand Senior President <u>shall</u> appoint, subject to confirmation by a vote of a majority of the Grand Council or until the next National Convention."

- 40. It was moved by the Oklahoma Alumni Council, seconded by the Beta Delta Alumni Council and PASSED BY A HAND VOTE OF 29-5 that Article X, Section 4 of the Constitution be amended to read:
- "... Any vote not returned to the Executive Vice President (if the notice issued by him) or Grand Secretary (if the notice issued by him) by a member, Chapter, or Chartered Alumni Council entitled to vote shall be considered an <u>abstention</u> vote."
- 41. It was moved by Grand Junior President Larry G. Spees, seconded by Grand Marshal Robert G. Cabello and NOT PASSED BY A HAND VOTE to:

End debate.

42. It was moved by the Oklahoma Alumni Council, seconded by the Central Ohio Alumni Council and PASSED BY A VOICE VOTE that Article XIII B, Section 5 of the By-Laws be amended by adding an additional sentence to read:

Each Chartered Alumni Council shall pay annual dues of fifty dollars (\$50.00) plus two dollars (\$2.00) per member per year for each member in excess of twelve.

- 43. It was moved by the Oklahoma Alumni Council, seconded by the Central Ohio Alumni Council and PASSED BY A VOICE VOTE that Article XIX, Section 2B of the By-Laws be amended to read:
- "... Any vote not returned to the Executive Vice President (if the notice issued by him) or Grand Secretary (if the notice issued by him) by a member, Chapter, or Chartered Alumni Council entitled to vote shall be considered an <u>abstention</u> vote."
- 44. Hearing no further motions from the floor Grand Senior President Stan G. Thurston called for a vote on the main motion. The motion PASSED BY A HAND VOTE OF 44-0.

The Constitution and By-Laws Committee moves that the revised Constitution and By-Laws, with the ratified Amendments, of Alpha Sigma Phi be adopted by this convention one minute after the adjournment of this convention and that the Grand Council be given the authority to make grammatical changes to the document, provided such changes do not change the intent or meaning of the Constitution and By-Laws.

- 45. The Report and Recommendations of the Committee on Standards and Ethics were presented to the Convention by committee chairman Sanjay Ibrahim, the delegate from Beta Theta Chapter at Rutgers University.
- 46. It was moved by the Standards and Ethics Committee and PASSED BY VOICE VOTE that:
- WHEREAS In 1994-1995 Alpha Sigma Phi developed a pilot community/brotherhood building program to help our chapters in the development of healthy interpersonal relationships.
- WHEREAS This program offers chapters the opportunity to conduct a retreat with a professional facilitator who works to help the chapter build a stronger sense of brotherhood.
- WHEREAS Through activities, workshops, videos, and lectures, members challenge themselves and the chapter to achieve greatness.
- BE IT RESOLVED The committee on Standards and Ethics recommend the Brotherhood Building Program be continued, as well as expanded, in order to make this program accessible to more chapters.

- BE IT ALSO RESOLVED THAT the committee recommends a follow-up program between 4-6 weeks upon completion of the Brotherhood Building Program.
- 47. It was moved by the Committee on Standards and Ethics and PASSED BY VOICE VOTE that:
- WHEREAS the Ralph F. Burns New Member Program will be the most innovative and creative programs in the Fraternity world.
- WHEREAS this national conference will be provided to all new members who were initiated/pledged in the previous year.
- WHEREAS all new members will share in common experiences as they develop leadership and communication skills while learning about themselves and their fellow brothers.
- WHEREAS this program will unite new brothers from around the nation for a once in a lifetime conference.
- BE IT RESOLVED the committee on Standards and Ethics recommend that the Ralph F. Burns New Member Program be endorsed nationally by all chapters of Alpha Sigma Phi Fraternity.
- BE IT ALSO RESOLVED THAT the committee on Standards and Ethics recommend that allocations be given from the 1997-1998 budget as to commence the Ralph F. Burns New Member Program as a pilot program in the summer of 1997, which will include at least 2 new initiates from each chapter.
- BE IT FURTHER RESOLVED THAT the committee recommends that the program be fully implemented by the summer of 1999.
- 48. It was moved by the Standards and Ethics Committee and PASSED BY VOICE VOTE that:
- WHEREAS Alpha Sigma Phi's Mission is To Create And Perpetuate Brotherhood.
- WHEREAS Alpha Sigma Phi Fraternity endeavors at all times to give its brothers the highest quality of membership possible.
- WHEREAS a New Member Program that is based on our ritual and mission is needed for the continued success of Alpha Sigma Phi.

- BE IT RESOLVED the committee on Standards and Ethics recommend that the New Member Education Program be a national guide for the continued success of the pledge program of Alpha Sigma Phi.
- 49. The Report and Recommendations of the Committee on Nominations were presented to the Convention by committee chairman Chris Sieben, from Delta Upsilon Chapter at Virginia Tech.
- 50. It was moved by the Beta Delta Alumni Council, seconded by R.P.I. and NOT PASSED BY A HAND VOTE to:

Re-open nominations for the Grand Council.

51. It was moved by the Nominations Committee and PASSED BY A VOICE VOTE to slate the following officers:
