Zeta Chapter moves to reinstate Article V, Section 12 as previously described. Second by Grand Councilor Maurer. ¾ needed. 49 ayes, 0 nays. The motion carries by a show of hands vote.

Zeta Chapter moves to amend the Const- Article VI – Article IX as submitted. Seconded by Grand Councilor Hittle. 3/4 vote required. 49 ayes, 0 nays. The motion carries by a show of hands vote.

Zeta Chapter moves to amend the Constitution, Article X as submitted with the correction of "affiliated group" for "alumni chapters" through out the Article. Seconded by Grand Councilor Opel.

Hamburger moves to amend the proposed Article to change "some probationary status" to "not in good standing status". Second by Grand Marshal Ritter. Majority vote needed. The motion to amend carries unanimously with a voice vote.

As for the main motion: $\frac{3}{4}$ vote needed. 49 ayes, 0 nays. The motion carries by a show of hands vote.

Zeta Chapter moves to adopt the proposed changes (new) article XI and article XII of the Constitution. Seconded by Grand Councilor Tilden.

Friendly amendent to remove officer designations from the text. Accepted.

Motion requires a $\frac{3}{4}$ vote. 16 ayes, 33 nays. The motion fails by a show of hands vote.

Zeta Chapter moves to remove all "H" designations and replace with secular titles and to correct chartered alumni councils with RCA. Second by Grand Junior President Grissom. 49 ayes, 0 nays. The motion carries.

Zeta Chapter moves to amend the Bylaws to reflect the changes as submitted in Articles I – Article IX.

Friendly amendment to Article IX, Section 3 as follows: "Educational Foundation" to "Board of Directors of the Educational Foundation" Second by Grand Councilor

Hittle. 2/3 vote required. 50 ayes, 0 nays. The motion carries by a show of hands vote.

Zeta Chapter moves to amend the Bylaws to reflect the changes as submitted in Article X. Seconded by Gamma Zeta Chapter.

Motion to amend the proposal as follows "the higher of 2.5 or the campus all-male GPA" instead of "cumulative minimum GPA for the group is 2.5" Seconded by Beta Rho Chapter. The motion to amend carries by a voice vote.

As to the main motion: 2/3 vote required. 46 ayes; the motion carries by voice vote.

Zeta Chapter moves to amend the Bylaws to reflect the changes to Articles XI – XV as submitted. Seconded by Beta Omicron Chapter.

Grand Junior President Grissom moves for division of the question to remove Article XV, Sect. 3 for separate consideration. Second by Grand Councilor Maurer. Motion to divide carries by voice vote.

As to the main motion: 2/3 vote required. 50 ayes, 0 nays. The motion carries by a show of hands vote.

As to the divided question of Article XV, Sect. III:

Past Grand Senior President Gibson moves to amend the proposal as follows: "perpendicular to the ground or at a slight angle in honor of Ralph Burns" Second by Beta Rho Chapter. The motion to amend carries by a voice vote.

As for the divided question: 2/3 vote required. 16 ayes, 33 nays. The motion fails by a show of hands vote.

Zeta Chapter moves to amend the Bylaws to reflect the changes to Article XVI – XVIII as submitted. Second by Alpha Tau Chapter.

Friendly amendment that the dates and voting rules in Article XVIII, Section 2 be changed to reflect the wording of the Constitution.

2/3 vote required. 49 ayes, 0 nays. The motion carries by a show of hands vote.

Grand Secretary Burns joins the meeting at 10:15am

Grand Senior President Still dissolves the Constitution Committee and ask for new business.

Grand Junior President Grissom announces his resignation and asks that the Grand Chapter select his replacement.

Grand Senior President Still reconvenes the Nominations Committee and invites the Chair of the Nominations Committee to offer his recommendation to the Grand Chapter.

Brother Dutton moves to accept the nomination of Brother Rick Buss to fill the vacant term on the Grand Council. Brother Buss's nomination carries unanimously by voice vote.

Grand Senior President dissolves the Nominations Committee.

The Grand Chapter is recessed until 10:35am so that the Grand Council may select its officers.
