Statement of Conditions since date of Petition.

Since the date of our petition, vz. April 1923, this fraternity has been making considerable progress. Some of our most active men were graduated last June, but the younger members of the group are shouldering their share of the responsibility with the determination to "carry on" as their predecessors have.

At the present time, the active membership of our fraternity consists of three seniors, five juniors, nine sophomores, and eight freshmen.

Of the seniors, M. A. Monaghan is leader of the Case Musical Clubs, and J. V. Johnson is a plunger on the Case swimming team and a member of the Case Musical Clubs. The juniors are very active on the campus; among them G. N. Davis is Manager of the Varsity Basketball Team, Assistant Editor of the Case News Service and a member of the Case Musical Clubs. William F. Billingsley and Howard J. Fahrney are both aspiring track men. The sophomores and freshmen are gradually taking hold of the helm of the campus activities. H. G. Mabry has made two varsity letters this year - one for football and one for basketball, and he undoubtedly will make one for track. F. W. Brooks is a member of the Case Musical Clubs and the Case Band, and is trying out for Assistant Manager of the former organization, a position which leads to managership in the senior year. He also ranks second in the sophomore class in scholarship. E. C. Muetzel is a member of the Case Musical Clubs and is out for track. P. F. Nuhn is out for both the Case Club Board of Managers and track, while N. L. Hawn is a reporter on the Case News Service. B. L. Matthews is out for track and C. Morey is out for the Case Club Board of Managers. He ranks seventh in the sophomore class in scholarship. R. E. Henninger made the Freshman Football Team and N. J. Reiff made both the Freshman Football Team and the Freshman Basketball Team. Reiff also ranks high in the freshman class in scholarship. L. B. Crosby is a member of the Case Band and R. D. Squibb is out for Football Marshall, a position which leads to management of one of the athletic teams in the senior year.


I am writing you with reference to the Tau DeltatTau Fraternity at Case School of Applied Science, which is making application to you to be established as one of your chapters.


The Tau Delta Tau Fraternity requests a letter from me as a member of the Case Faculty to your honored fraternity.

Tau Delta Tau has an honorable record at Case. Their scholarship record is average. The system of marking at Case School is a very strict one. A member of the faculty has just been in my office complaining of its undue severity. He has charge of athletics at Case and expressed himself as unable to secure a sufficient number of students to fairly represent the institution in athletic meets. If an investigating committee should examine the results at Case, I feel quite sure that they would be convinced that men must maintain a high average in order to secure the points necessary for graduation.

For the month of February, Tau Delta Tau maintained an average of 72.3 per cent and for March of 69.2 per cent. This is just about the average of all the men in fraternities.

I know personally most of the men in Tau Delta Tau and have known some of them a good while. It is my personal judgment that your honored fraternity has in them material which would prove entirely satisfactory in a chapter of your order. 
I understand that our local fraternity, Tau Delta Tau, has applied to your fraternity for a charter, and I have been asked to advise you of my opinion of the personality of its members.



1. We take pleasure in transmitting herewith to the Active Chapters for action thereon, under the Seal of the Fraternity, the petition for a charter to Alpha Sigma Phi Fraternity from Tau Delta Tau of the Case School of Applied Science of Cleveland, Ohio.

2. Accompanying this petition is the official report of the Grand Junior President which contains excellent recommendations relative to the petitioning group, to the general fraternity situation at Case, and to the institution itself. Letters of recommendation from Wayne M. Musgrave (GJP Emeritus), George H. Worthington (GCS), and the three Ohio chapters (the Delta, the Epsilon and the Zeta) are appended. There is also attached a report from the Executive Secretary who visited Cleveland last month as the personal representative of the GPC.

3. In addition to the material mentioned in Paragraph 2 above, a "Supplement" to the petition is submitted by Tau Delta Tau in order to place before you up-to-date information regarding their organization. It also contains letters of recommendation from several local chapters of national fraternities, from the President, the Dean and other members of the Case Faculty. Under separate cover a copy of the 1923-24 Catalogue of Case School and a book of "Campus Views" are being forwarded.

4. The Grand Prudential Committee heartily endorses all of the sentiments expressed in the letters and other documents accompanying this petition and respectfully requests the Active Chapters to give due and careful consideration to all of the material forwarded. Our committee has gone on record unanimously as favoring the Tau Delta Tau petition and it is our hope that the chapters may arrive at a like verdict.

5. Your chapter is requested to take action on this petition as early as convenient; to record your vote on the Official Ballot provided; and to return the same to this office. A majority vote of the active members present at the meeting at which action is taken will be favorable to the petition; less than a majority will reject it.

A BRIEF HISTORY OF CASE SCHOOL OF APPLIED SCIENCE

Case School of Applied Science was founded on February 24, 1877. Although Mr. Leonard Case, the founder, executed the trust deeds which set aside lands to establish and endow the college in 1877, there were no legal proceedings for incorporation until after his death in 1880.

In this year instruction was begun in the old Case homestead, while plans were made for the construction of a building on Euclid Avenue opposite Wade Park, the present location of Case.

This first building was ill-fated and twice destroyed by fire entailing huge financial losses.

In 1885 five students were graduated at the first commencement. By this time the enrollment has reached fifty-one and plans for expansion were put in motion. Mr. Cady Staley, a civil engineer of note was elected as first president of Case.

From this time on Case has advanced rapidly. Its student body has sprung from fifty-one to seven hundred and now has six modern buildings and a gymnasium and club house combined.

The intensive development is even more marked, for in its comparatively short period of existence it has risen to the foremost rank among engineering schools.

The student body is entirely male. Courses are offered in the following branches of engineering, Civil, Mechanical, Electrical, Mining and Chemical and in Physics. The degree conferred on the graduates of the regular four-year courses is that of Bachelor of Science. Higher degrees are conferred for post-graduate work.

Tau Delta Tau, the author of this petition, refers to its own standing in scholarship and college activities and likewise that of its predecessors as definite evidence of the field for a future chapter of Alpha Sigma Phi on the Case campus.

At present there is some agitation on the part of the alumni of Case and Western Reserve University for a combination of the two colleges into a greater University of Cleveland. However, no definite action has been taken in the matter.

HISTORY OF TAU DELTA TAU FRATERNITY

To properly understand the present situation it is necessary to digress for a moment and investigate the conditions behind the present organization that is known as Tau Delta Tau Fraternity. In 1911 a chapter of the professional honorary fraternity known as Theta Tau was established at Case. Elsewhere it took its members from the honor grade men in professional schools. At Case it became a competitor with the social fraternities, then seven in number. A house was secured and furnished and men were admitted without much attention being paid to whether they were already members of social fraternities so long as they did not belong to any having a local chapter at Case. In this way the alumni soon segregated themselves into members of other nationals (rather few in number), a loyal and interested alumni and a few indifferents. As a result of this anomaly in the national organization of Theta Tau the alumni of the Case chapter found themselves almost without national affiliation who were not already members of such. This produced a condition that in turn reacted upon the local chapter and made it still more difficult to maintain competition with the local nationals at Case. As a result a movement originating in the active body to transform the national organization of Theta Tau into a social fraternity was met with a stern rebuke, largely due to the alumni influence of the other chapters in the fraternity. There was but one recourse,—to seek affiliation with a strong national, social in character.

The practical difficulties in the way, however, were greater than the members of the active chapter had contemplated. There was a division in the alumni members of the chapter, as some were ineligible to join a second social fraternity, others were undesirable under any conditions, a few were indifferent, but the majority were enthusiastic. With this in view we petitioned Alpha Sigma Phi Fraternity early in 1922, only to be met with a demand from its national officers that we make our peace with Theta Tau as a condition precedent to any consideration whatever for our petition. We had a house well furnished, a comfortable balance in the bank, and a pledged building fund of about \$7,000.00. It became apparent early in the negotiations that the house would have to be given up and other financial conditions settled between the various interests before tangible results could be expected. In the meantime the national officers of Theta Tau and Alpha Sigma Phi were adjusting all difficulties between the fraternities. This accomplished the latter demanded that the petition we had sent them be withdrawn and the lines of organization of our local be adjusted to the changed conditions, and that we lend our undivided support to make the Case chapter of Theta Tau conform to those of the other chapters of that fraternity. This was accomplished by organizing Tau Delta Tau from the membership and alumni eligible from Theta Tau without withdrawing our support of that organization.

Accordingly Tau Delta Tau became formally organized on April 17, 1922. The active members pledged a number of new men who were not pledged to Theta Tau. Delta Chapter of Theta Tau was reorganized by taking only the honor men in the school as members of the honorary professional fraternity and men already belonging to it who did not fall into this category were temporarily suspended from it with the

understanding they would be honorably reinstated at graduation. This was to insure that the reorganized Theta Tau would not be dominated by any who were not in fact chosen except on account of their scholarship. It was also insisted that Theta Tau should not in turn dominate the movement to socialize the members of the local fraternity thus organized.

The financial differences were fully and agreeably adjusted. The new fraternity took over the house and its furnishings, and the building funds were transferred to it by consent of all pledgors except two who ineligible to go into the national social organization in case our petition was granted. These pledges were released. About fifty of the alumni remained loyal to the local organization and we are assured of their financial and personal backing. The local active membership are united in this movement. With our decks all cleared we now again petition Alpha Sigma Phi for membership in that organization. We especially invite your attention to the following important matters:

Scholarship.

The members of Tau Delta Tau stand well among other fraternities in scholarship. Last month we ranked fourth among the eleven Case fraternities and this is our average ranking. We have four Tau Beta Pi men this year.

Student Activities.

In student activities we rank unusually high. Participation in these is awarded by the student governing body, the Case Senate. Out of a total of 770 points for the entire school we have 101. Fifteen honor keys were awarded the entire school and we have five of them.

Recognition.

Among the more important honor positions held by Tau Delta Tau are: President and other members of the Case Senate; Captain and three letter members of the track team; three letters in basketball; two in football; two in baseball; Manager of the football team; Vice-president of the Senior Class; Vice-president of the Freshman Class; Manager and seven members of the musical clubs; four members of the leader corps; Junior Class Historian; one member of the *Case Tech*, a weekly; and two of the Differential Board, which publishes the annual.

Membership.

At present we have 34 undergraduate and about 50 graduate members. The organization has been recognized by the faculty and all its members are in good and regular standing in the college. The average scholarship has always been maintained or exceeded by the organization. We have practically twelve years existence as a local though only about two as a formal organization. The future seems assured and those participating in this movement are loyal and enthusiastic. We have made a solidarity in our ranks by assuring ourselves of the interest and support of that part of the alumni of the old Theta Tau chapter who are not only eligible but are selected for their interest in this movement. Alpha Sigma Phi will secure a chapter of which it can well be proud for the types of men who are our alumni are the very best. We will let your local alumni and representatives pass upon the personnel of our active members who are petitioning for a charter.

Gentlemen & Brothers, -

I have the pleasure to transmit to you the enclosed Petition of Tau Delta Tau Fraternity of Case School of Applied Science with its recommendations and the report of the Investigating Committee. This entire matter was carried to completion by my predecessor, Brother Musgrave before he went out of office and the only reason that the matter has been held up is that there was a question with reference to some property rights as between this organization and Theta Tau. This I am given to understand has been straightened out. In view of the above circumstances I have not gone into the matter myself and therefore will quote from Brother Musgrave's letter with reference to his opinion with regard to this Petition. I make no recommendation myself:

"FIRST: The Case School of Applied Science is located on the same campus with Western Reserve University and will soon become a part of a new institution to be named the University of Cleveland, made up of the combination of Western Reserve University and the Case School, the combined institution to be backed by a heavy endowment provided by a powerful group of wealthy men and institutions. At present the academic standing of either of these institutions is of the character to warrant our full recognition and support. That of the

combined institution will be at least maintained if not strengthened. As a technical education institution Case School of Applied Science is one of the best in the country.

Sigma Chi has a chapter at this institution which takes its members from both institutions and the chapter is getting along nicely. While this would be an innovation for us I can see no serious objections to it if we decided to grant such a charter. The two institutions are working together now. Men taking pure science and technical training are trained in the same classes, sometimes under the tutelage of one faculty and sometimes under that of the other, as I understand it. An arrangement similar to that which exists between Harvard and Massachusetts Institute of Technology applies at present between these two institutions.

For the reasons set forth I can fully recommend the academic standing of the institution at which these petitioners are students.

"SECOND: The fraternity situation at Case spells success. These men have existed practically for ten years and are well established. There is no serious break between what would be our new chapter and its alumni. A few of its former members who have shown poor fraternal spirit were left out and a few more were ineligible by reason of already belonging to other social fraternities. A few of the former crowd started trouble and tried to stampede the movement of transferring to a social fraternity from that of a semi-honorary professional fraternity. They made a lot of noise, kicked up a little trouble, but in the end developed the backing of a loyal and carefully sifted body of alumni. If we grant this charter we will get a well established chapter, well backed, well housed, well circumstanced. All the matters in controversy between Theta Tau and Alpha Sigma Phi have been settled to the satisfaction of all. What was once threatened was the result of the efforts of the disappointed soreheads left out in the cold by the petitioners and their backers. A little more loyalty to the ideals and support of the chapter by these fellows when they had a chance to help would have saved them from their bitter disappointment later. They are in the same boat that every one of our chapters experience after a few years existence. You all have a few men who are not of much value to you as alumni or otherwise.

This charter, if granted, will produce a fine healthy chapter that has demonstrated its ability to compete successfully with nationals and locals on the Case campus. There is plenty of room for development and the fraternity situation is not overdone. I fully recommend them from this standpoint.

"THIRD: A careful investigation of the personnel disclosed a fine body of young men, congenial, excellent students, and in every way equal to our membership elsewhere. I shall particularly refer you to the strong backing our Cleveland Alumni Council has given this organization. It is due to their careful investigation and enthusiasm for them that we have this petition. I can strongly endorse their views and good opinions of these men.

In conclusion, I feel that we should take this chapter. While it may give us a chapter that is temporarily at least strongly technical in its membership, I believe this is not a serious handicap. We have technical schools in agriculture already well represented in our roster and I am sure none of us regret having entered this class of educational institutions. Case will soon become general and as we have an excellent chance to add to our roster a good crowd in a strong school I unhesitatingly recommend this petition to your favorable consideration. We will make one of our greatest mistakes if we refuse to accept this petition."

BROTHERS IN ALPHA SIGMA PHI:

On March 29 a committee of Zeta actives including the H.S.P., H.M., H.C.S., and H.C. of the chapter went to Case School of Applied Science at Cleveland, Ohio, to inspect Tau Delta Tau Fraternity, which is petitioning to become a chapter of Alpha Sigma Phi Fraternity.

In company with Brother W. P. Dumont, a Zeta alumnus now located in Cleveland, the committee spent several hours at the Tau Delta Tau House, interviewing members of the local, and going thoroughly into their history, their present social, scholastic and financial status, their activities, and their prospects.

The Zeta delegation was very favorably impressed by Tau Delta Tau. The committee feels that this local has all the qualifications of a good Alpha Sigma Phi chapter. Its members are of the best type of young manhood, and as nearly as we could ascertain, the petitioning fraternity ranks among the highest at Case. At the school there are some eleven fraternities, most of them nationals.

Tau Delta Tau is represented in a large number of school activities. It has a good home, now under lease, but with arrangements already under way for the purchase of the house.

We feel that the location of a chapter at Case, in the Fifth City, is especially strategic at the present time because of the strong indications that Western Reserve and Case will in the near future be united into one large school. One of the

strongest alumni councils in the country is located at Cleveland. The alumni council is composed of representatives of a dozen different chapters, and all of these men recommended Case to us.

Not satisfied with our own impressions, we discussed the petitioning local at some length with the Cleveland Council, as well as with alumni of Tau Delta Tau. Several of the men of our own chapter whose homes are in Cleveland, are acquainted with the local and its status on the Case campus. All of these alumni and actives we have found to recommend the local and to be heartily in favor of its admission as a chapter of Alpha Sigma Phi.

The report of the inspecting committee was heard at a special meeting of Zeta Chapter held April 2, and acting on the report, the Chapter voted to recommend to the various chapters of Alpha Sigma Phi Fraternity, the acceptance of the petition of Tau Delta Tau Fraternity at Case School of Applied Science.

1. Following your instructions that I should return by way of Cleveland from the Alpha Beta installation ceremonies at Ames and make an inspection of the local fraternity at the Case School of Applied Science which is petitioning Alpha Sigma Phi for a charter, I arrived in Cleveland on March 5 and remained there until midnight of the following day.

2. During my stay in Cleveland, I visited the Tau Delta Tau Fraternity in its home located at 11439 Mayfield Road, Cleveland; attended a luncheon specially arranged by the Cleveland Council; and made several calls in the City with reference to Case and the local in question.

3. My visit to the Tau Delta Tau house was a very pleasant one. I met most of the active members and a few of the alumni who happened to be there at that time. Though I talked with a number of the actives, it was during a conference with Mr. Paul F. Pfau, president of Tau Delta Tau this academic year, that I learned of the actual inside workings of the chapter. I found that the local has an excellent leader in Mr. Pfau, one who is vitally interested in Case, in his fraternity and in the men who comprise its membership, and one who looks hopefully to the future and expects much from his organization, especially if the petition to Alpha Sigma Phi is favorably acted upon by our fraternity. The members are of the type that we want in our organization. That this local has been able to get the kind of men that comprise its membership in spite of the keen competition with nationals there speaks well for Tau Delta Tau.

4. I was shown over the entire house and found it to be adequately furnished to take care of the men living there. As I recall the house can accommodate about twenty men comfortably. The dormitory system is in use, most of the third floor being given over to that purpose. Tau Delta Tau has house rules similar to our own as regards gambling and liquor.

5. With respect to finances, the chapter is apparently on a sound basis. Plans are being perfected with the ultimate aim of owning a home in the near future. At present the chapter leases the property in which it resides at a reasonable rental.

6. In scholarship the chapter is doing well. Though not ranking highest among the fraternities at Case, Tau Delta Tau stands above the average for fraternity men and was one of the very few organizations on the campus that was able to initiate the whole of its Freshman delegation at the end of the first semester this year. Every one of the eight Freshmen pledges "made" the necessary grades in the School which is a requirement in order to be initiated.

7. Relative to the Case School of Applied Science, I feel that since its reputation as a scientific school is second to none in the United States no comment regarding its standing is necessary here.

8. Being located in the midst of a manufacturing area and near to the great industries of Detroit and other Lake cities, statistics show that the graduates of Case are for the most part absorbed in the manufacturing plants located in Cleveland and vicinity and consequently very few of the Case alumni have filtered through to the East and West. Case graduates have proved their worth on account of their ability to perform the exacting requirements demanded by their employers and the latter have in turn recognized that Case furnishes the quality of technically trained men needed in their industrial plants.

9. At the Council luncheon the Case matter came up for discussion. I found that every member of the Cleveland Alumni Council is vitally interested in the placing of a chapter at Case and is working hopefully toward that end. That point was very evident from the expressions of the men and from the enthusiasm shown. At this luncheon it was announced on authority that all legal difficulties heretofore standing in the way of effecting a union between the Case School of Applied Science and Western Reserve University had been removed and that only the consent of a few members of the faculty (though not necessary to obtain but for policy's sake the better to have it) was awaited before the amalgamation would be completed.

10. I was agreeably surprised to find that there were so many members of the Council that I have known for a number of years. Among the Cleveland membership are some whose opinion I regard so highly that I have never questioned their judgment on any matter whatsoever and would not care to do so now. Since these men in particular are convinced of the advisability of placing a chapter at the Case School of Applied Science, and since the entire membership of the Cleveland Council is favorable to the granting of a charter to the Tau Delta Tau at Case, and moreover, since a knowledge of conditions generally in Cleveland is better known to our Alpha Sig brothers than to any other group of individuals in our fraternity, I want to heartily endorse their opinions on this proposition. From first hand information and from my own observations I am convinced that it will be a wise move on the part of Alpha Sigma Phi to place a chapter at Case. I recommend, therefore, that the request of the Tau Delta Tau be granted in the form of a charter from our fraternity.
