History of North Carolina State University

North Carolina State University, more commonly known as N.C. State, was founded by the North Carolina General Assembly in 1887 as a land-grant college. With an enrollment of over 30,000 students, N.C. State is currently the largest university in North Carolina. The university is the primary technological school of the University of North Carolina school system that includes 16 universities throughout the state. While North Carolina State is historically acclaimed for schools in design, engineering, textiles, agriculture, and veterinary medicine, the school also offers over 100 Bachelor degrees in areas including business, education, forestry, and the humanities and social sciences. During reconstruction after President Lincoln passed the Morrill Land-Grant Act, Chapel Hill received the annual endowment to establish a college that would provide a "liberal and practical education." In the mid 1880s, a group of farmers and business leaders argued that the university was not meeting the mandates of the federal act. The North Carolina College of Agriculture and Mechanic Arts was established in 1887 with funding allocated by the North Carolina General Assembly. R. Stanhope Pullen gave land in Raleigh for the school to be established on and construction began with the transfer of the endowment to the new Raleigh location.

The college formally opened on October 3, 1889. Between this date and World War I, the college expanded with the agriculture of North Carolina. New extension programs allowed the college to directly benefit other North Carolinians. By 1918 the college had around 700 students and the name was changed to North Carolina State College of Agriculture and Engineering. The Great Depression caused many stresses for the entire educational system and the State of North Carolina created the Consolidated University of North Carolina that combined State College with the University of Carolina at Chapel Hill and the Women's College at Greensboro. The North Carolina College of Agriculture and Engineering of the University of Chapel Hill remained a single entity until 1972 when the University of North Carolina system was created. Between the end of the Great Depression and the Second World War enrollment in fluctuated between 1,000 and 2,000 students. The G.I. Bill that was passed after World War II caused State to grow rapidly and the university expanded to accommodate over 5,000 students in 1947. In the following decade State College received national acclaim for various programs and also began enrolling African American students. Throughout the early 1960's the school was caught in a struggle between administrators and legislators surrounding the name. After attempts to call the college The University of North Carolina at Raleigh, the name became North Carolina State University at Raleigh in 1965. This name has remained since.

In 1966 enrollment was over 10,000 students and within the following decade the university was home to over 19,000 students. Much of the added enrollment was caused by the addition of the College of Humanities and Social Sciences. Although North Carolina State is renowned for engineering, design, and textile programs the extension into humanities and social sciences was a successful step. The school continues to grow and in 1987 the university began calling the individual schools colleges and also received 700 acres to begin work on Centennial Campus that is currently finishing construction and accommodating the engineering departments.

Today N.C. State is one of the three anchors of the Research Triangle with UNC Chapel Hill and Duke University. The university now has over 30,000 students and 7,000 employees. With an \$820 million budget and a \$380 million endowment, North Carolina State continues to grow and develop to meet the needs of all students. This past year marked even more public

acclaim for the university as both the Princeton Review and the U.S. News and World Report ranked the university 2nd in America's Best Value Colleges. The student newspaper is *The Technician*, and *The Agromeck* is the annual year-book. The former has allowed students a voice and connection since 1920. As a founding and lasting member of the Atlantic Coast Conference, N.C. State competes in 24 intercollegiate sports. The Wolfpack have won 8 national titles within these athletic events and welcome the new basketball coach, Sidney Lowe to Raleigh for the 2006-2007 season. Many great Americans have received powerful educations through the university including Vice Presidential Candidate and Senator John Edwards. Bill Cowher, the coach of the National Champion Pittsburgh Steelers also attended the university along with many other prominent individuals.

North Carolina State University Greek Life

North Carolina State University is composed of men's and women's fraternities. These organizations include North American Interfraternity Conference fraternities, National Panhellenic Conference sororities, National Pan-Hellenic Council fraternities and sororities, and Collaborative Greek Council fraternities and sororities. Each governing body has specific guidelines and requirements related to recruitment of new members. Each member organization has additional requirements of students seeking membership to their respective chapters.

Greek Life at North Carolina State University is an important part of the co-curricular experience at NC State. While enhancing your personal development by committing to ideals of scholarship, leadership, and service it also creates a respect for your individuality while being part of a brotherhood/sisterhood with individuals who share the same goals and values. Members of Greek life have built a commitment to the ritualistic values of their organizations, a commitment to service, an understanding of their responsibility for being a contributing member of the community, and to the personal and professional development of members. Fraternity men and Sorority women are involved in various campus organizations such as Student Government, sports clubs, and academic honor societies. Many these men and women hold leadership positions in these groups. Individual involvement is the key to fraternal success

Social

College life involves learning to live and work with others, respecting them as individuals, and making friendships that will last a lifetime. Greek life enhances the social experience in a relaxed atmosphere. This can be seen in events throughout the year such as mixers, band parties, and Greek Week.

Service

Service to our university, to our community, and society as a whole is a very important aspect of fraternal life. Fraternities and sororities strive to have members recognize their responsibility to help people in need. Chapters hold fundraisers for organizations such as Breast Cancer and Youth AIDS awareness. Greek Life also promotes philanthropic events to support those such as the Hurricane Katrina victims.

Scholarship

Academics are the reason you attend college and scholastic excellence is important to each Greek organization at North Carolina State University. The Interfraternity and PanHellenic Councils require a minimum GPA of 2.25 for current students. Every chapter on this campus has individual specific academic requirements on both a local and national level, which they are to uphold

History of Alpha Sigma Phi – Beta Zeta Chapter At North Carolina State University

On December 4th, 1920 eight men joined together to form Sigma Delta, a local fraternity, at this time it was impossible for them to truly realize the powerful influence their legacy would have on North Carolina State University and it's students. While living at 10 Enterprise Street, in the spring of 1926, these men petitioned Phi Pi Phi for a charter. Their wish was granted and on April 29th, 1927 when they became the Xi Chapter of Phi Pi Phi. The Xi chapter moved to 219 Forest Road in 1931. Unfortunately, during the Great Depression the Xi chapter of Phi Pi Phi closed due to low membership and financial difficulties.

Perhaps the true cornerstone of Beta Zeta Chapter history occurred in 1929 when Albert Bennett formed the Alpha Club another local fraternity at North Carolina State College. The Purpose of the Alpha Club was to seek a charter from Alpha Kappa Pi and their goal was reached on May 26th, 1930. Instantly the chapter was a success winning the IFC scholarship cup in 1933. However, in 1942 only six members returned to school in the fall of 1941 and not soon after Alpha Kappa Pi suspended operations early in World War II. Nonetheless, the paramount moment occurred when Alpha Sigma Phi and Alpha Kappa Pi decided to merge in 1946 and the Chapter at North Carolina State University was re-designated Beta Zeta of Alpha Sigma Phi. Three years Later, in 1949 an effort was made to begin the first true Beta Zeta Chapter with two men initiated, however the effort failed.

Once again in 1974 efforts began to revive Beta Zeta Chapter of Alpha Sigma Phi, this time the effort was prosperous under Gary Gourley an early leader of the group. On March 19th, 1976 the group of men was recognized as a colony of Alpha Sigma Phi. However, the day the men set out to achieve came on February 18th, 1978 when George Lord, E '61 and Gary Anderson, AN '73 presented them with the re-chartered Beta Zeta Chapter. In a strange twist of fate the chapter returned to 10 Enterprise Street, the former home of Xi chapter of Phi Pi Phi. There the Beta Zeta chapter named the newsletter, "The State of Beta Zeta". Also Jeff Hoffman, MAL '75; Wes Nobles, BZ '76; and Brian Lilly, B Z '78 won the F. F. Hargear Award, the largest contingent from any chapter. Hoffman went on to serve on the Fraternity staff and Editor of the "Tomahawk." Regrettably, after several years of sound operations the lack of progress toward an adequate sized chapter house began to take a toll on the strength of the organization and in 1988 the Charter was revoked.

In 2004 efforts were again taken to revive the "Old Gal" and On April 13th, 2005 the Group was recognized as a Beta Zeta colony of Alpha Sigma Phi. With such a rich history the men of the colony want to once and fore all establish a never ending circle of brotherhood on North Carolina State University campus with the Beta Zeta Chapter of Alpha Sigma Phi.

North Carolina State University Alpha Sigma Phi Beta Zeta Colony Short Term and Long Term Goals

Progress for Goal One: Academic Excellence

Beta Zeta colony has been actively pursuing academic excellence throughout our existence. We recognize that we have fallen short of our goal of rising above the all-male and all-student campus average of 2.9. This is unacceptable, and we have therefore developed the following academic initiatives to help our brothers achieve excellence in their specific majors. Be aware that NC State offers some of the most difficult academic majors in higher education, such as engineering, chemistry, math, and other sciences. Regardless, we have implemented the following plan for achievement:

Brotherhood Academic Initiative: No Sig Left Behind Program

For all brothers who fail to meet our minimum grade point average of a 2.5 (semester and/or cumulative), the following requirements exist:

- Each brother will meet individually with Dr. Jim Barker, professor of history and academic advisor for Alpha Sigma Phi, Beta Zeta. Dr. Barker will work with each brother to craft a semester plan to increase his term GPA to at least a 2.5, but preferably higher.
- Each brother will meet with the Prudential Committee following his meeting with Dr. Barker. The committee will provide any support and encouragement to the brother that is physically possible, including, but not limited to: study help sessions, tutoring, assistance with time management skills, and class attendance tracking.
- Each brother will submit to his advisor (GCA and Academic Advisor) a copy of each of his syllabi, which outline dates for examinations and major papers. The student will then craft a schedule which tracks each of these course along with the respective advisor(s).
- Each brother will collect from his professors a monthly assessment of his own progress in the course, including a midterm evaluation. This progress sheet will be turned in to the Academic Advisor and the Scholarship chair no later than one week following the completion of each month (i.e., by the 5th of each month).
- For those brothers who fail to surpass the 2.5 grade point average during the completion of the semester, the chapter will meet to discuss his circumstances and future in the chapter.

Note that this initiative is intensive and involves each brother pulling his weight, and recognizing his own personal struggles. This, we feel, is the cornerstone of academic success and excellence.

Progress for Goal 2: Growth and Expansion in Membership Resources

We are aggressively recruiting on a regular basis to grow and develop quality members. At 37, we exceed all but 7 of the 20 active fraternities. Our goal is to continue to push these numbers,

knowing that quality men are the expectation and the rule.

Recruitment and retention go hand in hand. In order to support quality recruitment, we have developed a sound set of recruitment activities, including participation in Fall Move-In, the Interfraternity Council's Fall Recruitment program, and quality Alpha sigma Phi recruitment events, such as a Pig Pickin', Oyster Roast, Recruitment mixers with sororities on campus, and various athletic events. Our goal is to show these recruits that Alpha Sigma Phi provides a sound and meaningful experience for all men, and that, while we expect great things from each brother, we also recognize that fun is a major component in fraternity life. Please see the Recruitment Schedule for Fall, 2006 (below).

Progress for Goal 3: Brotherhood Services

During the 2005/2006 academic year, we have strengthened brotherhood relationships and communication. Through our Brotherhood Chair, we created and implemented three Brotherhood retreats, focusing on building relationships, developing expectations, and strengthening our understanding of Alpha Sigma Phi.

Our GCA, Barry Olson, implemented our Pledge Education program, focusing on the seven precepts of the Pledge Pin. The education program occurred throughout the spring semester, and helped us to better understand the inner workings of Alpha Sigma Phi, as well as to strengthen our own planning and development. The semester culminated with an examination, which tested our understanding of the Old Gal. To become more knowledgeable of all Alpha Sigma Phi teaching, history and rituals we as brother will do one on one and group sessions conducted by our brotherhood chair, historian and marshal before our chartering in the Fall. In addition to this all brothers are also expected to further their own understanding through informal, personal contact with area alumni. This will help us to better understand the origins of the Beta Zeta chapter at NC State, and the hidden teachings of Alpha Sigma Phi (as soon as we are allowed to learn them).

Progress for Goal 4: Developing Strong Organizational Administrative and Budgeting Practices

We have developed and implemented in-depth, comprehensive administrative procedures for managing our fraternity. We have written and implemented our first Constitution and By-Laws, which were unanimously passed in the Spring semester, 2006. We also developed, with the assistance of Alumni Richard Dyer, a complete budget for the academic year. This budget was patterned from budgets of chapters in North Carolina, as well as nationwide. Brother Dyer helped us to understand and create a sound savings plan for future program needs.

To successfully continue to establish strong organization administrative and budgeting practices each chairman will develop a complete set of committee manuals. These will use the resources provided us by the National Office, as these documents serve as a wonderful template for a successful manual, but each officer will address issues that have or have not worked for our chapter, this will provide future reference for all new officers.

Progress for Goal 5: Campus and Community Involvement

We have been active participants in the following volunteer programs: Adopt-A-Highway, The YMCA, The Orphans Rescue Project (fundraising efforts with other Greek fraternities and sororities), Packaging food for Hurricane relief and local families in need, and the Canned Food Drive during Greek Week. We recognize that this is an area in need of more participation and growth among all brothers, and have implemented participation requirements for each man during each semester (each man must complete 15 hours of service each semester MINIMUM).

The Constitution Of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University As Underwritten by its Founding Fathers

February 19, 2006

PREAMBLE

In the traditions and the beliefs of Alpha Sigma Phi Fraternity, established at Yale College, to create and perpetuate brotherhood through high scholastic achievement, we, the brothers of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University, do hereby adopt and adhere to this Constitution and its By-Laws as the underlying body of this organization.

ARTICLE I - NAME

The formal name of this organization shall be known as the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University. For the purposes of recognition on The North Carolina State University campuses and its surrounding communities, we will be known as Alpha Sigma Phi.

ARTICLE II - MISSION

Section I - Brotherhood

The mission of this chapter, as set forth by the Founding Fathers of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity is as follows: Building a diverse brotherhood through leadership, scholarship, and service. This chapter will also ensure a rich environment in which to create and perpetuate brotherhood. In doing so, we will create lifelong relationships based on mutual love, respect, and support. We will seek a deeper awareness and understanding of each other as well as the community around us. We will invite all gentlemen into this chapter without prejudice or persecution by recognizing the qualities that make each human being a unique individual.

Section II - Service and Philanthropy

The Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University will uphold our dedication to serving others; within the Greek system, the North Carolina State University campuses, and its surrounding communities. In addition to pledging our time to serve those in need, this chapter will raise funds for various charitable organizations through philanthropic events. The Brothers of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University recognize the non-profit organization, Canine Companions for Independence, as our primary benefactor.

Section III - Education and Scholarship

The Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University will encourage and foster the ideals of the University and the importance of higher education to each of our brothers. In recognition that education is the primary reason for attending a University, this chapter will not impede upon ones course of study, but embrace it and assure its development. The brothers of this chapter will pursue and maintain the highest standard of scholarship.

ARTICLE III - MEMBERSHIP

The Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University will not discriminate against any man interested in this organization based on age, race, creed, color, religion, or sexual preference; however, he will need to demonstrate virtues favorable to this brotherhood and meet the requirements set forth by this chapter and North Carolina State University.

ARTICLE IV - OFFICERS AND OFFICES

The successful growth and development of a chapter depends largely upon knowledgeable and efficient leadership. The officers of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University, whether elected or appointed, shall provide the leadership that this chapter needs in order to pursue its personal and fraternal dreams, ideas, goals, and ambitions. The officer is to represent the values and beliefs of this organization by maintaining the highest standards for all brothers to follow. An officer will help to regulate various meetings in which he is involved, be an informant to the General Assembly, and always support fellow brothers. All officers are elected annually by the General Assembly. Any office left vacant for any reason shall be filled by a Presidential nomination and the Prudential Committee confirmation until the following election. Should the Presidential Office become vacant, an election shall be held to replace him within two weeks. All officers are subject to review at any given time by the Prudential Committee if there is concern over the officer's performance. Any office deemed unnecessary may be eliminated by recommendation from the Prudential Committee to the General Assembly, followed by a two-thirds vote of the active General Assembly.

ARTICLE V - COMMITTEES

The committee system is established to delegate the workload of specific officers between individual members in the Fraternity. As a result, the organization fosters the development of each member through experiences, and helps to create future leaders from within each committee. Each officer will be appointed a committee if deemed necessary.

ARTICLE VI – BOARDS

Section I - Prudential Committee

The Prudential Committee of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University shall be assembled 1) to define and solve those problems pertaining to this organization. This act pursues and perpetuates the ideas and goals of this Fraternity and its Founding Fathers. 2) To review and control the financial obligations incurred by and for this Fraternity. The Committee shall create a budget by which officers of the Fraternity may withdraw funds. It will be responsible for the collection of membership dues and fines incurred by this Brotherhood. The Committee will establish an account with a local bank. The Prudential Committee shall also determine the amount of money that will be distributed to various charitable organizations, with an affirmation of 1/2 the general assembly. The Committee shall be chaired by the Vice President and comprised of the President, Treasurer, and two members at large. It shall be the decision of the Vice President to open or close Prudential Committee meetings to the Brotherhood. At no time should the information discussed be held in confidence from the Brotherhood, keeping in mind that a closed meeting only serves as an efficient meeting.

Section II - Judicial Board

The Judicial Board of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University shall be established to review and enforce this Constitution and its By-Laws. This board shall be comprised of the President, Vice-President, and three members at large. The Judicial Board is an essential body to the maintenance of the Fraternity, and its beliefs, values, and image. Thus, the Judicial Board shall review and make objective judgments on cases that may jeopardize the foundations of this Chapter. In such an event, each case shall be individually investigated in an unbiased atmosphere. To resolve the proper course of action, this Brotherhood shall act in accordance with the Constitution and its By-Laws.

ARTICLE VII - VOTING

The active General Assembly of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University is defined as all active brothers. Voting on any issue can take place when there is fifty percent plus one of the active General Assembly present. Active membership is defined as all undergraduate brothers in good standing with the Fraternity.

ARTICLE VIII- THE ALUMNI CORPORATION

Section I - The Board

An Alumni Corporation shall be established to perpetuate brotherhood and ensure that the foundations of the Fraternity shall remain strong and true to its mission. The Alumni Corporation of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University shall adhere to the Chapter Alumni Corporation Guidelines as set forth by the National Fraternity of Alpha Sigma Phi Fraternity. Any decisions made by the Alumni Corporation regarding conduct of the chapter may be contested by a hearing with the national headquarters. The Board will conduct an annual audit of the undergraduate Treasury. They will in turn be subject to a biannual audit by the undergraduate Prudential Board. This board may raise money for the sole benefit of this chapter, and/or its national philanthropy. Finally, the Alumni Corporation should act as a Board of Directors to the undergraduate body of this Fraternity in terms of its past, present, and future. The Alumni Corporation shall always act in the best interests of this Fraternity.

Section II - Housing

The Alumni Corporation of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University will take complete control of the Housing Fund of this chapter once established. The Beta Zeta Chapter will be responsible for an annual donation of ten percent of the gross revenue raised to the Housing Fund controlled by the Alumni Corporation. This money is restricted to housing concerns for the undergraduate body including, but not limited to, the building and maintaining of a nationally recognized house. This money may also be used in storing and maintaining the archives gathered by this chapter.

ARTICLE IX - NON-DISCRIMINATION CLAUSE

The Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University and the brothers within the Fraternity recognize that no two persons are absolutely alike; each having his own beliefs, values, and culture. Therefore, the brothers within this Fraternity feel that any discrimination based on age, race, creed, color, religion, or sexual preference would be contrary and detrimental to the foundations set forth by the Fraternity. Any such discrimination will not be tolerated and will be discouraged at all times.

ARTICLE X - DISSOLUTION CLAUSE

In the event that the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University should dissolve, the funds remaining shall be given to the Alpha Sigma Phi Headquarters. Under their discretion, a Barry

Olsen Scholarship for North Carolina students will appropriate the remaining funds to candidates of their choice.

ARTICLE XI - SUSPENSION CLAUSE

With the possibility that the By-Laws of the Constitution of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University may not cover specific areas of concern, they may be suspended, in part or in whole, by a two-thirds vote of the active General Assembly, for the designated time suggested within a motion.

ARTICLE XII - AMENDMENT CLAUSE

In recognition of the ever-changing environment around us, the articles of this constitution, by-laws, and policies may be amended, revised, or altered in part or in whole by a two-thirds vote of the active General Assembly.

ARTICLE XIII - SUPREMACY CLAUSE

All policies, procedures, and regulations set forth by Alpha Sigma Phi Grand Chapter shall unequivocally become policy of Beta Zeta Chapter and need not ratified. This document shall serve as supplement to all policies, procedures, and regulations set forth by the Grand Council and delegates as ratified during the Grand Chapter.

The By-Laws to the Constitution Of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University As Underwritten by its Founding Fathers

Ratified February 19, 2006

PREAMBLE

The By-Laws of this Constitution outline the rules and regulations set forth by the National Fraternity, as well as this organization. They are meant to evolve and grow through time in order to adjust to the environment around the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University in a positive and visionary manner.

ARTICLE I - MEMBERSHIP

Section I

Undergraduate membership into the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University is only open to those men attending North Carolina State University as a full time student. They must not have been initiated into any other social fraternity. They will meet the high standards set forth by the Beta Zeta Chapter of Alpha Sigma Phi Fraternity and its members.

Section II

Membership into the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University will be extended to those gentlemen who receive a vote of ninety five percent or more, of the brothers present, at the time of voting by the General Assembly, including absentee ballots. To vote on new members, there must be seventy five percent plus one of the General Assembly present. Should an individual be extended a bid from this organization, he maintains the right to turn the invitation down without question. He also maintains the right to defer the bid until the following semester.

Section III

Brothers who have entered the Chapter in the spring of 2006 and thereafter must achieve a 2.50 grade point average to remain in good standing with the Beta Zeta Chapter of Alpha Sigma Phi Fraternity.

Section IV

All brothers of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University must maintain the educational standards established by this Chapter, its University, and the Interfraternity Council regarding education. Should a brother fail to meet these standards, he will be placed on probation for one semester as a member not in good standing. Should he not fulfill his educational requirements at the completion of one semester of being a brother not in good standing, the Judicial Board of the Chapter will take action in the best interests of the Chapter and the individual brother. This decision should be made while taking into account the individual circumstances of the brother involved, the advice of the Scholarship Chairman, and the Beta Zeta Grand chapter Advisor. If upon judgment by the Judicial Board, the brother involved wishes to appeal the decision, he may do so as outlined in Article IV, Section V.

Section V - Alumni Status

An alumnus of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University shall be defined as an initiated brother who has graduated from North Carolina State University with a degree in his field of study. An initiated brother may also go on Alumni Status should he transfer to another institution of higher learning. If an initiated brother finds that he must discontinue his education for any reason, and does not return within a semester, he may be granted Alumni Status. An alumnus of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University may attend any meeting, social, service, and/or philanthropic events at any given time. They are relieved of their dues and lose their voting rights.

Section VI - Pledgeship

New Member Requirements:

- 1. Attend New Member Education courses.
- 2. Pay local dues, national dues, and any other fees set forth by the treasurer.

If for whatever reason a new member does not become an initiated brother after one semester of new membership, he will be required to enter new membership for a second semester. At the end of the second semester, if the New Member does not meet the requirements to become an initiated brother, he will be removed from the roster and all affiliation with the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University. If at any point the individual meets the requirements to become an initiated brother, he will be allowed to rejoin the Chapter. At this point, he is responsible for carrying out the duties of an initiated member, excluding new member initiation.

ARTICLE II - OFFICERS

Section I - Duties and Responsibilities

- 1. Officers and Committee Chairmen shall perform the duties of their respective positions as set forth by Alpha Sigma Phi Officer and Committee Chairman Manual and the respective Alpha Sigma Phi officer manuals and guidelines. Should an officers' position not be described, that officer will accept the responsibilities bestowed upon him by the President, the Prudential Committee, and/or the general membership and shall abide by the general rules and laws applicable to any officer of the brotherhood.
- 2. Each officer and committee chairman shall be responsible for formulating a budget for each semester, if necessary, and submitting it to the Treasurer at a time of his discretion.

Section II - President

The President of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University will oversee the operation of this Fraternity so that it will continue to create and perpetuate brotherhood, as well as foster the Judicial Board and the Prudential Committee. As the executive head of the Chapter he is responsible for:

- appointing brothers to vacant offices and to initiate a periodic review of each officer's education among the members.
- Helping supervise, instruct, and evaluate all work carried out by each committee.
- Being fully informed of the financial standing of this Chapter.
- · Assisting the Chapter in developing, implementing and evaluating goals.
- Enforcing the laws of this Chapter, the National Fraternity, its university, as well as Federal, State, and Local Laws.
- Representing the Fraternity at all functions outside this Chapter in a positive way.
- Assisting each individual member in obtaining a positive Fraternal experience through the involvement in chapter operations.
- Keeping the Chapter striving for excellence in all of its phases.
- Making sure the Chapter is well represented in all National sponsored events.
- Being sure that each brother or pledge is aware and understands the Fraternity's position on all issues.
- Ensuring that the Chapter Secretary provides the University, Alumni Corporation, and the National Fraternity with a complete list of all new officers upon election.
- Ensuring that the Secretary files a list of all active members and pledges with the University and the National Fraternity at the beginning of each semester.
- Helping to seek out a faculty and/or staff member of the University to work as an advisor to the Chapter and filing the advisor's name with their University and National Fraternity.
- Maintaining an active association with the Alumni Corporation.

Finally, the President will set an example of high standards for all brothers to follow.

Section III - Vice President

The Vice President of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University will be responsible for:

- Serving as the President's temporary replacement as needed.
- Organizing the composites for the Fraternity each academic year.
- Serving as a member of the Judicial Board
- · Chairing the Prudential Committee.
- Supervise, instruct, and evaluate all work carried out by the committees.
- Helping to enforce the laws of this Chapter, the National Fraternity, its university, as well as Federal, State, and Local Laws.

Finally, the Vice President will set an example of high standards for all brothers to follow.

Section IV - Treasurer

The Treasurer of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University will be responsible for:

- The collection and safe-keeping of funds within the Fraternity.
- Establishing a relationship with a local bank for the deposit and withdrawal of funds.
- Serving as a member of the Prudential Board.
- Creating a budget that will assist the Fraternity in allocating funds correctly.
- Maintaining neat and accurate records of all transactions made within the Fraternity.
- Keeping the Prudential Board and the General Assembly informed of the financial status of this Chapter.
- Meet all financial obligations that the Fraternity incurs through daily operations with the Fraternity's funds.
- Making sure that each brother and pledge understands the financial requirements and obligations set forth by this Chapter.
- Collecting from each brother the amount owed to the Chapter and report financial delinquencies to the Prudential Board.
- Utilizing the authority he has to place a fine system on late dues.
- Keeping accurate service records of all employees.
- Ensuring all members complete online Alcohol Edu.

Acting as the purchasing agent for the Chapter and to pay all creditors on time.
 Finally, the Treasurer will set an example of high standards for all brothers to follow.

Section V - Secretary

The Secretary of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University will be responsible for:

- Recording the minutes of the General Assembly and any other meeting in which a record has been requested by the President or Vice President.
- Publishing and posting minutes of each meeting within forty-eight hours of its date.
- Keeping an attendance record of all meetings.
- Maintaining and updating address files of alumni and undergraduate brothers of the Beta Zeta Chapter.
- Maintaining and updating the calendar of events.
- Publishing an accurate phone list of this Chapter.

Finally, the Secretary will set an example of high standards for all brothers to follow.

Section VI- Corresponding Secretary

The Corresponding Secretary of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University is responsible for:

- · Keeping correspondence with other chapters, headquarters, alumni associations and other campus groups.
- Assist Editor in publishing and distributing Newsletter

Finally, the Corresponding Secretary will set an example of high standards for all brothers to follow.

Section VII - Marshal

The Marshal of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University is responsible for:

- The proper execution of all rituals.
- Being in charge of the storing, cleaning, and safe keeping of the ritual equipment.
- Maintaining a serious atmosphere during ritual.
- All ritual reviews for this Chapter and its members.
- Holding a ritual ceremony after every initiation.
- Holding at least one additional ritual review per semester.

Finally, the Marshal will set an example of high standards for all brothers to follow.

Section VIII - Sergeant at Arms

The Sergeant at Arms of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University is responsible for:

- Preparing the Chapter Room for meetings and ceremonies.
- Maintaining order and dignity during chapter meetings.
- Guarding the door during every meeting and excusing only those who have received proper permission from the Chair.
- Enforcing all meeting policies at every meeting.
- Acting as the Chaplain during ceremonies.
- Assisting the Marshal in organizing and performing all ritualistic ceremonies.

Finally, the Sergeant at Arms will set an example of high standards for all brothers to follow.

Section IX - Scholarship Chairman

The Scholarship Chairman of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State

University is responsible for:

- The encouragement and promotion of high academic performance for this Brotherhood.
- Helping to establish scholarship goals for the Chapter and a program directing brothers and pledges in attaining these goals.
- Creating a suitable atmosphere for study in the Chapter House or on campus.
- Providing and assisting brothers in applying for scholarship awards.
- Maintaining reference materials, scholarship opportunities, test files, and paper files for use by the Chapter.
- Arranging for speakers from alumni, Career Services, faculty, and industry to present workshops for the Chapter in the areas of scholarship and career development.
- The creation and distribution of the Beta Zeta Founders Scholarship.
- . Monitor and maintain all academic records and progress for each member and potential member

Finally, the Scholarship Chairman will set an example of high standards for all brothers to follow.

Section X- Editor

The Editor of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University is responsible for:

- Publishing at least one chapter newsletter per semester and distribute copies to all the undergraduate brothers, alumni, parents, chapters in the province, Greek life at North Carolina State University and to the National Fraternity.
- Sending materials twice a year containing information about this Chapter's activities for publication in *The Tomahawk* and the *Old Gal Gazette*.
- A monthly brief overview of major actives to be placed into the Brotherhood Bulletin.
- Establish and maintain website, scrapbook and video journal.

Finally, the Editor will set an example of high standards for all brothers to follow.

Section XI- Alumni and Parents Chairman

The Alumni and Parents Chairman of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University is responsible for maintaining communications with all alumni of this Chapter as well as periodic communication with the local alumni of Alpha Sigma Phi Fraternity. He will also be responsible for:

- Planning and executing at least two events per year for the return and participation of alumni in accordance with the Alumni Board.
- Ensuring invitations are made to alumni for chapter functions.
- Providing a representative to every Alumni Corporation meeting.
- Maintaining an updated list of all alumni of this Chapter and those alumni of Alpha Sigma Phi Fraternity living within one hundred and fifty miles from North Carolina State University.
- Informing the parents of the undergraduate body of chapter activities and functions.
- Informing the parents of new members that their son has accepted an invitation to join our brotherhood.
- · Periodically evaluating the program to ensure that the needs of the alumni and parents are being met.

Finally, the Alumni and Parents Chairman will set an example of high standards for all brothers to follow.

Section XII - Recruitment Chairman

The Recruitment Chairman of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University is responsible for:

- The recruitment of new members into Alpha Sigma Phi Fraternity.
- Establishing Recruitment goals with the Chapter and organizing a calendar of events to meet those goals.
- Securing a list of potentials and developing a follow-up program.
- Educating the members of our chapter on techniques that should be used during Recruitment.
- Organizing our participation in IFC recruitment.
- Creating a system that maintains a close contact with all potentials.
- Attending any recruitment conventions to obtain any information pertaining to Recruitment.

• Following all Risk management procedures, rules, and regulations associated with recruitment. Finally, the Recruitment Chairman will set an example of high standards for all brothers to follow.

Section XIII - Service Chairman

The Service Chairman of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University focuses on our involvement in service projects throughout the community and on the campuses of North Carolina State University. He is responsible for:

- Planning and executing at least three fraternity wide service projects per semester and must receive proper authorization to hold each event.
- Fulfilling the duty of reporting service hour totals to the General Assembly at every other General Assembly meeting.
- Applying for the Award of Service through the National Fraternity.
- Evaluating all projects and making suggestions for improvement in the future, so that the maximum number of brothers is involved.
- Planning weekly service opportunities for brothers to fulfill services hours.

Finally, the Service Chairman will set an example of high standard for all brothers to follow

Section XIV - Philanthropy Chairman

The Philanthropy Chairman of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University is responsible for:

- Creating successful fundraisers that benefit our national philanthropy, a charitable organization, or this Chapter directly.
- Attaining permission from all authorities to hold each event and completing all paperwork that is associated
 with that event.
- Recording the attendance of any event in which eighty percent of all revenue raised goes to charity, applying the brothers' participation at the event towards required service hours.
- The Philanthropy Chairman may serve as the collection agent for all funds raised at each event. In turn, all
 revenue must be turned in to and accounted for by the Treasurer.

Finally, the Philanthropy Chairman will set an example of high standards for all brothers to follow.

Section XV - Social Chairman

The Social Chairman of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University is responsible for:

- Planning and executing social functions within this organization and in conjunction with other organizations established on this campus.
- Making sure that all social events and parties will comply with Federal, State, and Local Laws pertaining to alcohol consumption, as well as those policies set by North Carolina State University.
- Making sure that all socials will be subject to Risk Management policies of this Chapter as well as this Constitution, its By-Laws, and with the National Constitution and By-Laws.
- Making sure that at no time will any individual be put at risk during a social event.
- Promoting responsible use of alcohol through speakers, workshops, and other social activities.

Finally, the Social Chairman will set an example of high standards for all brothers to follow.

Section XVI - Brotherhood Chairman

The Brotherhood Chairman of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University is responsible for:

- Promoting brotherhood in this Fraternity. This will be achieved by helping to identify the problems in the Chapter and the internal conflicts that individual brothers may be having.
- Organizing events that helps to contribute to the creation and perpetuation of brotherhood.
- Serving as a mediator, giving suggestions of possible solutions.

- Assisting in the maintenance of lifelong fraternal relationships.
- Coordinating with the President, the Chairman will plan and execute a brotherhood retreat each semester.
- Reaffirming the position statements of this Fraternity with the Brotherhood.
- Coordinating special guest speakers on topics including etiquette, interviewing skills, parliamentary procedure, and other such topics for membership enrichment.
- Presenting a presentation once a semester on hazing.
- Informing and encouraging brothers to participate in campus, Interfraternity Council, or Greek sponsored
 events or programs.

Finally, the Chapter Relations Chairman will set an example of high standards for all brothers to follow.

Section XVII - Public Relations Chairman

The Public Relations Chairman of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University is responsible for:

- Publicizing the events of any and all committees in this Fraternity.
- Promoting the values of belonging to a fraternity through media, contests, and other devices both on and off campus.
- · Acting as a liaison between the sororities and fraternities of North Carolina State University.
- · Promoting inter-Greek relations.
- Making sure the Chapter is represented in major campus organizations and committees.
- Keeping the Chapter informed of all campus activities and obtaining optimum participation by the Brotherhood.
- Planning and executing at least one event per semester on campus to promote Alpha Sigma Phi.

Finally, the Public Relations Chairman will set an example of high standards for all brothers to follow.

Section XVIII - New Member Educator

The New Member Educator of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University is responsible for:

- Planning and organizing the New Member's program for the New Members of the organization.
- Using the *To Better The Man* and the New Member Educator's Manual as a reference to provide the knowledge and skills necessary for development of educated active brothers.
- Ensuring that each New Member learns the history, operations, values, and beliefs of this Chapter and its National Fraternity of Alpha Sigma Phi.
- · Covering all of, but not limited to, the following topics:
 - o A scholarship goal
 - o Mock General Assembly
 - Hazing presentation
 - o Local history
 - o Interfraternity Council
 - o Committee presentation
 - o Service project
 - o Mentoring program
 - o National history
 - o Alcohol awareness
 - o Gentlemen training
 - o Holding a mini-retreat
- Integrating the new members and their activities with the Brotherhood.
- Enlisting the aid of outside speakers for developmental programs.
- Organizing and administering the Big Brother Program.
- Eliminating any form of hazing that may be present.
- Appointing an assistant to help administrate the New member Program with the President's consent.

 Each semester making sure his program is evaluated by the Judicial Board to make adjustments and recommendations for the next New Member Education Program.

Finally, the New Member Educator will set an example of high standards for all others to follow.

Section XIX - Risk Management Chairman

The Risk Management Chairman of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University is responsible for:

- Administrating a safe and effective risk management policy. This policy will predetermine the number of
 party monitors present during all socials and parties to maintain a safe atmosphere.
- Holding a meeting with all the party monitors before any event to assign duties and review the policy.
 Assigning a party monitor to be in charge of that event, should the Chairman be unable to perform any duty outlined in the Risk Management Policy.
- Establishing the Safe Ride Program.
- Assigning all brothers to the Safe Ride Program and Risk Management Policy prior to the start of any given semester.

Finally, the Risk Management Chairman will set an example of high standards for all brothers to follow.

Section XX - Historian

The Historian of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University is responsible for:

- Preserving this Brotherhood's history through the use of photographs, articles, personal writings by individual brothers, and memorabilia.
- Providing access to all history and encouraging its learning.
- The care of all awards and inventory of the Chapter's possessions.
- Displaying any of the Chapter's history in any fashion to ensure its safety and well-being.

Finally, the Historian will set an example of high standards for all brothers to follow.

Section XXI - Intramural Chairman

The Intramural Chairman of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University is responsible for:

- Organizing teams for the Beta Zeta Chapter of Alpha Sigma Phi Fraternity to compete in university, greek, and intramural programs.
- Maintaining contact with the university's Intramural Office with regard to rules, regulations, and eligibility requirements.
- Informing teams, well in advance, about the times and places of events.
- Making sure that the teams arrive on time with the proper equipment.
- Arranging practice sessions for the teams, if needed.
- Announcing the results of the intramural athletic events at chapter meetings.

Finally, the Intramural Chairman will set an example of high standards for all brothers to follow.

Section XXII - Two Members-at-Large of the Prudential Board

The two Members-at-Large of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University will serve as a member and part of the voting body of the Prudential Board. They will help in all financial decisions that this Fraternity shall make. Each member may hold another office with the exception of

President, Vice-President, and Treasurer. Finally, the Members-at-Large will set an example of high standards for all brothers to follow

Section XXIII- Three Members-at-Large of the Judicial Board

The three Members-at-Large shall serve as Judicial Board Members for the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University. They are responsible to serve this Fraternity in providing an unbiased decision concerning the issues that face this Brotherhood and individual brothers based on the Constitution and By-Laws of this Chapter. They are also accountable for the review and revision of the Constitution and the By-Laws of the Beta Zeta Chapter. Each member may hold another office with the exception of President or Vice President. Finally, the Judicial Board Members will set an example of high standards for all brothers to follow

ARTICLE III - COMMITTEES

Section I - The Committees

The following committees have been established for the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University to help aid in the creation and the perpetuation of this Brotherhood and to help foster leadership:

- The Recruitment Committee
- The Service Committee
- The Philanthropy Committee
- The Social Committee
- The Brotherhood Committee
- The Public Relations Committee
- The Scholarship Committee
- The Alumni and Editor Committee
- The Special Committees

Section II - The Recruitment Committee

The Recruitment Committee will:

- Be headed by the Recruitment Chairman.
- Organize and execute all Recruitment activities and events for the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University throughout the year.
- Have the discretion to restrict events to men only, but may also open events to local sororities to help coordinate events.
- Be subjected to follow the rules and regulations set up by the National Fraternity, Interfraternity Council, and North Carolina State University.
- Not permit any activity or event that could possibly endanger a person's health or well being.
- · Not tolerate any form of hazing.

Section III - The Service Committee

The Service Committee will:

- Be headed by the Service Chairman.
- Organize and execute service projects for the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University.
- Have the discretion to restrict participation in such projects for brothers only, or open those projects to other organizations.
- Be subjected to follow the rules and regulations set up by the National Fraternity, Interfraternity Council, and North Carolina State University.

- Not permit any activity or event that could possibly endanger a person's health or well being.
- Not tolerate any form of hazing.

Section IV - The Philanthropy Committee

The Philanthropy Committee will:

- Be headed by the Philanthropy Chairman.
- Organize and execute Philanthropic and fundraising events for the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University.
- Have the discretion to restrict participation in such projects for brothers only, or open those projects to other organizations.
- Be subjected to follow the rules and regulations set up by the National Fraternity, Interfraternity Council, and North Carolina State University.
- Not permit any activity or event that could possibly endanger a person's health or well being.
- Not tolerate any form of hazing.

Section V - The Social Committee

The Social Committee will:

- Be headed by the Social Chairman.
- Organize and execute social events for the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University.
- Have the discretion to restrict participation in such projects for brothers only, or open those projects to other organizations.
- Be subjected to follow the rules and regulations set up by the National Fraternity, Interfraternity Council, and North Carolina State University.
- Not permit any activity or event that could possibly endanger a person's health or well being.
- Not tolerate any form of hazing.

Section VI - The Brotherhood Committee

The Brotherhood Committee will:

- Be headed by the Brotherhood Chairman.
- Organize and execute brotherhood events and retreats for the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University.
- Have the discretion to restrict any event for brothers only, or open them to family, friends, and/or alumni.
- Be responsible for instilling spirit and song into the Chapter.
- Be subjected to follow the rules and regulations set up by the National Fraternity, Interfraternity Council, and North Carolina State University.
- Not permit any activity or event that could possibly endanger a person's health or well being.
- Not tolerate any form of hazing.

Section VII - The Public Relations Committee

The Public Relations Committee will:

- Be headed by the Public Relations Chairman.
- Organize various public relation campaigns for the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University.
- Draft letters to other organizations when necessary.
- Maintain a positive image for the Fraternity through various media tools.
- Be subjected to follow the rules and regulations set up by the National Fraternity, Interfraternity Council, and North Carolina State University.

- Not permit any activity or event that could possibly endanger a person's health or well being.
- Not tolerate any form of hazing.

Section VIII - The Scholarship Committee

The Scholarship Committee will:

- Be headed by the Scholarship Chair.
- Organize scholarship programs for the encouragement and promotion of high academic performance of this Brotherhood.
- Be in charge of fundraising for the Beta Zeta Founders Scholarship.
- Be subjected to follow the rules and regulations set up by the National Fraternity, Interfraternity Council, and North Carolina State University.
- Not permit any activity or event that could possibly endanger a person's health or well being.
- Not tolerate any form of hazing.

Section IX - The Alumni and Editor Committee

The Alumni and Editor Committee will:

- Be headed by the Alumni and Parents Chairman.
- Organize various activities for the alumni of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University.
- Draft a semester newsletter to be mailed to all parents and alumni.
- Use the newsletter and other forms of communication, as deemed necessary, to contact alumni and parents.
- Be subjected to follow the rules and regulations set up by the National Fraternity, Interfraternity Council, and North Carolina State University.
- Not permit any activity or event that could possibly endanger a person's health or well being.
- Not tolerate any form of hazing.

Section X - The Special Committees

The Special Committees will:

- Be appointed by the President.
- Operate as long as the President deems necessary.
- Be subjected to follow the rules and regulations set up by the National Fraternity, Interfraternity Council, and North Carolina State University.
- Not permit any activity or event that could possibly endanger a person's health or well being.
- Not tolerate any form of hazing.

Section XI - Approval of Committee Actions

All Committee decisions pertaining to the Beta Zeta Chapter of Alpha Sigma Phi at North Carolina State University must be presented to the Prudential Committee and approved before being presented to the General Assembly at the next meeting. For a Committee decisions to be put in place it must gain quorum by the General Assembly.

ARTICLE IV - JUDICIAL BOARD

Section I - Judicial Board

The Judicial Board of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University shall be composed of the President, Vice President, and three members-at-large elected by the General Assembly. The five members of the board will decide the Judicial Board Chairman.

Section II - Purpose

The purpose of the Judicial Board is to interpret and uphold the governing Constitution and By-Laws of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University, as well as the governing Constitution and By-Laws of the National Fraternity, for the protection and discipline of all brothers and new members of this Chapter. At any time, the Constitution and By-Laws may be amended by the Judicial Board will go before the Prudential Committee and then must get 2/3 Approval by the General Assembly.

Section III - The Constitution and By-Laws

With the understanding that the Constitution and By-Laws of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University are living documents, the Judicial Board will constantly review the Constitution, By-Laws, and any policy of this Fraternity and make suggestions as to the improvement of the above mentioned, when deemed necessary. All amendments will go before the Prudential Committee, and will then be voted on by the General Assembly for approval.

Section IV - The Judicial Board Trial Process

At any time, the Judicial Board may hold a hearing to determine whether an individual brother has stepped beyond the beliefs and values of this Chapter. A brother may report an incident to the Judicial Board Chairman, or the Judicial Board may pursue an issue that they feel is endangering the beliefs and values of this Chapter. The Judicial Board will act upon an incident within two weeks from the time the incident was reported to the Judicial Board Chairman. Any member of this Chapter may attend the hearing. During the hearing, those accused will be allowed a maximum time of thirty minutes to state their case, followed by a questioning period from the Judicial Board. The Judicial Board, as well as the individual(s) on trial, may have witnesses to their case in which they will follow the same procedure as the defendant this time is included in the maximum thirty minute time period. The Judicial Board will convene privately for an appropriate amount of time to discuss the issue and make a judgment. If found innocent, the individual(s) on trial case will be dropped; if found guilty by a majority vote, with no members abstaining, the Judicial Board will apply an appropriate measure upon the individual(s) on trial that applies to the severity of the case. All five members will issue a vote of Guilty or Not Guilty.

Section V- Sanctions upon an individual

An appropriate measure upon the individual(s) on trail that applies to the severity of the case will be issued. The Sanctions issued by the judicial board will be based on a 3/5 decision during. If individual does not agree with the sanctions they may appeal by the appeal process.

Section V - The Appeal Process

If the guilty party feels that the Judicial Board's judgment was made unfairly, he may appeal it to the Prudential Committee with both a written statement and an appearance at the next Prudential Committee meeting immediately following the hearing. The Prudential Committee has the right to uphold or overturn the Judicial Board's judgment. If the guilty party feels that the judgment of the Prudential Committee was made unfairly, he may appeal it to the General Assembly with a written statement and an appearance at the next General Assembly meeting immediately following the Prudential Committee hearing. The General Assembly has the right to uphold or overturn the Prudential Committee Judgment with a ¾ vote to overturn the decision. With the Voting Process as defined in Article VII.

Section VI - Judicial Board Involvement with a Case

If a Judicial Board member is asked to appear before the Judicial Board, or a member feels he cannot perform his unbiased duty, that member will be temporarily removed from the Judicial Board for the duration of the hearing. The Judicial Board remaining members will appoint someone for the duration of the process.

Section VII - Attendance Policy

The Judicial Board will enforce attendance policies as stated in Article V, Section II, Article V, Section III, and Article V, Section VII.

ARTICLE V - MEETINGS

Section I

All meetings pertaining to the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University will be held on a regularly scheduled basis each week, or as deemed necessary by the chairman of each individual meeting.

Section II - Attendance Policy

Attendance by all members is mandatory for the General Assembly meetings and scholarship program. The Attendance policy is as follows:

- The first absence will be considered an academic leave.
- The second absence will result in a written warning.
- The third absence will result in a written warning, as well as a loss of voting privileges for one month.
- The fourth absence will result in referral to the Judicial Board by the Secretary.

Absences are considered:

- Not attending official General Assembly meeting.
- Not meeting your required weekly hours for the scholarship program.
- Not attending at least sixty percent of recruitment events
- Excessive absences from General Assembly meetings due to severe illness, religious holidays, military
 obligations, or other appropriate special circumstances will not be counted against a brother in accordance
 with the attendance policy.

Section III - Attendance at Ritual

The Attendance policy at all official Alpha Sigma Phi rituals is as follows:

- Attendance at ritual is mandatory for all brothers
- In order for this absence to be assessed, the aforementioned ritual(s) must be part of the official semester calendar
- Should a brother not come to a ritual that is on the official semester calendar that brother will be brought up
 to the Judicial Board
- Absence from Rituals due to severe illness, religious holidays, military obligations, or other appropriate special circumstances will not be counted against a brother in accordance with the attendance at Ritual policy.

Section IV - Meeting Procedures

All meetings will follow general Parliamentary Procedures as outlined in Alpha Sigma Phi's, Beta Zeta Chapter Parliamentary Procedures for General Assembly Meetings. This helps to ensure orderly General Assembly meetings.

Section V - New Business

All motions to be put on the agenda must be given to the President in writing four hours before the start of the meeting the day of the meeting.

Section VI - Minimum Planning Time

Big/Little, New Member Ceremony, and Initiation Ceremony must be placed on the official schedule and announced at a General Assembly meeting a minimum of fourteen days prior to when the particular event is to occur.

Section VII - Attendance at Prudential Committee Meetings

Attendance by all Prudential Committee members is mandatory to all Prudential Committee meetings. The Prudential Committee Attendance Policy is as follows:

- The first absence will be considered an academic leave.
- The second absence will result in a written warning.
- The third absence will result in a loss of position.
- Excessive absences from Prudential Committee Meetings due to severe illness, religious holidays, military
 obligations, or other appropriate special circumstances will not be counted against a brother in accordance
 with the Prudential Committee Attendance Policy.
- Should an officer be asked to step down from their position, A new officer will be elected by the general
 assembly.

Article VI - Voting

Section I - Voting Options

A show of hands or secret ballot will be the two primary sources of voting used by this Chapter. The voting style will be determined by the President or presiding chairman of the meeting. To vote, members must be in good standing. The President or presiding chairman will not cast a vote unless a tie must be broken. For a vote to be taken, quorum must be present. Quorum is defined as fifty percent of the voting body plus one.

Section II - Officers and Chairmen

All officers and chairmen will be voted on through a secret ballot. Each member, except for the President, will be able to cast one vote per person, per office. An officer or chairman must win the election by fifty percent plus one, or a run off between the top two will result. No member may abstain in elections. Those running for a position may also vote.

Section III - Potential Brothers

A secret ballot will be used when determining if the Chapter will extend an invitation to an individual. For a potential member to be extended an invitation to become a member of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University, he must receive at least a ninety-five percent yes vote of at least seventy five percent of the members. Should a potential member not receive ninety-five percent yes vote but has at least eighty percent yes vote after the first voting round, there will be a deliberations and another round of voting. At this stage if the potential member does not receive more then eighty-five percent yes vote he is not extended an invitation, However if the potential member receives more then eighty-five percent yes vote there will be one finial round of deliberations and a final round of voting. If the potential member does not gain the required ninety-five percent yes vote at this time he will not be extended an invitation this recruiting period. No member may abstain in the extending an invitation process.

Any man, who accepts an invitation within two weeks after the extension of an invitation, will be part of that semester's current class. Any man who accepts an invitation after the previously mentioned period will be part of the next semester's class.

Section IV - Choices in Voting

The following are the possible choices when voting:

Yes absolute No absolute Abstain undecided

Abstaining will count towards the quorum, but not figure into the numerator or denominator of a voting percentage.

ARTICLE VII - ELECTIONS

Section I - Date of Elections

Elections will begin during the first General Assembly meeting in the month of November and continue for the two following General Assembly meetings.

Section II - Breakdown of Elections

The first and second General Assembly meeting of November will consist of nominations and self-nominations. At the third General Assembly meeting of November, speeches by those nominated for a position will be given, followed by deliberations and elections, members will cast their votes as outlined in Article VI, Section II. The fourth General Assembly meeting in the month of November will serve as an official transition of officers through the Installation of Officers Ceremony.

Section III - Nominations

There will be one round of nominations, followed by one round of self-nominations for each office. Members in good standing and those not in good standing are eligible to be nominated. A qualified member may run for up to three offices and must have a grade point average of 2.55 at the beginning of their first full semester in office.

Section IV - Grade Point Average

All officers must maintain a grade point average of 2.55 or greater.

ARTICLE VIII - FINANCIALS

Section I - Amount

The amount of dues shall be recommended by the members of the Prudential Committee and voted upon by the General Assembly. This amount will be reassessed when deemed necessary by the elected officers of the Chapter.

Section II - Dues Payment

At the beginning of every semester the Treasurer will set a date when dues must be paid. Dues must be paid in full on or before this date. On this date, a brother must have his dues paid in full or have his name on a promissory note in order to retain his voice and voting privileges during new and old business. If a brother has not paid his dues in full or does not sign a promissory note to Alpha Sigma Phi Fraternity, he will lose his voice and voting privileges during both new and old business. Once a brother has paid his dues in full or has signed the promissory note, his voice and voting privileges during new and old business will be returned.

Section III - Special Financial Circumstances

Special assessments may be levied by a three-fifths vote of the Prudential Committee.

Section IV - Failure to Meet Financial Obligations

Financial obligations include, but are not limited to the following: promissory note payments, national dues' payment, and local dues' payment. Any brother who fails to meet his financial obligations for more than one month will lose all social and voting privileges until his account is current. If upon the second month his account is not current, the brother shall be taken to Judicial Board for review.

Section V - Parlor Fee

A parlor fee of ten dollars per semester will be charged to each brother living outside what is designated as the Chapter House of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University for that school year. This fee will only be in effect if there is a designated parlor for the Brotherhood, or used as needed. The parlor will be defined as a room, not used for living purposes, with a locking door that is open to all brothers, and displays memorabilia of the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University.

Section VI - Internal Controls

To limit the possibility of potential corruption within the financial actions that the Beta Zeta Chapter of Alpha Sigma Phi Fraternity at North Carolina State University deals in, these internal controls have been set in place. The internal controls are as follows, and shall be enforced by the Judicial Board:

- There is a requirement of two signatures on all checks written by the Fraternity.
- For all transfers and withdrawals, there must be two members of the Prudential Board present to complete
 the transaction.
- The Treasurer must confirm his payment of local dues to the Vice President.
- A receipt shall be written for all funds that are collected by the Fraternity.
 - One copy of the receipt will be kept for the Fraternity's records.
 - o One copy of the receipt will be given to the individual that is giving payment to the Fraternity.

When the monthly bank statement is received, the Vice President and one of the members at large from them Prudential Board will review the statements.

ARTICLE IX - IMPEACHMENT

Section I

Any officer is subject to impeachment when his actions are unfavorable for the good of the Brotherhood.

Section II - The Process

For an officer to be impeached, a brother must bring the impeachment request to the Judicial Board. Should such an event take place, the Judicial Board will gather information concerning the defendant's conduct and present the information to the General Assembly. A discussion will then take place, followed by a closed ballot vote. A three-fourths yes vote is required for the impeachment of the officer. The results will be counted by the Advisor and the President or Vice President, whichever is appropriate, and announced at that meeting.

Section III - Filling a Position Due to Impeachment

Should an officer be impeached, the President or presiding officer will nominate a brother for the office a majority vote by the general assembly will confirm the nominee.

Section IV - Resignation

Should an officer decide to resign from his position during the impeachment process, or at any other time, he may

do so with a written request to the General Assembly, at any time.

Section V - Filling a position due to Resignation

Should an officer resign from his position, the President or presiding officer will nominate a brother for the office, a majority vote by the general assembly will confirm the nominee.

ARTICLE X - ACADEMIC PERFORMANCE

Section I - Grade Point Average

All members are required to maintain a cumulative grade point average as outlined in Article I, Section III.

Section II

Members whose grade point average falls below the grade point average outlined in Article I, Section III, will be made a member not in good standing. He must pay all dues to the Fraternity, and remain as active as possible in respect to his studies. He must work with the Scholarship Chairman through the Associate Member Program.

Section III

Should he not fulfill his educational requirements at the completion of one semester of a member not in good standing the Judicial Board of the Chapter will take action on the best interests of the Chapter, and the individual brother. This decision should be made while taking into account the individual circumstances of the brother involved, the advice of the Scholarship Chairman, and the Beta Zeta Grand chapter Advisor. If upon judgment by the Judicial Board, the brother involved wishes to appeal the decision, he may do so as outlined in Article IV, Section V.

ARTICLE XI - Service Hours

Section I

All brothers must accumulate a minimum of fifteen service hours each semester. Failure to do so will put the individual brother on social probation for the following semester. If the brother involved wishes to Appeal the probation, he may do so as outlined in Article IV, section V after one month into the following semester.

He was only diagnosed with it in January and it came very sudden to my whole family. My family is a very tight family and this affected us all greatly. I have and am received counseling for the depression and I feel that I am back to the person that I was before all this had occurred, which is very active and fun loving.

I do not want to make this all a downer to read, so on a positive note one of the best things that came out of this is the bond that I share with the brothers of the Alpha Sigma Phi - Beta Zeta Colony. The support that I received from them was amazing, when I returned to school there was a card waiting for me that everyone had signed and along with the fact of knowing that I could talk to anyone of them for a shoulder to lean on. I know that through this experience, and the many others that we have shared, this group of guys will bring back the Beta Zeta Chapter of Alpha Sigma Phi strong on the North Carolina State Campus for many years to come.

Alpha Sigma Phi's new Constitution is a big step in the right direction,

Summary of the Constitution

Ratified on February xx, 2006, our constitution is a step in the right direction. It has answers for almost all foreseeable questions, problems, and issues. The constitution includes Alpha Sigma Phi's missions in brotherhood, service and philanthropy, education and scholarship, and membership. Article IV in the first section describes the roles officers play and how to fill vacant positions. Later articles of the constitution address issues such as dissolution of the fraternity, non-discrimination, and amending the constitution.

The real "meat and potatoes" of the constitution is found in the by-laws. Article I of the by-laws addresses membership issues. It requires members be full time students and states the process of voting in new members. It also discusses probation, pledgeship, and alumni status. Article II describes the role of all officers and what will be expected from them. This section helps new officers get involved quickly and helps members figure out which office they could best fill, and it also sets requirements for members filing positions on the prudential committee or the judicial board. Article III of the by-laws describes the requirements and responsibilities for the fraternity's eight committees. These committees include recruitment, service, philanthropy, social, brotherhood, public relations, scholarship, and the alumni/editor committee. Some roles many committees have in common include:

- 1. Do not tolerate any form of hazing.
- 2. Do not permit any activity or event that could possibly endanger a person's health or well-being.
- 3. Be subjected to rules set up by the National Fraternity, Inter Fraternity Council, and North Carolina State University.

Article IV describes the functions and actions of the judicial board. The judicial board may amend the constitution with the approval from the prudential committee and the general assembly. Also the judicial board is to interpret and uphold the constitution and its by-laws. The trial process is set forth in detail. The appeal process is also described. The judicial board will also enforce attendance policies set forth in Article V, which focuses on meetings. Article V also describes the attendance policy, which includes the repercussions for absenteeism. It also addresses attendance to rituals and ceremonies as well as the procedure Alpha Sigma Phi's meetings will follow. Lastly, Article V sets forth an attendance policy for the prudential committee. Article VI is all about voting. It describes the different kinds of voting to be used and when to use each one. It establishes the process for voting in new brothers. All issues related to voting are addressed in Article VI.

Profile of a Famous Alpha Sig: Ralph Burns, "Mr. Alpha Sig"

- Born in New Castle, Pennsylvania on May 12, 1912, and he attended high school in Youngstown Ohio.
- Attended Ohio-Wesleyan University in 1931, and took vows of membership February of 1932.
- Earned a degree in social work at his 1935 graduation.
- Served as Executive Secretary of Alpha Sigma Phi from 1936 until 1976.
- Superior qualities of Ralph Burns: brotherhood, charity, and gentleman.
- He thought the fraternity should provide a family like atmosphere through which young men become gentlemen, scholars, and patriots.
- William P. Swartz, a brother from the Sigma Alpha Mu chapter, said of Ralph Burns: "[He] was interested in others. He cared about people. That's how he lived his life. Rather than wasting away, he died with his boots on, a dignity he richly deserved.
- Passed to Omega Chapter on September 12, 1993.

Constitution (continued)

Article VII is about elections. IT sets the date for officer elections. It also gives the process to be used for nominations and requires officers to have a grade point average of 2.55 or greater. Article VIII describes how the finances of Alpha Sigma Phi are to be handled. It describes the payment of dues. This article also sets forth a system of internal controls. This system is designed to prevent any potential corruption. Article IX is about the impeachment process. It details the steps that must be taken in order to remove and officer from his office. It also addresses filling positions that have become vacant due to impeachment or resignation. Article X sets forth academic guidelines for the fraternity to follow. It sets a minimum grade point average and describes actions taken if a brother cannot fulfill his academic requirements. Article XI requires all members to perform a minimum of fifteen service hours per semester.

Past Events

On Saturday March 18, Alpha Sigma Phi had a successful service event. Twenty brothers and select alumni helped with the Adopt a Highway project.

On Wednesday night, March 22, Alpha Sigma Phi held its first mixer with the ladies from Zeta Tau Alpha. The theme of the night was "White Trash Bash." Everyone dressed up in the most "country" clothes they had. While no awards were formally given out, brothers JD Poetsch and Mike Machovec both receive special mentions for their attire.

On March 24-26, Alpha Sigma Phi took a brotherhood retreat down to Carolina Beach to campout for the weekend. Brothers camped out on the beach.
