THE UNIVERSITY OF MARYLAND AT COLLEGE PARK

The University of Maryland was founded in 1856 as a small farming school, the Maryland Agricultural College. The past one hundred and forty years have seen many changes to the campus, including the admission of women in 1912, the admission of African-Americans in 1950, and the appointment of the College Park campus as the flagship institution of the newly expanded University of Maryland System.

Located in Prince George's County, Maryland, on 1580 acres of rolling hills and brick buildings, the campus is 9 miles from Washington, D.C., 35 miles from Baltimore and 29 miles from Annapolis, Maryland's capital. This location allows the students of Maryland to take advantage of the natural and cultural resources in these historic cities.

Currently, the University maintains thirteen colleges, with more than fifty degrees available. This year, the Van Munching Business School was ranked in the top 25 of the country, for the third consecutive year. The Government and Politics Department is ranked 28th in the country, 16th as a state school. The Journalism School received a ranking in the top 30 schools in the U.S. last year.

Enrolled in the University are 24,000 undergraduate students, representing all fifty states and over 100 countries around the world. There is an additional 9,000 graduate students. Of this 33,000, roughly 8,000 live in campus housing, one of the largest percentages in the country. There are 2,832 faculty members at the University, as well as 4,174 staff members.

The University has two specialty programs available for undergraduate students, the Honors Program and the College Park Scholars Program. Each of these programs has received national attention, appearing in newspapers like <u>The Washington Post</u>, and <u>USA Today</u>. The Honors program is designed to target those students with outstanding academic records, and offers many interesting and challenging classes. The Scholars Program has been established as a living and learning program, where students studying a specific area of interest live and study closely with faculty and staff.

The University of Maryland System, led by the College Park campus, has also adopted a general studies program known as CORE, the Center for Teaching Excellence, and more than 100 on campus activities and resources for the students, faculty and staff.

THE GREEK COMMUNITY AT THE UNIVERSITY OF MARYLAND

The Greek system at the University of Maryland promotes the ideals of leadership, community involvement, diversity, non-hazing, alcohol management, and scholarship.

The University of Maryland has had a Greek community since 1914. There are three governing bodies for fraternities and sororities on campus, including the Inter-Fraternity Council (for fraternities), the Pan-Hellenic Association (for sororities), and the Pan-Hellenic Council (for traditionally black fraternities and sororities)

There are currently 19 sororities on campus and 27 fraternities. Not included in the traditional Greek community are over thirty specialized fraternities, including those for community service and scholarship.

The University of Maryland has published a packet entitled <u>Greek Life: A</u> <u>Foundation for the Future</u>. This packet outlines the general requirements for a Greek house, the relationship between the Greek system and the University, and examines generally problematic areas of interest and discussion.

One such area is the Hazing Policy. Although the University has a strict anti-hazing policy, a study in 1995 showed that it hazing still a problem. Alcohol has also been classified as a problem on campus, a small reminder of the national problem with these hazards. In response to these problems, the University, in conjunction with the Greek community, has implemented and begun a serious education program on hazing and alcohol abuse. A study planned for next year hopes to show positive changes in the attitudes and practices of the Greek system.

The Greek system also has many positive aspects. Through leadership and programming, the system has raised thousands of dollars for local charities, performed service hours with children, animals, national organizations and the elderly; and developed strong scholarship relations with the University. Also, many of the student leaders on campus are Greeks.

There is a three-step process to become Greek at Maryland. The first is a Rush Expo, where all the houses present themselves to the student body. Next is rush week, where students visit their desired houses to meet the sisters or brothers. Finally, after receiving and accepting a bid, there is a six week pledge/new member period, in which the new member learns the history, customs and goals of their new brotherhood.

About 15% of the students at the University of Maryland are Greek, making Greek life an important part of the college experience.

ALPHA SIGMA PHI COLONY AT THE UNIVERSITY OF MARYLAND

The Alpha Sigma Phi Colony at the University of Maryland was begun on the principles of scholarship, service, and leadership.

IN November, 1996, three gentleman decided to begin a fraternity that held and practiced strict laws against hazing, while still promoting the unity of brotherhood and scholarship. The creation of the group was a direct reaction to the unjust and problematic occurrences of the Greek System at the University of Maryland.

Over a period of three months, until the group was officially made an interest group, these men, and the twenty seven that followed, worked to expand and promote this idea to their friends and floormates.

With a brotherhood of thirty members, the colony was well on its way to becoming a reality, much faster and stronger than anyone ever expected. Goals established at this point suggested membership at 40 in December, 1997; as well community service hours, philanthropy and overall GPA of the fraternity to reach a 2.8.

The end of Spring Semester 1997 brought our Colonization Banquet and initiation into the Mystic Circle as pledges. The beginning of the 1997-1998 school year renewed many's faith in the fraternity and the Greek system, and the brotherhood began to expand and prosper. Difficulties in interpretations and foresight caused some problems in November and December of 1997, but ultimately joined the brotherhood and tightened the bind that had began to form.

Currently, the group has expanded to 45 gentleman, each devoted to the fraternity and promoting its anti-hazing, gentleman and scholarship initiatives. In addition, the colony has established ties with The Compassion Center, a local community service organization devoted to rebuilding homes for the needy. The group has also helped promote unity and participation in concurrent Greek activities.

The group has been warmly received at the University, achieving Colony status with Maryland's Interfraternity Council in October, 1997. In addition, a successful pairing with Delta Delta Delta and Tau Epsilon Phi for homecoming led to the first win of Spirit week and overall participation for the event.

At this point, the colony is looking into the future. Having established ourselves, we are now looking to expand our brotherhood, our living arrangements, and our participation in community service and philanthropy.

Alpha Sigma Phi at the University of Maryland has continued to promote and defend the principles on which it was founded.

CONSTITUTION AND BY-LAWS

The Constitution of the University of Maryland, College Park Colony of Alpha Sigma Phi Fraternity

PREAMBLE:

We, the brothers of the University of Maryland, College Park Colony of Alpha Sigma Phi Fraternity, in order to provide for effective management and judicious legislation in the operation of the colony, and to provide a structure within which this colony may grow successfully in the pursuit of the ideals of Alpha Sigma Phi National Fraternity, do hereby adopt and approve this Constitution.

ARTICLE I. NAME

This organization shall be known as the University of Maryland, College Park Colony of Alpha Sigma Phi Fraternity.

ARTICLE II. PURPOSE

The purpose of this colony shall be to organize its membership in such a manner as to foster greater academic achievement, to promote community and campus service, to create a more productive individual in society, and to teach ideals of integrity, honor, and chivalry within the hearts and the minds of its members.

ARTICLE III. MEMBERSHIP

Section 1.Members shall be duly initiated male students at the University of Maryland, College Park, during the period of colonization which begins on May 10, 1997, and ends upon the initiation date of the founding fathers. "New Member" male students of the University of Maryland at College Park shall be considered as brothers. Section 2.There shall be no discrimination such that race, creed, religion, color, or sexual orientation will affect a candidate's possibility for membership. Section 3.Membership shall be granted by virtue of acceptance of invitation extended by vote of the members. Section 4.Membership may be suspended or revoked through a judicial process overseen by the Prudential Board.

ARTICLE IV. MEETINGS

Section 1.Stated meetings of this colony shall be held at least once a week during the academic year with the exception of conflicting holidays and other major conflicting events as approved by the President. Location and time of meetings shall be at the discretion of the President. Section 2.Special meetings of the colony may be called only by the President, or at the request of fifty percent (50%) of the active members. Section 3. The procedure for all meetings shall be governed by those stated in the current edition of Robert's' Rules of Order.

ARTICLE V. OFFICERS & ELECTIONS

Section 1. The elected officers of this colony shall be the President, Vice President, Recording Secretary, Corresponding Secretary/Public Relations Chairman, Treasurer, two Members-At-Large of the Prudential Board, Rush Chairman, Scholarship Chairman, Service/Philanthropy Chairman, New Member Educator, Editor/Webmaster, Sergeant-At-Arms, Marshal, Intramural Chairman, Brotherhood Development Chairman, Historian, Social Chairman/Risk Management Officer, Parent/Alumni Director, and secondary Interfraternity Council Representative.

ARTICLE VI. COMMITTEES

Section 1. The permanent Standing Committees of the colony shall be as follows:

- a) Prudential Board
- b) Rush Committee
- c) Service/Philanthropy Committee
- d) Social Committee
- e) Parent/Alumni Committee
- f) Brotherhood Development Committee

Section 2. The Prudential Board shall consist of the President, the Vice President, the Treasurer, and two Members-At-Large. The Vice President shall serve as chairman. The Prudential Board shall be responsible for all matters of finances, budgeting, judicial concern, and management of the general operation of the fraternity. Section 3. The Rush Chairman shall be chairman of the Rush Committee; The Service Chairman shall be chairman of the Service Committee; The Social Chairman shall be chairman of the Social Committee; The Alumni/Parents Director shall be chairman of the Parent/Alumni Committee. The Brotherhood Development Chairman shall be chairman of the Brotherhood Development to the defined committees of Alpha Sigma Phi.

ARTICLE VII. FINANCES

Section 1. The revenues of this colony shall be derived from the members' dues, the colony's fund-raising projects, and any donations.. Section 2. All finances shall be managed by the Prudential Board.

ARTICLE VIII. HAZING

Section 1.Alpha Sigma Phi is the fraternity "To Better the Man" and all of her functions and actions should exhibit this as listed in the Code of Conduct. Section 2.Every human being deserves to be treated with dignity and not harassed,

tormented, abused, or violated by another human being. Section 3.No activity construed even in the slightest way as abusing someone physically, psychologically, or sexually or placing someone into circumstances such that the person's dignity, individuality, or beliefs are compromised, will be tolerated by this brotherhood.

ARTICLE IX. SUSPENSION OF THIS CONSTITUTION

Section 1. This clause hereby allows for the opportunity for the membership to suspend the constitution and by-laws of this fraternity only when deemed necessary under particular special circumstances.

ARTICLE X. CONSTITUTIONAL PROCEDURES

Section 1. This Constitution of the University of Maryland, College Park colony of Alpha Sigma Phi Fraternity may be amended in part or in full by the active members. Section 2.A copy of this constitution shall be filed with the National headquarters of Alpha Sigma Phi Fraternity, the Dean of Student Affairs at the University of Maryland, College Park, the Interfraternity Council at the same institution, and the Prudential Board.

By-laws of the University of Maryland, College Park Colony of Alpha Sigma Phi Fraternity

PREAMBLE:

These By-laws are the statutes for the government of the University of Maryland, College Park Colony of Alpha Sigma Phi Fraternity, enacted in conjunction with the Constitution of the Colony to more fully define the powers, duties and functions which are authorized thereunder.

Article I. Membership

Section 1.To maintain active status, an initiated member of the University of Maryland, College Park Colony of the Alpha Sigma Phi Fraternity must a)Be a male student at the University of Maryland, College Park. b)Not affiliated with another Greek social/general fraternity. c)Maintain a cumulative GPA of 2.30. Section 2.To receive a bid for membership in University of Maryland, College Park Colony of the Alpha Sigma Phi Fraternity a prospective must

a)Be a male student at the University of Maryland, College Park. b)Have completed twelve (12) credit hours. c)Have a cumulative 2.3 grade point average or higher. d)Not be affiliated with another Greek social/general fraternity. Section 3.A bid for membership into the University of Maryland, College Park Colony is

extended to those who receive a four-fifths (4/5) vote from the present general assembly.

a)No abstentions for membership voting is permitted. b)Prospective members will be voted on individually. c)Bids by proxy must be given directly to the Marshal prior to the voting session. d)At least fifty percent plus one of the membership must be present to hold a voting session. e)The Marshal shall not vote on the membership's acceptance of an individual. The Marshal shall count the ballots and shall report to the membership whether or not a bid will be extended to the prospective member. f)Should an individual be extended a bid to join the University of Maryland, College Park Colony, he maintains the right to turn the invitation down without question. g)Should an individual not be given a bid, he will be notified as an act of courtesy by the Rush Chairman. h)An individual who wishes to become a member of the Colony may accept the bid within four weeks of receiving it. Section 4.All members of the University of Maryland, College Park Colony must maintain the standards established by the University of Maryland, the Interfraternity Council, and the Colony regarding education and scholarship. Section 5.Should a member fail to meet the scholarship standards or the general requirements and/or responsibilities of the Colony, he shall be placed on probation for the time period of one semester, and given "Associate Membership."

a)An "Associate Member" is allowed but not required to attend meetings of the general assembly. b)All voting rights shall cease. c)An "Associate Member" must remain financial responsible to the local and national fraternity. d)An "Associate Member" has one semester to meet the scholastic requirements. e)If an "Associate Member" does not meet the scholastic requirements of the chapter, he shall be suspended from all activities and functions of the colony until his cumulative GPA is above the required 2.30. f)A suspended member is relieved of financial obligations to the local and national fraternity. All paperwork for suspension must be submitted to the National Headquarters. g)If a suspended individual does not raise his GPA above 2.30, the individual will be made an alumnus. All paperwork must be completed and submitted to the National Headquarters. Section 6.All members of the colony must abide by all federal, state, local, university, Interfraternity Council, and fraternity laws and code of conduct.

Article II. Officers

Section 1.The officers of this colony shall be the President, Vice President, Treasurer, Secretary, Corresponding Secretary, Sergeant-At-Arms, Marshal, Editor, Historian, and New Member Educator. The Chairmen shall be the Social Chairman, Brotherhood Development Chairman, Service/Philanthropy Chairman, Scholarship Chairman, Rush Chairman, Parent/Alumni Director, and Intramural Chairman. Officer and Chairman positions beyond those listed here may be created by the President or Prudential Board for the benefit of the brotherhood. Section 2.All Officers shall perform the duties of their respective positions as set forth by the Alpha Sigma Phi Chapter Officers Guide. Should an officer's position

not be described by the guide, that officer will accept the responsibilities bestowed upon him by the President, the Prudential Board, and/or the general membership and shall abide by the general rules and laws applicable to any officer of the brotherhood.

Article III. Committees

Section 1. The Rush/Recruitment Committee, headed by the Rush/Recruitment Chairman, will organize and educate all rush activities and events for the Colony. The committee may restrict events to members only, or open events to local Sororities to help coordinate the activities. The committee is subject to follow the rules and regulations set up by the Alpha Sigma Phi National Headquarters, the Interfraternity Council and the University of Maryland, College Park. Section 2. The Service and Philanthropy Committee, headed by the Service and Philanthropy Chairman, will organize and execute service and philanthropic projects for the brotherhood of our colony. The committee may restrict said projects for the Brotherhood only or open them to other organizations on or off campus. In the case of a Philanthropic event, the Prudential Board will determine where the moneys raised from these activities will be donated. The committee is subject to follow the rules and regulations set up by the Alpha Sigma Phi National Headquarters, the Interfraternity Council and the University of Maryland, College Park. Section 3. The Social/Risk Management Committee, headed by the Social Chairman, will organize and execute social events for the Brothers of the Colony. The committee may restrict said projects for the Brotherhood only or open them to other organizations on or off campus. The committee is subject to follow the rules and regulations set up by the Alpha Sigma Phi National Headquarters, the Interfraternity Council and the University of Maryland, College Park to protect the health of those attending functions hosted by Alpha Sigma Phi. Section 4.Parent/Alumni Committee, headed by the Parent/Alumni Chairman, will organize and execute events for the Brothers, Alumni and Parents of the Colony and shall keep Alumni and Parents informed as to the goals and events decided and acted upon by the membership. The committee is subject to follow the rules and regulations set up by the Alpha Sigma Phi National Headquarters, the Interfraternity Council and the University of Maryland, College Park. Section 5. The Brotherhood Development Committee, headed by the Brotherhood Development Chairman, will execute and organize development retreats, the mediation and well being of the Brotherhood, and the education and leadership of the Colony. The committee is subject to follow the rules and regulations set up by the Alpha Sigma Phi National Headquarters, the Interfraternity Council and the University of Maryland, College Park. Section 6.Any Special Committees will be appointed by the President and shall operate as long as deemed necessary by the President. The committee is subject to follow the rules and regulations established by the Alpha Sigma Phi National Headquarters, the Interfraternity Council and the University of Maryland, College Park.

Article IV. Prudential Board

Section 1. The Prudential Board has been established to manage the financial, judicial, and managerial affairs of the Colony of Alpha Sigma Phi Fraternity. The members of this board will include the President, Vice President, Treasurer, and two (2) members at large, with the Vice President being the chairman. Section 2. The Prudential Board will periodically revue the Constitution and the by-laws of the Colony and make suggestions to the general assembly as to the improvement of the above mentioned. All amendments will be reviewed by the Prudential Board, and shall be approved by the general assembly by a two-thirds (2/3) vote. Section 3. All Prudential Board meetings will be closed with minutes posted each week.

a)Financial meetings will be open to those requiring funds. b)Guests may be invited into the meeting, only by the Vice President, for purposes of discussion relevant to the meeting. Section 4.The Prudential Board should meet once a week during the school year and once a month during the summer. Section 5.In order to protect the Foundation and Image of the Colony, at any time the Prudential Board may hold a hearing to determine whether an individual brother has stepped beyond the beliefs and values of our colony. If such a hearing takes place, the Prudential Board should hold a hearing within one week of the reported incident. Any member of the brotherhood may attend this hearing, unless the accused requests a private meeting. During the hearing, the accused will be allowed to state his case followed by a questioning period by the Prudential Board. The Prudential Board as well as the accused individuals may have witnesses to their case, who will be required to follow the above mentioned procedures on testimony and questioning. The Prudential Board will convene for an appropriate amount of time to discuss the issue and make a judgment.

a)If found innocent, the case is dropped. b)If found guilty, the Prudential Board will apply an appropriate measure upon the individual(s) that applies to the severity of the case. c)If the guilty party feels that the judgment was made unfairly, he may appeal the General Assembly with a written statement and an appearance at the next meeting of the General Assembly.

1)A vote by secret ballot will immediately following the hearing to overturn the judgment of the Prudential Board. 2)If the General Assembly votes to overturn the punishment of the Prudential Board, the Prudential Board will reassess its ruling. 3)A reassessed ruling can again be challenged by the same process. 4)The General Assembly may also chose to overturn the case in its entirety, therefore relieving the brother of all punishment and further investigation. 5)A two-thirds (2/3) vote is required to overturn a punishment or decision by the Prudential Board. Section 6.The Prudential Board will enforce an attendance policy at the General Assembly meetings. The first and second excuse will be considered an academic leave. The third absence will result in a loss of voting privileges for the remainder of the semester. The fourth absence in a semester will result in a dismissal hearing in front of the Prudential Board.

Article V. Meetings

Section 1.Committee meetings, Prudential Board meetings, and General Assembly meetings will be held on a regularly scheduled basis each week or as deemed necessary by the chairman of each individual meeting during the school year. Section 2.Attendance by all members is mandatory for the General Assembly meetings as defined in Article 5, Section 5. Attendance policies for all other meetings are determined by the chairman of the meeting. Section 3.A quorum consisting of fifty percent plus one of the active membership must be present in order to act upon any legislation. Section 4.A majority vote of the present brotherhood is required to pass a general motion unless otherwise specified for matters described in this constitution. Section 5.A two-thirds (2/3) vote of the present brotherhood is required to pass a constitutional by-law change. Section 6.A four-fifths (4/5) vote of the present brotherhood is required to a prospective member. Section 7.All meetings will follow general parliamentary procedures as outlined in Robert's Rules of Order to ensure orderly meetings.

Article VI. Officers and Chairmen

Section 1.All permanent standing officer and Chairman positions shall be decided by yearly election by the membership. A majority vote is required by each candidate in order to win the election to that position. Section 2.Elections shall be held in the month of November of each year. The term of office shall be for the period of one year, beginning on January 1, following the election.

a)Nominations for officer and chairman positions shall be made by the membership at the first weekly general assembly meeting in November. A member may not nominate himself. The nomination becomes official when the nominee accepts the nomination. b)Nominees shall present speeches to the membership during the second weekly general assembly meeting in November. The Sergeant-At-Arms shall establish the guidelines for candidates' speeches and/or debates and/or question and answer periods. c)During the third weekly general assembly meeting, the membership will vote on all officer and chairman positions. A majority vote by the present membership is required for a candidate to win an officer or chairman position. d)At the last meeting of the fall semester, the officer transition ceremony of Alpha Sigma Phi will take place. Section 3.All officer and chairman elections shall be by secret ballot, and counted by an active advisor of the colony. Section 4.The President retains the power to appoint members to special positions and committees for purposes of fulfilling a specific temporary or short term goal with approval of the Prudential Board.

a)The President's appointments may be challenged to the Prudential Board by any member. b)An appointment can last no longer than one year before a reappointment is needed. Section 5.Any officer or chairman may be impeached if an officer or chairman is negligent in his duties and/or in violation of university, state, federal, or Alpha Sigma Phi National Headquarters regulations. The Prudential Board will host an investigation and make a ruling. A ruling may be appealed to the General Assembly and overturned by a two-thirds (2/3) vote of the General Assembly.

a)An officer under investigation shall be temporarily suspended from the duties of his office until due process has taken place. b)An officer may resign before being impeached. c)If the President is under investigation, the Vice President will assume the duties of the President until due process has taken place. Section 6.In the event that an officer or chairman is removed from his office or resigns or is unable to effectively fulfill his duties, the President shall appoint, with approval of the Prudential Board, a member to replace the officer until the next yearly election. If the office of President becomes vacant, the Prudential Board will set a time and date for a special election.

Article VII. Dues

Section 1. The Prudential Board shall determine the appropriate amount of dues that each member must pay, at which time the general assembly will vote to amend the dues. A two-thirds (2/3) vote of the general assembly is required to amend the dues. Section 2.Local dues are currently set at one hundred and fifty dollars (\$150) per semester. Section 3. Dues will be paid at the first weekly meeting of each semester. Section 4. Special Assessments: Under such circumstances that a member may have difficulty paying the full amount of dues at one time, that member may opt to accept an alternative payment plan provided by the Prudential Board, which will extend a maximum period of the current semester. Section 5. Should a member be unable to pay the full amount of dues, even with respect to the Special Assessments Clause, within the same semester the individual will be suspended from all chapter activities and functions for a maximum of one year.

a)If he does not become financial in good standing, the chapter will petition the Grand Council for suspension. b)All paperwork must be filed appropriately with the National Headquarters. Section 6.Should a person whose membership has been suspended due to financial difficulties wish to rejoin the membership, he must repay all his outstanding debts to the brotherhood, be approved for readmittal or for release of suspension by a four-fifths (4/5) vote of the membership, and apologize in person to the entire brotherhood.

Article VIII. Amendments

Section 1.All proposed amendments to the Constitution and/or the By-laws will be presented to the Prudential Board. The Prudential Board will then present the amendment to the brotherhood at the next General Assembly meeting. Section 2.A two-thirds vote of the membership may amend the Constitution and/or By-laws of this Colony.

Article IX. Upholding the By-laws

Section 1.All members of this brotherhood shall do their utmost to uphold the justness and the integrity of each of these by-laws, and to obey them to the best of their ability. Section 2.It shall be the duty of each brother to report to the Prudential Board any violation of these by-laws by a fellow member. Responsibility falls upon each member to act in the manner that is best for the brotherhood, namely insuring that his fellow brothers do not disrespect the laws and traditions which have been set by the brotherhood both within this Constitution and as decided upon by the membership.



MEETING PLACE

Alpha Sigma Phi Colony at University of Maryland currently does not have an official chapter residence. There is a small house leased by five brothers which is used for social functions, but weekly general body meetings are held in a classroom building. These rooms usually contain 50 student desks, arranged in a circle. Seating is determined based on priority number, except for the Sergeantat-Arms, who remains standing to keep order.

The meetings are run by Robert's Rules of Order. The President retains control over the meeting by calling on speakers and suggesting alternative routes to pursue in discussions. The brothers have chosen to cap the meeting time to one and a half hours.

In order, the President, Vice President, Treasurer, H officers, Committee Chairman, Non Committee Chairman, local chairman and representatives talk to the brotherhood. A system of checks and balances have been built into the system, thereby removing any unnecessary discussion or comments. Old business, new business, for the good of society and announcements, in that order, complete the meeting. Special consideration is given to the alumni, who are allowed to speak at any time. This is done to gain information and opinions from our advisors.

Plans are being made for an official chapter house where all functions can be held and which can be inhabited by many more members of the colony. Alpha Sigma Phi is currently working for an on-campus house (on Fraternity Row) and is also looking into off-campus housing options. Until that point, we will continue to have meetings on campus, and social functions in a private residence, rented to the fraternity.

On a rainy Saturday morning, we set out to pick up trash from the banks of a stream in College Park. Despite the bad weather, we were glad that we were able to support MaryPIRG as well as the town by participating in this project.

In the same semester, over half the brotherhood participated in the JSU's Snack Pack Attack. We assisted in making over 2000 sandwiches to be distributed to homeless people in the D.C. area.

This year we have continued our aggressive community service goals. We have initiated an ongoing relationship with The Compassion Center, a local non-profit organization intended to aid those who are bereaving the deaths of loved ones. The Center's director intends to provide tranquil gardens for mourners to be able to enjoy in their time of need. We have been working on all aspects of landscaping and other miscellaneous projects to achieve the director's vision.

Last semester, we also sponsored a GAMMA late-night event. One of our brothers currently serves on the GAMMA committee, and we are planning to host another late-night soon.

We currently have two other plans for future service events. Our Service committee is investigating participating in the Adopt-a-Highway program. Additionally, our Philanthropy committee is working on a raffle to raise money for Alpha Sigma Phi's national charity, Canine Companions for Independence.

Alpha Sigma Phi: Chapter Management

Since we are still young and are constantly growing, effective chapter management is essential to our continued success.

Communication. We have many ways to disperse important information. Our weekly meetings serve as the primary method for committees to give reports and make announcements of upcoming events. The Vice-President reads the minutes from the Prudential (executive) Board meeting and introduces any new business. Our policy is that brothers have one week to discuss and debate any issue, and the issue will be voted upon at the next general meeting. General meeting minutes are always posted on our chapter's web page, so that any meeting absentees can see what they missed.

A very important communications tool for us is our e-mail mailing list. Since our brotherhood is scattered throughout the campus and town, we make extensive use of the mailing list to notify everyone of important announcements. Our local alumni are also on the mailing list.

Documentation. One of our requirements for colonization last spring was the drafting of a formal Constitution and by-laws, so our Constitution is current and representative of our current ideals and goals.

At the beginning of each semester, committee chairs must submit to the Prudential Board a tentative calendar of events for the entire semester. This helps the Prudential Board set the budget and realize any potential conflicts or financial problems. Additionally, several times during the semester, every committee chair meets with our President for mid-semester reports and evaluation of the chairman's goals and responsibilities.

Finances. We have an official business account set up with Nation's Bank, and our treasurer keeps organized, computerized records of our expenses and cash inflow. At any time, the treasurer can produce our current balance.

As mentioned before, the budget is set at the beginning of each semester, once committee chairs submit calendars and budget requests. The Prudential Board reviews this information, estimates the cash inflow, and assigns committee budgets accordingly.

Our programming continues to improve, even with very low dues – only \$200 a semester. This fact exemplifies our ability to be cost-effective and responsibly handle our finances.
