Dear Sirs:

The Fraternity of Delta Lambda is a local social fraternity on the campus of Bowling Green State University. We have received formal recognition by the University and by the Interfraternity Council. We hold associate membership on the Council (no voting rights, but the right to participate in all discussion that comes up before the Council), and an ammendment has just been passed which could give the fraternity full membership as soon as we have 25 members, have sat on the Council for one full semester, and maintained a 2.5 accume for the semester we were on the Council.

Last semester (Fall 1963-1964) the fraternity had a group accume of 2.56; at mid terms this semester (Spring 1964), the fraternity had an accume of 2.48. ## BOWLING GREEN STATE UNIVERSITY

Bowling Green State University is a state-supported, coeducational institution of higher learning located in northwest Ohio, 23 miles south of Toledo. It has a campus of more than 800 acres, 60 permanent buildings, and modern facilities necessary for carrying on a program of university education in the highest tradition of American scholarship. The University is organized into three colleges; Education, Liberal Arts, and Business Administration, and a Graduate School.

Enrollment at the beginning of the 1963-64 school year was 9,185 students, an increase of 700 from the previous year. The faculty number 383 full time members and 76 part time.

The history of the University began on January 24, 1910, when John H. Lowry, representative from Henry County, introduced a bill in the Ohio General Assembly "to provide for the appointment of a commission to establish two normal schools and to provide for the maintenance thereof."

The bill was passed on May 10, 1910, and approved by Governor Judson Harmon nine days later. On November 22, of the same year, the city of Bowling Green was officially notified that it had been chosen as the site for the normal school to be located in northwest Ohio.

The General Assembly of Ohio in 1929, enacted legislation which brought about a significant expansion in the functions of the institution at Bowling Green, from that of a normal school to Bowling Green State College, with facilities for a four-year liberal arts education, professional and pre-professional training.

The establishment of the College of Liberal Arts in 1929, in addition to the College of Education, paved the way for the conversion to a university six years later in 1935. Legislation in May of that year changed the name to Bowling Green State University. In the reorganization that followed, the College of Business Administration and the Graduate School were added to meet more effectively the challenges of the rapidly changing times.



Accreditation is accorded Bowling Green State University by the appropriate agencies. Each of the University's colleges is also accredited in its own field. As a result of this accreditation and the wide recognition of the University by various state certification boards, each Bowling Green State University student is assured that the credits he earns at the University will be honored by other accredited institutions of higher learning.

The academic year is divided into two semesters over periods approximately 17 weeks each. An undergraduate student enrolls in one of the three colleges--Liberal Arts, Education, or Business Administration. Courses of instruction leading to degrees are provided through one of these three colleges plus the School of Journalism, which is included in the College of Business Administration.

Four year undergraduate programs are available leading to the degrees of Bachelor of Arts, Bachelor of Fine Arts, Bachelor of Science, Bachelor of Science in Business Administration, and Bachelor of Science in Journalism.

One who has been graduated with the bachelor's degree and wishes to do advanced study in some particular field, enrolls in the Graduate School. Graduate instruction is provided leading to the degrees of Master of Arts, Master of Business Administration, Master of Education, Master of Fine Arts, Specialist in Education, and Doctor of Philosophy.

## FRATERNITIES AND SORORITIES

The University administration extends to social fraternities and sororities self-governing powers and privileges which are among the most far-reaching in the United States. To receive and exercise self-governing authority, the fraternity or sorority must be recognized by the University and must maintain good standing.

Procedures for rushing are established by the Interfraternity Council and the Panhellenic Council. A freshman does not become eligible for pledging membership in a fraternity or sorority until his or her second semester, and then only if he or she has met University requirements.

## HISTORY OF DELTA LAMBDA

The fraternity started forming in early October of 1963 through the combined efforts of Bernard Borowski, David Phillips, John Varis and Hugh Williams. These four men interested other men who they thought would be an asset to the organization. By the end of the first semester they had gained nine more new members and were well along on the composition of a constitution.

At this time the group was known as "The Forum" since it had not as yet chosen a Greek name. With the start of the new semester, four more men were added to make a total of seventeen members of "The Forum". Early in the second semester, on Feb. 6, the members adopted the Greek name of Delta Lambda.

Then, on Feb. 11, the men went to the University with their constitution seeking official recognition from the administration, and it was granted. The Dean of Students gave the official recognition on Feb. 16. Work was then begun, with the help of Dean Taylor, dean of men, for the purpose of petitioning the Interfraternity Council. The fraternity presented its petition for association with the Interfraternity Council and it was accepted on Feb. 19 in time for the fraternity to begin working on a program for Spring rush. Due, in part, to the newness and inexperience of the members, rush was not as successful as had been anticipated. Delta Lambda recently activated the five men the fraternity took as pledges, three of whom were sophomores and two of whom were freshmen.

After rush was over, the remaining projects before the fraternity were undertaken; first, getting the name of Delta Lambda before the campus, and second, looking toward national affiliation.



## ACTIVITIES OF DELTA LAMBDA

Delta Lambda has participated in as many activities as we were capable. We were limited to some extent by finances, and by the fact that we were not officially recognized by the University in time to schedule events for the Spring semester.

Among the brotherhood itself, Delta Lambda participated in varied activities. Athletic competition among ourselves was enjoyed throughout most of the school year. These included touch football, basketball, bowling, and softball. There was also active participation in group discussion of many and varied topics, in addition to many informal coffee hours held in the University Union. In addition, Delta Lambda attended many of the University functions in a group.

The first major all-campus event which Delta Lambda took part in was the Delta Upsilon Annual Bike Race. Next, we participated in Spring Weekend activities, the Kappa Sigma Chariot Race, and numerous fraternity sports, including softball and track. One of our members won first place in the track meet.

There was vigorous participation by all the brothers in all the activities and all enjoyed them. Next semester we have plans to participate in all the events possible.

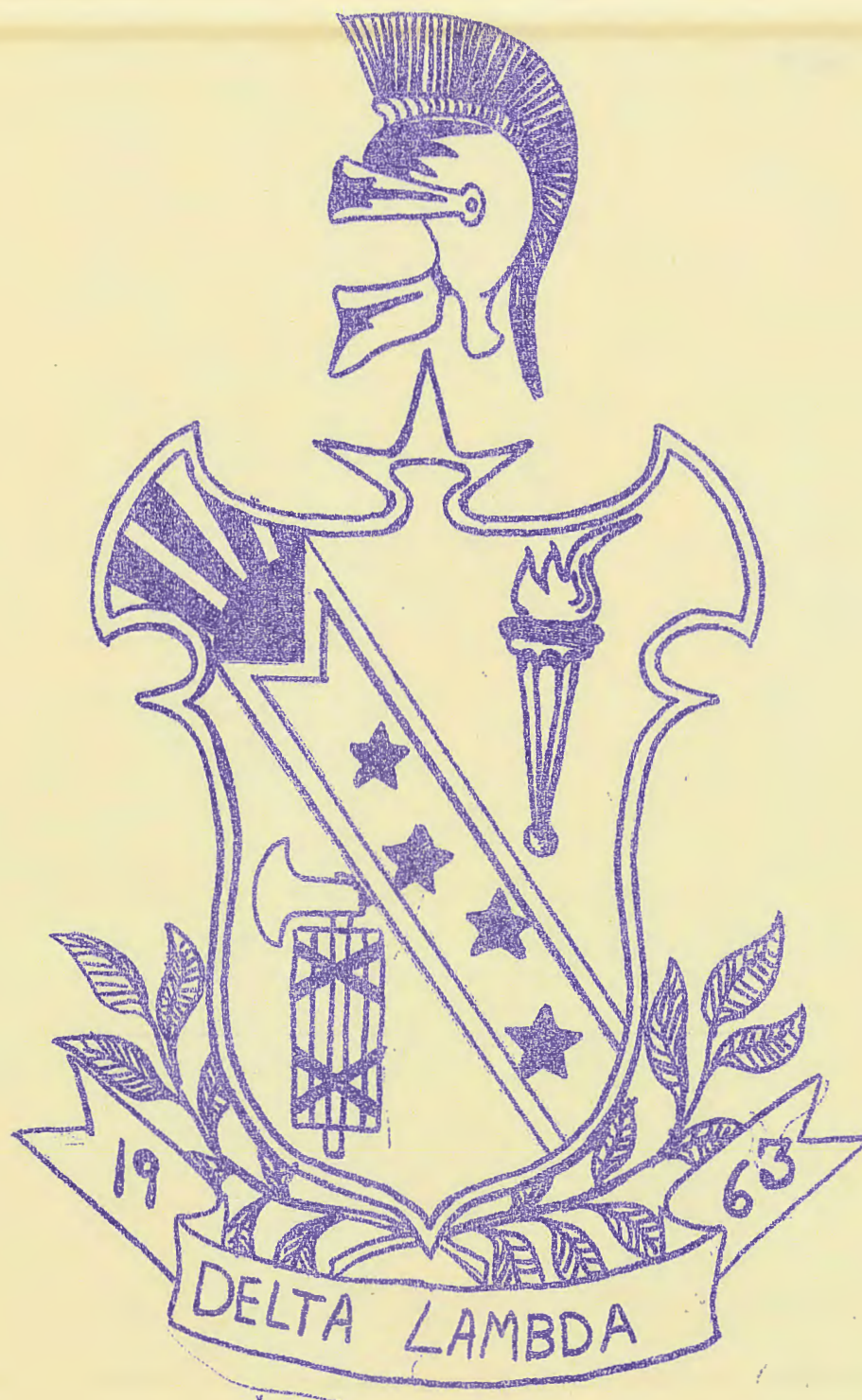

CONSTITUTION OF THE FRATERNITY OF DELTA LAMBDA



We the herein signed in order to form a more perfect bond of friendship, protect our common cause, safeguard our mutual interests, promote the opportunity of the college experience, and secure for ourselves the blessings of this brotherhood; do enact and establish this constitution for ourselves and those who shall come after us.

Wherefore we, in mutual deliberation and consultation, and in consideration of the rights, responsibilities, and duties to which we now aspire; herein set our hands.

Done in the city of Bowling Green, Ohio, this 16th day of January, 1964; in the fifty-fourth year of the University.

## Article I Name

This fraternity shall be known as The Fraternity of  
Delta Lambda

## Article II Purpose and Powers

Section I: We claim as our individual and common purpose the furtherance of the concepts of brotherhood, scholarship, leadership, and comradeship among our members and within our University.

Section II: This fraternity shall have as its explicit power, the right to recommend and adopt any resolution or regulation pertinent to the achievement of its goals.

## Article III Membership

Section I: Membership shall be open to those men who have a 2.0 or better grade average for the semester prior to rushing, and who are in good standing with the University.

Section II: Membership shall be limited to those persons who show favorable interest in advancing the goals and purposes of the brotherhood.

Section III: No person shall be excluded or denied the privilege of membership solely on the basis of race, color, creed, or national origin.

Section IV: The fraternity shall have the power to levy fines, dues, and impose assessments upon its members by a majority vote of the entire membership.

Section V: If a prospective member shall receive one-third negative votes of the entire membership, he shall



be considered ineligible for membership.

#### Article IV: Officers and Elections

Section I: The officers of the fraternity shall consist of: President, Vice President, Pledgemaster, Treasurer, Membership Chairman, Recording Secretary, Corresponding Secretary, Chaplin, Centurian, Scholastic Chairman, Social Chairman, and House Manager.

The term of office shall be from the third Thursday in May until the third Thursday of the following May, unless circumstances shall warrant a special election. Qualifications for Officers: An accumulative point average of 2.25; a member of the fraternity for one year, with the exception of the President and Vice President which shall require two years of active service.

Nominations for offices shall come from the Nominations Committee. The Nominations Committee shall submit a slate of candidates to the Executive Board one week prior to the third Thursday of May. Nominations may also be made from the floor upon recognition by the President.

Voting shall be accomplished by secretive ballot, unless the membership shall otherwise specify.

A majority of all votes cast constitute power to elect to any office of the fraternity.

Section II: The President shall serve as presiding officer of the fraternity at all regular and special meetings, and at all meetings of the Executive Board.



The President shall introduce business in proper order and require members to be recognized before presenting motions or otherwise engaging in discussion before the fraternity. The President shall have the power to represent the interests of the fraternity in preventing any faction from forcing a motion to vote before free and open discussion has been concluded.

The President shall have the power to see that the fraternity is operated in conformity with the policies set forth in this constitution.

The President shall perform such other duties as his office may require.

Section III: The Vice President shall serve as the highest administrative officer of the fraternity. He shall be responsible for the coordination of all committee activities.

The Vice President shall perform all presidential functions in the absence of the President. He shall also succeed to the presidency upon the removal of the President.

The Vice President shall perform such other activities as the President shall direct.

Section IV: The Treasurer shall be charged with the responsibility of keeping the financial records of the fraternity in proper order.

The Treasurer shall be responsible for the collection of all fines, assessments, and dues imposed by the constitution, by-laws, or the membership.



The Treasurer shall be responsible for the disbursement of all funds only on written notice and authorization of the Executive Board, only after the amount and purpose of such disbursement shall have been recorded in the official records of the fraternity.

The Treasurer shall be required to read an account of the financial position of the fraternity at each regular meeting and at each special meeting when directed in the agenda to do so.

Section V: The Corresponding Secretary shall be charged with the handling and processing of all correspondence and mail. He shall further perform other such duties as the President shall direct.

Section VI: The Recording Secretary shall record the minutes of each regular meeting and each special and emergency meeting, and each meeting of the Executive Board.

The Recording Secretary shall be charged with the keeping of the official documents and records of the fraternity. He shall further perform such other assignments as the President shall deem fit.

Section VII: The Chaplin shall offer prayer at the beginning of each regular meeting and each special meeting. He shall also offer grace before each evening meal and at Sunday dinner.

He shall also perform such other duties as the President shall deem fit and proper.



Section VIII: The Centurian shall maintain the meeting place and its exits.

He shall perform such other duties as the President shall direct.

Section IX: The President shall appoint with the advice and consent of a majority of the membership, the chairmen of the standing committees and the Pledgemaster.

These chairmen shall restrict the activities of their committees to the official mandates of the membership. Reports of chairmen of standing committees shall be rendered at each regular meeting, and as directed by the agenda; at each special meeting.

#### Article V Committees and Boards

Section I: There shall be the following standing committees and boards:

- Executive Board
- House Board

- Scholastic Committee
- Membership Committee
- Sports Committee
- Social Committee

Section II: The chairmen of the standing committees and special committees shall direct their committees in the following areas:

- Organization
- Procedural Development
- Meeting Assigned Responsibilities
- Developing Broad Programs of Activities

Chairmen of standing committees shall serve for a term of one semester, and those of special committees for the term of the committee.

Section III: All standing committees shall consist of



five members and a chairman appointed in accordance with Section IX, Article IV of the constitution.

Additional committee members may be added when needed.

Section IV: The President shall appoint special committees and chairmen at his discretion and shall fix their powers and responsibilities.

Section V: The Executive Board of the fraternity shall consist of the Vice President, Treasurer, Recording Secretary, Corresponding Secretary, House Manager, chapter Advisor, and the President, acting as chairman.

The Executive Board shall be vested with the power and authority to exercise physical and legal control over the possessions and property held in the name of the fraternity. Decisions of the executive board pertaining to the power and authority granted in the preceeding paragraph shall not be subject to the approval of the membership.

All powers, rights, and privileges not specifically granted by the constitution or its amendments to the membership shall be exercised by the Executive Board until specific action of the membership shall deny these powers, rights, and privileges to the discretion of the Board.

All members of the Executive Board shall be entitled to one vote on all issues. All decisions shall be reached by a two-thirds vote thereof. No member of the Executive Board shall be permitted to abstain from voting on any issue.



Section VI: The House Board shall consist of five members appointed with the advice and consent of the membership by the President.

The House Board shall be responsible for procuring all necessary supplies and equipment necessary to the operation of the house and the fraternity.

The House Board shall maintain the physical appearance and internal order of the facilities provided this fraternity by the University.

The House Board shall not have the power to contract any debt in the name of the fraternity unless written authorization has been given by the Executive Board.

#### Article VI Meetings

Section I: The regular meeting of this fraternity shall be held every Tuesday evening.

Section II: A special meeting shall be defined as a meeting wherein the need arises for action prior to the next regular chapter meeting and wherein two days notification can be given. Special meetings may be called by the Executive Board at any time upon written notice two days in advance, such notice stating the time, place, and agenda of the special meeting. The Executive Board shall have the power to fix the agenda of any special meeting.

Section III: An emergency meeting shall be defined as a meeting wherein the need arises for action prior to the regular chapter meeting and wherein two days notice cannot be given.



An emergency meeting may be called by the highest ranking officer available at the time of the emergency.

Said officer shall be responsible for due notification of any type, written or oral, consisting of time, place, and agenda of the meeting.

The agenda shall be proposed by the officer calling the meeting.

Section IV: Committee meetings shall be called by the committee chairman with due notification of time, place, and agenda of the committee meeting.

The agenda shall be proposed by the committee chairman.

Section V: All excuses for meeting shall be presented to the Executive Board at its next regular meeting. Assessments shall be made at this time. Failure to present a valid excuse shall result in an automatic assessment.

A member may be excused for a regular or special meeting for reasons of personal emergency or illness, or University requirement. Notification of absence from a regular or a special meeting should be given five hours prior to the time set for the meeting, if possible.

A member may be excused from an emergency meeting for reasons of failure of notification, personal emergency or illness, or University requirement. Notification of absence from an emergency meeting should be given by the member prior to the time set for the meeting, if possible.

A member excused from a committee meeting, shall be excused by the committee chairman for reasons of personal emergency or illness, University requirement, or by special permission of the chairman.



Section VII: All regular meetings shall be conducted in the following order:

- A. Call to order
- B. Introduction of visitors, if present
- C. Prayer by the Chaplin
- D. Reading of the previous meeting's minutes
- E. Reports of standing committees
- F. Reports of special committees
- G. Reports of officers
- H. Unfinished business
- I. New business
- J. Miscellaneous items and announcements
- K. Good of the order
- L. Adjournment

Section VIII: The parliamentary code for this fraternity shall be J. Jeffery Auer's Essentials of Parliamentary Procedure, third edition.

A permanent parliamentarian shall be appointed at the beginning of each University semester, and a temporary assistant shall be appointed for each regular meeting and shall be notified one week in advance of such appointment.

A member ruled out of order must yield the floor immediately, and may have his remarks stricken from the record at the discretion of the President.

#### Article VII Amending and Suspending

Section I: This constitution may be amended by a two-thirds vote of the entire membership at any regular or special meeting, only after previous notice of intent to do so has been given.

Section II: The membership is specifically denied the power to suspend this constitution in its entirety.

Section III: No committee shall have the power to amend or suspend any provision or article of this constitution, nor shall any board exercise this power.



Section IV: With the exception of Section III, Article III of this constitution, any article or section herein may be ammended or suspended at any regular or special meeting of the chapter.

Section V: Section IV, Article VLL of this constitution shall not be ammended or suspended at any time. Nor shall Section V, Article VII be ammended or suspended at any time.

Section VI: Standind rules may be adopted or suspended at any regular or special meeting by a majority vote of the members present.

#### AMENDMENT I

Article III, Section V shall read, "It shall require two  
(2) negative votes to deny membership to a pledge; and two  
(2) ne,ative votes to deny pledgeship to a rushee.



## Standing Rules And By-Laws

1. All committee reports shall be submitted in writing, signed by the chairman, to the secretary at the meeting which the report is made.
2. Dues shall be paid by the 15th of each month.
3. A ten (10) dollar fine shall be assessed for failure to attend any rush function without an approved excuse.
4. Regular business meetings of the fraternity will be held at 10:00 p.m. each Tuesday of each month.
5. All lineups shall be called by the Pledgemaster and shall end by mutual agreement of those present, or when there are less than seven (7) active brothers present. After the Pledgemaster leaves the highest ranking officer present shall be in charge.
6. The Executive Board shall convene one half hour before each regular chapter meeting.
7. Every brother shall attend all lineups. He must be at the lineup within five (5) minutes after it has started, and he must remain for a length of time he deems fit.


Gentlemen:


I have been privileged to work with Delta Lambda local fraternity since its establishment on the Bowling Green State University campus.
