New Province Chiefs Named

PROVINCES Five, Ten and Eighteen have new leaders. Appointment of new Province Chiefs in these areas has resulted from Brother Coccia moving to Europe, Brother Sandercox resigning from office because of additional responsibilities, and the establishment of Arizona as a new province.

The new province chiefs already have assumed their duties of helping chapters, visiting them at least once a year, and, between sessions of the biennial Convention, holding conclaves which in-

clude one or more provinces.

Robert Bower Eckles, Harvard '30, new chief of Province Five, will have chapters at Purdue, Illinois, Illinois Tech and Milton College under his jurisdiction.

He received his Ph.D. from Harvard and studied at Oxford. An author, he also is active in historical associations, currently serving as chairman of the Committee on Documentary Reproduction of the American Historical Association.

Brother Eckles, associate professor of history at Purdue, served as Alpha Pi's Grand Chapter Advisor and, as one of his first jobs as province chief, held a conclave for his chapters at Chicago. He, his wife and their two children live at 235 Littleton, West Lafayette, Indiana.

Robert M. Sharp, Jr., Bethany '50, will work with chapters at Bethany, Davis & Elkins, and West Virginia University.

Brother Sharp served as a radio operator in the U. S. Army following graduation and is now a buyer at Hagan Chemicals & Controls, Inc. He is a member of the Purchasing Agents Association and the Jaycees as well as director of the Hagan Chorus.

Since graduation, Brother Sharp has been a member of the property association at Bethany and is currently serving as president. A bachelor, he lives at 500 Bower Hill Road, Pittsburgh 28, Pa.

Brother Glos Retiring

DR. RAYMOND E. GLOS, Illinois '22, dean of Miami (Ohio) University's School of Business Administration, has asked to be relieved of the deanship June 30, although he plans to continue teaching.

In announcing Dean Glos' request, Miami President John D. Millett said that "it is being accepted with great reluctance, and we are happy that he is planning to remain as a teacher."

Dean Glos said he felt that "after 25 years as head of the school, it's about time I stepped down to see what someone else can do, to get rid of all these administrative responsibilities and have some time to teach." In addition to the position of dean, Dr. Glos is chairman of the Department of Business in the School of Business Administration and holds full professorship.

Brother Glos went to Miami in 1927, the year the School of Business Administration was established, and has headed the school since 1937. He officially was named dean in 1939 after filling the post for two years as assistant dean; he calls this his 25th year because he took a one-year leave of absence to complete a book several years ago.

He was named acting dean at age 34 when the first dean of the school, Dr. Harrison C. Dale, left Miami to be-

DID IT AGAIN


"Last SPRING a Minnesota surgeon — who several times has caught the attention of the whole medical world — did it again," reported Victor Cohn of the *Minneapolis Tribune*. "'Now Wangensteen is freezing stomachs to treat ulcers!' said doctors to each other, just as startled as anyone."

Freezing stomachs is only the latest accomplishment of Dr. Owen Harding Wangensteen, Minnesota '19. At 64, he is probably the most important medical figure Minnesota has produced since the Mayo brothers, according to Writer Cohn, who went on to write:

"Back in the late '20's the University Medical School was in the doldrums, with only a few full-time teachers. A full-time surgery chief was needed. A Harvard man looked the place over and said, 'There is nothing worthwhile here, nor will there ever be.'"

"A Johns Hopkins man uttered the same opinion. In January 1930 the job was given to Owen Wangensteen, age 31. He still has it, and is considered by many authorities to be the country's greatest surgical teacher. Thirty-two of his former students are now department chiefs or full professors at leading medical schools and hospitals.

"He has been ill this year for the first time in his life. He has remained surprisingly active—he is now back on the campus several days a week—but puts on only part of what is ordinarily one of the most extraordinary performances outside of Dr. Ben Casey."

ONE OF the nation's top travelogue speakers and color photographers is busy bringing to fellow Americans a series of illustrated programs concerning the beauty of this country.

Col. H. C. "Bud" Anderson, Minnesota, is being sponsored by The General Telephone System in the program, "Beautiful America."

Brother Anderson is public relations manager of the General Telephone Company of Florida and lives in St. Petersburg. However, his travels to gain knowledge of our great scenic areas and photograph them for presentation take him some 60,000 miles a year.

Col. Anderson produced one of the first three-dimension travelogues ever made, and shoots additional pictures each summer to expand his seven travelogues on as many different areas of our scenic West. Thousands of persons have enjoyed this new medium of expression.

A member of several historic and riding groups, Brother Anderson takes part in the picturesque Rancheros Vitadores' annual trek through California's old Spanish rancho country. He is a member of Roundup Riders of the Rockies, whose annual ride takes its members through the magnificent Colorado Rockies, and is an official of the nationally known One Shot Antelope Hunt at Lander, Wyoming. Through these connections he brings many tales of the old West and his own personal experiences to his audiences.

Before that he served seven years on active military duty during and after World War II, serving overseas with the Army.
