

EDUCATIONAL FOUNDATION KICKS OFF \$1 MILLION CAMPAIGN,

Over \$600,000 already raised

The highlight of the 1984 National Convention Final Banquet was the announcement that the Alpha Sigma Phi Educational Foundation has raised over \$610,000 for a project called The Third Founding Endowment Campaign, and that the campaign's goal is to raise over \$1 million by December 6, 1985—the Fraternity's 140th Anniversary! Ralph F. Burns, Executive Secretary Emeritus, was named a "Third Founder" by the Grand Council. The current council joined with 37 past Grand Council members and Headquarters staff to donate over \$250,000 in honor of Burns and his 40 years of service to the "Old Gal." Any brother who donates \$100,000 or more to the Campaign will be named a "Third Founder" and have his portrait displayed at the National Headquarters. The presentation of Burns's portrait highlighted the announcement.

The Alpha Sigma Phi Educational Foundation had previously been named The Alpha Sigma Phi Memorial Fund. The purpose of the name change,

which was made with full I.R.S. approval on July 1, 1984, by the Trustees of the Foundation, is to better describe the purposes of the fund. The name change in no way adversely affects the tax-deductibility of past or future gifts. The Alpha Sigma Phi Educational Foundation is a fully qualified public foundation by the I.R.S. and may accept tax-deductible gifts. The Foundation supports the educational activities of the Fraternity. All alumni gifts go to the Foundation, whether they are designated for The Third Founding Endowment Campaign or the Annual Loyalty Fund.

Far-reaching changes on college campuses and rampant inflation during the mid-1970s made two facts very clear to the Fraternity: 1) Our quality local and national operations could not continue without upgraded services and guidance from the National Fraternity, and 2) We could not financially survive on undergraduate dues without supplemental income—an Endowment.

Over five years ago the Grand Council identified more than \$2 million worth of Endowment needs for improving Fraternity programs and began making long term plans with the Trustees of the Alpha Sigma Phi Educational Foundation to develop the first plan ever to build an Endowment for Alpha Sigma Phi.

The magnitude and importance of developing an Endowment is so great that the Grand Council and Trustees chose to call this project "The Third, Founding of Alpha Sigma Phi." Alpha Sigma Phi

A New Era

was founded at Yale in 1845. The work of Wayne Musgrave and Edwin Waterbury in the early part of this century in making the Fraternity a major national organization is spoken of as The Second Founding. Since 1979, detailed programs and plans have been made. The decision was made to raise \$1 million by December 6th, 1985, during the "Campaign" and then to encourage brothers to continually build the endowment beyond the \$2 million level with bequests, other deferred gifts, and other planned giving in the years following the Campaign's deadline.

"This is the single most important key to our Fraternity's continued quality operation," said Stan N. Miller, Purdue '64, Immediate Past Grand Senior President, who was named by new Grand Senior President, Evin C. Varner, Presbyterian '58, as Chairman of The Third Founding Endowment Campaign "We simply cannot operate a quality Fraternity in today's economy without substantial financial backing. I challenge every brother to make Alpha Sigma Phi a priority in his personal giving over the next five years. We need every brother's participation at the best level he can do so. The success of this project will continue Alpha Sigma Phi's commitment as the greatest Fraternity in America."

To date over 300 brothers, who were contacted prior to the official announcement of the Campaign, have made gifts and pledges of \$610,000 towards the \$1 million goal. Already \$250,000 in payments on these pledges has been received! Cash pledges over a five year period, as well as stocks, bonds, and other authorized real property are being accepted as gifts. Between now and December 6, 1985, every brother will be asked to make pledges to this historical project. Alpha Sigma Phi needs you, brother!

MORE THAN 10 GOOD REASONS TO SUPPORT THE THIRD FOUNDING

1. Alpha Sigma Phi #1. The most obvious reason for making a gift to The Third Founding is that it will help to maintain Alpha Sigma Phi's high standing in the fraternity world. Some "nationals" have a jump on us in the endowment area. We must maintain our battle for blue-ribbon undergraduate members. Twenty-two other "nationals" are involved in campaigns similar to ours; more are planning them.

2. Leadership and Character

Development. The single most identifiable need of today's youth is that of Leadership and Character Development. The breakdown of American family life, the declining role of the church in our everyday lives, and the . "liberalization" most universities have had to allow are key changes in society which further emphasize this great need. The challenge is clear to America's fraternities—we must take a more active role in developing a student's leadership abilities and character. We must promote patriotism and our free enterprise system. It is simply not being done on today's college campus by anyone else.

- 3. Responsibility. Conservative or Liberal, Republican or Democrat, we must react to the changes taking place in our country's Federal Government philosophy. Private organizations are being called on to fill the void being left by other public institutions. It has always been our Fraternity's desire to be as actively involved as necessary—and today the need is great.
- 4. Your chapter stronger. Stronger national programs will make every chapter stronger. More leadership development programs will be available to chapter officers, nationally and regionally. Chapter Leadership Consultants will be able to visit chapters more often to diagnose and treat weaknesses which may lead to serious problems. If your chapter is inactive, it may be reactivated through a staff-run recolonization program. Alpha Sigma Phi reactivates chapters if the Greek System on that campus is ripe for it, and if resources exist. Over the past five years, ten chapters have been reactivated. Your gift will help us continue the reactivation program.
- 5. **Tax-Deductible.** Your donation is tax-deductible. This takes away a bit of the sting. If your gift is appreciated property/securities, you will save even more in taxes. Consult National Headquarters for further tax advantage questions.
- 6. **National Leadership.** Think about our country and society. Never has so much change taken place so quickly in our country than over the past twenty years. Life is fast-paced and technological. These tumultuous changes have rocked our society. The country suffers from lack

of leadership. As always, we need to turn to the youth of our nation to insure our future. We must prepare them to take responsibility for our society.

- 7. Benefits Forever. The opportunity to participate in an endowment campaign presents a chance to provide educational services to young men for generations to come. The principal of the endowment will be prudently invested to provide an annual income and growth to keep pace with inflation. None of us lives forever, but only rarely does an opportunity come along to support a cause that surpasses our mortality.
- 8. Make a Difference. This is Alpha Sigma Phi's first endowment campaign. The brothers who participate will be recognized as leaders who helped to meet the Fraternity's greatest financial challenge ever. Considering the relatively small size of our endowment needs, your gift will be an important, identifiable, and significant building block in this pioneer effort. It will not be lost among the millions some organizations raise and spend annually. Your gift will make a difference.
- 9. Low Overhead. An incredible percentage of your gift's income will be spent on the actual educational process. The Fraternity's overhead is almost insignificant. We need no classrooms, eating facilities, or dormitories. You will be supporting personal interaction between trained leaders and young undergraduates. There is no greater impact on a young man than receiving guidance from a brother in whom he takes pride.
- 10. **Tradition.** Although Leadership and Character Development programs are being expanded, this does not detract from the traditional fraternity experience. The value of fraternity life in developing close personal friendships, interpersonal skills, social aptitude, social graces, and "polish" to the man continue to be important.
- 11. Moral and Spiritual Ideals. While educators have always believed in the development of the "whole person," most universities have given up their role of "in loco parentis" and are simply providing book knowledge. Our Fraternity must work even harder in the areas of moral, spiritual, and character development to make up for this void.
- 12. Void Left by Others. A lot of people are concerned about the moral fiber of our nation. In a day when there are fewer and fewer organizations on college campuses that talk about ideals or standards, Alpha Sigma Phi is renewing its commitment to them. We need to actively support these ideals and fill the void left by those other organizations.

John P. Commons Bequests Foundation \$20,000

John P. Commons, Colorado '18, passed into Omega Chapter on November 17, 1983, but his service to Alpha Sigma Phi will continue for generations. Brother Commons left the Alpha Sigma Phi Educational Foundation \$20,000 in his will for The Third Founding Endowment Campaign. Thousands of young Alpha Sigs will benefit from Brother Commons's generosity for ages to come.

When he first learned about The Third Founding, John Commons was all too eager to give! Even though age 83 and living in a retirement community, Commons began giving annual gifts of \$2,500 to the Campaign in 1980. He vowed then to continue that practice for the rest of his life and also to leave a substantial bequest to the Foundation. Brother Commons's giving to The Third Founding now totals \$27,500. John Commons and all brothers who contribute between \$25,000-\$49,999 are recognized as members of the "Founder's Society of The Third Founding." All brothers who contribute at this level will have their names inscribed on the Founder's Society Tablet at the National Headquarters.

Bequests and other deferred gifts are wonderful tributes to the years of Alpha Sigma Phi brotherhood members enjoy. If you have not included the Foundation in your will, do it today. Future generations of Alpha Sigs will reap the benefits of your thoughtfulness.

13. It is up to You. Alpha Sigma Phi has few sources of income. Undergraduates have voted themselves fee increases of over 40% at the past two National Conventions, but they can't foot the whole bill. Alpha Sigs must support Alpha Sigma Phi; there is no one else.

14. It is a Need. Alpha Sigma Phi needs an endowment. It's not a frivolous desire. Foundation endowments are the key to existence for today's fraternities. For a fraternity that has emphasized quality in chapter locations and high standards in membership, as opposed to having hundreds of chapters upon which to build a financial base, an endowment is a necessity.

Hanna Contributes \$50,000 to The Third Founding

"I wish to express my gratitude to Alpha Sigma Phi for the many years in which it has enriched my life during the past 66 years, and last, but not least to express my great appreciation for the dedicated and indefatigable services to the Fraternity of Brother Trusten P. Wadsworth." It was with these words that Warren L. Hanna, Minnesota '18, made a \$50,000 contribution to the Fraternity's Third Founding Campaign. Brother Wadsworth of whom he speaks is the long time leader of the Bay Area Alumni Council in San Francisco to which Hanna has belonged since the 1940s. Wadsworth was instrumental in the reactivation of Nu Chapter, University of California, Berkeley, and received the Distinguished Service Award in 1982.

Hanna is the former managing partner of the law firm Hanna, Brophy, Maclean, McAleer & Jensen of San Francisco. He received the Distinguished Merit Award in 1983 in recognition of his outstanding professional accomplishments in the area of workmen's compensation law. He is also considered an expert on the life of Sir Francis Drake whom he has written about and researched extensively.

Brother Hanna and others who contribute at the \$50,000 level are honored by the Fraternity as members of the Delta Society of The Third Founding. Bronze likenesses of all Delta Society members will be displayed at the National Headquarters. The Fraternity needs more contributors at this level of giving, and remember, it's tax-deductible!

A Special Man



"He is a special man, and the special Alpha Sig." That is how Past Grnad Senior President Raymond E. Glos, Illinois '22, describes Ralph F. Burns, Ohio Wesleyan '32, Executive Secretary Emeritus of Alpha Sigma Phi. Glos led the effort to honor Burns as a "Third founder of Alpha Sigma Phi" by receiving over \$100,000 in Burns's name from all current and past Grand Council and Headquarters Staff brothers. A whopping \$250,000 was raised from 37 brothers—quite a tribute to Mr. Alpha Sig!

Every brother who contributes a \$100,000 or more to The Third Founding is honored by being named a "Third Founder" and having his portrait displayed at the National Headquarters for posterity. Burns's portrait was dedicated at the recent 1984 National Convention (see coverstory) and now hangs in the reception are at the National Headquarters in Delaware, Ohio.

Ralph F. Burns served as Executive Director of Alpha Sigma Phi from 1936-76. He guided the Fraternity through the important mergers with Phi Pi Phi (1939), Alpha Kappa Pi (1946), and Alpha Gamma Upsilon (1965). He has signed the membership cards of brothers who have gone on to fight in World War II, Korea, and Vietnam. Burns even had to take on another job during World War II and do Fraternity work in the evenings. He is known in the Interfraternity World as the "Dean of Fraternity Executives." He has served as President of the Fraternity Executives Association and College Fraternity Editors Association, and was awarded the prestigious National

Interfraternity Conference Gold Medal Award in 1976. He has received both the Distinguished Merit Award and Distinguished Service Award from Alpha Sigma Phi. Today, Burns still serves as the volunteer Secretary of the Alpha Sigma Phi Educational Foundation and remains very involved in Fraternity activities.

"There is no way to thank Ralph enough for his 40 years of dedicated service." Says Executive Director, Robert M. Sheehan, Jr., "Those of us who have contributed in his name are giving a small token of our great appreciation."

A plaque honoring the brothers who contributed to this project for "the special Alpha Sig" now hangs near Burns's portrait at the National Headquarters. The following is a list of these brothers:

Taking the "sting" out: tax-deductible!

All gifts made to the Alpha Sigma Phi Educational Foundation are tax-deductible. Of course that doesn't mean it won't cost you anything to give, but it does take a little of the sting out of it! A number of brothers have already taken advantage of the outstanding tax advantage of making a gift of appreciated securities of real property. In these instances Capital Gains Tax is avoided and you receive a deduction at the appreciated value. It is important to give ownership of the securities or property to the Foundation before it is sold in order to qualify for this "double dip" tax advantage. Consult your attorney or accountant to see what method of donating is best for you, or contact Alpha Sigma Phi National Headquarters.





WHEREAS, The NIC House of Delegates and its member fraternities are concerned about the increasing consumption and abuse of alcoholic beverages on college campuses, and

WHEREAS, The dangers of misuse of alcohol to individuals, to groups, to the fraternity system and to the campus community are becoming increasingly evident, and,

WHEREAS, An affirmative program to deal with the problems will only be effective by common consent and unified action,

NOW THEREFORE BE IT RESOLVED by the NIC that the following policies be adopted and be recommended to its member organizations for their adoption:

- That the possession, use, sale and/or consumption of alcoholic beverages on the premises of any chapter or at any entertainment or function of any chapter shall be in compliance with all applicable laws.
- That moderation be encouraged during lawful consumption, and that chapters develop and support programs and those groups and organizations seeking to educate chapter members on alcohol awareness.
- That open parties, meaning those with unrestricted access, where structured around the sale or consumption of alcoholic beverages shall be prohibited.
- 4. That non-alcoholic rush shall be actively promoted on all campuses.
- That there shall be no open solicitation or encouragement of alcoholic consumption by contest or promotions in any chapter.

The Third Founding A New Era In Brotherhood.

THE OFFICIAL PROCLAMATION OF THE THIRD FOUNDING: A JOURNEY OF GREATNESS



Newly elected grand senior president Evin C. Varner, Presbyterian 58, (challenges every Alpha Sig to do his share for the "Old Gal")

(At the Final Banquet of the 1984 National Convention, newly elected Grand Senior President Evin C. Varner, Presbyterian '58, issued The Third Founding Proclamation to the Brotherhood. The following is the transcript of Brother Varner's "challenge.")

On a cold winter evening in December, 1845, three men "challenged" their classmates at Yale to join them on a long journey. Louis Manigault, Stephen Ormsby Rhea and Horace Spangler Weiser's "challenge" was answered, and they led the Founding of Alpha Sigma Phi—a Journey of Greatness.

By the early 1900s, the flame of Alpha Sigma Phi burned low. Only Delta Chapter at Marietta remained. But two men at Yale rediscovered the "challenge," and it spread from coast to coast. Wayne Montgomery Musgrave and Edwin Waterbury led the Second Founding of Alpha Sigma Phi—and The Journey of Greatness continued.

Today we gather together over 75 years after the Second Founding and nearly 139 years since our Founding. Our Brotherhood of over 45,000 from 56 chapters and colonies across this country, has met the challenge of The Journey of Greatness at every turn. Alpha Sigma Phi has never been stronger.

And now comes a new challenge. Our nation's economic expansion has laid great financial burdens on our "Old Gal." It is a financial challenge that requires Alpha Sigma Phi to create an Endowment, which will provide income to supplement our annual budget, if we intend to maintain our quality standards of operation. Alpha Sigma Phi Brotherhood has never allowed dollars and cents to stand in the way of our Journey of Greatness.

Therefore, let the new challenge ring out from coast to coast. I, Evin C. Varner, Grand Senior President, hereby proclaim this day, August 4, 1984 as the beginning of the Third Founding of Alpha Sigma Phi. The challenge is to raise a \$1 million Endowment for the Alpha Sigma Phi Educational Foundation by December 6, 1985—our 140th Anniversary. Brothers, let the Journey of Greatness continue!

We need great leadership from every Alpha Sig to meet this challenge of The Third Founding Campaign. I have chosen one of our Fraternity's greatest men to lead us all through this challenge. I hereby appoint immediate Past Grand Senior President, Stan N. Miller as the Chairman of this Third Founding Campaign!

Brothers, it has been decided that any Alpha Sig who contributes \$100,000 or more to The Third Founding will be named a Third Founder of Alpha Sigma Phi. Portraits of all Third Founders will be hung in the National Headquarters in honor and appreciation of this gift. Thus far, no individual has yet given \$100,000, but I am proud to tell you that there are many brothers who have already heard the call and the challenge of The Third Founding. In fact, as we sit here this evening, over \$610,000 of our \$1 million goal has already been pledged! Over \$235,000 of that \$610,000 has been pledged by 37 current and past members of the Grand Council and National Headquarters Staff. Each of these brothers had a special purpose in making his contribution. They wanted to combine their contributions to raise over \$100,000—and they have done much more than that-to honor a very special brother as a Third Founder of Alpha Sigma Phi.

Therefore, as my first act as Grand Senior President, in consideration of over \$250,000 donated in his name to The Third Founding Campaign I hereby name Ralph F. Burns, Executive Secretary Emeritus, as a Third Founder of Alpha Sigma Phi Fraternity and unveil this portrait in his honor.

Richard R. Gibbs, Oklahoma '51, is past Grand Senior President of Alpha Sigma Phi. He is also an honorary member of Alpha Sigma Phi Philippines.

Toward the end of his term as GSP, Gibbs arranged an international business trip so he could fly—at his own expense—to the Philippines and attend the Fourth National Convention of the Philippine fraternity.

That there is an Alpha Sigma Phi in the Philippines is a matter of remarkable coincidence. In 1959 students at Central Mindano University, an agricultural university, formed a group and chose the name Alpha Sigma Phi to stand for Agricultural Students of the Philippines. In 1965, a group at Silliman University formed a fraternity and picked from a library book on U.S. fraternities the name Alpha Sigma Phi and appropriated a few symbols.

Eventually the two groups discovered each other and formed an affiliation. The fraternity spread, thanks to dedicated alumni, across the country. Today there are 30 chapters and an auxiliary sorority.

With growth, the group has established a national headquarters and hired a part-time executive director.

As the fraternity grew, more and more members discovered that there was an Alpha Sigma Phi in the U.S. And many assumed it was the parent of the Philippine group. After a lot of correspondence, an affiliation was sought with the U.S. Fraternity.

In addition to experiencing remarkable hospitality, Gibbs learned some important facts:

- Both groups share similar ideals and values but have no common ritualistic ties.
- The Philippine group has been remarkably effective as a pioneer organization that welcomes

both Christians and Moslems and has helped ease tensions between the two.

- Philippine chapters have a strong service orientation for community and campus. There are no chapter houses, but generally a corner of campus where the groups gather.
- Hazing has been strong in the past, but in 1982 the group voted to wipe out all hazing by 1984
- Centralized operations are comparatively new. Record-keeping, systems and publications on a national basis are just beginning. The group is characterized by hard-working dedicated alumni and strong spirit among undergraduates.
- The drive for expansion is strong—in the Philippines where there is only one other true national fraternity and with hopes of adding chapters in neighboring Malaysia.
- The auxiliary sorority operates separately at the chapter and province level; at the national level the national sorority officers are a committee of the national council
- Membership selection is similar to that in the U.S. The fraternity puts emphasis on good scholarship performance. The quality of education there is comparable to U.S. college level work.

While in the Philippines, Gibbs was greeted at every stop by undergraduates and alumni with banners, gifts and receptions. He spoke at several universities about the role of fraternities in the U.S. Gibbs was taken on special tours and visited in private homes. He attended all sessions of the group's convention in tropical Tagbilaran on the island of Bohol. After addressing the convention, he was presented with a stunning handcrafted guitar made of laminated bamboo.

Everywhere Gibbs was besieged with questions about Alpha Sigma Phi U.S. The Philippine group

looks to the U.S. body as role model, "spiritual parent" and hopes for gradual closer ties.

Richard Gibbs, now Director of Provinces for Alpha Sigma Phi, reflects on his fraternal tour of the Philippines a year later. "It has to be one of the highlights of my life, rated right up there with being elected president of Alpha Sigma Phi."

Noting cultural and economics differences plus distance, Gibbs is unsure that a true merger would ever be possible, but he suggests the possibility of forming Alpha Sigma Phi International, to which both the U.S. and Philippine groups would belong. This council type structure would allow her coordination, communications and working toward mutual goals. Work has begun on such an agreement.

Gibbs also sees the ties as a unique opportunity for better international understanding. As the Philippine group's national organization grows stronger it may be possible to coordinate relationships between chapters. Undergraduates could have a special chance to learn personally of another culture through correspondence exchange.

"Alpha Sigma Phi is a strong positive force in our own country. Alpha Sigma Phi-Philippines is becoming just that there...and perhaps spreading to other countries. We have a special chance to work toward better understanding between peoples and an international recognition of the ideals of Alpha Sigma Phi," says Gibbs.

Early in his business career, Founder Louis Manigault visited the Philippines. In the Fraternity archives is a photograph of young Manigault in Manilla. Now, 100 years after his visit, the movement he and two friends began on a cold December night in 1845 at Yale appears to have become international.


