Delta celebrates 125 years of brotherhood



In 1935 over 100 Delta Chapter alumni gathered at the Lafayette Hotel in Marietta to celebrate the chapter's 75th Anniversary.



On the 100th Anniversary of Delta's chartering the National Convention was held at Marietta in her honor. Brothers joined in cutting the anniversary cake!

After 125 years the traditions of Delta are still strong on the Marietta campus. The chapter is planning a major celebration of its anniversary this fall.



"This is a story of Delta Chapter of Alpha Sigma Phi. It cannot pretend to be complete, for the whole story is of men who, in youth, grasped at a dream of brotherhood, and never let it go. For a season, they were able to experience it in a close association which left an imprint of idealism on the remainder of their lives. It engendered loyalties without remuneration, values not commonly appreciated, and cherished memories of a continuing tradition to which they and we, in the real sense, belong.

"The Idea is not new, nor can it be simply stated. Its central theme is in the great University Tradition with its medieval symbols. Beyond that, it goes back to the pre-Christian era and the Brotherhood of Pythagoras—to concepts mystical, philosophical, and heroic.

"Most of the Greek societies in the early American colleges held the same inspiration, so

it must not be forgotten that we are part of a larger movement, not without its effect on the history of our country. In the world-movements of forces and idea, History may yet write finis to this tradition and this story. But the men of Alpha Sigma Phi proclaim its continuity as Delta Chapter starts upon her second hundred-years.

"FRANCKE HUNTINGTON BOSWORTH, son of a Marietta merchant, after a term or two in Marietta College, went off to Yale in 1858, as befitted a man of old New England ancestry. At the end of his freshman year at Yale, he fell into the hands of the popular sophomore society and was duly initiated into Alpha Sigma Phi in 1859. So gratifying was his experience in the ensuing year that he negotiated a petition from his friends in Marietta College. Hence, Bosworth is the founder of Delta Chapter."

It was in this eloquent manner that **Thomas L. Bush, Marietta '19** began his historical tribute to Delta Chapter at its 100th Anniversary celebration. On this, the eve of her 125th Anniversary, it seems once again a fitting way to honor Delta.

Delta's 125 years of brotherhood

Captain William B. Whittlesey, Marietta 1860, left, and Adjutant George B. Turner, Marietta 1860 both fought and died in the Civil War on the side of the Union Army. Both brothers bequeathed their swords to the chapter which still proudly displays them even today.

Ten Marietta men were initiated into the Mystic Circle of Alpha Sigma Phi on June 12, 1860, and the Charter of Delta Chapter was officially conferred on June 30, 1860. It was a tumultuous time in history for the young chapter to start. The Civil War was brewing up, but Delta somehow survived even though many of its members went to fight for the Union Army. Four of the Founders were killed in that great war. Two of them, **Capt. William B. Whittlesey, Marietta '60**, and **Adjutant George B. Turner, Marietta '60**, bequeathed their swords to the chapter. These swords remain today in the chapter's trophy case as a symbol of lifetime brotherhood.

By 1875, Delta carried on as the only active chapter of Alpha Sigma Phi in America. Alpha at Yale was forced sub rosa as Delta Beta Xi in

1864, and completely disappeared by 1875. The traditions, customs, ideals, and ritual of the Fraternity were carried alone by Delta until 1907. But Delta's survival through this period was no easy task.

Throughout the 1870s other national fraternities tried to lure Delta into their company. Finally, in 1882 when one such attempt looked like it might succeed, Delta alumni living in Cincinnati acted. First, they persuaded the college President Andrews, himself an honorary brother and his son, William C. Andrews a '77 initiate, to excuse the whole chapter from classes for a week. Realizing the gravity of the situation, Andrews granted the unheard of request. The alumni then, brought the whole chapter to Cincinnati by steamship. Accounts of this meeting, which lasted for several days, include entertainment, dining, ritual, and many toasts. The final event of the week, a "Sig Bust," held on April 28, 1882, secured the survival of Delta and gave the chapter strength to continue alone for the next 25 years.

In 1907, Alpha Chapter at Yale was revived by **Wayne M. Musgrave, Yale '07** and **Edwin M. Waterbury, Yale '07**. The five new members of Alpha traveled to Marietta to be officially initiated. It was the signal of a new beginning and is heralded as our Second Founding.

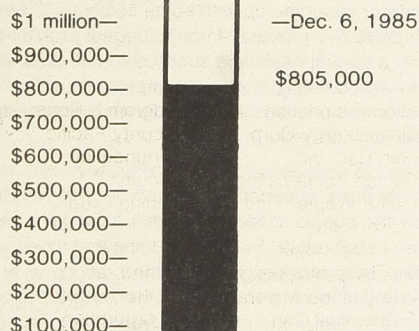

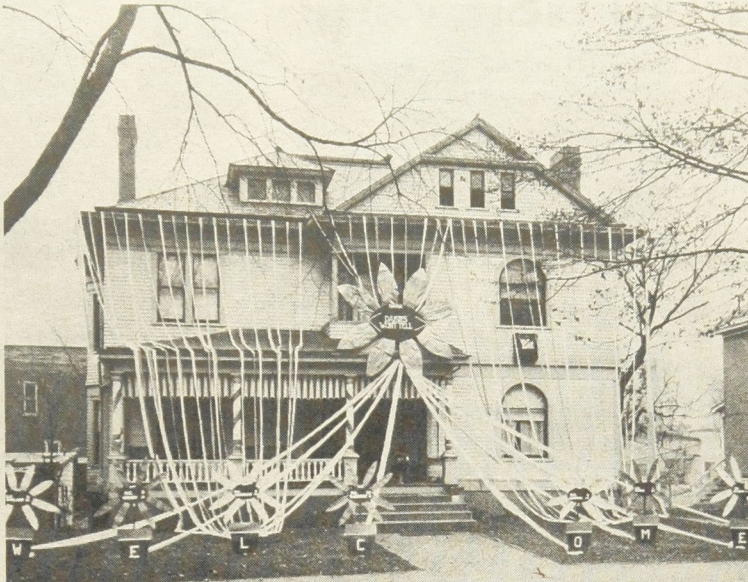

The first Delta Chapter house was located here at 205 Fourth Street in Marietta. The high spirited brothers decorated the house proudly for Homecoming. The chapter moved into a new building on the exact location of the first house in fall 1984.



Delta thrived now with more "sister" chapters being started across the country. On October 14, 1909, Delta occupied its first house in 205 Fourth Street. The chapter continued to produce the top scholars and athletes at the college. **Sheldon C. "Pete" Gilman, Marietta '04**, is a noble example of the time. Gilman was a 13 letter man at Marietta and threw a 47-yard pass for a completed play in the first year the pass was allowed in college football. That pass stood as an intercollegiate record for ten years. Gilman later served as a Trustee of Marietta College and his generosity led to the building of the Gilman Student Center there. Brother Gilman also spearheaded the drive for the new chapter house in 1960.

In the 1930s Delta acquired a new house on Fifth Street which it maintained until after World War II. It was from this location that the chapter celebrated a very successful 75th Anniversary with over 100 alumni attending.

By 1946 the brotherhood of Delta was recovering from the war and getting back to business! In 1947 with the help of alumni **Chuck Otto, Marietta '28**, **Ed Stitt, Marietta '27**, and **Ed Sprague, Marietta '27** the chapter moved into a house on 302 Sixth Street. By 1949 the chapter bought this house, known as the "Red Barn." It was reputedly the second oldest structure in the Northwest Territory until it was demolished in 1960.

The National Convention of Alpha Sigma Phi was held at Marietta in 1960 in honor of Delta's 100th Anniversary. On September 7-9, a brand new Delta Chapter House, erected on the same site as the "Red Barn" on Sixth Street, was dedicated during the meeting. U.S. Secretary of H.E.W., **Dr. Arthur Flemming, Ohio Wesleyan '24** was on hand to deliver a message to the assembled brotherhood.

The 1960s were a heyday for fraternities, and Delta was the cream of the campus. Brothers participated on virtually all the sports teams, were outstanding scholastically, and distinguished themselves with many intramural titles. Names like **Stacy Evans, Marietta '66** who served as Captain of the College Bowl Team or **Dave Wilcoxon, Marietta '63** who was captain of both the baseball and basketball teams are reminders of Delta's involvement on campus.

The next decade, the 1970s, were rough years for colleges and fraternities. Delta experienced the same problems as many chapters did.

Today though, in the finest Delta tradition, the chapter is once again a force to be reckoned with on campus. Currently, 52 men belong to the chapter. Many of them are members of sports teams, and distinguish themselves academically, including **Steve Smith, Marietta '82** Football captain and Honorable Mention All OAC defensive lineman. **Phil Schmucker, Marietta '83**, second team OAC linebacker, and **Tim Williams, Marietta '84**, recognized as the Greek freshman with highest GPA.

Over her 125 year history Delta Chapter has given Alpha Sigma Phi and our society many great leaders. **Alfred Dewey Follett, Marietta '72** served as the first Grand Senior President of Alpha Sigma Phi (1907-09) and was the President of the State Bar Association of Ohio. **Albert B. White, Marietta '74**, was the second Grand Senior President (1909-13) and served as Governor of West Virginia from 1901-05. Delta has given the "Old Gal" three other Grand Senior Presidents, **John H. Snodgrass, Marietta '86** (1921-25), **Charles B. Elliott, Marietta '04** (1925-29), **John H. Roemer, Marietta '83** (1929-32), and one Executive Secretary, **A. Vernon Bowen, Marietta '25** (1928-32). Three members of the Marietta

College Board of Trustees are Alpha Sigs, **Neil R. Christy, Marietta '38**, **Carl Broughton, Marietta '61**, and Chairman **Robert Evans, Ohio Northern '59**.

May the ideals, traditions, and glorious successes of Delta's first 125 years guide her next 125! Happy Birthday Delta!! □

Don't get me wrong—I drank—maybe not as much as some, but my share.

The trend of the loose tongue approach has me concerned. The enclosed article is unfortunate but done and gone. However, we need to avoid this spotlight at a time, at least in Alaska, when alcohol related activities are coming under close scrutiny and public concern. Alcoholism is a serious disease, ask any MADD mother.

So I am writing to suggest this might be a worthy topic for the next education conference. Let the undergrads come up with some solutions if they perceive any problem. Alcohol Resolution

Eta Chapter

University of Illinois

Whereas;

Fraternities are frequently the hosts of social activities where alcohol is served to members, pledges, and guests, and

Whereas; there exists a growing concern of the bodily injury and material damage stemming from the abuse of alcohol, and

Whereas; the members of Eta Chapter of Alpha Sigma Phi wish to reduce the health hazards subjected on its members, pledges, and guests resulting from alcohol consumption, and

Whereas; the members of Alpha Sigma Phi find the irresponsible serving and consumption of alcohol contradictory to the primary academic, service, and social objectives of the fraternity,

Therefore;

Be It Resolved; that the members and pledges of Alpha Sigma Phi Fraternity shall adhere to the following guidelines concerning alcohol:

- The chapter shall not sponsor an activity where drinking is the only activity.
- The chapter shall always serve food and alternative beverages when alcohol is served.
- Members, pledges, and guests shall not be forced to drink at any time nor shall they be encouraged to consume large quantities of alcohol.
- The chapter shall not sponsor members participating in drinking contests or other activities where alcohol is misused, and similarly, the chapter shall not sponsor such activities.

I'd like to express my deepest appreciation to the brothers of the Grand Council for their support and understanding. My illness has added to their workload—and they've come through like the special men they are.

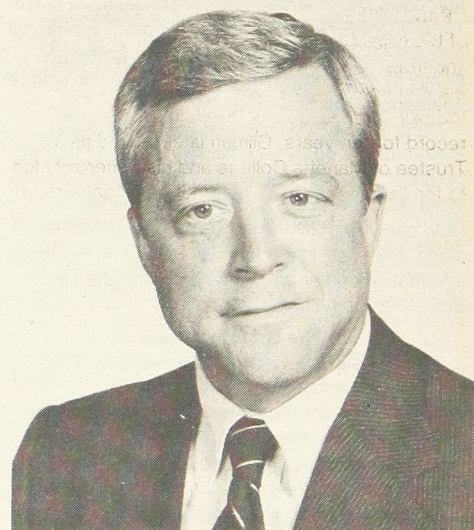

I am proud to be a fraternity man. I am proud of our brotherhood. I am proud to be an Alpha Sig. □

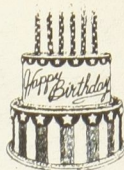

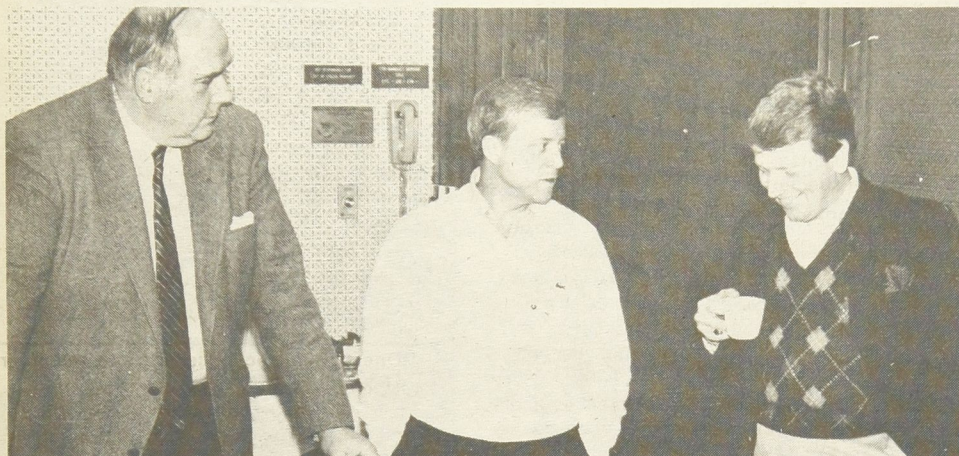

- The chapter shall not use alcohol as a prize or award for sports contests or other functions.
- Members acting as bartenders at chapter functions shall be instructed not to serve any person who appears drunk or violent or who poses a threat to the safety of the guests.
- Guests of the chapter shall be provided with transportation or be given escorts if they are not sober enough to drive themselves home. Furthermore, chapter members and pledges shall look out for the safety of their peers when drinking at the chapter house or away, in which case they shall not drink and drive or permit their peers to drink and drive. □

The Grand Council

It all starts at the **National Convention**. The undergraduate delegates at the biennial conventions elect the **Grand Council** to operate the Fraternity for the two year period between conventions. The alumni elected to the Grand Council are **volunteers**, serving without compensation, who typically have spent years in service to the "Old Gal" in other capacities.

The seven members of the Grand Council are elected to a four-year term and may not serve more than two successive terms. The Grand Council serves as the "Board of Directors" of Alpha Sigma Phi. They cannot change the constitution or set undergraduate fees (only the National Convention can do that). It is their responsibility to operate the Fraternity within the guidelines of the Constitution.

The Grand Council is also responsible for hiring and directing the **National Headquarters** professional staff. Brothers serving on the staff are

full time, paid employees of the Fraternity. Administrative and secretarial support staff are also hired. The staff is responsible for the day-to-day administrative operations of the Fraternity, and carry out the directives set by the Grand Council.

The Grand Council meets at least twice a year and these brothers spend numerous other days during the year away from their jobs and families to do the volunteer work of Alpha Sigma Phi.

Program Directors

The Grand Council appoints volunteer alumni **Directors** to serve as coordinators for various Fraternity programs which deserve and require attention beyond that which the National Headquarters staff can offer. These alumni are appointed by the Grand Senior President for two-year terms following the National Conventions.

Volunteer Directors serve in the areas of Scholarship, Publications, Career Development, Awards, and Province Programs.

Grand Province Chiefs

Alpha Sigma Phi is a brotherhood and a business. And like a large, national business, it is wise to break the total "company" down into divisions. Alpha Sigma Phi does it for the same reason that big business does it—more manageable units, geographical similarities, and opportunities to share and learn from nearby operations. See the charts on Pages 8-11 for the current Province geography.

The Director of Provinces serves as the coordinator of the Province Program. He recommends outstanding brothers to the Grand Council to serve as Grand Province Chiefs. The Grand Senior President appoints the Grand Province Chiefs, and they serve two-year terms following the National Conventions. Consecutive

additional terms may be served.

The Grand Province Chief visits every chapter in his Province at least once each academic year. He communicates with the HSPs and Grand Chapter Advisors at each chapter on a regular basis, and is in charge of setting up the annual Province Conclave. The Province Conclave is a weekend educational retreat held for the officers and members of all the chapters in the Province. It is usually held at a chapter house, and gives brothers a chance to learn and exchange ideas.

Grand Chapter Advisors

The Grand Chapter Advisor can play the **key role** in the future of every chapter. "The biggest inherent problem that every chapter has," says Executive Director, **Robert M. Sheehan, Jr.**, "is that they change officers so frequently that they

"A shocking percentage of our young brothers today come from broken homes. Many have never identified with an adult figure. Many have had little training in managing their lives or anything else. The campus can be a pretty cold, impersonal place. The campus may provide some highly-trained professionals for them to turn to, but they're not comfortable with them. lose a lot of institutional knowledge regularly. A Grand Chapter Advisor who attends meetings regularly can help solve this problem and make transitions smooth. The local advisors of a chapter are undoubtedly the key to a chapter's success."

The Grand Senior President appoints the Grand Chapter Advisor upon the recommendation of the Grand Province Chief, and he serves a two-year term following National Conventions. Consecutive additional terms may be served.

Besides attending regular chapter meetings, the Grand Chapter Advisor works with the officers, Prudential Committee, and other local advisors or Alumni Corporation/Association officers, and works closely with the Grand Province Chief to serve his chapter best.

Alumni Corporations/Associations

"Every chapter should have its own Alumni Corporation or Association with elected officers, regular meetings, and regular social events for alumni from the chapter to participate in," says Grand Senior President **Donald R. Morgan, Purdue '57**. "It is an essential part of the 'lifetime experience' of Alpha Sigma Phi."

The difference between an Alumni Corporation and Alumni Association is a small one. Both exist to promote chapter alumni involvement and to help the chapter improve. In instances where property is owned, such as a chapter house, the alumni incorporate their organization for legal purposes.

Alpha Sigma Phi Alumni Corporations/Associations vary in their degree of activities and involvement with the chapter. A complete program would include: annual dues for house needs or scholarships, annual elections of officers, regular officers meetings, annual social events (such as Founder's Day Dinner, Homecoming, Spring Sig Bust), help with the Chapter Alumni Newsletter, and assignment of an alumnus to advise various chapter officers.

"Alpha Sigma Phi is for life!" adds Grand Senior President Morgan, "and the Alumni Corporation/Association helps to keep every alumnus brother in the chapter in touch with his pledge brothers and all chapter alumni. After all, this is the deepest meaning of our Fraternity. There is an opportunity for **every** brother to be involved with his own chapter's Alumni Corporation/Association."
