
WAJNERT NAMED FOUNDATION TRUSTEE

Thomas C. Wajnert of Bernardsville, New Jersey, was named as a Trustee for Alpha Sigma Phi Fraternity's Educational Foundation. The announcement was jointly made by Dr. Robert E. Miller, Trustee Chairman, and John R. Chaney, President.

Wajnert was the founding officer and is now President and Chief Executive Officer of AT&T Capital Corporation, a subsidiary of AT&T specializing in equipment leasing and financing for commercial customers. He is also a Director of AT&T's American Transtech subsidiary and a Director of AT&T Universal Card Services Corporation.

He joined Alpha Sigma Phi at Illinois Institute of Technology in 1961. He received a Bachelor of Science degree in Engineering from the Chicago school in 1965 and a Master of Business Administration in Finance from Southern Methodist University in 1966.

As an Educational Foundation Trustee, Wajnert will oversee financial investments and assist in increasing the overall endowment.

ALPHA SIG CONNECTIONS

As a service to brothers, Alpha Sigma Phi last year developed the Alpha Sig Connections Program. Alpha Sig Connections is designed to assist all brothers with utilizing alumni connections for employment opportunities.

Those brothers who are searching for employment and choose to enroll in the program will send ten resume originals to the Fraternity Headquarters with the application. A listing of the brother's name, initiation year, school, degree, and position desired will be placed in *The Tomahawk* based on the information from the application. Any brother interested in recruiting a listed brother can then contact the Headquarters for a copy of the resume without any obligation and contact the applicant if he wishes.

There is no fee for the program. The Fraternity provides this information as a clearinghouse of information and makes no recommendations, guarantees, or promises. Applications for the program are included in this mail packet. If you need more applications or more information please contact the Fraternity Headquarters.

TAX TIME TIPS

Every Alpha Sigma Phi chapter in the U. S. is exempt from paying tax. However, most chapters are required to file an income tax return known as the Return of Organization Form (Exempt from Income Tax) or Form 990.

The form may be obtained at a local office of the IRS. It must be filed annually on or before the 15th day of the fifth month following the close of the chapter's fiscal year. Form 2758 may be used to file for an extension of the filing deadline.

If your chapter has gross receipts averaging \$25,000 or less for the current and prior two tax years, you will not be required to file a Form 990. Gross receipts are the total amount the chapter has received from all sources during its annual accounting period, without subtracting any costs or expenses. If your chapter is sent the Form 990 by the IRS, you <u>must</u> file it. A penalty may be assessed when a return is filed late, unless it can be proven that the late filing was due to reasonable cause.

Please note that your chapter cannot use the Fraternity Headquarter's tax identification number. Each chapter and house corporation must have its own identification number; note that these numbers must be distinct from one another as active chapters and house corporations are coded differently by the IRS. Contact your local IRS office to obtain a number if your chapter does not presently have one.

IDEAS FROM THE ROAD

Goal: Inexpensively acquire a complete set of ritual equipment.

Idea: Involve brothers in making the equipment, then have them donate it to the chapter.

Seen in Action at: Alpha Zeta Chapter, UCLA; Delta Xi, SUNY Plattsburgh; Beta Delta, Marshall University.

Officer Responsible for Implementing Idea: HM (Marshal)

How to Implement Idea at Your Chapter:

Most chapters the CLC's visit do not have enough robes or lanterns to perform a Black Lantern Processional which includes all the members. By asking each brother to be responsible for securing the proper equipment, the burden on the HM and the chapter budget is greatly reduced. Perhaps in connection with Founders' Day, or another chapter event, ask each brother to purchase and/or make a robe and lantern and then donate it to the chapter.

<u>Lanterns</u> Your local hardware or camping store should sell a suitable lantern for \$7.00-\$8.00. The problem is that these lanterns are red. Solution: Have the HM coordinate the purchase of lanterns, then hold a "painting" party where brothers can spray paint their lanterns black. Also get some white paint, and have them paint "Donated by Joe Sig #444", so they can be forever remembered and acknowledged for their gift to the chapter.

Robes A pattern to make your own robes can be purchased from the Alpha Sigma Phi Headquarters Office (614) 363-1911 for \$8.00. Making your own robes is labor intensive, but dividing the work among the entire brotherhood can make the job a lot easier. Every brother can cut the material from the pattern. Once the pieces are cut, have a volunteer proficient in the use of a sewing machine assemble the robes (if none of the brothers can sew, ask your parents club, or perhaps you can make a deal with the Home Economics class at a local high school). The HM should coordinate the purchase of the material, cost is approximately \$14.00 per robe, depending on the quality of material. Other alternatives for inexpensive robes are: purchasing robes from a Halloween Supply or costume shop, or recycling graduation robes and adding a hood.

Other ritual material can be ordered from the Alpha Sigma Phi Headquarters. Call, or ask the consultant who visits your chapter for an order form. Some of the equipment can be quite expensive; consider asking brothers or alumni for donations.

Do not forget to make the proper arrangements with campus officials, newspapers, and campus ethnic groups before performing the Black Lantern Processional. Many of our chapters have encountered problems of misunderstanding because they have not properly notified the campus community before performing the BLP, and are no longer allowed to do the ceremony on their campus. Call the headquarters office or ask your CLC for the Black Lantern Processional Public Relations Packet.

The Chapter Leadership Consultants of Alpha Sigma Phi travel through the country assisting the chapter and learning new ideas from each chapter they visit. "Ideas from the Road" is a special feature of the Old Gal Gazette in which the Consultants will share some of the different ideas they feel are noteworthy and explain how they can be implemented at your chapter.
