- 7. Anderson then gave a brief Report of the Executive Director and called attention to the written report in each delegate's packet.
- 8. GSP Lord highlighted the Grand Council Report, voting the stewardship of the Council to have been diligent and productive. He elaborated on the good success of Alpha Sigma Phi in the past biennium and indicated such can continue if we continue to work for it.
- 9. Grand Treasurer Richard Gibbs highlighted the Grand Treasurer's Report, which was also included in printed form in the delegate's packets. This report notes we have balanced the Fraternity's budget for the first time in eight years and have increased membership significantly in the past year.
- 10. Chapter Consultant Philippi read the committee assignments, and GSP Lord outlined and charged the delegates with their committee responsibilities. The committees were: Alumni Affairs, Awards, Credentials and Resolutions, Expansion, Finance, Housing, Interfraternity Relations, Law and Nominations, Province, Public Relations and Community Service, Publications, Rush, Scholarship, and, at the request of the Convention, an ad hoc committee on Hazing was appointed.

The Final report of each committee is attached in the exhibits to these minutes. The reports carry the names of the chairmen and the committee members.

RECESS

At 3:30 the opening session was concluded. At that point, Grand Secretary Richard Dexter met to discuss committee guidelines he had authored with the committee chairmen. The chairmen also received a status report in each program area prepared by Executive Director Anderson.

Wednesday evening's activities included dinner, a session for the delegates to get acquainted conducted by Kevin Garvey, Westminster '75, and a mixer under the muscial direction of Larry Lukas, Ohio Wesleyan '42.

THURSDAY, AUGUST 17, 1978

- 11. The business session reconvened at 8:30 a.m. Chapter Consultant Philippi took Roll Call.
- 12. Committee assignments were reviewed and the charge repeated. The meeting then broke into committees to begin work.

- 13. At 1:00 p.m. the business session reconvened and interim committee reports were given.
- 14. At 2:00 p.m. the business session recessed and the assembly viewed the movie "Fraternity Row". Thereafter, Stuart W. "Scooter" Anderson presented a resolution intended to create the "Newsletter Association of Alpha Sigma Phi". The resolution was properly moved and seconded and passed. It is attached as Exhibit A.

While in general session, the Convention divided into Provinces for short meetings under the direction of Kevin Garvey. The groups began considering individuals who might be elected Province Presidents.

Following the Province meetings, Chapter Consultant Philippi conducted a brief session on Pledge Education programming. His main points were that the Pledge Educator's Material, which supplements To Better the Man, is a high quality resource in the planning of an education program; that sound education of new members in the operation of a Chapter and the Fraternity is the only way for a Chapter to assure its continued well-being; and that hazing - debasing or demeaning pledges in any way - is not only out of place but dangerous. Executive Director Anderson added some emotional comments about the potential harm of even seemingly harmless hazing violations.

15. Following dinner, Larry Philippi conducted a session on rush. Larry demonstrated, by a graphic break-down of the time in a week, that every average student has time for fraternity involvement, even if he has a part-time job.

Larry also stressed friendship as the control objective in attracting men to pledge the Chapters, and urged for rush to be a continual, sincere effort in every Chapter.

Dennis R. "Skip" Parks, Baldwin-Wallace '72, then gave a presentation on the value of positive interfraternity relations. Skip is the Advisor to Student Organizations and Greek Activities at Memphis State University. As a practical way of improving the worth of IFCs, Skip advocated elimination of "representative" organizations and replacing them with "councils of presidents" organizations, which will give the IFC more ability to make quick and binding decisions on matters.

Evin C. Varner, Director of Publications, presented thoughts on the production of a Chapter newsletter. He opened with a clever series of examples of newsletters which typically get discarded by alumni. They indicated some, or much, time had passed since the alumni had heard from the undergraduates, but that now there is a need for alumni contributions and...instant turn-off. Evin mentioned various items that should appear in a good newsletter - undergraduate news, news about alumni, upcoming events and chapter operational goals, plus other special activities that have, or will, occur to the Chapter or an individual member. Fund-raising appeals are best handled completely separate from the newsletter.

FRIDAY, AUGUST 18, 1978

16. The business session was reconvened by Roll Call at 8:00 a.m. Final Committee reports were presented, discussed, in some cases amended, and either accepted as reports or approved for action. Some committees not ready to report were deferred until Saturday morning. All committee reports are attached as exhibits. An index precedes the exhibits to aid in locating the specific reports.

RECESS

The Convention recessed for brunch. The afternoon was free for sports activity or other activities afforded by the area.

- 17. At 6:00 p.m. the Awards Dinner began. GSP Lord was the Master of Ceremonies. The program was as follows:

18. At 8:00 p.m. selected scenes of the rituals of Alpha Sigma Phi were exemplified under the direction of Frank Sine, Lehigh '77. In addition, a Chapter ritual developed at Psi, Oregon State, was exemplified. This has been adopted by other Chapters since Psi performed it before those attending the 1975 National Educational Conference.

SATURDAY, AUGUST 19, 1978

- 19. The legislative session reconvened at 8:00 a.m. The remaining committees presented their reports, which were properly moved, seconded and passed. The Finance Committee's proposal to raise the per man annual dues and make them permanent required a Bylaws change. Roll call vote was taken and the measure passed as stated in the report attached in the exhibits.
- 20. Election of Province Presidents took place and the Brothers elected appear in the Province Committee report attached in the exhibits.
- 21. The Nominations Committee presented a slate of candidates for the Grand Council which was adopted by acclamation. From the Grand Council candidates for the various offices were presented and, again, elected by acclamation. The Council and its officers appear on the Nominations Committee report attached in the exhibits.

RECESS

At approximately 11:00 a.m. the Convention adjourned sine die. The afternoon was available as free time. Kevin Kinney, Widener '77, had some scheduled sports activities and a bus was made available to those wishing to tour the Independence Square area in downtown Philadelphia.

The newly elected Grand Council used this time for its first meeting.

At 6:00 p.m. the Grand Council hosted a reception. The Convention photograph was taken at 6:30 and the Convention Banquet was served at 7:00 p.m.

EXHIBIT C Alumni Affairs Committee Report 1978 National Convention

The committee was chaired by Garrett Riegg (Bay Area Alumni Council) and included:

Keith McKenzie, American Unversity Bill Doyle, Penn State David Kennemuth, Baldwin-Wallace Bobby Floyd, North Carolina State

The chairman summarized a report from the staff which showed only three fully active area alumni councils. Committee members made clear that numerous other Chapter alumni organizations were active but probably not publishing a newsletter or otherwise communicating with Headquarters.

Problems of alumni organization were listed as:

1. Lack of communication and newsletters

- 2. Poor address files
- 3. Need for specific annual joint activity with actives

4. Cliques of alumni from a few class years dominate

5. Lack of encouragement from Headquarters

Proposed policies to encourage alumni councils are:

- 1. At least once a year, chapters should mail a newsletter to all alumni and Headquarters.
- 2. Current address files should be checked against Headquarter's computer files.
- 3. Once or more each year, alumni should be invited to visit the Chapter.
- 4. Headquarters should publicize and distribute pamphlets on structures and operation of alumni councils.

- 3. Friend of the Chapter Award selected by the Chapter, unlimited number - given to parents, friends, neighbors, administrators, faculty or any others to show appreciation for support or services rendered

4. Grand. Province. Chief. Award. - selected by the Grand. Province. Chief, up. to three per year per province - given to any Brother (undergraduate or alumnus) who has excelled in aiding the Fraternity

- 5. Alpha Sigma Phi Community Development Award selected by the standing Awards Committee, unlimited number - given to any Brother having a key position in a service organization such as Lions, Kiwanis, Rotary or the like
- 6. Alpha Sigma Phi Professional Man of the Year - selected by the standing Awards. Committee, up to ten per year - given for outstanding achievement in the professional fields - recipients become eligible for the Distinguished Merit Award
- 7. Grand Senior President Citation - given with approval of the GSP for any accomplishment or contribution not specifically covered by the other awards, unlimited number

This committee wishes to have the standing Awards Committee establish the breaking point for large and small numbers of Chapter alumni.

This committee also recommends the standing Awards Committee give consideration to an award for outstanding contribution by a Chapter in Alpha Sigma Phi to campus life. Since this would require comparison of our Chapters to other fraternities' chapters, the possibility of input from deans or campus fraternity advisors should be investigated. This would have to be an unlimited number of awards each year, since every Chapter could conceivably be the best on its campus in this regard.

This committee recommends that these new awards consist only of a certificate and possible mention in The Tomahawk for now, but encourages the standing Awards Committee to make recommendations to the 1980 Convention Committee on Awards for additional tokens of recognition to awards winners, such as plaques, paper weights or medallions. the second states and ship

BE IT RESOLVED THAT ALPHA SIGMA PHI:

RESOLUTION TO ASSOCIATE PHILIPPINE FRATERNITY

- Whereas, representatives of Alpha Sigma Phi in the Philippines.have sought and maintained contact with the Headquarters of Alpha Sigma Phi in the United States of America for a period of time in excess of seven years; and
- Whereas, in recent months, Mr. Manuel M. Momongan, National President of Alpha Sigma Phi in the Philippines, has communicated freely with Gary A. Anderson, Executive Director of Alpha Sigma Phi in the United States of America regarding the operations and traditions of the Filipino group, and
- Whereas, for an extended time, Mr. Joel V. Pal, in various capacities, has undertaken to keep Alpha Sigma Phi in the United States of America informed of developments, activities and statistics regarding Alpha Sigma Phi in the Philippines, and to raise continually the question of affiliation; and
- Wheneas, correspondence from a number of the members of Alpha Sigma Phi in the Philippines has indicated their deep devotion to the principles of fraternalism; and
- Whereas, the leaders of Alpha Sigma Phi in the Philippines have declared a willingness to accept the guidance of Alpha Sigma Phi in the United States of America in their administration of the Filipino Fraternity,
- THEREFORE, be it resolved that Alpha Sigma Phi in the United States of America continue to explore the possibility of affiliation with Alpha Sigma Phi in the Philippines through an association with said group under the terms set forth in the separate association agreement.
- Further, be it resolved that this Convention charge the Grand Council with a study of a possible affiliation of Alpha Sigma Phi in the Philippines, reporting their results no later than at the 1980 National Convention.

ASSOCIATION AGREEMENT BETWEEN ALPHA SIGMA PHI, INC. AND ALPHA SIGMA PHI in the Philippines

By accepting this agreement, Alpha Sigma Phi in the Philippines assumes recognition as an International Associate of Alpha Sigma Phi, Inc., a New York corporation. This recognition carries some privileges and responsibilities which are outlined below.

1. Annual report of Filipino operations to be sent to the Headquarters in the United States - to include membership statistics by Chapter, an assessment in the areas of recruitment success, alumni activity, pledge education, community service and publications, and a statement of the Fraternity's goals in these areas for the upcoming year.

- 2. Annual reports of the operations of Alpha Sigma Phi in the United States will be sent to the National President of Alpha Sigma Phi in the Philippines.
- 3. Reports on changes in national officers of the Filipino group to be sent to the U. S. Headquarters immediately after such changes should occur. Similar information on the U. S. officers will be sent to the Filipino National President.
- 4. Regular reports to be sent by the Filipino Associate for inclusion in the publications of Alpha Sigma Phi in the U. S., especially for TheTomahawk.
- 5. A life-time subscription of The Tomahawk to be given to each National President of Alpha Sigma Phi in the Philippines on a complimentary basis.
- 6. Permission to publish copies of <u>To Better the Man</u>, including the creation of a section on the history and operations of Alpha Sigma Phi in the Philippines.

Finance Committee Report 1978 National Convention

Committee Members:

Bill Hasse, Purdue; John Anderson, Cornell; Alan Bland, North Carolina State; Dennis Simmonds, Oregon State; Richard Gibbs and Al Wise, Co-Chairmen.

1. Knowing that this Convention is operating at a financial loss and desiring to eliminate losses at future conventions, we recommend that future conventions be shortened by one day. This savings will enable us to avoid raising the Chapter Fees or other assessments.

(Note: Following discussion of this item of the Finance Committee Report, a further recommendation developed on the Convention floor:

Sense of the body recommends that the staff in planning the 1980 Convention, work to cut the costs of meals, not cutting quality or quantity of the food, possibly by having more buffet meals or entrees requiring less preparation.)

2. To decrease by \$2,000 the deficit budgeted for the 1978-1979 fiscal year, we recommend increased staff effort for fund raising. We propose a goal of \$23,000 net income from the Loyalty Fund drive. We note this still leaves \$5,000 of the budgeted income as borrowed money for expansion, which will need to be paid back.

3. In anticipation of the increased cost of education and leadership development, we recommend to the Grand Council that 75% of the income each year from the Tomahawk Fund be used for that purpose and 25% of the income be reinvested to allow for future increased costs.

4. All undergraduate members of a Chapter as of October 1, of each calendar year who we initiated prior to July 1, of that calendar year will pay undergraduate dues of \$7.00 per year.

This item was properly moved, seconded and passed for addition to Article XIII, Section 9 of the Bylaws of Alpha Sigma Phi Fraternity.

EXHIBIT H.

Housing.Committee Report 1978 National Convention

The housing committee respectfully recommends that volunteer alumni advisors be appointed to the standing Committee on Housing to assist the individual Chapters with housing problems including legal matters, contracting and maintenance, architecture, insurance and financing. These advisors should be made available for consultation.

This committee also recommends making the report on loss prevention and property and liability insurance, which was authored by Brother Robert McDowell, Indiana '70, available to every Chapter and be labeled required reading for each house manager. Periodic supplements to this report should be shared with the Chapters as they are developed.

This committee also recommends the Grand Treasurer make available a description of the financial aid for housing available through the national Fraternity and the necessary procedures for making application for this aid.

At present, all decisions are made by our volunteer Director of Publications allowing for consistency in style and appearance. But, since the director is a volunteer, other demands on his time have delayed publication work. People must be attracted to fill support roles under the director.

<u>The</u> <u>Tomahawk</u> -	Maintain the high standards of this publication and the feature story on the cover. By the next Convention funding of The Tomahawk must be addressed, with some form of subscription being implemented, after a cost effectiveness study is made.
"Old Gal Gazette" -	It is not receiving the attention it deserves. Importance of of the publication should be stressed.
Manuals -	A compiled list of all publications and related services available through Headquarters is the top priority. Also, all officers manuals will be revised and standardized in order of priority in keeping with the Grand Council's policy.
To Better the Man -	It has been updated to 1978 and has a durable vinyl cover. Also, the pledge educator's pages have been revised and expanded and are available to all Chapters.
Ritual -	Reprinting is necessary. It will be more legible and compre- hensive. Instructions would be clarified via diagrams, and building of props would be explained. The language of the pledging ceremony should be clarified so that the ceremony may be administered in either an esoteric or exoteric manner, as determined by the Chapter and in keeping with the Fraternity's Constitution. Lastly, instructions for the Black Lantern Procession would be included.

Our goals are that the above be implemented and:

Resolution

Recommendations

- 1. Develop decals, bumper stickers, cast iron symbols, matches, T-shirts, or any other product with the Phoenix design to be made available to the Chapters to raise the awareness of Alpha Sigma Phi on campus.
- 2: Operation Manpower Rush Manual updated and condensed for more effective use by Chapter rush chairmen.

Scholarship.Committee Report 1978 National Convention

Committee Members: Otto Sondor, Chairman; Randy Engleman, Indiana; Peter Brewington, American; Jim Vanco, Rio Grande.

The recommendations of the Scholarship Committee to the Convention are that:

- 1. The National Scholarship Award, which has been given to the Chapter holding the highest academic average and which has been suspended in recent years, not be revived at this time.
- 2. That each Chapter's Honored Scholarship Chairman report regularly to the National Director of Scholarship. And, that this new procedure be used to:
 - a. Stimulate interest among the Chapters in the development of individualized scholarship programs appropriate to the needs and wishes of each Chapter.
 - b. Provide strong encouragement and advisory service to those Chapters which take initiative in the development of such programs.

Recommended steps for Chapters to use in demonstrating interest in the development of strong scholarship programs:

- 1. Upgrade the importance of the Honored Scholarship Chairman, including regular reporting to the Chapter meetings.
- 2. Appoint and encourage the regular operation of a Scholarship Committee consisting of the HSC as chairman, the HSP as a regular member, and at least two other junior and/or senior Brothers.
- 3. As a Chapter, define and accept some realistic and attainable scholarship goals. Examples of such goals might be:
 - a. An increased awareness that a scholarship program for the Chapter involves much more than a collective grade point average.
 - b. Emphasis on scholarship motivation should be a vital part of the rush process.
 - c. Emphasis on scholarship as an integral part of the pledging program.
 - d. The development of such physical aids to scholarship as a Chapter library and study center.
 - e. The development of a series of faculty lectures to be given by faculty members to the Brother and Pledges.
 - f. The development of tutorial programs for Brothers and Pledges.
- 4. As a Chapter, develop specific means by which each of the agreed upon goals will be implemented.

- 5. As a Chapter, decide upon means by which the degree of attainment of the goals can be measured to determine successes and weak spots.
- 6. Keep the National Director of Scholarship informed of the ways in which the program is being planned and carried out.

It is intended that the results of the efforts to develop such individualized scholarship programs will become the basis for an eventual new Scholarship Manual. This Manual may consist of a series of "case studies" of Chapters and their own programs which have seemed to work for their own needs. No recommendation is made to revise the present Manual at this time. It is believed that presently available stocks may be of value to some Chapters.

It is further intended that the Director of Scholarship will provide some recognition for Chapters which follow through with attempts to develop individualized programs.

Whereas, hazing has been a problem in the past, and

Whereas, Alpha Sigma Phi forbids any form of hazing in the Chapters, therefore

Let It Be Resolved that each Chapter of Alpha Sigma Phi keep their pledge education program free of hazing, and in its place a creative and inovative pledge education program be adopted.
