& Convention
The Adam's Mark Hotel
August 5-9, 1992
Charlotte, North Carolina

- 1. The Executive Vice President of Alpha Sigma Phi and Secretary of the Convention, John R. Chaney, Indiana '67, called the Convention to order at 7:30 p.m. on Wednesday, August 5, 1992.
- 2. Secretary Chaney called the roll. Chapters not answering the roll were:
 Delta (Marietta College), Theta (University of Michigan), Upsilon (Penn State University), Alpha Theta (University of Missouri), Alpha Omicron (Missouri Valley College), Beta Epsilon (Lehigh University), Beta Omicron (Tri-State University), Gamma Delta (Davis & Elkins College), Gamma Xi (Widener University), Delta Alpha (Loyola University) and Delta Nu (Lock Haven University).
- 3. Grand Marshal Dr. Larry G. Spees, Ohio Wesleyan '57, led the Convention Invocation Ceremonies.
- 4. Secretary Chaney introduced the members of the Grand Council.
- 5. Grand Senior President Charles J. Vohs, Penn State '75, delivered his address to the Convention. Brother Vohs then introduced our featured speaker, Brother Thomas C. Wajnert, Illinois Tech '61. At 9:00 p.m. Brother Vohs recessed the Convention for the evening to proceed with the Memorial Service and Black Lantern Processional. One hundred and three brothers joined in the traditional march.
- 6. Grand Senior President Vohs reconvened the Convention at 8:30 a.m. on Friday, August 7, 1992.
- 7. Secretary Chaney called the roll of registered delegates. The following chapters were not present: Delta (Marietta College), Upsilon (Penn State University), Alpha Theta (University of Missouri), Alpha Omicron (Missouri Valley College), Beta Epsilon (Lehigh University), Beta Omicron (Tri-State University), Gamma Delta (Davis & Elkins College), Gamma Lambda (Barton College), Gamma Xi (Widener University), Gamma Rho (Lycoming College), Delta Alpha (Loyola University) and Delta Nu (Lock Haven University).
- 8. The Chairman of the Committee on Standards and Ethics, Michael E. Macfarlane, Longwood '90, discussed the Committee's work.
- * Includes only major motions.

- 9. It was moved by Longwood, seconded by Illinois Tech and PASSED BY UNANIMOUS VOICE VOIE that:
- WHEREAS the Standards and Ethics Committee has discussed the issues of keg usage and cases of alcohol, the risk management, university relations and legal issues involved, and
- whereas it is the recommendation of the Standards and Ethics Committee that the National Leadership Conference & Convention go on record as reaffirming the present policy of Alpha Sigma Phi and adherence to FIPG Standards with respect to purchase, possession and provision of alcohol,
- BE IT THEREFORE RESOLVED that the 1992 National Leadership Conference & Convention affirm and continue to present policies of Alpha Sigma Phi with respect to purchase, possession or provision of alcohol.
- 10. It was moved by Longwood, seconded by Delaware and PASSED BY UNANIMOUS VOICE VOIE that:
- WHEREAS the Grand Council has recommended that the seven year <u>Tomahawk</u> subscription constitutional limit be returned to the lifetime subscription,
- THEREFORE BE IT RESOLVED that the Constitution Article III, Section 9 be amended as follows: All Chapters of this Fraternity shall supply each member at the time of initiation with an official badge, paraphernalia (to be held by him so long as he shall remain a member), and a lifetime subscription to The Tomahawk, and
- BE IT FURTHER RESOLVED THAT the by-laws would then be amended as follows:

(Article XI, Section 6G)
A lifetime subscription to <u>The Tomahawk</u> for each member to be initiated.

(Article XIV, Section 1)

A fee in the amount of one hundred ten dollars (\$110.00) shall be paid to the Fraternity for every initiate by the Chapter desiring to admit him to membership before authorization shall be issued. Said fee shall include costs of an official badge, shingle, and lifetime subscription to The Tomahawk for each initiate. All undergraduate members, actives and pledges, of a Chapter as of July 1, 1990, shall pay to the Fraternity Undergraduate Dues of sixty dollars (\$60.00) per year.

(Article XV, Section 1)

The Tomahawk shall be the official exoteric publication of the Fraternity. It shall be available to all members during the natural life of each.

- 11. It was moved by Longwood, seconded by Miami and PASSED BY UNANIMOUS VOICE VOTE that:
- WHEREAS the undergraduates of Alpha Sigma Phi hereby approve the formation of the two distinct committees of Brotherhood Development and Parents' Liaison,
- BE IT FURTHER RESOLVED THAT the two above mentioned committees shall have a committee chairman for each said committee to be fully integrated into the chapter committee system under the supervision of HJP.
- 12. It was moved by Longwood, seconded by U.N.C.C. and PASSED BY UNANIMOUS VOICE VOTE that:
- WHEREAS the Grand Council of Alpha Sigma Phi Fraternity has moved to adopt a national philanthropy, and
- WHEREAS the Grand Council has provided nine national philanthropies to be considered, by the undergraduate members of Alpha Sigma Phi,
- BE IT THEREFORE RESOLVED that the undergraduate brothers of Alpha Sigma Phi direct the Grand Council to provide three philanthropies to be considered by the undergraduate brothers and one of which to be affirmed by mail vote as the national philanthropy of Alpha Sigma Phi Fraternity.
- 13. It was moved by Longwood, seconded by R.P.I. and CARRIED BY VOICE VOTE that:
- WHEREAS Alpha Sigma Phi Fraternity believes sororities and women's fraternities offer excellent opportunities for women to share a fraternal experience, and
- WHEREAS auxiliary women's groups organized by men's fraternity chapters commonly referred to as "little sisters" are inconsistent with the concept and philosophy of separate and equal women's fraternities, and
- WHEREAS Alpha Sigma Phi Fraternity believes that these groups inhibit the accomplishments of chapter goals by:
 - *DIVERTING resources of time, effort and money, which are needed for chapter operations and programming;

*DISTRACTING chapter members in the performance of essential duties, e.g. membership recruitment and membership education;

*INVITING disharmony within the chapter by usurping the roles and responsibilities of initiated members;

*WEAKENING the bonds of brotherhood by adversely affecting interpersonal relationships within the chapter; and

WHEREAS Alpha Sigma Phi Fraternity and several member fraternities have taken a position against these auxiliary groups,

- BE IT THEREFORE RESOLVED that Alpha Sigma Phi Fraternity believes that "little sisters" groups are not desirable adjuncts to the collegiate chapters of men's fraternities and urges and recommends that chapters work to eliminate these programs at the earliest possible time.
- 14. It was moved by Longwood, seconded by SUNY-Plattsburgh and PASSED BY UNANIMOUS VOICE VOTE that:
- WHEREAS the Committee on Standards and Ethics reviewed and discussed the Scholastic Performance Stipulation of 1988, and
- WHEREAS the Committee felt that a Minimum GPA of 2.0 or a "C" average is still appropriate,
- BE IT THEREFORE RESOLVED the 1992 National Leadership Conference & Convention reaffirms the Scholastic Performance Resolution of 1988.
- 15. It was moved by Longwood, seconded by Hartwick and PASSED BY UNANIMOUS VOICE VOIE that:
- WHEREAS the Committee on Standards and Ethics has discussed the chapter reporting process,
- BE IT THEREFORE RESOLVED that the 1992 National Leadership Conference & Convention of Alpha Sigma Phi direct the Grand Council to investigate and report the efficiency of the chapter reporting process and state its recommendations at the 1993 National Leadership Conference.
- 16. It was moved by Longwood, seconded by Illinois Tech and CARRIED BY VOICE VOIE that:
- whereas some men have participated in an undergraduate interest group or colony, have participated in a local fraternity subsequently committed to becoming a chapter of Alpha Sigma Phi, and due to cause beyond the undergraduate's control did not qualify for initiation, and

WHEREAS

some men may have participated in the pledge program of an Alpha Sigma Phi chapter and have left school in good standing and without having failed to qualify for initiation based on secret vote of the chapter, and

WHEREAS

on investigation by the Grand Council they may determine that initiation of such man or men would be in the best interests of the Fraternity and consistent with Article II, Section 1 of the Constitution,

BE IT THEREFORE RESOLVED that the 1992 National Leadership Conference & Convention direct the Grand Council to submit the following proposed Constitutional Amendment to the chapters for vote pursuant to Article VIII, Section 3 of the Constitution:

To rename Article II, Section 2 (D) Article II, Section 2 (E) and to insert as Section 2 (D), the following:

- "D. Members at Large: After investigation and approval by the Grand Council, a member of a former colony or interest group of Alpha Sigma Phi, or of a local fraternity which had petitioned for colony status, or a former pledge of a chapter of Alpha Sigma Phi who left the college and chapter in good standing, may be initiated by direction of the Grand Council as members at large of Alpha Sigma Phi. Members at large shall have the same rights, privileges and obligations as alumni members. Members at large qualifying by undergraduate work at a college where Alpha Sigma Phi has an active or inactive chapter may be enrolled on the roster of the chapter with consent of the chapter, if active, the alumni board of an inactive chapter, if active, or by direction of the Grand Council if there is no active chapter or alumni group."
- 17. The Chairman of the Committee on Finance, Blair A. Huizingh, U.C.L.A. '90, discussed the Committee's work, recommended that we continue to maintain a balanced budget and that future Convention Committees on Finance consider recommending regular undergraduate dues and/or fees increase at a rate similar to the Consumer Price Index biannually, to avoid uneven or possibly uncomfortable increases in the same.
- 18. It was moved by U.C.L.A., seconded by Washington and NOT PASSED BY A ROLL CALL VOTE OF 24-23 to amend Article XIV of the By-Laws as of July 1, 1992 to read as follows:

Section 1 - Initiation fees shall be changed to \$120.00, and undergraduate dues shall be changed to \$65.00

Section 3 - Chapter fees shall be changed to \$255.00 and,

further that on July 1, 1993, Article XIV of the By Laws shall be amended to read as follows:

Section 1 - Initiation fees shall be changed to \$130.00 and undergraduate dues shall be changed to \$70.00

Section 3 - Chapter fees shall be changed to \$270.00

19. It was moved by U.C.L.A., seconded by Illinois Tech and NOT PASSED BY A ROLL CALL VOTE WITH 20 NO VOTES, 30 YES VOTES AND 2 ABSTENTIONS that:

Article XIV of the By Laws be amended effective July 1, 1993 to read as follows:

Section 1 - Initiation fees shall be changed to \$130.00 and undergraduate dues shall be changed to \$70.00

Section 3 - Chapter fees shall be changed to \$270.00

- 20. The Chairman of the Committee on Nominations, Joseph G. Strines, Ohio State '91, discussed the Committee's work.
- 21. It was moved by Ohio State, seconded by U.N.C.C. and PASSED BY UNANIMOUS VOICE VOIE that Dr. Dennis R. Parks, Baldwin-Wallace '72; Stan G. Thurston, Iowa State '66; Dr. Larry G. Spees, Ohio Wesleyan '57; and Robert G. Cabello, Eastern Michigan '70, be elected to fill regular vacancies on the Grand Council and that Larry D. Philippi, Bowling Green '76, be elected to fill a Grand Council vacancy caused by the resignation of Grand Senior President Charles J. Vohs.
- 22. It was moved by Ohio State, seconded by Michigan and PASSED BY UNANIMOUS VOICE VOIE that the Grand Council officers shall be:

- 24. It was moved by SUNY-Plattsburgh, seconded by Ohio State and PASSED BY UNANIMOUS VOICE VOTE the following resolutions:

The National Convention Committee System

The committee system is the key to a productive Alpha Sigma Phi National Convention. The time we will have together is so brief that each committee will have to cover its subject area very efficiently.

Any Alpha Sigma Phi brother may participate on a committee. Alpha Sigma Phi colony representatives and pledges may have a voice in committee meetings. Only official voting members of the Convention (this includes delegates from chapters and alumni councils in good standing, Grand Council members, and Past Grand Senior Presidents) may vote in committee concerning resolutions or recommendations to the Convention.

Every committee elects its own Chairman and, with the exception of the Committee on Nominations, which is chaired by the Immediate Past Grand Senior President, the Chairman shall be an undergraduate brother. It is this brother's duty to chair discussions of the committee and make the official report of recommendations and resolutions to the Convention body. Every committee also elects its own Secretary who shall submit the final report of the committee and any resolutions it may make to the Convention Chairman.

Every committee has been assigned an advisor, a brother who may be of help in providing direction, answering questions, and offering various points of view worth considering. Of course, in the case where an advisor is also a voting member of the Convention, he has a vote in the committee.

Committee chairmen, or their authorized representatives, should be sure to clear all resolutions, recommendations, and reports with the Committee on Credentials, Resolutions and Law to ensure that they are not in violation of the Fraternity's Constitution and By-Laws.

The following committees will meet and report to the 1992 National Convention of Alpha Sigma Phi Fraternity. They are charged with the following responsibilities:

The Committee on Finance

To review the Fraternity's financial status and recommend changes in dues and fees; to propose any recommendations to ensure financial stability.

The Committee on Chapter Standards and Ethics

To recommend programs and/or policies to help chapters fulfill the Fraternity's ritualistic "To Better The Man" purposes, and thereby maintain a positive perception on their campuses and in their communities.

The Committee on Credentials, Resolutions, and Law

To certify credentials of Delegates; to propose resolutions giving public recognition and/or fraternal thanks and/or honor to deserving individuals or organizations; to verify that no committee recommendations or reports are in conflict with Alpha Sigma Phi's Constitution and By-Laws.

The Committee on Nominations

To review candidates and recommend a slate of brothers to fill open positions on the Grand Council.

the Fraternity Undergraduate Dues of sixty dollars
(\$60.00) per year.

(Article XV, Section 1)

The Tomahawk shall be the official exoteric publication of the Fraternity. It shall be available to all members during he natural life of each.

- WHEREAS the undergraduates of Alpha Sigma Phi hereby approve the formation of the two distinct committees of Brotherhood Development and Parents' Liaison, and
- BE IT FURTHER RESOLVED THAT the two above mentioned committees shall have a committee chairman for each said committee to be fully integrated into the chapter committee system under the supervision of HJP.
- WHEREAS the Grand Council of Alpha Sigma Phi Fraternity has moved to adopt a national philanthropy, and
- WHEREAS the Grand Council has provided nine national philanthropies to be considered, by the undergraduate members of Alpha Sigma Phi,
- BE IT THEREFORE RESOLVED that the undergraduate brothers of Alpha Sigma Phi direct the Grand Council to provide three philanthropies to be considered by the undergraduate brothers and one of which to be affirmed by mail vote as the national philanthropy of Alpha Sigma Phi Fraterity.
- WHEREAS Alpha Sigma Phi Fraternity believes sororities and women's fraternities offer excellent opportnities for women to share a fraternal experience, and
- WHEREAS auxiliary women's groups organized by men's fraternity chapters commonly referred to as "little sisters" are inconsistent with the concept and philosophy of separate and equal women's fraternities, and
- WHEREAS Alpha Sigma Phi Fraternity believes that these groups inhibit the accomplishments of chapter goals by:
 - *DIVERTING resources of time, effort and money, which are needed for chapter operations and programming:
 - *DISTRACTING chapter members in the performance of essential duties, e.g. membership recruitment and membership education;
 - *INVITING disharmony within the chapter by usurping the roles and responsibilities of initiated members,
 - *WEAKENING the bonds of brotherhood by adversely affecting interpersonal relationships within the chapter; and

- WHEREAS Alpha Sigma Phi Fraternity and several member fraternities have taken a position against these auxiliary groups.
- BE IT THEREFORE RESOLVED that Alpha Sigma Phi Fraternity and the Presidents

of its members fraternities believe that "little sisters" groups are not desirable adjuncts to the collegiate chapters of men's fraternities and urges and recommends that member fraternities work with thir chapters to eliminate these programs at the earliest possible time.

- WHEREAS the committees on Standard and Ethics reviewed and discussed the Scholastic performance stipulation of 1988, and
- WHEREAS the Committee felt that a Minimum GPA of 2.0 or a "C" average is still appropriate,
- BE IT THEREFORE RESOLVED the 1992 National Leadership Conference and Convention reaffirms the Scholastic performance resolution of 1988.
- WHEREAS The Committee on Standards and Ethics has discussed the chapter reporting process,
- BE IT THEREFORE RESOLVED that the 1992 National Leadership Conference and Convention of Alpha Sigma Phi direct the Grand Council to investigate the efficiency of the chapter reporting process and state its recommendations at the 1994 National Leadership Conference and Convention.
- WHEREAS Some men have participated in an undergraduate interest group or colony, have participated in a local fraternity subsequently committed to becoming a chapter of Alpha Sigma Phi, and due to cause beyond the undergraduate's control did not qualify for initiation, and
- WHEREAS Some men may have participated in the pledge program of an Alpha Sigma Phi chapter and have left school in good standing and without having failed to qualify for initiation based on secret vote the chapter, and
- WHEREAS On investigation by the Grand Council they may determine that initiation of such man or men would be in the vest interests of the Fraternity and consistent with Article II, Section 1 of the Constitution,

BE IT THEREFORE RESOLVED that the 1992 National Leadership Conference and Convention direct the Grand Council to submit the following Constitutional Amendment to the chapters for vote pursuant to Article X, Section 3 of the Constitution the following proposed amendment to the Constitution:

To rename Article II, Section 2 (D) Article II, Section 2 (E) and to insert as Section 2 (D) following:

1) Members at Large: After investigation and approval by the Grand Council, a member of a former colony or interest group of Alpha Sigma Phi, or of a local fraternity which had petitioned for colony status, or a former pledge of a chapter of Alpha Sigma Phi who left the college and chapter in good standing, may be initiated by direction of the Grand Council as members at large of Alpha Sigma Phi. Members at large shall have the same rights, privileges, and obligations as alumni members. Members at large qualifying by undergraduate work at a college where Alpha Sigma Phi has an active or inactive chapter may be enrolled on the roster of the chapter with consent of the chapter, if active, the alumni board of an inactive chapter, if active, or by direction of the Grand Council if there is no active chapter or alumni group.

RESOLUTIONS FROM THE COMMITTEE ON FINANCE:

WHEREAS The finance committee has reviewed the current fiscal situation of the Fraternity,

BE IT THEREFORE RESOLVED THAT as of July 1, 1992 Article XIV of the By-Laws shall be amended as follows:

Section 1 - Initiation fees shall be changed to \$120.00, and undergraudate dues shall be changed to \$65.00.

Section 3 - Chapter fees shall be changed to \$255.00.

AND BE IT FURTHER RESOLVED that as of July 1, 1993 Article XIV of the By-Laws shall be amended as follows;

Section 1 - Initiation fees shall be changed to \$130.00 and undergraduate dues shall be change to \$70.00

Section 3 - Chapter fees shall be changed to \$270.00.

ALPHA SIGMA PHI FRATERNITY 1990 NATIONAL LEADERSHIP CONFERENCE & CONVENTION THE AMERICAN UNIVERSITY AUGUST 8-12, 1990 WASHINGTON, DC

- 1. The Executive Vice President of Alpha Sigma Phi and Secretary of the Convention, John R. Chaney, Indiana '67, called the Convention to order at 7:45 p.m. on Wednesday, August 8, 1990.
- 2. Secretary Chaney called the roll. Chapters not answering the roll were: Bowling Green State University (Gamma Zeta), Davis and Elkins College (Gamma Delta), Lehigh University (Beta Epsilon), University of Missouri (Alpha Theta), The Ohio State University (Zeta).
- 3. Grand Marshal Robert G. Cabello, Eastern Michigan '70 led the Convention Invocation Ceremonies.
- 4. Secretary Chaney introduced the members of the Grand Council.
- 5. Grand Senior President Edmund A. Hamburger, Polytechnic '45, delivered his address to the Convention. Brother Hamburger then introduced our featured speaker Brother Norman R. Hamilton, Stanford '47. At 9:15 p.m., Brother Hamburger recessed the Convention for the evening to proceed with the Black Lantern Processional. One hundred and sixty-five brothers joined in.
- 6. Grand Senior President Hamburger reconvened the Convention at 8:50 a.m. on Friday, August 10, 1990.
- 7. Secretary Chaney called the roll of registered delegates. Not present were: Baldwin Wallace (Alpha Mu), Bowling Green (Gamma Zeta) and Davis and Elkins (Gamma Delta).
- 8. The Chairman of the Committee on Finance, T. Gunnar Holmstrom, Washington '88, discussed the Committee's work and recommended that we continue to maintain a balanced budget.
- 9. It was moved by Washington, seconded by William Paterson and CARRIED BY VOICE VOIE that Section 1 of Article XIV of the Fraternity's By-Laws be amended to provide that each undergraduate member, actives and pledges, of a chapter shall pay, commencing July 1, 1990, to the Fraternity undergraduate dues of \$60.00 per year in respect to each undergraduate member as of July 1 of each year.
- 10. It was moved by Washington, seconded by Marietta and CARRIED BY VOICE VOIE that Section 2 of Article XIV of the Fraternity's By-Laws be amended to change the words and figures "Forty Dollars (\$40.00)" to the words and figures "Fifty Dollars (\$50.00)".
- * Includes only major motions.

- 11. The Chairman of the Committee on Standard and Ethics, Jim Jones, Westminster '89, discussed the Committee's work.
- 12. It was moved by Westminster and seconded by Purdue and PASSED 35-15 BY DIVISION VOTE that:
- WHEREAS, Certain communities where member chapters are located may receive negative racial connotations from the Black Lantern Processional, and
- WHEREAS, Alpha Sigma Phi abolished discrimination based on ethnic or religious criteria at the National Convention in 1950 and supports equal treatment among men, and
- WHEREAS, The chapters of Alpha Sigma Phi strive to promote good relations with their campuses and communities,
- BE IT RESOLVED, That the 1990 National Convention recommend making the white robe optional in the Black Lantern Processional when community pressure dictates it, or a suit and tie may be worn in the place of all robes.
- 13. It was moved by Westminster, seconded by Bethany and PASSED BY VOICE VOIE that:
- WHEREAS, It is understood that Alpha Sigma Phi is based on charity and philanthropy, and
- WHEREAS, Alpha Sigma Phi Fraternity expects its members to participate in helping those that are less fortunate than ourselves,
- BE IT RESOLVED, That the 1990 National Convention propose that the Grand Council consider adopting a national philanthropy.
- 14. It was moved by Westminster, seconded by Loyola and PASSED BY VOICE VOTE that:
- WHEREAS, The Standards of Excellence is a program designed to give every chapter a vehicle to develop outstanding levels of performance, and
- WHEREAS, The Standards of Excellence program has been formally adopted by the 1988 National Convention,
- BE IT RESOLVED, That the 1990 National Convention make the Standards of Excellence program required participation for all chapters.
- 15. Grand Senior President Hamburger ruled that the following resolution proposed by Westminster was out of order since it only clarified existing rules:

- WHEREAS, Alpha Sigma Phi is the Fraternity "To Better The Man" and all of her functions and actions should exhibit this as listed in our Code of Conduct, and
- WHEREAS, Our Constitution and By-laws, Article II, Section 2, lists the three categories of membership: undergraduate, alumnus, or faculty, not mentioning any such status as an "Inactive Member,
- BE IT RESOLVED, That all members shall be classified as either undergraduate, alumnus, or faculty member.
- BE IT RESOLVED, That at no time shall a status of "Inactive" member exist because of financial difficulties.
- BE IT RESOLVED, Article XVIII, Section 2 of the Constitution, chapter may impose suspension or expulsion on a member because of financial difficulties pending approval of the Grand Council.
- BE IT FURTHER RESOLVED, That all members are obligated to fulfill their (financial) responsibilities to the Fraternity, or risk sanctions as outlined in the Constitution.
- 16. It was moved by Westminster, seconded by Purdue and PASSED BY UNANIMOUS VOICE VOICE that:
- WHEREAS, Alpha Sigma Phi is the fraternity "To Better The Man" and all of her functions and actions should exhibit this as listed in our Code of Conduct, and
- WHEREAS, Our Constitution and By-laws, Article XVII, Section 1 and 3, prohibits inappropriate conduct of members of our fraternity, and
- WHEREAS, The illegal use of substances or abuse of legal substances is in direct opposition to the purpose of our organization "To Better The Man." It does not foster brotherhood, demonstrate leadership or help to build a better community; therefore
- BE IT RESOLVED, That the 1990 National Convention supports the Position Statement on Substance Abuse issued by the Grand Council of Alpha Sigma Phi Fraternity.

Validity of Credentials

At the present time, the following chapters are under administrative suspension sanctions by the National Fraternity:

American - Summer 1992. Allegations of violations of FIPG and Alpha Sigma Phi policy concerning the collective purchase of alcoholic beverages. Allegations of university policy of alcohol improperly during summer orientation.

<u>Lock Haven - Fall 1990</u>. Chapter remains under Fraternity sanctions until December 1992 due to University imposed probation. Chapter has completed all Fraternity improved sanctions and sanctions will automatically be lifted when the administration removes the probation.

The Committee may also want to consider chapters that are in arrears to the Fraternity without a valid promissory note or those that have failed to complete the required Annual Chapter Report, Standards of Excellence Program or Report of Undergraduate Membership also as not being in good standing. A list of those chapters are available from the Fraternity Office.

THE COMMITTEE ON CHAPTER STANDARDS AND ETHICS

General Purpose and Direction, Charge

To recommend programs and/or policies to help chapters fulfill the Fraternity's ritualistic "To Better The Man" purposes, and thereby maintain a positive perception on their campuses and in their communities.

Alpha Sigma Phi's purposes and teachings instruct our members to conduct ourselves as gentlemen at all times, to command the respect of the colleges and communities at which we are located, and to fulfill Our Reasons For Being:

- To foster education, to maintain charity, to promote patriotism.
- To encourage culture, to encourage high scholarship.
- To assist in the building of character, to promote college loyalties.
- To perpetuate friendships, to cement social ties within its membership.
- And to foster the maintenance of college homes by chapters for their undergraduate members.

How well do Alpha Sigma Phi chapters and members meet these purposes? Certainly improvements can be made. This Committee can help chapters and members more completely fulfill our purposes by developing resolutions, position statements and/or constitutional changes which further define or adjust Alpha Sigma Phi Standards and Ethics in a wide area of topics, a few of which are included in the following section.

Issues of Standards and Ethics

Alcohol Abuse. The issue of Alcohol Abuse is, by far, the greatest problem area in which all fraternities are criticized for not maintaining proper standards. This issue has strong public relations, health and legal implications. Alcohol abuse has continued to grow as a concern and challenge to all national fraternities. A great deal of negative national publication has resulted from various tragic alcohol-related incidents, involving fraternity members. These incidents occur with alarming regularity. The outrage from the public, the university, the parents and the national fraternity seems to focus unfortunately on "incidents." These incidents are then perceived as the "norm." This, in turn, reflects adversely on even the most mature chapters. Universities are concerned. Many of them have considered getting rid of their fraternity system. National interfraternal groups are concerned. On July 9, 1988, the Fraternity Executives Association (FEA) unanimously adopted a recommended Policy on Alcohol for every national fraternity to consider adopting. That has evolved into the current FEA position (Attachment A). From that FEA beginning the Fraternity Insurance Purchasing Group (FIPG) Risk Management Policy (Attachment B) has evolved and forms the framework for our own risk management policies (Attachment C) which also includes the FIPG policy. Recently, the FIPG adopted the Third Party Vendor Checklist (Attachment D) which has automatically been incorporated into our risk management policy.

To date, some 34 fraternities and sororities (including Alpha Sigma Phi) have identical risk management policies to that of the FIPG. Some 30 others

have very similar or nearly identical policies. A list of FIPG members is included as Attachment E.

Insurance companies are concerned. Even with our adopted risk management policies, our current liability insurance rates have risen significantly over the past five years even though we had no direct alcohol related losses. An alarming related statistic is that approximately 95% of all campus "acquaintance/date" rape situations involve alcohol abuse. In March 1990, the Grand Council passed a Position Statement on Substance Abuse (Attachment F). The 1990 Convention delegates unanimously voted to reaffirm this statement. The Committee may want to affirm this position statement.

Brotherhood Development. The Grand Council recognized the importance in having a single chapter action officer in charge of brotherhood development. They established that one Prudential Committee Member-at-Large be the Brotherhood Development Officer. The Committee may wish to affirm this action.

<u>Campus/Community Relations</u>. Service projects are a good way to build relations with a chapter's campus and community. However, day to day relations with faculty, neighbors, other fraternities and sororities, non-Greek students, campus administrators and community organizations also need attention. The Committee may recommend national adoption of a service project, philanthropy or a designated charity, or allow the Grand Council authority to so designate a service project or philanthropy and encourage support by Alpha Sig chapters and individual members nationwide.

<u>Chapter House Maintenance</u>. Many chapter houses do not maintain high general housekeeping levels or keep up with minor repair work. These practices hurt alumni relations, university relations and parent relations. The perceived advantage of having a chapter house can be negated by appearance of the facility itself. The property can also lead to general liability insurance issues. The Committee may want to address this issue.

Chapter Status. Over a period of time, chapter officers have involuntarily changed an undergraduate member's status from "active" to "inactive." Alpha Sigma Phi has only two categories of members—undergraduate and alumnus. While the transfer of an undergraduate brother to alumnus status is possible under certain limited circumstances, it is not appropriate to make such a maneuver just to avoid payment of undergraduate per capita expenses based on the chapter's undergraduate roster. The Committee may want to recommend actions/sanctions for undergraduate members who fail to pay their dues to their chapter thus creating a financial burden for the chapter.

<u>Conduct with Women</u>. Fraternities are criticized as being sexist and promoting abusive attitudes toward women. One area that is seen as especially criticized is "little sisters." Our Fraternity does not recognize "little sister" groups in any form. In December 1987, the National Interfraternity Conference, which is made up of the Presidents of all National/International Fraternities, passed a "resolution regarding 'little

sister' groups" (Attachment G). Additional information on "little sisters" is also contained in Attachments H and I. In February 1988, the Grand Council voted to support this resolution. An affirmation of the Policy Statement on Human Dignity from this Committee for the delegates to vote on may be considered. Also, an absolute ban on support and recognition to any group of "little sisters" may be considered appropriate by the Committee.

<u>Drug Abuse</u>. The issue of drug abuse is also a common concern. Like alcohol abuse this issue also has significant public relations, health and legal implications (Attachment F).

Membership Responsibilities. It has been suggested that many chapters do not have clear definitions of what they expect from their individual members. Alpha Sigma Phi convention delegates in 1986 and 1988 passed a "code of Conduct" to which all brothers and pledges should be committing themselves (Attachment J). The Committee may want to consider updating and improving this important document or affirming it by resolution.

Membership. The Grand Council has accepted an advisory committee suggestion creating an At-Large Membership status for male persons who did not have an opportunity for or did not choose Greek affiliation as an undergraduate, but who in later life desire Greek affiliation, subject to Grand Council approval. To adopt this suggestion, the Fraternity will have to take action to amend the constitution. The Committee may wish to make such a constitutional action.

<u>Parents Liaison</u>. The Grand Council, recognizing the importance of strong parents liaison has established that the second Prudential Committee Member-at-Large have that additional duty within the undergraduate chapter. The Committee may wish to affirm this action.

Pledge Program. As suggested by an unidentified chapter, a restructuring of the current pledge education program to better coincide with the overall purpose and goals of the Fraternity might be in order. Ideally, the pledging is a period of orientation designed to prepare the new members to become good brothers, administrators and officers; not good pledges. Antihazing is strictly enforced and stress should be placed on academics, time management, responsibility and leadership. To allow ample time to accomplish these goals, pledging activities such as community service, fundraising and house projects should be combined with house activities. This will promote integration of new members with the rest of the house, versus segregation as a pledge class and this will also end the misconception that initiation is an end to participation.

<u>Pledging</u>. Chapters on some campuses may be confronted with challenges from other fraternity chapters that they have a "no pledging period." Historically, Alpha Sigma Phi has had pledging periods commensurate with what was the campus "norm." While our Grand Council has reiterated that certain educational processing of non-initiated members is required, we have no designated pledge period. The only current restriction is that the pledge must be reported to Headquarters and that a request for initiation must be

submitted not later than ten days prior to the designated ritual date. Thus, we have no restriction, other than this ten day period. The Committee may want to consider minimum or maximum pledge periods (constant with host institution policies) and encourage initiation as soon as permitted by the host institution. In 1990, the convention unanimously voted to accept our present Position Statement on Positive Pledgeship (Attachment K). The Committee may want to review this document and make improvements or reaffirm by vote.

<u>Position Statements</u>. The Committee might want to recommend reaffirmation of the Grand Council Position Statement on Human Dignity (Attachment L), Racial and Religious Discrimination (Attachment M) and AIDS (Attachment N). Our Risk Management Policies on Pre-Initiation Activity and Hazing (Attachment C) and that of the FEA (Attachment O) may be of assistance.

<u>Risk Management</u>. Recognizing the extreme importance of risk management, property and fire safety, the Grand Council has included a risk management officer at the undergraduate chapter level in the role of the HJP and one for each alumni association or alumni corporation. The Committee might want to affirm this action.

Rush. Our average chapter size is 45 compared to the NIC average of 54. This places many of our chapters at a numerical and financial disadvantage on their own campus. The Committee may wish to address this issue and consider various solutions and recommendations.

Scholastic Performance. While many outstanding scholars are members of Alpha Sigma Phi, many chapters still have grade point averages below the allmen's average. The "Old Gal" was founded in 1845 as a literary society, but many members and chapters seemingly make scholarship a low priority. In the 1960 Report of the National Scholarship Chairman, Past Grand Senior President Raymond E. Glos reported, "Chapters must constantly be reminded that no chapter can be a really good chapter without regard to its scholarship standing." In 1988 the Convention approved a requirement for a minimum "C" GPA as a prerequisite for initiation. Now, making a recommendation to the delegation for a minimum sustained overall chapter GPA that exceeds some academic milepost may help in sending a signal message that Alpha Sigma Phi's first reason for being is "to foster education." One issue that may be considered for support is Gamma Sigma Alpha (Greeks Supporting Academics) and is contained in Attachment P.

Standards of Excellence. For years Alpha Sigma Phi had the "Minimum Standards." These came about from a desperate need to outline the minimum operating requirements a chapter needed before the chapter came up for revocation procedures. The problem is that these minimum standards have turned into "maximums" for some chapters. The Grand Council abolished the "minimum standards" knowing that a program was being created for excellence that would give every chapter something to strive for and create a "Roadmap to Success" for our chapters.

The Standards of Excellence program has been in the evolutionary process for six years. This program is not meant to mold every chapter to be alike, but rather as a model for what an Excellent Chapter should be. Over the years, the following comments have been recorded:

"I think the Road Map to Success concept is an excellent one. It can be used as a guide for chapters across the nation in our pursuit of excellence."

"This program has the potential to give all chapters the ability to take a close look at all its operations and then make provisions for improvement and change."

"It allows chapters to plan their operations, not just react to a lack of planning."

This program is a milestone in Alpha Sigma Phi's history. It has the ability to help improve Alpha Sig chapters as never before, making our entire Fraternity a better organization. This Committee may also want to address a proactive issue such as encouraging all chapters to have a minimum of one Grand Chapter Advisor and one Faculty Advisor continuously registered with the Fraternity Headquarters. The Committee may also want to make a statement concerning annual chapter retreats and chapter reports.

<u>Substance Free</u>. The trend toward substance free chapters and host institutions is increasing. Many chapters have recently received a complete reorganization into a "substance free chapter" after being disciplined by their general fraternity. Can a general fraternity be far behind? Information on this trend from BACCHUS is included as Attachment Q.

Tomahawk. The Committee may wish to consider the constitutional returning of <u>The Tomahawk</u> from a seven year to a lifetime subscription (Attachment R).

The Fraternity Executives Association

Statement of Position

on Alcohol

- While the moderate and legal consumption of alcohol, in and of itself, does not constitute a problem when conducted in a mature, socially responsible atmosphere, the illegal use and abuse of alcoholic beverages are widely recognized as a major problem in our society. As responsible members of society, particularly the higher education community, college fraternities are highly concerned about alcohol abuse.
- Considering that the majority of students on any college campus are underage, the purchase of alcohol, and in most cases its consumption, is illegal for the majority of the campus student population. Typically, fraternity membership is lower in average age than the campus in general, making alcohol illegal for the majority of chapter members.
- In its Statement of Position on Dry Rush, the Fraternity Executive Association, Inc., has stated its belief that the excessive and/or illegal use of alcohol to attract young men to fraternity membership is counterproductive to introducing and developing true brotherhood. Believing this to be true to the concept of brotherhood on the broader scale and considering recent state laws across the country which have made alcohol illegal for the majority of chapter membership, the Fraternity Executives Association takes the following position on alcohol in the life of the fraternity.
 - 1. The possession, use, and/or consumption of alcoholic beverages while on chapter premises during an official fraternity event, or in any situation sponsored or endorsed by the fraternity chapter, must be in compliance with any and all applicable laws of the state, province, county, city and university.

2. No alcohol should be present at any pledge/associate member/novice program or activity of the chapter.

3. No chapter member should permit, tolerate, encourage, or participate in "drinking games."

4. The image of fraternity is not enhanced by the co-sponsorship of an event with an alcohol distributor, or tavern, and therefore, this type of activity should be actively discouraged.

5. Open parties, meaning those with unrestricted access by non-members of the fraternity, without specific invitation, are counterproductive to the interests of the fraternity chapter and the fraternity system, and should be actively discouraged.

6. With less than half of the members of the average fraternity chapter legally able to consume alcoholic beverages, it is believed by the Fraternity Executives Association that alcoholic beverages should not be purchased through the chapter treasury nor purchased for members or guests in the name of or on behalf of the chapter.

7. The fraternity with its important responsibility to the development of its youngest members should not permit chapter members, collectively or individually, to purchase, serve, or sell alcoholic beverages to any minor (i.e., those under legal drinking age).

• The members of the Fraternity Executives Association, Inc., who serve as the chief administrative or executive officers of their college fraternal associations, believing that the long-term health and beneficial nature of the American college fraternity system is dependent upon responsible actions by student members of the system, hereby encourage and actively recommend that the concepts set forth in this Statement of Position on Alcohol be actively promoted and communicated within the college communities across North America and that each member of the Fraternity Executives Association actively support these concepts in principle, in spirit, and in philosophy to the betterment of the American college fraternity system.

FRATERNITY INSURANCE PURCHASING GROUP Risk Management Policy

The Risk Management Policy of the Fraternity Insurance Purchasing Group includes the provisions which follow and shall apply to all entities and all levels of fraternity.

ALCOHOL AND DRUGS

- 1. The possession, use and/or consumption of ALCOHOLIC BEVERAGES while on chapter premises, during an official fraternity event, or in any situation sponsored or endorsed by the chapter, must be in compliance with any and all applicable laws of the state, province, county, city and institution of higher education.
- 2. No alcoholic beverages may be purchased through the chapter treasury nor may the purchase of same for members or guests be undertaken or coordinated by any member in the name of or on behalf of the chapter. THE PURCHASE AND/OR USE OF A BULK QUANTITY OF SUCH ALCOHOLIC BEVERAGE, I.E., KEGS, IS PROHIBITED.
- 3. No chapter members, collectively or individually, shall purchase for, serve to, or sell alcoholic beverages to any minor (those under the legal "drinking age").
- 4. The possession, sale and/or use of any ILLEGAL DRUGS or CONTROLLED SUBSTANCES at any chapter house, sponsored event, or at any event that an observer would associate with the fraternity, is strictly prohibited.
- 5. No chapter may co-sponsor an event with a distributor of alcohol, charitable organization or tavern (tavern defined as an establishment generating more than half of annual gross sales from alcohol) where alcohol is given away, sold, or otherwise provided to those present.
- 6. No chapter may co-sponsor or co-finance a function where alcohol is purchased by any of the host chapters, groups, or organizations.
- 7. All rush activities associated with any chapter will be DRY rush functions.
- 8. *OPEN PARTIES*, meaning those with unrestricted access by non-members of the fraternity without specific invitation, where alcohol is present, shall be prohibited.
- 9. No member shall permit, tolerate, encourage or participate in "drinking games".
- 10. No alcohol shall be present at any pledge/associate member/novice program or activity of the chapter.

HAZING

No chapter shall conduct hazing activities. Hazing activities are those defined as:

"Any action taken or situation created, intentionally, whether on or off fraternity premises, to produce mental or physical discomfort, embarrassment, harassment or ridicule. Such activities may include but are not limited to the following: use of alcohol; paddling in any form; creation of excessive fatigue; physical and psychological shocks; quests, treasure hunts, scavenger hunts, road trips or any such activities carried on outside or inside the confines of the chapter house; wearing of public apparel which is conspicuous and not normally in good taste; engaging in public stunts and buffoonery; morally degrading or humiliating games and activities; and any other activities which are not consistent with fraternal law, ritual or policy or the regulations and policies of the educational institution."

SEXUAL ABUSE

The fraternity will not tolerate or condone any form of sexually abusive behavior on the part of its members, whether physical, mental or emotional. This is to include any actions which are demeaning to women and/or men, including but not limited to, date rape, gang rape or verbal harassment.

FIRE, HEALTH AND SAFETY

- 1. All chapter houses shall, prior to, during and following occupancy, meet all local fire and health codes and standards.
- 2. All chapters must have posted by common phones emergency numbers for fire, police and ambulance and must have evacuation routes from chapter houses, common areas and sleeping rooms posted in said areas and on the back door of each sleeping room.
- 3. All chapters shall comply with engineering recommendations as reported by the insurance company.
- 4. The possession and/or use of firearms or explosive devices of any kind within the confines and premises of the chapter house is expressly forbidden.

EDUCATION

Each student member, associate member and pledge shall be instructed annually on the Risk Management Policy of the Alpha Epsilon Pi Fraternity, Inc.

ALPHA SIGMA PHI RISK MANAGEMENT POLICIES

Passed by Grand Council August 3, 1989 Revised March 4, 1990

The founding principles of Alpha Sigma Phi, beautifully explained in our Ritual, guide us to achievement of our ultimate human potential. This purpose is expressed simply in our open motto "To Better The Man." Unfortunately, chapters may stray from these guiding principles from time to time. It is the responsibility of the Grand Council to uphold the standards of Alpha Sigma Phi. The following policies have been developed to provide chapters with specific guidance regarding their activities. Members of Alpha Sigma Phi--including, but not limited to, chapter officers, volunteer alumni advisors, and Fraternity Headquarters Staff--are expected to report violations of these policies immediately to the Grand Council through the National Headquarters. Violations of these policies cannot be tolerated, and the Grand Council will take action on each violation discovered.

POLICY ON PRE-INITIATION ACTIVITIES AND HAZING

Alpha Sigma Phi was founded upon sacred principles which include the Law of Brotherly Love. The Pledge Education Program a chapter develops should emphasize the development of brotherhood among all members, pledges and brothers alike. Pledge Education is also a time for learning about the Fraternity--its history, traditions, organizations and operation. Chapters that teach all these things to a pledge will be preparing him well for his responsibilities as a brother, and will secure the strength of the chapter into the future.

Unfortunately, sometimes a chapter will stray from the true purposes of pledge education and sanction activities which run counter to these purposes. It has therefore become necessary to develop a policy concerning these counter-productive activities, to insure that they are short-lived. The purpose of this policy is to provide for the health and safety of all Alpha Sigma Phi brothers and pledges, to encourage a strong sense of brotherhood within each chapter and colony, and to earn the respect of the campus and community by engaging in activities beneficial to those groups.

Alpha Sigma Phi Fraternity forbids its chapters and colonies to sponsor any preinitiation activity that may be "dangerous" or "potentially dangerous" to the physical and mental health of any person, to the level of brotherhood within each of its chapters and colonies, and to the level of respect on campus and in the community of which all Alpha Sigma Phi brothers and pledges are worthy. "Sponsorship" is defined as "peer-group supported," as well as a sanctioned activity.

ACTIVITIES INVOLVING ALCOHOL

Activities engaged in by Alpha Sigma Phi chapters and chapter members should always comply with all state, local, and university rules and regulations, including those regarding alcohol and illegal drug usage. The following policy should be followed by every chapter and chapter member regarding the legal use of alcohol:

- 1. Alcoholic beverages shall not be purchased through the chapter treasury nor shall the purchase of same for members or guests be undertaken or coordinated by any member in the name of or on behalf of the chapter.
- 2. If a chapter allows members and guests to "bring their own" alcohol to chapter functions, then:
 - A. The Chapter is responsible for assuring that the alcohol is consumed legally and responsibly.
 - B. The Chapter shall not allow individuals to make available common sources of alcohol (such as kegs, etc.)
 - C. Alternative beverages (non-alcoholic) shall be provided. These should be set in plain sight, labeled as non-alcoholic.
 - D. Food of substantial quality shall be made available, free of charge for everyone. (High protein foods, i.e., cheese, meats, unsalted nuts are strongly encouraged.)
 - E. Rides or escorts shall be provided for those unable to drive or walk themselves home.
- 3. Alpha Sigma Phi chapters shall not sponsor "open parties" in any form. All parties shall be limited to chapter members and invitees. Capacity of any event should comply with the Fire Safety Codes set by the proper authority.
- 4. There shall always be two sober party monitors at every event who will be trained to deal with any situations as they arise.
- 5. Chapters shall not co-sponsor an event with an alcohol distributor, charitable organization or tavern (tavern defined as an establishment generating more than half of annual gross sales from alcohol) where alcohol is given away, sold or otherwise provided to those present.
- 6. All rush, pledging, and ritual activities associated with any chapter shall be non-alcoholic, Dry functions.
- 7. Chapter members shall not permit, tolerate, encourage or participate in "drinking games."
- 8. Anyone arriving at an Alpha Sigma Phi event already intoxicated shall not be admitted to the function.
- 9. Chapters shall not co-sponsor or co-finance a function where alcohol is purchased by any of the host chapters, groups or organizations.

Alpha Sigma Phi Fraternity Adheres to the following:

Fraternity Insurance Purchasing Group Risk Management Policy

The Risk Management Policy of the Fraternity Insurance Purchasing Group includes the provisions which follow and shall apply to all fraternity parties and all levels of fraternity membership.

ALCOHOL AND DRUGS

- 1. The possession, use and/or consumption of ALCOHOLIC BEVERAGES, while on chapter premises, during an official lfraternity event, or in any situation sponsored or endorsed by the chapter, must be in compliance with any and all applicable laws of the state, province, county, city and university.
- No alcoholic beverages may be purchased through the chapter treasury nor may the purchase of same for members or guests be undertaken or coordinated by any member in the name of or on behalf of the chapter.
- 3. No chapter members, collectively or individually, shall purchase for, serve to, or sell alcoholic beverages to any minor (i.e., those under legal "drinking age").
- 4. The possession, sale and/or use of any ILLEGAL DRUGS or CONTROLLED SUBSTANCES at any chapter house, sponsored event or at any event that an observer would associate with the friemity, is strictly prohibited.
- 5. No chapter may co-sponsor an event with an alcoholic distributor, charitable organization or tavern (tavern defined as an establishment generating more than half of annual agross sales from alcohol) where alcohol is given away, sold or otherwise provided to those present.
- 6. No chapter may co-sponsor or co-finance a function where alcohol is purchased by any of the host chapters, groups or organizations.
- 7. All rush activities associated with any chapter will be a DRY rush function.
- 8. OPEN PARTIES, meaning those with unrestricted access by non-members of the fraternity, without specific invitation, shall be prohibited.
- 9. No member shall permit, tolerate, encourage or participate in "drinking games."
- 10. No alcohol shall be present at any pledge/associate member/novice program or activity of the chapter.

HAZING

No chapter shall conduct hazing activities. Hazing activities are defined as:

"Any action taken or situation created, intentially, whether on or off fraternity p[remises, to produce mental or physical discomfort, embarrassment, harassment, or ridicule. Such activities may include but at not limited to the following: use of alcohol; paddling in any form; creation of excessive fatigue; physical and psychological shocks, guests, treasure hunts, scavenger hunts, road trips or any other such activities carried on outside or inside of the confines of the chapter house; wearing of public apparel which is conspicuous and not normally in good taste; engaging in public stunts and buffoonery; moral degrading or humiliating games and activities; and any other activities which are not consistent with fraternal law, ritual or policy or the regulations and policies of the educational institution."

SEXUAL ABUSE

The fraternity will not tolerate or condone any form of sexaually abusive behavior on lthe part of its members, whether physical, mental or emotional. This is to include any actions which are demaning to women including but not limited to date rape, gang rape or verbal harassment.

FIRE, HEALTH AND SAFETY

- 1. All chapter houses shall, prior to, during, and following occupancy, meet all local fire and health codes and standards.
- All chapters must have posted by common phones, emergency numbers for fire, police and ambulance and
 must have posted evacuation routes from chapter houses, common areas as well as posted on the back of
 the door of each sleeping room.
- 3. All chapters shall comply with engineering recommendations as reported by the insurance company.
- 4. The possession and/or use of firearms or explosive devices of any kind within the confines and premises of the chapter house is expressly forbidden.

EDUCATION

Each student member, associate member and pledge shall be instructed annually on the Risk Management Policy of the Fraternity Insurance Purchasing Group.

POSITION STATEMENT ON SUBSTANCE ABUSE

- WHEREAS, Alpha Sigma Phi is the fraternity "TO BETTER THE MAN" and all of her functions and actions should exhibit this as listed in our *Code of Conduct*, and
- WHEREAS, our Constitution and By-Laws, Article XVII, section 1 and section 3, prohibits illegal alcohol and substance use and prohibits inappropriate conduct of members of our fraternity, and
- WHEREAS, the illegal use of substances or abuse of legal substances is in direct opposition to the purpose our organization "TO BETTER THE MAN."

 It does not foster brotherhood, demonstrate leadership or help to build a better community.

THEREFORE,

- BE IT RESOLVED, that all members of our fraternity be educated on the perils of substance use and abuse. That peer pressure is used in a positive manner of responsibility and influence.
- BE IT RESOLVED, that all chapters, colonies and alumni organizations promote and participate in peer intervention strategies for brothers and/or pledges with symptoms of substance addiction as well as responsible use of legal substances.
- BE IT FURTHER RESOLVED, by the Grand Council of Alpha Sigma Phi Fraternity that it is the position of our fraternity that no illegal substances shall be used in the structure of our fraternity nor shall the abuse of legal substances be encouraged or tolerated at fraternity events.

National Interfraternity Conference FRATERNITY CRITERIA

The 200-year-old, tradition-rich fracturity system is uniquely qualified to contribute positively to the primary functions of colleges and universities. Recognizing that a partnership exists between the fraternities and the bost institutions to promote the most complete personal, intellectual, physical and social development of its members, the NIC fraternities affern that:

- L. The objectives and activities of undergraduate chapters be in accord with the aims and purposes of the institution where the chapter is located.
- II. Undergraduate chapters build within their ranks, through participation in campus and Greeklife, long-lasting supportive loyalties to the institution; it be mutually recognized that fraternities, founded on idealism, riperced on beritage, and nurtured by lifelong allegiances, offer colleges a valuable ally in providing students with a sustaining and rewarding college experiences.
- 111. Undergraduate fraternity chapters, working in a spirit of cooperation with their alumni and representatives of the college, promote conduct consistent with responsible behavior and citizenship.
- IV. A primary goal of our undergraduate chapters be to create an atmosphere which will stimulate substantial intellectual achievement and leadership development.
- V. Praternity chapters where housed be in quarters that are safe and wholesome in atmosphere.
- VI. Undergraduate chapters demonstrate principles of sound Susiness practice in chapter financial management and that they inculcate a similar sense of responsibility within each member.

The NIC fraternities seek to meet these criteria through a close exoperative partnership between our organizations at all levels with the faculty and administrative authorities of the institutions. We view it critically important that college representatives work positively with undergraduans and alumni members of their fraternities extending beyond a relationship limited by legal and procedural boundaries.

RESOLUTION REGARDING

"LITTLE SISTER" GROUPS

WHEREAS, the National Interfraternity Conference believes sororities and women's fraternities offer excellent opportunities for women to share a fraternal experience, and

WHEREAS, auxiliary women's groups organized by men's fraternity chapters, commonly referred to as "little sisters" are inconsistent with the concept and philosophy of separate and equal women's fraternities, and

WHEREAS, the National Interfeateralty Conference believes that these groups inhibit the accomplishment of chapter goals by:

- *DIVERTING resources of time, effort and money, which are needed for chapter operations and programming;
- *DISTRACTING chapter members in the performance of essential duties... e.g., membership recruitment and membership education;
- *INVITING disharmony within the chapter by exerping the roles and responsibilities of initiated members;
- *WEAKENING the bonds of brotherhood by adversely affecting interpersonal relationships within the chapter; and

WHEREAS, the Fraternity Executives Association and several member fraternities have taken a position against these auxiliary groups,

BE IT RESOLVED, That the National Interference in Conference and the Presidents of its member fraternities believe that "little sister" groups are not desirable adjuncts to the collegiate chapters of men's fraternities and urges and recommends that member fraternities work with their chapters to eliminate these programs at the earliest possible time.

STATEMENT OF POSITION

ON EXPANSION

The member (raternities of the National Interfratemity Conference believe the establishment of new chapters to provide a fraternity experience for an increasing number of college students to be in the best interests of higher education and of the fraternity movement.

To this end, the member framenities of the Conference agree to:

Educate their undergraduate chapters and the Interfraternity Council leaders and interested alumni about the overall benefits and responsibilities of expansion and to foster ongoing support for the growth of the fraternity movement.

Offer only those statements and promises in expansion discussions which accurately reflect their capabilities.

Encourage the highest academic, social and moral standards among all interested students in all expansion endeavors.

Make every reasonable attempt to coordinate expansion effort with the administration and with the Interfraternity Council of colleges and universities at which they are pursuing expansion opportunities.

Recognize that the size of a member fraternity is not indicative of that member fraternity's ability to administer an expansion project at any particular institution.

Respect the right of any organized collegiant group to seek a member fraternity of its choice in an effort to affiliate with that general fraternity.

Request approval of the appropriate college or university official before granting colony status.

(Adopted by unanimous vote of the NIC House of Delegates - December 3, 1983)

RESOLUTION ON ALCOHOL

WHEREAS, The NIC House of Delegates and its member fraternities are concerned about the becreasing consumption and abase of alcoholic beverages on college campuses, and

WHEREAS, The dangers of misuse of sleebed to individuals, to groups, to the frateroity system and to the campus community are becoming increasingly evident, and

WHEREAS, An affirmative program to deal with the problems will only be effective by common consent and milled action.

NOW THEREFORE BE IT RESOLVED By the NIC that the following policies be adopted and be recommended to its member organizations for their adoption:

- That the possession, use, sale and/or consumption of alcoholic beverages on the premises of any chapter or at any emertainment or function of any chapter shall be in compliance with all applicable laws.
- That moderation be encouraged during lawful consumption, and that chapters develop and support programs and those groups and organizations seeking to educate chapter members on alcohol awareness.
- That open parties, meaning those with unrestricted access, where structured around the sale or consumption of alcoholic beverages shall be prohibited.
- 4. That zon-alcoholic rush shall be actively promoted on all campuses.
- That there shall be no open solicitation or encouragement of alcoholic consumption or promotions in any chapter.

(Adopted by maximous vote of the NIC House of Delegates - December 3, 1983)

LITTLE SISTER OR FRATERNITY MEMBER?

Many fraternities are affiliated to varying degrees with le sister organizations. These fraternities should be mind-of the fact that if the fraternity and affiliated little sister organization are structurally intertwined, the fraternity may face a challenge to its ability to exclude women from its general membership.

Someone wishing to assert such a challenge would undoubtedly scrutinize the relationship between the fraternity and the little sister organization. When this is done, the following factors might play a role in determining membership eligibility:

- Does the fraternity chapter possess absolute authority to create and disband the little sister organization? The fraternity generally exercises this power through a vote of the chapter membership.
- Does the fraternity chapter charge the little sisters a pledge or initiation fee? In addition, some fraternities require that the little sisters pay semesterly dues to the treasurer of the fraternity.
- How does the fraternity participate in decisions on the selection of members of the little sister organization? The control which the fraternity chapter exercises over the selection process varies depending on the fraternity chapter. In some cases, the membership of the fraternity chapter makes all decisions on the membership of the little sister organization. In other cases, the decisions on membership are made by a joint committee of members of the fraternity and members of the little sister organization.
- Does the fraternity chapter make decisions in regard to the approval of the bylaws and constitution of the little sister organization? Additionally, does the fraternity refer to the little sister organization in its own bylaws or constitution? Some chapter bylaws provide for a Little Sis Chairman who acts as a liaison between the fraternity and the little sister organization. Typically, the Little Sis Chairman is charged with coordinating the fraternity chapter and the little sister organization on social events and special events and projects.
- Does the little sister organization hold its meetings in the fraternity chapter house?
- Are the little sisters' composite pictures hung in the chapter house (sometimes together with the composite pictures of the chapter members)?
- Does the fraternity chapter have the authority to approve or disapprove of the activities of their little sister organization?

The more intertwined the affairs of the fraternity chapter are with those of the little sister organization, the more the fraternity chapter jeopardizes its status as a single sex organization. If a court perceives from the answers to the questions presented above, and perhaps others, that the fraternity chapter and the little sister organization are in essence functioning

as a single organization, the fraternity may find it difficult legally to exclude female applicants from membership in the fraternity chapter itself. In order to avoid potential problems, the fraternity chapter should strive to stay as independent as possible from its little sister organization.

If the fraternity and its little sister organization are too closely intertwined, the membership policy of the fraternity may be challenged.

In Roberts v. United States Jaycees, 462 U.S., ___ 82 L.Ed.2d 462 (1984), the United States Supreme Court established general guidelines which fraternities must follow in order to preserve their single sex status. First and foremost the fraternity must retain its "high degree of selectivity" of membership and "seclusion from others in critical aspects" of the operation of the fraternity. The functioning of the fraternity chapter and its little sister organization as a common unit at social events and special events, along with the other factors of control outlined above, could open the fraternity chapter to female membership under the standards set forth in the Jaycees case.

In addition to jeopardizing its single sex status, a fraternity chapter may unnecessarily subject itself to liability for conduct of members of the little sister organization. If the fraternity exercises significant control over the organizational structure, membership and functions of the little sister organization with which it is affiliated, the fraternity may create an agency relationship.

The fraternity's bylaws and constitution should not refer to the little sister organization.

If the little sisters are considered agents of the fraternity, the fraternity may be responsible for closely supervising the conduct of the little sisters. The fraternity may then be responsible for injuries that occur at or after little sister events or parties to the same extent as if it were the fraternity's own party or event.

Fraternities should examine their relationship with affiliated little sister organizations. If the fraternity's bylaws or constitution refer to a little sister organization, it should consider amending these documents to delete the references. It is in the best interest of the fraternity that little sister organizations remain as independent as possible from the fraternity. Otherwise, the "little sister" may suddenly become a fraternity member in the eyes of the law.

Alpha Signs Eld Fravernity, Inc.

At the Sigma Alpha Epsilon 135th National Convention, held in San Diego, California last summer, the delegates to the Convention voted to permanently disband all little sister organizations effective January 1, 1992. This essentially means that any ΣAE Chapters which are currently operating a little sister program of any kind will have to cease the program on the stated date.

Although this will come as disappointing news to many, we believe it was an insightful action on the part of the delegates. There were a number of issues which led to this action, and each of them have a direct effect on our organization, the Greek system's future, and, most importantly, the well-being of individuals.

This issue has been raised at each National Convention since 1987 and each year has gained momentum as we witnessed more and more all-male groups lose their right to single sex membership.

Undergraduate groups such as Princeton's all-male eating clubs were recently instructed to open their membership to women. The little sister programs only threaten to put our organization and others in a position of having to do the same.

Of equal importance have been the problems associated with sexual harassment in these programs. On too many occasions, little sister programs have involved behavior that does not reflect with the "True Gentleman" or the ideals or values of Sigma Alpha Epsilon.

Chapter programming and operations have suffered in many chapters as a result of too much emphasis being placed on the organization of the little sister program; therefore, areas such as scholarship, rush, pledge education and community involvement have suffered.

Most colleges and universities and/or the local IFC and Panhellenic Councils have already banned these programs on campus and more follow suit everyday. Many other National Fraternities, such as Alpha Tau Omega, Lambda Chi Alpha, Sigma Chi, and Sigma Phi Epsilon, have already taken similar action in their organizations.

In turn, the value placed upon this bonding is such that the educational experience can only be fulfilled gradually. This assures the security of our Reasons for Being.
- BE IT FURTHER RESOLVED, that the pledgeship of Alpha Sigma Phi is of vital importance to the continuation of the traditions and values of the fraternity.





POSITION STATEMENT ON HUMAN DIGNITY

- WHEREAS, Alpha Sigma Phi is the fraternity "TO BETTER THE MAN" and all of her functions and actions should exhibit this as listed in our Code of Conduct, and
- WHEREAS, every human being deserves to be treated with dignity and not harassed, tormented, abused or violated by another human being, and
- WHEREAS, our fraternity's Code of Conduct states that each member "will respect the dignity of all persons, and therefore, I will not physically, psychologically or sexually abuse any human being," and
- WHEREAS, we instill the principles of diligence, honor, integrity, virtue, duty and respect for human dignity.

THEREFORE

- BE IT RESOLVED, that all chapters, colonies and alumni organizations follow the Code of Conduct and educate our membership on the value of each person.
- **BE IT RESOLVED,** that there is no place in our fraternity for those who think anyone should be treated as a sub-human or a lower class citizen.
- BE IT FURTHER RESOLVED, by the Grand Council of Alpha Sigma Phi Fraternity that it is the position of our fraternity that everyone should be treated with dignity and respected for their individual rights and principles.





POSITION STATEMENT ON RACISM AND RELIGIOUS DISCRIMINATION

- WHEREAS, Alpha Sigma Phi is the fraternity "TO BETTER THE MAN" and all of her functions and actions should exhibit this as listed in our *Code of Conduct*, and
- WHEREAS, we believe that all people are created equal and should have the right to be treated the same no matter what their ethnic or religious background may be, and
- WHEREAS, Alpha Sigma Phi abolished discrimination based on ethnic or religious criteria at the National Convention in 1950 and supports equal treatment among men, and
- WHEREAS, racism is counter to everything that Alpha Sigma Phi stands for. It does not encourage bonds of friendship based upon individual merit and achievement. It does not demonstrate leadership. It does not prove an individual's or a group's superior qualifications in any way.

THEREFORE

- BE IT RESOLVED, that the spirit of brotherhood knows no color, creed, religion, or national origin; we are working actively to promote cultural, religious and racial diversity in our memberships and will oppose acts of racism and religious discrimination.
- BE IT RESOLVED, by the Grand Council of Alpha Sigma Phi Fraternity that it is the continuing position of our fraternity that membership privileges should be granted to any qualified candidate without consideration of ethnic or religious background.





POSITION STATEMENT ON AIDS

- WHEREAS, Alpha Sigma Phi is the fraternity "TO BETTER THE MAN" and all of her functions and actions should exhibit this as listed in our *Code of Conduct*, and
- WHEREAS, we strive at all times to be educated about the world situations and strive to educate our brothers so that they can be better informed citizens, and
- WHEREAS, we are a brotherhood of gentlemen who extend brotherly love and concern to all brothers and friends of Alpha Sigma Phi Fraternity, and
- WHEREAS, the membership of Alpha Sigma Phi is knowledgeable of and concerned with the epidemic of ACQUIRED IMMUNE-DEFICIENCY SYNDROME (AIDS), and we realize that <u>all</u> persons are at risk who are active sexually regardless of sexual orientation.

THEREFORE,

- BE IT RESOLVED, that all chapters, colonies and alumni organizations educate our membership about how AIDS is transmitted and what precautions can and should be taken to lessen the risk of being infected.
- BE IT RESOLVED, that any brother/pledge who contracts the AIDS virus is entitled to all of the rights and privileges that our fraternity can extend to him; and shall not be condemned for any activity which may have led to this situation.
- BE IT FURTHER RESOLVED, by the Grand Council of Alpha Sigma Phi Fraternity that it is the position of our fraternity that any brother or pledge who contracts the AIDS virus is indeed no less a brother.



The Fraternity Executives Association

Statement of Position

on Hazing and Pre-Initiation Activities

The Fraternity Executives Association has stated its position, periodically, in support of constructive educational and inspirational programs and has asserted unequivocally its opposition to hazing and pre-initiation activities which do not contribute to the positive development and welfare of pledges and members.

Because hazing and other pseudo-initiation practices have not been rejected and eradicated completely in undergraduate activities and therefore remain a menace to the well-being of the College Fraternity System, the Fraternity Executives Association reaffirms and reasserts its position on this question.

- The Association believes that true fraternalism is nurtured in an atmosphere of social and moral responsibility, respect for duly constituted authority and loyalty to the principles of higher education.
- The Association further believes that while social behavior cannot be legislated, a fraternity without morally sound precepts and practices is not a constructive influence upon college men.
- The Association further believes that a fraternity has a solemn obligation in the development of its pledges and members and that this responsibility extends alike to the institutions where it is represented; to parents and others who make possible the education of pledges and members; to the communities where chapters are accountable for good citizenship; and to the college fraternity system of which it is a part.
- The Association further believes the fact that much progress has been made, that one of the most damaging instruments to the fraternity system is the employment of a program of

- education, which includes, hazing, and that this unproductive, ridiculous and hazardous custom has no rightful place in the fraternity system.
- The Association defines hazing as any action taken or situation created, intentionally, whether on or off fraternity premises, to produce mental or physical discomfort. embarrassment, harassment or ridicule. Such activities and situations includes paddling in any form; creation of excessive fatigue: physical and psychological shocks; quests, treasure hunts, scavenger hunts, road trips or any other such activities carried on outside the confines of the house; wearing, publicly, apparel which is conspicuous and not normally in good taste; engaging in public stunts and buffoonery; morally degrading or humiliating games and activities; late work sessions which interfere with scholastic activities and any other activities which are not consistent with fraternal law, ritual or policy or the regulations and policies of the educational institution.

Attention trend watchers!



We have seen "substance-free" residence halls gaining huge popularity at campuses of all sizes this year. It seems to be the "cool" thing to do, and this is the first publicized example of a "substance-free" fraternity house that I've seen. A Sobering Pledge

RONO, Maine—The spring social season was in full swing along the University of Maine's fratemity row, with a beer bust at Phi Delta Theta, a beer and barbecue party at Sigma Nu, the usual weekend-long, flood of suds at Delta Tau Delta, and at Sigma Chi, an evening of . . . milk and cookies.

"There were a lot of women here, and they all seemed to be having a great time," said fra-ternity president Tyler Bat-teese. "It was a great success."

It was also the group's first social function in its new incarnation as an organization that permits no alcohol, no tobacco and no drugs stronger than aspirin on its premises.

In an undergraduate social structure where drinking is a virtual assumption, one bachanalian blowout too many joited Sigma Chi into a re-examination of its purposes and an overnight yow of sobriety. "We're still going to socialize," Batteese asid. "It's just that our events are not going to contain alcohol."

The local chapter of Sigma Chi purports to be the nation's first chemical-free college fra-ternity, and the move put the emphasize its use.

The weekend-long rampage was common practice at most nouses, fraternity members houses, fraternity members here insist. As the sole undergraduate occupant of the rambling old house, he found ample opportunity to reflect on what he believes to be the purpose of fraternal organizations in the 1990s: "This is a new era.

"If the purpose is to hang out together and drink," he said, "then you have to rethink."

This kind of logic, however, places Batteese in a minority. Without a perpetual beer keg, a fraternity is almost unimaginable. many students said.

"That's for sure," said Kerrie Johnson, a 21-year-old psychology major who was doing stretching exercises in front of the Delta Tau Delta house here.

"I just can't see how they're going to get very many people" with their no-chemicals requirements, Johnson said.

Pi Beta Phi sorority member Debbie Lebrun echoed her friend's sentiments. "It seems like everybody who wants to join a sorority or fraternity is kind of social." the 20-year-old psychology major said. "Alcohol just kind of makes people more social."

To Batteese, however, the notion of excessive drinking is at odds with the kind of socializing he would like his fraternity to pro-

"There are people out there, believe it or not, who are our age and who don't drink, or who do so responsibly," Batteese said. He, for example, is just as likely as the next guy to head for the local watering hole and quaff a few pints. "I'm just not going to go back and throw furniture through the window," he said.

"It's not like I'm some kind of Prohibitionist." Batteese continued. "I'm no fanatic. But I am fanatically committed to this idea."

The chemical-free program intrigued M.E. Prichard, the president of the Sigma Chi Charitable Foundation in Evanston, Ill., "because I'm old enough to have been in college (when) there wasn't beer and booze in the fraternities." That was in the 1940s, and "we managed to survive."

Prichard said the ideas of liability and risk-management also figured in the decision to support the chemical-free policy at the University of Maine. "They're all time bombs out there, where there are no restrictions." Prichard said of houses where excessive drinking goes on.

Most of the trouble he hears about on campus is "drink-related." said Prichard. "There's still an enormous amount of beer consumed out there.'

Dwight Rideout, the University of Maine's dean of student services. praised Sigma Chi's action: "We believe they're where fraternities need to be to succeed in the '90s.

"We're going to watch them

Sigma Chi president Tyler Batteese: "it's not like I'm some kind of Prohibitionist. I'm no fanatic. But I am fanatically committed to this idea."

very closely," he added. "We know that if they're successful, others will head in that direction—and we see that as very positive."

Just in the last few months, Batteese managed to recruit 10 new members who have promised to uphold Sigma Chi's chemicalfree rules. Garrick Frost, 18, said he signed on because "I wasn't impressed with what I saw at the other houses. I mean, guys riding bikes through the house and smoking pot all the time. I wasn't brought up like that."

Another new member, Andrew Dionne, 18, said he thought four years of beer busts was a good way to waste his college education. But. he added: "We're not saying we're a bunch of stiffs. We've said that this is a chemical-free house, not that we're chemical-free guys."

As for whether the absence of wild parties may mean that this Greek house will become known as a geek house, Sigma Chi pledge Brian Feldman, 18, said: "People

who say that don't know us. If they don't take the time to find out what we're about, who cares what they think?'



1992 National Leadership Conference & Convention

DATE: March 20, 1992

The Constitution of our Fraternity is scheduled to be amended at the 1992 National Meeting.

The Grand Council has recommended that the seven year <u>Tomahawk</u> subscription constitutional limit be returned to a lifetime subscription, thereby changing Article III, Section 9 as follows:

All Chapters of this Fraternity shall supply each member at the time of initiation with an official badge, paraphernalia (to be held by him so long as he shall remain a member), and a 7-year (lifetime) subscription to The Tomahawk.

The by-laws would then be changed as follows:

(Article XI, Section 6G)

A seven-year (lifetime) subscription to The Tomahawk for each member to be initiated.

(Article XIV, Section 1)

A fee in the amount of one hundred ten dollars (\$110.00) shall be paid to the Fraternity for every initiate by the Chapter desiring to admit him to membership before authorization shall be issued. Said fee shall include costs of an official badge, shingle, and seven-year (lifetime) subscription to The Tomahawk for each initiate. All undergraduate members, activities and pledges, of a Chapter as of July 1, 1990, shall pay to the Fraternity Undergraduate Dues of sixty dollars (\$60.00) per year.

(Article XV, Section 1)

The Tomahawk shall be the official exoteric publication of the Fraternity. It shall be available to all members during the natural life of each for those initiated prior to September 1, 1980, and for seven years for those initiated after September 1, 1980.

Additional amendments to the Constitution may be considered at this time, provided they comply with the existing constitutionally provided process.

1990 REPORT FROM

THE COMMITTEE ON CHAPTER STANDARDS AND ETHICS

- Whereas, It is understood that Alpha Sigma Phi is based on charity and philanthropy, and
- Whereas, Alpha Sigma Phi Fraternity expects its members to participate in helping those that are less fortunate than ourselves,
- Be It Resolved that the 1990 National Convention propose that the Grand Council consider adopting a national philanthropy.
- Whereas, Certain communities where member chapters are located may receive negative racial connotations from the Black Lantern Processional, and
- Whereas, Alpha Sigma Phi abolished discrimination based on ethnic or religious criteria at the National Convention in 1950 and supports equal treatment among men, and
- Whereas, The chapters of Alpha Sigma Phi strive to promote good relations with their campuses and communities,

Therefore.

- Be It Resolved that the 1990 National Convention recommend making the white robe optional in the Black Lantern Processional when community pressure dictates it, or a suit and tie may be worn in the place of all robes.
- Whereas, The Standards of Excellence is a program designed to give every chapter a vehicle to develop outstanding levels of performance, and
- Whereas, The Standards of Excellence program has been formally adopted by the 1988 National Convention,
- Be It Resolved, that the 1990 National Convention make the Standards of Excellence program required participation for all chapters.
- Whereas, Alpha Sigma Phi is the fraternity "To Better The Man" and all of her functions and actions should exhibity this as listed in our Code of Conduct, and
- Whereas, Our Constitution and By-Laws, Article II, Section 2, lists the three categories of membership: undergraduate, alumnus, or faculty, not mentioning any such status as an "Inactive Member,

Therefore,

- Be It Resolved, that all members shall be classified as either undergraduate, alumnus, or faculty member.
- Be It Resolved, that at no time shall a status of "Inactive" member exist because of financial difficulties.
- Be It Resolved, Article XVIII, Section 2 of the Constitution, chapters may impose suspension or expulsion on a member because of financial difficulties pending approval of the Grand Council.
- Be It Further Resolved, that all members are obligated to fulfill their (financial) responsibilities to the Fraternity, or risk sanctions as outlined in the Constitution.
- Whereas, Alpha Sigma Phi is the fraternity "To Better The Man" and all of her functions and actions should exhibit this as listed in our Code of Conduct, and
- Whereas, our Constitution and By-Laws, Article XVII, Section 1 and 3, prohibits illegal alcohol and substance use and prohibits inappropriate conduct of members of our fraternity, and
- Whereas, the illegal use of substances or abuse of legal substances is in direct opposition to the purpose of our organization "To Better The Man." It does not foster brotherhood, demonstrate leadership or help to build a better community.

Therefore,

- Be It Resolved, that the 1990 National Convention supports the Position Statement on Substance Abuse issued by the Grand Council of Alpha Sigma Phi Fraternity.
- Whereas, Alpha Sigma Phi is the fraternity "To Better The Man" and all of her functions and actions should exhibit this as listed in our Code of Conduct, and
- Whereas, we believe that all people are created equal and should have the right to be treated the same no mater what their ethnic or religious background may be, and
- Whereas, Alpha Sigma Phi abolished discrimination based on ethnic or religious criteria at the National Convention in 1950 and supports equal treatment among men, and
- Whereas, "racism is counter to everything that Alpha Sigma Phi stands for. It does not encourage bonds of friendship based upon individual merit and achievement. It does not demonstrate leadership. It does not prove an individual's or a group's superior qualifications in any way.

Therefore,

- Be It Resolved, that the 1990 National Convention supports the Position Statement on Racism and Religious Discrimination issued by the Grand Council of Alpha Sigma Phi Fraternity.
- Whereas, Alpha Sigma Phi is the fraternity "To Better The Man" and all of her functions and actions should exhibit this as listed in our Code of Conduct, and
- Whereas, we strive at all times to be educated about the world situations and strive to educate our brothers so that they can be better informed citizens, and
- Whereas, we are a brotherhood of gentlemen who extend brotherly love and concern to all brothers and friends of Alpha Sigma Phi Fraternity, and
- Whereas the membership of Alpha Sigma Phi is knowledgeable of and concerned with the epidemic of Acquired Immune--Deficiency Syndrome (AIDS), and we realize that <u>all</u> persons are at risk who are active sexually regardless of sexual orientation.

Therefore,

- Be It Resolved, that the 1990 National Convention supports the Position Statement on AIDS issued by the Grand Council of Alpha Sigma Phi Fraternity.
- Whereas, Alpha Sigma Phi is the fraternity "To Better The Man" and all of her functions and actions should exhibit this as prescribed by the proposed Position Statement on Positive Pledgeship,

Therefore,

Be It Resolved, that the 1990 National Convention formally adopt the proposed Position Statement on Positive Pledgeship.
