

DR. JOHN ROSCOE TURNER

Dr. John Roscoe Turner was born February 13th, 1882, at Matville, W. Va. He received his education at West Virginia Conference Seminary, Ohio Northern University, and Princeton University. His teaching career began in a small school in Louisiana, and from there he went to Willie Hassell College in Oklahoma. After serving as Principal in a Kentucky Seminary, he became an Instructor in Cornell University. In 1920, Dr. Turner accepted a position as head of the Economics Department at Washington Square College, New York, and later became Dean of the same College. He is a noted economist, having served as Chairman of the Advisory Board of the United States Tariff Commission. He is also the author of "Recardian Rent in Economics," and "Introduction to Economics." Dr. Turner assumed the office of President of West Virginia University July 1st, 1928.

## HISTORY OF THE UNIVERSITY

The University of West Virginia was established as such December 4, 1868, but the institution was known from February 7, 1867 as the Agricultural College of West Virginia. Prior to February 7, 1867 and before the Civil War, a female college under the name of Woodburn Seminary occupied a small portion of the land now included in the University Campus. The University is the peak and center of the public school system of the State, and also the central institution of higher learning in West Virginia, being as it were, the mother of some 7 or 8 partially State-supported Normal schools, including Fairmont and Marshall Colleges.

The University derives its main support from biennial appropriation of State funds by the legislature. Additional and reserve funds are held for the benefit of the University. These are derived from the Morrill, Hatch, Adams, Smith-Hughes, Smith-Lever and I. C. White funds, and also the I. C. White Realty Donation of some 4 acres of land contiguous to the former University Campus. The University is the recipient of a Federal Land Grant to the extent of \$115,750. A tuition of not in excess of \$50 per semester is required for registration. This latter applies to the students coming from within the state. A tuition of \$107.50 is charged for out-of-state students per semester.

The University consists of the departments, Colleges and Schools here in the order of their foundation:

The College of Arts and Sciences, 1867, which confers the degrees A. B., M. A., B. S., and M. S.

The College of Law, 1878, which confers the degree of LL. B.

The College of Engineering, 1887, which confers the degrees B. S. M. E., M. S. M. E., B. S. C. E., M. S. C. E., B. S. E. E., M. S. E. E., B. S. Ch. E., M. S. Ch. E.

The Agricultural Experiment Station, 1888, and the College of Agriculture, 1897, which awards the degree of B. S. Agr., M. S. Agr., and B. S. H. E.

The School of Music, 1897, in which a student may be awarded the degree of B. S. in Music.

The School of Medicine, 1902, which awards the degree B. S. in Medicine.

The School of Pharmacy, 1908, which confers the degree of B. S. in Pharmacy.

The Graduate School, which is newly founded.

The Division of Military Science and Tactics.

The Department of Physical Education, 1928, which confers the degree of B. S. in Physical Education.

The Campus borders on the Monogahela River and consists of approximately 50 acres of land undivided, except for the State Farms of almost 700 acres about 1 mile distant from the campus proper.

The University is equipped with 17 buildings of brick and stone, including a large, new Field House, a new Women's Gymnasium and a new classroom building costing some \$1,300,000, besides 5 frame buildings. The Board of Governors of the University has adopted a plan covering 25 years of regular and systematic expansion of buildings. The Staff of Instruction includes 88 professors, 40 assistant professors, 74 instructors, 52 assistant instructors, 27 student assistants, 47 members of the Experiment Staff, and 18 Librarians. Forty-two laboratories are conducted on the Campus. The equipment is for the most part modern, and such part as is not is being modernized with all possible speed.

The University has shown a constant increase in the enrollment since its founding. The enrollment for the year 1916-17, shows that the number of men enrolled was 608, and women 237. For the year 1917-1918, the number of men was 640, and 324 women. Over these figures the increase can be stated by the enrollment for 1922-23, which shows that the number of men was 1,314, and 565 women, and for 1927-28, the number of men was 2,058, and 972 women. During the present year the enrollment is in excess of 2,600.

At the present time there are 22 national Fraternities on the Campus, and 3 local Fraternities. There are 9 national Sororities, and 1 local sorority. The Fraternities at West Virginia University are all in a stage of building. The number of national Fraternities is inadequate for the number of students registered. Viewing these facts, and the increase in the enrollment of the University, it seems that there is no better time than the present for an increase in the number of national Fraternities.

## MORGANTOWN

Capital and Judicial Seat of Monongalia County

Morgantown is located in the north central part of West Virginia, at the foot of the Cheat Mountains, a ridge of the Appalachian System. By direct air-line, Morgantown is just six miles south of the Pennsylvania boundary, and 50 miles due west of the Maryland line. Morgantown is 102 miles south of Pittsburgh on the Monongahela river, on the Monongahela R. R., Morgantown and Kingwood R. R., the Morgantown and Wheeling R. R., and the Fairmont division of the Baltimore and Ohio R. R. The Morgantown and Kingwood R. R. connects with the main line of the B. & O. at the M. & K. Junction, 47 miles distant from the city. The Fairmont division also connects with the main line of the B. & O. 45 miles north of Morgantown at Connel sville, Pa. The New York Central meets the Monongahela R. R. at Brownsville, Pa., approximately 45 miles from Morgantown, and the Pennsylvania R. R. connects at Fairmont 23 miles south.

Morgantown is the seat of the State University, and has developed into one of the most thriving manufacturing cities, as well as the center of the West Virginia glass trade. Slackwater navigation is extended from Morgantown to Fairmont by the construction of locks and dams. It is possible to run large boats from Pittsburgh to Fairmont, via Morgantown, practically all the year around.

Penetrating the county east of the city, which section is rich in timber, coal, fire clay, limestone, sandstone, glass sand and other materials, is the Morgantown and Kingwood branch of the Baltimore and Ohio R. R., which connects the city with Kingwood, 26 miles east. It has already opened up one of the richest portions of the State. Vast fields of bituminous coal underlie all of the western portion of the county in seams from seven to eleven feet thick. Natural gas is abundant within a few miles of the city.

Cheap fuel makes Morgantown an admirable site for manufacturing plants many of which are located here. Several large glass plants are in operation, a wire glass factory, and the only factory in the world for the production of pressed prism glass is located here. Other industries include cigar making, watch crystal plant, planing-mill, and the tin mill of the American Sheet and Tin Plate Company. There are two daily and two weekly newspapers.

Morgantown has grown in twenty-five years from a village of 1,000 to a city of approximately 30,000 inhabitants.

Since a large percentage of the coal fields have remained untouched, it may readily be seen that Morgantown holds great possibilities for a steady growth, and still greater center of natural resources.



## HISTORY OF TAU DELTA THETA

The history of Tau Delta Theta, the petitioning body herein, begins in the fall of 1919, shortly after the opening of school for that year. A great number of male students returned to school for that year who had been in the service of their country during the World War, and a result thereof, the enrollment of the University was greatly increased beyond all expectations and far beyond the enrollment for any prior year. The Council of Administration of the University was immediately confronted with problems of providing for the proper housing facilities necessitated by the unusually increased enrollment. The first plan recommended by the Council of Administration, by which it hoped to relieve the situation, was the formation of new local fraternities, and immediately thereafter the petitioning body was organized.

The requirement of the University before any recognition would be given a local fraternity was, that the body should consist of at least twelve in number who were upper classmen, and who had successfully passed all college work without the failure of any single course. Such a group was organized by the petitioning body, with Howard Lucky, a then senior in the College of Law as its president, E. E. Hamstead, vice-president and C. D. L. Ropp, secretary-treasurer. This newly organized body then petitioned the University for recognition as a local fraternity, and having complied with all the requirements, the petition was granted and Tau Delta Theta thereupon became the first local fraternity of the campus, following the recommendations of the Council of Administration of the University.

The new organization enjoyed a very rapid growth, within a short time its number had doubled, and within four months after its organization it had purchased a large and beautiful home in the most restricted residential section of the city. It still owns the same property and now has the same nearly paid for including all furniture and fixtures therein. At the present time the organization has under consideration plans for building a new stone home to be located nearer the campus of the University and sufficient enough in size to accommodate about forty members.

Due to the careful selection of its members the fraternity has always been represented in every extra-curricular activity. During the year 1923 from its membership the captain of the West Virginia Football Team was selected, and at least as many as two all-stars on our football team. The fraternity has also at all times been well represented in all other athletic activities, having one year the captain of the University's Wrestling Team, as well as other offices in all lines of sports. At present, Brothers C. M. Price, C. D. Leiphart, and J. L. Simpson are all members of the Track Squad, Brother Simpson having won the pole vault in the West Virginia Indoor Games, held here last month. Brother Hyer was a member of the Freshman football squad last fall, and is expected to show up well on the varsity next year.

The fraternity has been active in other activities as well as athletics. From its membership during the past ten years there have been several class presidents and other class officers elected. During the first year of its existence one of its members was elected chairman of the University's Social Committee at a general election of the University. That position was highly sought after by every fraternity on the campus. The organization was also represented on the Inter-Class Council of the University for several years. In the year 1926 one of its members was elected editor-in-chief of the Athenaeum, the college paper, the following year another one of its members was elected to the same position, and the managing-editor was also elected from its group.

The fraternity has maintained a good scholastic record, its position being at about the average grade of all fraternities on the campus. From its membership several have been added to the Phi Beta Kappa, and many of its members who were in the Engineering College have been taken into honorary engineering fraternities. The same facts are true relative to all other colleges in the University, such as Law, Medicine, Agriculture, etc., many of the group have from year to year been taken into the honorary fraternities of their respective college in which they have been enrolled. According to the latest reports available (Mar. 5, 1931), Brother D. L. Farnsworth will lead the Campus in the Scholastic Averages for the past semester, having received a grade of A in all of his twenty hours of work.

Fortunately the fraternity has never encountered any financial embarrassment. Upon its organization the sum of one thousand dollars (\$1,000.00) was raised by the group with which to make the original payment of the purchase of its home. Shortly thereafter a special assessment was made on all its members with which furniture and fixtures were purshased. The property was financed through a local building and loan association on an easy payment plan and all the payments have always been promptly made by the organization when the same have fallen due. In addition to meeting all

deferred purchase payments the fraternity has maintained and created a sinking fund with which it hopes to find of great usefulness when making a further purchase of a new home. All of its furniture is fully paid for and there are no outstanding debts against the organization, except what remains unpaid on the purchase price of its home, which does not total more than about four thousand dollars, and two years ago it was offered eighteen thousand dollars for its home, which fact clearly shows that the fraternity must

be on a good substantial footing financially.

The alumni of the fraternity now number about one hundred and twenty-five members, who upon passing from their active membership in the organization at once became members in a well organized alumni association. Each member of the latter organization pays into its organization dues which are accumulated into a fund which is also to be used, if needed, in the purchasing of a new home for the active organization at some future date. This latter organization has its regular annual home-coming meetings at which meeting new officers are elected from year to year and all other business of the fraternity reviewed. The meeting is usually held at Thanksgiving and always partakes of the nature of a banquet. Quite often the banquet is given by the active fraternity to the alumni organization for those who have passed beyond the active membership.

The history covers a period of over twelve years, and to give the same in detail, naming its various members who obtained outstanding recognition and honor on the campus in various activities, would be of not much interest to any one except its own members, and in the end would be of very little value. The following members have been the various presidents of the fraternity: Howard Lucky, John Frum, Kline Lawson, James Clower, Earl Eckles, E. E. Hamstead, George Goodwin, Francis Clark, Dana L. Farnsworth, Benjamin Moats, Joe Craig, James Feeney, A. Edward Reed, and Dana L.

In reply to your recent inquiry as to the scholastic standing of Tau Delta Theta for the first semester of the current scholastic year I regret to state that the averages have not yet all been compiled. I have, however, the following information: The average for all men students, expressed in honor points per hour of credit is .784; the average for Tau Delta Theta computed in the same way is .943. As you know, fraternity averages, for many years past, have consistently been lower than the averages for all men students and any group which was definitely above the all-men's average was among the leaders. All fraternity groups so far averaged for last semester except yours have shown averages below that for all men.

Dear Mr. Burton:

It may be of interest to your fraternity to learn that I have just completed the work of ranking the fraternities according to their scholarship for the first semester of the current year, 1930-1931. The standings which I now have will not be affected by any possible corrections in such a way as to make it possible for your group to rank lower than it does in these tentative ratings; it might rank one place higher. However, it is probable that there will be no changes in standings due to corrections.

The standings can not yet be made public, so far as the names of the groups are concerned. They are based on the average number of grade or honor points per hour of work carried; Tau Delta Theta is fourth in a group of twenty-four; it is surpassed by one local organization, ane Jewish National and one National, member of the Interfraternity Council. The averages are as follows:

First..... 1.1297
second..... 1.603
third..... .9514
fourth..... .9432 (Tau Delta Theta).

The twenty remaining groups averaged down to .3037.

The average for all mens organizations is .7140; for all men in the university the average is .7840.

To the Grand Extension Committee, Chapters, and Alumni Councils Greetings:

It is with pleasure that I refer to you for action the petition of Tau Delta Theta, local at the University of West Virginia, for a charter as a chapter of our organization.

This is the first petition to be presented for action under the Constitution and By-Laws as amended at the Ithica Convention in 1929.

This group as you will remember petitioned us heretofore but the action upon said petition was unfavorable. The last vote on said former petition fell short by only one vote of being sufficient for the granting of a charter. After the action the petitioners continued to show a desire to make further efforts to enter our chapter roll and so indicated in correspondence with the undersigned.

Upon my advice the matter of another formal petition was withheld as it seemed expedient to secure an expression of the 1929 convention as to desirability of having this group re-petition. The convention was only a few months away and a discussion of the whole matter by representatives of all of the chapters was considered quite material.

The 1929 convention did consider the matter of a re-petition by this group and the consensus of opinion was that the petitioners should again be allowed to petition. This opinion was practically unanimous.

A new petition has therefore been prepared in accordance with the views so expressed by said convention of 1929 and the same is submitted to you herewith for action in accordance with the Constitution and By-Laws as amended with respect to Petitions and the granting of Charters.

You will note that I have attached to the petitions the reports of the committee who investigated the group when it submitted its first petition.

It did not seem necessary in view of these reports to have the whole matter gone into again in every detail and therefore the last committee reporting rather restricted its report to bringing the old reports up to date; hence the necessity of the old reports.

I desire you to note that the report of the Alumni Committee which investigated this group in connection with the first petition, was composed of three men who were very capable and men who at all times have had the interest of our organization at heart. (Unfortunately Brother A. H. Savenye has since been taken from our midst.) The active committee who investigated at that time was composed of three men from chapters located fairly near the petitioners and which men probably were in a position to know first hand a great deal about the institution and essential facts pertinent to our inquiry. The committee, which has just reported, you will note is composed of one active man from Delta and two alumni, one of whom, Brother C. W. Cleworth, is a member of the Grand Prudential Committee. It seems to me, therefore, that you have every reason to place full reliance and confidence in these reports and assume that the conclusions of the committee are based upon authentic information and are the result of mature judgment.

I will now endeavor to point out what seems to me to be the essential matters to be considered in passing on a petition and compare these requirements with the institution and group at hand. The essential matters and the order of their importance seems to me are:

- 1. The Institution.
- 2. What is the fraternity situation and what are the possibilities for a new group.
- 3. The Group.

### I. The Institution.

#### We have here

- 1. A State Institution.
- 2. A broad curriculum.
- 3. Ample financial support by the State Legislature.
- 4. A president of the institution who is a leader and apparently believes in the value of fraternities.
- 5. A faculty of good standing (The percentage of doctors' degrees among this group being somewhat above the average of Universities and Colleges) and a faculty which is pro-fraternity.
- 6. A student body which according to the reports and my own personal observation can favorably be compared with a majority of the student bodies on the campuses where we have chapters.

It seems to me that the above statement of facts presents to us an institution which can be compared favorably with a number of the schools in which we now have chapters and from the reports of the committee, an institution which undoubtedly is rapidly coming to the front and raising its standards and standing among the Colleges and Universities of this country. Therefore, it seems to me, the institution is quite satisfactory for our purpose.

# II. The Fraternity Situation at West Virgina

This matter, it seems to me, should be considered from two stand-points.

- 1. The present fraternity situation on the West Virginia campus in so far as it warrants additional organizations from the standpoint of numbers.
- 2. The attendant conditions which may or may not permit a new group to be something more than just another fraternity on the campus.
  - (a) There are at the present time twenty-one national fraternities and three locals on the West Virginia campus. The groups are not large, having from thirty to thirty-five men, so that about 40% of the men on the campus are members of national organizations. The reports all indicate that there is available material over and above the requirements of the present national organization so that the question of requisite material is answered.
  - (b) What are the prospects or possibilities for the new group? Would it have an opportunity to bring itself up to a par with other outstanding groups on the campus? Is there a distinct line of demarkation between certain groups which because of age or otherwise would result in a new group for a number of years remaining a second rate group so to speak? Referring to the reports we find that they all indicate that the national groups now on this campus are desirous of seeing the group in question go national, and that as a national organization it would be admitted and recognized as a member of the inter-fraternity council. From my own observation, I find that all of the national fraternities seem very friendly with this group and the group seems to have already brought itself to the point where it is not far below the leading nationals now on the campus. I am quite certain therefore, that an aggressive new national would have every opportunity to make something of itself within a reasonable time.

# III. The Group

The last and of course quite necessary inquiry is with respect to the cause of such inquiry, the petitioners.

Our thoughts, with respect to the group should, I believe fall under the following heads and their degree of importance it seems to me is in the order named:

- 1. Personnel.
- 2. Scholarship.
- 3. Present standing on the campus and their possibilities if they become national.
  - 4. Their method of organization and cooperation as a group.
  - 5. Finances.

- (1) In passing on the personnel of the group, we must rely practically and solely on the report of the committees. True there is something to be gathered from a photograph of a man and also from the nationality of his parents and his past and present student activities. The committees who saw these men and myself feel that the personnel of this group is on a par with the usual petitioning group which as a local does not have the opportunity to average as high in this respect as a leading national on the campus. There are, however, always a few outstanding men, as in the case of this group, and I believe, therefore, it is satisfactory in this respect.
- (2) The scholarship of the group has been about average until this current school year when you will note from the letter attached to the petition, the group brought itself up to fourth position among the national and local fraternities totaling twenty-four. Their scholarship, therefore, seems satisfactory.
- (3) By reference to the history of this group as set forth in the petition and the biographical sketch of its members, it seems to me one may be satisfied that this group as a local has secured ample recognition at West Virginia. There is no need for me to go into details with respect to this as the committee reports and the petition clearly show this. With such an aggressive group and conditions at West Virginia as favorable to a new group as heretofore indicated, there seems little reason why this organization should not prosper and thrive.
- (4) My own observation and the reports of the committees indicate that this group is well organized, and that its members cooperate as a group, keep orderly reports and apparently are, as a body, interested in their organization.
- (5) Referring to the petition, we find a financial statement of this group which it seems to me for a local organization is subject to anything but criticism. Early as an organization they purchased their home and have steadily reduced their indebtedness in connection with it. They have a nucleus for a better home which I believe they contemplate acquiring. Their indebtedness is not large and it is offset by current accounts receivable. My experience with this group has indicated that they have always handled their affairs in a business-like manner and we all know from experience that this is quite an essential thing for either a new or an old group. It seems to me we have little to worry about from the standpoint of finances of this group.

Conceding the foregoing to be true, that we have a desirable institution, a favorable fraternity situation and a reasonably good local, the question may be asked, "Why a new chapter?" The answer, it seems to me, is:

- 1. That we are a national organization and should therefore be national geographically.
- 2. There have been repeated expressions by the fraternity as a whole and in convention that we should go South. The University of West Virginia, it seems to me, affords us an opportunity to expand in that direction. While it is not a southern institution, it brings us in closer proximity to the southern institutions which is, to my mind, a distinct advantage.
- 3. We have always considered that a good chapter in a good institution strengthens our chapter role and, I believe, this is true. We are not interested in just numbers but certainly the addition of another good strong unit should strengthen us nationally.

I direct your attention to the Constitution and By-Laws for such action as you may desire to take with respect to this petition.

I refer this petition to you with the highest recommendation and hope and trust that it will receive prompt and favorable action.

Dear Brother Clarke:

The undersigned, members of a committee of Alpha Sigma Phi Fraternity appointed to investigate Tau Delta Theta, a petitioning group at West Virginia University, visited Morgantown, West Virginia, on Saturday and Sunday, January 17th and 18th, 1931.

Since our mission was to supplement previous investigation and form a current evaluation of the petitioning local we will not duplicate information already supplied.

# 1. The State of West Virginia

The State is exceptionally rich in natural resources with coal, oil, gas, water-power, etc. It has a great many thriving industries. A large part of its area is rich agricultural territory, particularly suited for gardening.

Because of the fact that most of its natural resources are utilized and processed outside of the State maximum return from them has not accrued to the State. The University has proposed the training of real scientists familiar with the problems of the State who could devise methods of utilizing the natural resources within the State to a much larger extent than at present.

# 2. West Virginia University

Your committee met with President J. R. Turner who came to the University only three years ago from New York University. He has revitalized the University from top to bottom, replacing practically every department head and has put new life into those who remain.

Dr. Turner has sold the idea of a graduate school to the State Legislature, secured \$30,000 for an initial study of such a school and will ask at the next session an appropriation of \$900,000 for the construction and two years operation of a graduate division.

During his short tenure of office Dr. Turner has erected several new buildings ranging in cost from \$300,000 to \$500,000.

We were told on every hand that this man is a real educator and executive.

There are about 2600 students, 1700 of which are men. There are now 22 national fraternities represented and 2 locals.

Dr. Turner spoke highly of Tau Delta Theta fraternity. He said that there was a real place for another national fraternity there, and believed that this group would make a valuable chapter for Alpha Sigma Phi.

### 3. Tau Delta Theta

Your committee spent considerable time with H. E. Stone, Dean of Men, who has been there for nine years. He is a member of Phi Gamma Delta, which is not represented there, and has a son who is a member of the other local at W. V. U.

Dean Stone stated that the men of Tau Delta Theta are of exceptionally fine character - that no one of them has ever given him or others of the faculty and trouble - that their scholastic standing has consistently been above the average of the fraternities, and that he would give them his full cooperation in selecting new members. Dean Stone says that the group has been handicapped through its long petitioning to Alpha Sigma Phi, while younger locals have made desirable national connections, and believes that, were it to be granted a charter by Alpha Sigma Phi, it would very quickly secure a prominent place among the national chapters there.

Your committee talked with the president of the Interfraternity Council and was wholeheartedly assured that Tau Delta Theta would make a desirable chapter of Alpha Sigma Phi and that it would be taken into the Council.

Several alumni visited with your committee. Many of them occupy positions of prominence in business, the law, engineering, and education. They all promised full support of a chapter of Alpha Sigma Phi.

Three alumni of Alpha Sigma Phi are located at Morgantown. Brother H. C. Riggs, Delta '12, has for many years been an official of the leading bank there. He is a neighbor of Tau Delta Theta and has been a constant advisor to the group; Brother H. L. Samuel, Lambda '21, Director of Intramural Sports, is well acquainted with the group. Brother H. A. Smith Delta '13, who has been in educational work since leaving Marietta, has entered the West Virginia University School of Medicine. These three brothers highly recommend Tau Delta Theta and promise careful supervision of the group. All three are in excellent positions to secure valuable rushing material. There are a number of Alpha Sigs throughout the State who would lend their support.

Your committee scanned the books of the group and finds them in good financial condition.

Their house which was bought advantageously for \$15,000 is being paid for regularly through a Building and Loan Association. There is approximately \$4000 yet to be paid on it. At an appropriate time the alumni assure full cooperation in financing a more modern house.

There are fifteen actives and seven pledges. This is somewhat below former years. The same situation holds for the nationals there due to the business depression which has hit the state rather hard. The quality is perhaps better than in former years.

Your committee regards the men of this group as very suitable material for Alpha Signa Phi. Many of the men are outstanding on the campus, they take their fraternity seriously, they work in harmony, they are cultured and hospitable. They would be well received in any of our chapters.

Dana Farnsworth, President of Tau Delta Theta, is a very capable young man. He will be in office until Spring.

William Fahey, their most prominent member, who has been out of school this year because of an operation, will return next Fall. He will insure continued leadership of the group.

Your committee recommends favorable consideration on the petition of Tau Delta Theta.

# Report on Tau Delta Theta Petition.

Dear Brother Clarke:

The undersigned, members of the Alumni Committee of Alpha Sigma Phi appointed to investigate Tau Delta Theta, a petitioning local at West Virginia University, visited Morgantown on Monday and Tuesday, November 29th and 30th. Our report on the group is as follows:

# 1. General Character of the University.

West Virginia University, altho small as state universities now run, is apparently offering its students a well rounded curriculum. It has practically all the departments that we look for in a high grade institution of learning and provides a sufficient number of courses in each department to insure a thoro academic training. The various departments with their undergraduate enrollment for 1925-1926 are as follows:

The Arts and Science Department includes also the department of Economics, Business Administration and Sociology which offers an array of courses entitling it to consideration as a separate department. The Department of Education is also included under the Arts and Science School and a School of Home Economics is included under the College of Agriculture.

From a fraternity standpoint, West Virginia University appeals to this committee as being a good field for expansion of Alpha Sigma Phi. The attitude of the university officials is very favorable to fraternities and we were assured by everyone we met that there was no antagonism in the

state legislature. The Dean of Men and the President of the University are members of Phi Gamma Delta and many other fraternities are represented on the faculty. In addition there are no dormitories for men at West Virginia and faculty sentiment is distinctly in favor of establishing fraternities as means of particularly solving the housing problem.

At the present time there are 23 fraternities at this institution. There are 14 national, 6 local, 2 Jewish and 1 Italian fraternities. Both the president of the student council and the president of the inter-fraternity conference assured us they believed that there was room for more national fraternities on the campus and that they would look with favor upon the establishment of a chapter of Alpha Sigma Phi there. The president of the inter-fraternity conference further told us their rules provided that a national fraternity had to be on the campus one year before admission to the conference. He stated however that he knew there would be no difficulty in the present group obtaining membership if they should be granted a charter by Alpha Sigma Phi. We wish to endorse the views given above as we believe this school with an enrollment of over 1700 undergraduate men this year provides sufficient room for considerably more than 14 national fraternities. Incidentally two of the other locals are petitioning Phi Gamma Delta and Phi Delta Theta.

# 2. General Type of Men in the Institution.

West Virginia University enrolls most of its students from the state of West Virginia and southwestern Pennsylvania. Of the total enrollment of 1925-1926, 371 students were from without the state of West Virginia and most of these were from Pennsylvania.

Contrary to popular opinion we did not find the student body at West Virginia University to be crude and rough. The men we met, both within and without the petitioning group, would be at home on any campus on which we are now represented.

# 3. The Petitioning Group.

Tau Delta Theta fraternity was founded in 1919 by a group of men who had been in the service and who felt the need of forming a close social group or club. Their intention was to build up a strong local fraternity at West Virginia University that would not lose its identity and would be recognized as a desirable social affiliation thruout the state. Shortly after organization, thru a building and loan association, they purchased the property which they now occupy. After an existence of three or four years as a local the men began to feel that they were handicapped in securing members in their competition with national fraternities on the campus. They decided, therefore, to petition some national fraternity and thru the influence of a member of Alpha Tau Omega then in school selected that group as the recipient of their petition. However, shortly after the petition was sent in, they learned thru some source that the ATO chapter at Washington and Lee would not look with

favor upon a chapter at West Virginia University, (it seems that football relations at the time were rather strained and there were other sources of differences between the two schools) and, therefore, Tau Delta Theta withdrew their petition before it had been acted upon. This ended national aspirations for a time, but it seems that the urge was still there, for a year or so later they decided to petition Alpha Sigma Phi. We were informed that they selected Alpha Sigma Phi after a perusal of Baird's Manual. It was after this selection that they found an Alumnus of Delta Chapter in Morgantown, Brother Howard C. Riggs, who has since been very active in whipping the petition into shape.

Scholastically, Tau Delta Theta ranks above the average fraternity at West Virginia. We are attaching hereto statistics of scholastic standings of all fraternities for the year 1925-1926 which indicate the following:

At the end of the first semester of that year Tau Delta Theta ranked twelfth out of twenty-two with an average of 76.39. The average for all fraternity men during this period was 76.41. At the end of the second semester they ranked seventh out of twenty-two with an average of 79.68. The average for all fraternity men during this period was 78.04. This indicates that they not only bettered their position in fraternity ranking but also made a considerable improvement in scholarship during the past year. We are also attaching hereto a statement of the average mid-semester grades of the thirteen men who are now pledges of Tau Delta Theta. The average grade of the group is 77.8; if we leave off the standings of three men who are very low and who will probably be dropped due to scholastic difficulties, the ten remaining have an average standing of 80.5.

Tau Delta Theta appears to be fairly well represented in campus activities. One of their men is editor of the student newspaper, another is the first string fullback on the football team, several are officers in the cadet corps, one is a member of Phi Beta Kappa and various others are members of honorary societies. We were also informed that they have a system by which they interest each pledge in at least one campus activity.

We interviewed the Dean of Men, the President of the Student Council, the Commandant of the Cadet Corps and the President of the Inter-Fraternity Council regarding the reputation of the members of Tau Delta Theta both as individuals and as a group. From everything that we could gather they are very highly regarded and have never had any dark chapters in their past. They have of course had their occasional black sheep but it seems have gotten rid of them with promptness and dispatch. This was one point which the Dean of Men especially brought out, i.e. that they had always thoroly cooperated with him when called upon to do so.

There are at present 30 active members of Tau Delta Theta and 13 pledges. The actives are divided among the three upper classes as follows:

Seniors 9
Juniors 15
Sophomores 6

The pledges are divided as follows:

Sophomores 5 Freshmen 8 Thirteen of the men live at the house and twenty-eight of them eat there. They take in very few men from Morgantown as they have found, like many other fraternities that a large proportion of local students tends to destroy the coherence of the group. They appear to be well organized and to have in mind their future growth at all times. They take a personal interest in the scholastic standings of their various members and have an upperclassman advisor appointed to watch over the welfare of each pledge. Their alumni body is also organized and fairly active. It comprises at present some 60 or 70 members. We might add that only white gentiles are eligible for membership in Tau Delta Theta.

As regards morals we can only reflect the opinion of the members of the faculty and student representatives we met. It seems to be the consensus of opinion that the members of Tau Delta Theta as a whole are high grade. We do know that they have a set of house rules in which drinking is legislated against very heavily.

For a local fraternity Tau Delta Theta appears to be very well situated financially. The property which they occupy is appraised at somewhere between fifteen and twenty thousand dollars, and is practically paid for. We were told that there is still a balance of three thousand dollars due in fairly easy monthly payments. They have no other large obligations and their furniture is clear. Each man boarding and rooming at the house pays a total of forty-three dollars and fifty cents per month, which applies on board, room and dues. They endeavor to keep their chapter roll somewhere between thirty and forty men and find when they do this and keep their table filled that they are in easy financial circumstances. Quite a number of the present group are partially supporting themselves and seem to find it no burden to do this and still keep up their fraternity affiliations.

# 4. General.

We are attaching hereto a copy of the school paper, a fraternity questionnaire gotten out by the Dean of Men, and a paper published by the Dean, summarizing the results obtained by his questionnaire. We are also sending you, under separate cover, a copy of the university catalogue. We wish to submit these as exhibits which will bear us out in our recommendation as follows:

We believe that West Virginia is a suitable institution for the establishment of a Chapter of Alpha Sigma Phi fraternity. We further believe that Tau Delta Theta local at West Virginia University comprises a group of young men whom we could heartily welcome into Alpha Sigma Phi. We therefore recommend that their petition be acted upon favorably and as speedily as possible.

The following is the report of the active investigation committee on the Tau Delta Theta group of West Virginia University at Morgantown, West Virgina.

# I. GENERAL CHARACTER OF THE INSTITUTION.

- A. West Virginia University has an exceptionally broad curriculum which includes college of Arts, Science, Law, Agriculture, Mining, Engineering, Physical Education, Education and a two year course in Medicine. These departments are well provided with modern equipment. A new chemistry building has just been erected which would be a credit to any campus. The older buildings on the campus are in good conditions and those recently constructed, numbering about four, are modern in every respect.
- B. The University is especially fortunate in its faculty which includes an unusual number of doctors and full professors. The school as a whole compares very favorably with those in which we have chapters at the present time.
- C. There are thirteen national and seven local fraternities on the campus. Dean Stone, Dean of Men, believes that there is sufficient opportunity for three or four locals now there to establish themselves and become nationals. His opinion seems well justified. Dean Stone spoke very highly of Tau Delta Theta. It is the oldest local group on the campus, having been organized in 1918. The Interfraternity Council gave its unqualified endorsement of its petition to Alpha Sigma Phi and the president told us personally that the counsil would like very much to see this group go Alpha Sigma Phi.

# II. GENERAL TYPE OF MEN IN THE INSTITUTION.

A. The committee's impression of the student body of West Virginia does not carry out in the least the general impression of crudity and roughness of the state. If the culture of the state as a whole were to be judged from the evidence of that characteristic in the student body, a much higher opinion would result. We attended two dances; one was a formal school affair at which all the fraternities were represented. There was no evidence of the lack of breeding which we usually associate with the state of West Virginia; on the contrary, the men were of highest type and well worth association with even the most cultured.

B. The student body numbers about 2700 and represents the states of Ohio, Pennsylvania, Maryland very largely, in addition to students from more remote states. The University is a state institution and is therefore quite representative of all parts of the state, but the student body compares very favorably with those of similar institutions in which Alpha Sigma Phi has chapters.

# III. THE PETITIONING BODY.

- A. Tau Delta Theta was established at West Virginia University in 1918. They have been exceptionally active on the campus for a local group. They have had several football players that were given honorable mention by Walter Camp. They were the only local group, at the school, that ever had a member of their fraternity a football captain. They have been fairly active in other sports as well.
- B. The past year they stood twelfth scholastically among the nationals and locals there. This year they are seventh, there being only one national higher than they. At present they have the editor-in-chief of the school paper who is also connected with several other campus activities. They have several men on the basketball squad, and the regular fullback on the football squad is a Tau Delta Theta man. One man has just been elected to Phi Beta Kappa, and two others belong to Phi Bater Kapper, the junior honorary society, composed of the most active men on the campus. They have quite a few men associated with engineering and chemical societies on the campus.
- C. From the interview we had with Dean Stone we were led to believe that this group stood very high in the estimation of the faculty. He spoke very highly of them both as a group and individually. Their reputation with the other fraternity men that we met, and the Interfraternity Council president, all of whom gave them credit as being worthy of a national charter, was very good.
- D. They have both types of men so essential to a fraternity's success, the activity man and the inside worker. These groups are very well balanced. The men all seem to be very clean cut fellows with a high standard of morals and good breeding.
- E. This group seems to be very well organized. Their financial condition shows this as a good example. They all seem to be working to get their fraternity ahead. Their officers seem to have the organization well in hand and are very much respected by the members. We think Tau Delta Theta is exceptionally fortunate in having the large number of real leaders they have as their officers.

- F. This group has practically the same rules in regard to drinking, gambling and immoral acts within the fraternity, as we have in our constitution and by-laws. These rules are evidently well enforced. Brother Riggs of Delta, who has been acting as their advisor for some time assured us of this fact.
- G. At the present time this group owns its own house which is worth approximately \$25,000. This figure was given to us by Brother Riggs, who being a banker, is in a position to estimate the value of property in Morgantown. Their total indebtedness at present is about \$5,000, most of which is for improvements made in the past summer on the house. At their present rate of progress they expect to be completely out of debt in three years at the most, and at that time they hope to build a new house.

There is a little "deadwood" in the group, as one finds in every fraternity, but taking everything into consideration, we do not hesitate to give our unqualified approval to Tau Delta Theta of West Virginia University and hope that the chapters see fit to grant them a charter.
