COE COLLEGE HISTORY

Coe College, one of Iowa's oldest schools, currently ranks sixth among private colleges with an enrollment of 941 students of which 56% are men.

Coe had its beginning in 1851, when Reverend Williston Jones opened a school in his own home for sixteen Cedar Rapids young people. In 1853, the Reverend Jones obtained from Mr. Daniel Coe a gift of money to establish a permanent institution of learning in Cedar Rapids. Coe was dedicated to the concept of a liberal education, and devoted to the development of human reasoning in an atmosphere of Christian spirt. These ideals are still maintained at Coe.

The first building, now a part of Old Main, was built in 1867-68 on a corner of the eighty acre tract of land which had been bought with the gift from Daniel Coe. Gradually the campus was reduced to approximately eight city blocks, the present site of the campus, and the proceeds from the sale of the land were used as an endowment fund to perpetuate the institution.

Coe at present has active endowment funds amounting to \$2,500,000. The annual income from these funds exceed \$100,000. Early in the fall of 1956 Esso Education Foundation, through which Standard Oil Company of New Jersey and a group of affiliates assist private schools, granted Coe \$2,000. From the E.I. DuPont DeNemours & Co., Inc., Coe received \$4,000. Coe was one of the 122 colleges and universities chosen: in the nation.

Recently added to the campus was Sinclair Memoiral Chapel, a \$500,000 structure with a seating capacity of 1200. It houses a small worship chapel and complete staging facilities. Completed in 1930, the gymmasium houses an indoor track, boxing and wrestling rooms, and a playing floor 100 feet by 200 feet. To provide access to library materials, Stewart Mimorial Library was given to Coe in 1931. It contains some 63,000 books and 250 periodicals as well as specialized reference works and government documents.

The offerings of each department at Coe are designed, through their special subject matter and particular techniques, to further a liberal education as well as preparation in a vocational field.

Coe offers to its students two degrees: the Bachelor of Arts and the Bachelor of Music. Majors may be selected from any of the following: art, biology, chemistry, classical civilization, business administration, economics, English, French, German, Spanish, history, journalism, mathamatics, philosophy, physical education, physics, political science, psychology, religion, sociology, speach, music, and theatre.

Two assistant professors of the chemistry department were awarded Frederich Gardner Cotrell research grants amounting to \$6,800. The grants are being used to further research in fundamental organic chemistry and to aid students participating in the research projects.

Cited for its leadership in the field of faculty improvement, Coe was awarded \$320,900 last spring by the Ford Foundation. The grant included an "accomplishment grant" made to only 126 institutions for special leadership in improving the status and compensation of college teachers. Throughout the years Coe has increased and gathered 67 of the top educators in their respective fields. On the faculty is one of the four top chemists in the nation and an outstanding national historian among other great leaders 11 of which are Phi Beta Kappa and 7 Phi Kappa Phi.

Coe College is a charter member of the National Commission on Accrediting and is accredited by the North Central Association of Colleges and Secondary Schools.

Coe also holds membership in the Association of American Colleges, American Council on Education, Presbyterian College Union, National Conference of Church related Colleges, the National Collegiate Athletic Association, and Midwest Intercolligiate Athletic Conference.

There are five social fraternities and five sororities at Coe. Four fraternities are chapters of national organizations: Lamba Chi Alpha, Phi Kappa Tau, Tau Kappa Epsilon, and Sigma Nu. Alpha Theta Chi, our group, is a chartered local fraternity.

The five sororities, all members of the National Panhellenic Council are: Alpha Gamma Delta, Alpha Xi Delta, Chi Omega, Delta Delta Delta, and Kappa Delta.

There are the following chapters of Departmental Honorary societies, all of which are national: Pi Delta Epsilon, Arnold Air Society, Phi Kappa Delta, Mu Phi Epsilon, Phi Mu Alpha Sinfonia, and Alpha Psi Omega.

There are two national honorary sororities, Phi Kappa Phi and Phi Beta Kappa.

The "Kohawks" have always commanded a respect by their excellence in the Midwest Conference. In the last six years the Kohawks have taken two championships, two co-championships, and three undefeated seasons on the gridiron. In February of this year the Kohawks received their first defeat in two seasons of conference play which included the 1956 championship in basketball.

FRATERNITY CONDITIONS ON COE CAMPUS

Coe College has the dorm system for fraternity housing. Each fraternity has living accommodations and a chapter room on its respective wing in the dormitory. Generally the fraternity controls the room arrangement in respect to any person other than fraternity members living on their wing. Due to wing accommodations and size of the student body, the administration has limited the number of members per fraternity to sixty men.

It has been the practice for each fraternity to hold an open house on its wing sometime during the year. The faculty members and all other Greek letter organizations are invited. The chapter room may be used for small parties with the permission of the administration.

The Inter-fraternity Council made up of two representatives from each fraternity meets weekly to regulate and co-ordinate fraternal affairs with the college administration.

The Inter-fraternity Council organizes such activities as intramural sports and rushing. They, also, present a scholorship trophy and intramural trophies to the top competitors.

This year delayed rushing was adopted by the I.F.C. with open rush for all third semester students and above.

Fraternities, making up 42% of the men on the Coe Campus, have control, along with the sororities, of the Student Council.

Socially, fraternities are extremely active. Each fraternity holds a spring formal in one of the locations available in Cedar Rapids and surrounding area. In addition to this, two annual dances have been established which are sponsored by individual fraternities. Each fraternity participates in Home Coming by building a float for the parade and constructing house decorations for the campus.

Greek letter organizations play a major part in all campus activities.

HISTORY of ALPHA THETA CHI

Alpha Theta Chi Local Social Fraternity was founded at Coe College during the spring semester of 1955. At that time there existed on the Coe campus an organization known as Esquire Mens Social Fraternity. Fourteen members of that group decided to take advantage of a provision made by the college administration where by a fifth Greek letter fraternity might be created. The members selected the name Alpha Theta Chi.

On January 13, 1955, Alpha Theta Chi received the approval of the Inter-fraternity Council with the understanding that it would become nationally affiliated within a few years. The new organization thereby gained the privilege of participating in the 1955 spring rush and were successful in adding three new pledges. The final approval by the college administration came in May of 1955 after a satisfactory constitution and details of the organization had been worked out.

On May 21, 1955, the first annual spring formal, "Orchids In The Moonlight," was held in the Terrace room of the Cedar Rapids Municipal Airport.

During the summer of 1955, a new wing and a chapter room were prepared in the mens dormatory, Greene Hall. To furnish the new chapter room Alpha Theta Chi purchased modern wrought iron furniture valued at \$600.

The fall rushing brought fifteen new members, the third largest pledge class on the campus. Robert Richman, a new pledge, was elected in the fall of 55 as Freshman Class President and President of his pledge class.

On January 3, 1956 Alpha Theta Chi entertained two hundred and fifty quests at an open house on the new wing and chapter room. This was the largest crowd in recent years to attend an open house.

On January 23, 1956 a new cabinet were elected. They were: President Larry Bone, Vice-President Dean Cox, Secretary Phil DeWees and Treasurer Ed Baldwin.

Eight pledges who met the college grade point requirement were initiated into the active chapter. Three other pledges of the original pledge class of fifteen have since been activated.

During the first year of operation, Alpha Theta Chi took part in all campus activities, placing second in variety show and second in intramural baseball.

The second spring formal "Tahition Holiday," was held at the Ranch Supper Club, twenty miles south of Cedar Rapids.

The 1956-57 school year brought a new policy of open rush for upper-classmen and second semester rush for freshmen. Two upper-classmen were pledged under this new plan during first semester.

At the beginning of the first semester Lieutenant Colonel Lynn Blackwell affiliated with the A.F.R.O.T.C. department, was chosen by the fraternity as the faculty advisor for Alpha Theta Chi replacing professor Edmund Whiting.

In preparation for going National, Larry Bone and Bruce Woodson were selected as Alpha Theta Chi's representatives to attend the National Inter-fraternity Council during November 1956. Their mission was to discover the possibilities of becoming affiliated with a national fraternity. At this time the ground work with Alpha Sigma Phi was laid.

Both of our representatives came back with the highest indorsement for Alpha Sigma Phi and final approval of the organization followed very shortly after.

In January, 1957, our present cabinet was elected as follows: President, Edward Nuccio; Vice-President, Robert Richman; Secretary, Leland Stewart; and Treasurer, Bruce Woodson.

Alpha Theta Chi has always ranked with the best in Scholor-ship. Coe College is on a three point grading system. This past semester we averaged 1.599 which was the highest of all the fraternities on campus and entitled us to the Scholarship trophy awarded by the Dean of Students. The all fraternity average was 1.423. The Alpha Theta Chi average was also well above the all-mens average, the specific figure on this has not as yet been released.
