PETITION

We, the undersigned, students in good standing in the Sigma Alpha Fraternity located at Dartmouth College, having hereunto attached our individual and class records, a history of our alma mater, and our organization, do hereby petition Alpha Sigma Phi Fraternity to grant to us and to our successors a Charter for a Chapter of the Fraternity at this institution and to assign us a Chapter Letter.

Should this Charter be granted we agree to support the Constitution and By-Laws, Rules and Regulations, Customs, Laws and Traditions of Alpha Sigma Phi Fraternity, to perform its rituals, and to perform our part in the government and support of the Fraternity as such, and, under its laws govern ourselves as a Chapter in harmony and good fellowship, and that we and our successors shall work for the best interests and advancement of the Fraternity wherever and whenever we may, it being understood that nothing in this pledge shall in any way conflict with our religious or political scruples, or our duties and obligations to our college, our family, ourselves, our country, or our God.

HISTORY OF SIGMA ALPHA

The History of Sigma Alpha is a short one in terms of time yet this is more than compensated by the fact that in the short course of its existence, Sigma Alpha has been gaining in power and momentum. In the month of March of the year nineteen hundred and twenty-five a few men from each class in college decided to organize a new fraternity. Conditions proved that the time was ready and that a new Fraternity would be a welcome addition on the campus at Dartmouth.

The new organization met each week and gained in strength to such a degree that on the fifteenth of April it decided to ask for official recognition by the Interfraternity Council of the college. This recognition was given unanimously and then referred to each individual fraternity on campus for a final vote. The result again returned was unanimous for Sigma Alpha. At the time of the official recognition of Sigma Alpha there were twenty-six undergraduate members and two faculty members. At the close of the college year there were thirty-three undergraduate members.

A few salient points regarding the Fraternity are of interest. Sigma Alpha does not desire or intend to relinquish its treating scholarship as a pre-requisite for membership in the fraternity, though strongly reiterating that mere marks will not be considered as requisite in themselves. Sigma Alpha wants a strong group of men and it feels that scholarship is but one means of determining such strength. It will be noticed further that Sigma Alpha has concentrated more on the two lower classes in Dartmouth. This has been the policy of the Fraternity since Sigma Alpha feels that the permanency of the organization is greatly assured by this method.

Sigma Alpha has rented a house from the college which will be ready for occupancy next September. The house compares favorably with many other fraternity houses on campus and this house has just been vacated by the Delta Tau Delta Fraternity.

SCHOLASTIC STANDINGS

Scholastic standing at Dartmouth is computed as follows: A=4, B=3, C=2, D=1. Thus an average of 4.0 would be all As, 3.0 all Bs, and so on duly considering, of course, a range of grades for each individual which would cause fractions.

The average of the entire student body is 2.088. The average of all the fraternity men is 2.199. The average of non-fraternity men is 1.997. The average of Epsilon Kappa Phi which won the scholastic cup this year is 2.377. The average of Sigma Alpha which will be eligible for competition next year is 2.734.

THE HISTORY OF THE SIGMA ALPHA FRATERNITY (Cont.)

1925-1926

In the latter part of September 1925, we moved into the house recently vacated by the Delts. Brother Tilton, '25, presented the fraternity with a piano, and a pool table and various other pieces of furniture were bought from the Delts. It was well along into October before all was settled and the house could be called furnished.

The first social event of the year was an open house for friends and relatives on the evening of the Cornell game. More or less regularly thereafter for the remainder of the year we had open house Sunday evenings at which to meet proposed candidates for membership and to listen to outside speakers.

In the middle of November an informal group of Middlebury Alpha Sigs spent the afternoon in getting acquainted, and immediately after the Thanksgiving vacation the official inspection delegation composed of graduates and undergraduates from Harvard, Yale, etc., called on us. As did the majority of the fraternities on the Dartmouth campus, Sigma Alpha held a carnival party (February, 5,6,7). The house was turned over to the girls and we cooperated with Lambda Chi Alpha in giving two private dances. At Spring house party time (May) we were among the few fraternities giving a party of their own. Everyone agrees that it was one of the most orderly as well as successful parties on the campus.

In the past year Sigma Alpha has been represented in the following interfraternity contests: Baseball, basketball, swimming, skiing, tennis, bridge, and singing. Sigma Alpha won the interfraternity scholarship cup, given each year to the fraternity having the highest standing, our rating being higher than any since the existence of the cup. We have enrolled eight members during the past year, their names and classes being as follows: Lawrence Paquin, Faculty; Alexander Dunnett Gibson, 1924; Granville Hull Luten, 1925; Robert Lewis May, 1926; Charles Newcomb Field, 1927; Samuel James Dennis, 1928; William Allan Waters, 1928, and George Willard Wheland, 1928. Biographical sketches of these men will be found elsewhere in the petition.

Just a word regarding freshman rushing. Last year, first year rushing was abolished and the second year system put in its place. The Interfraternity Council assigned each fraternity two dates for open house, to which freshman might be invited. For each open house we sent out approximately one hundred invitations, basing our choice upon the scholarship and activity and personality of the man. We were extremely surprised and pleased to find that over seventyfive per cent of the invitations were accepted. Under the direction of the Membership Committee, a definite system of records is kept for each man in the fresh-class in whom the fraternity is interested.

Financially we have made slow, steady progress toward a firm basis. This year we have been paying dues of thirty dollars, but have voted to raise it to forty next year. Alumni dues of \$5.00 a year have been voted by the Alumni body, to be put into a building fund.

This summer the college has been remodelling the house which we occupy making it rather more modern that it was. In fact it is scarcely recognizable. This repairing made necessary extensive repapering, refinishing and refurnishing which is being carried on with money loaned the fraternity by various of the individual members.

Our second annual banquet was held on April 19, 1926, with all the active members and four of the eight alumni present. The speaker was Professor Rees H. Bowen of the Sociology Department. Two nights later came the annual

election of officers, Harold Trefethen, '26, giving up the President's chair to Henry R. Horton, '27, John H. Munro, '27, becoming vice-president, August Buschmann, '27, taking over the treasury, and Norman F. Page, '27, retaining his office as secretary. Such officers being considered necessary, constitutional provision was made forman assistant secretary, Robert W. Hankins, a historian, William W. Ballard, and an alumni secretary, Charles T. Brewster.

A larger number of the brothers are taking positions of responsibility in campus activities, and we close the first whole year of the fraternity's existence with a decided improvement both in good feeling within the group and our good name on the campus.

History of Dartmouth College



BIRD'S EYE VIEW OF DARTMOUTH COLLEGE

HISTORY OF THE COLLEGE

Dartmouth College, rich in tradition and custom, is located in one of the most beautiful spots of the Connecticut Valley. Here nature seems to rule and the busy world is left behind at the little railroad station as the visitor climbs the long hill to the college grounds. Hanover, selected by Eleazer Wheelock as the site for Dartmouth College in 1769, is surrounded by a wealth of natural scenery. Along the Connecticut, cathedral pines, the last of a giant forest give one an idea of the grandeur of that region when chosen by the founder of the college. Rising above the plateau, which is now the campus, and away to the North, lie green New Hampshire hills, extending higher and higher above each other until lost in the White Mountains, while on the opposite side of the river the rolling country rises westward to the Green Mountains.

Eleazer Wheelock, a graduate of Yale, desired to found a school for Indians. With this in view, the Moor's Indian Charity School was established at Lebanon, Conn. It was difficult to obtain funds to carry on the work of the school. Dr. Wheelock sent Samson Occum, his most promising Indian student, to England. So powerful was the appeal of this advocate that considerable money was soon subscribed and entrusted to the Earl of Dartmouth. It was to be used to found a college in America for both Indians and colonists. There is at the present time a trust fund which is set aside for the education of any Indians who can pass the entrance requirements of the college. Several have availed themselves of this opportunity.

Governor Wentworth granted a charter with the present site, and gave the college the name of its first patron. It took months of hard work to journey from Connecticut and erect in the heart of the wilderness the first college building. In 1771, a class of four, including John Wheelock, who became the second president, was graduated. Tradition has given rise to one of the present class day customs, a feature of the first commencement. On the hill overlooking the campus stood a giant pine, distinguished even in that forest of giants. Around this tree gathered the class of 1771, and smoked a parting pipe of peace. For a century this tree sheltered each departing class, and when it was destroyed by a storm in 1884, a tower was built to commemorate it. Ten classes participated in the erection of this tower, which was completed in 1895. From its balcony one can view the river valley for miles. Each class day, the seniors gather around the old stump of the Pine to smoke the parting pipe of peace.

After the death of Eleazer Wheelock in 1779, his son became president of the college. He was a brilliant scholar, but lacked the executive ability of his father and was forced to resign by the trustees. He was succeeded by Dr. Francis Brown. It was during Dr. Brown's administration that Daniel Webster, the college's most famous alumnus, won the "Dartmouth College Case" for the trustees. The state legislature wished to control the college and make it a state institution. They selected a board of trustees and attempted to reinstate John Wheelock. Webster defended the college. The Supreme Court decided that the state had no power over a chartered institution and thus handed down a decision which Henry Cabot Lodge says was "in its effects more far-reaching and of more general interest than perhaps any other ever made in this country." The trustees won at the cost of their president, Dr. Brown, who died that year, still a young man but broken in health.

For seventy years the college continued with little progress. Five presidents succeeded Dr. Brown and in 1893, William Jewett Tucker became president. The college needed a strong executive to reorganize and instill new life. In Dr. Tucker they secured a man of the right type. Under his leadership Dartmouth entered a new era. The physical plant of the college was enlarged and modernized. The faculty was increased from 42 to 107. The graduating classes increased from 69 in 1893 to 202 in 1909. Dr. Tucker's administration was the beginning of the "New Dartmouth."

After Dr. Tucker's resignation Ernest Fox Nichols became president of the college and for seven years Dartmouth continued its growth under his capable administration. In 1916 Ernest Martin Hopkins was called to the presidency. President Hopkins' intellectual keenness, his administrative ability, and strong personality immediately won the hearts and admiration of everyone connected with the college. President Hopkins has devoted much of his energy toward raising the educational standards of the college and widening its scope. His efforts have been rewarded for today Dartmouth is no longer the small New England college of former times. Its influence has become nation-wide.

The enrollment at Dartmouth is above the two thousand mark. It is representative of every state in the Union and of four foreign countries. The popularity of the college has been so great during the last few years that only about one in four applying for admission could be admitted.


In addition to the college there is the Tuck School of Business Administration, giving a two year course in that subject and finance. For undergraduates of the college, the fourth year in the college may be taken in Tuck School. The Medical School likewise gives a two year pre-medical course and is rated officially as one of the best pre-medical schools in the country. The Thayer School of Engineering offers good opportunities for men desiring that type of education.

At the present time there are eighteen dormitories at Dartmouth. These as well as other college buildings are heated from a central heating plant. Dartmouth boasts the second largest gymnasium in the country, a gift of the Alumnae. Besides recitation halls and dormitories there is College Hall, a social center for undergraduates; Robinson Hall, where are the offices of all non-athletic undergraduate activities; and Webster Hall, a large auditorium.



Dartmouth College is now among the leaders in the East. Its position and prestige are unquestioned. It is primarily a cultural college and not technical. On the score of age and tradition it is not wanting being founded since 1771. There are few powerful national fraternities which are not represented now on the Dartmouth campus. Yet the fraternity situation is such that new organizations can thrive. With a student body of twenty-one hundred there are but twenty-five fraternities, Sigma Alpha included. Slightly less than half the college is non-fraternity.

New fraternities are slow in forming. It has been five years since the formation of a new group. Sigma Alpha is very new, hardly five months old, yet it shows every sign of strength and permanency. A businesslike budget is in effect, financial strength improves daily. The fraternity was well received on the campus. The Interfraternity Council gave recognition at once by a unanimous vote. A house which compares favorably with others has been secured.

Rushing rules have just been changed at Dartmouth. Pledging will not take place until Sophomore year. This means that for the year 1925-1926 no pledging will take place except of upper classmen. During that year of grace Sigma Alpha desires to be nationalized so that it can compete on an equal basis with other nationals in 1926-1927. Sigma Alpha wants nationalization in the fall. Already several nationals have approached us. Sigma Alpha admires the organization and ideals of Alpha Sigma Phi. We petition you for nationalization.
