Dear Gentlemen:

As president of the Phi Delta Colony, I firmly believe our colony has met and exceeded the minimum standards in order to become a chapter of Alpha Sigma Phi.

The first requirement, membership, in which the minimum standard is 25, we have not only met that number but have exceeded by 13. Our colony currently has a total of 38. Secondly, Alpha Sigma Phi requires us to recruit and pledge 10 new members a year. Since obtaining our colonization on January 17, 1986, we have had two pledge classes. In the spring of '86 our Alpha pledge class contained 9 pledges which are currently active members. This semester, Fall of '86, we now have 13 pledges. I feel that our colony has done a great job in keeping a consistent number of members as well as rushing new prospects.

Our next requirement, service projects, has not only been an asset to the community and college, but to the fraternity as well. Our college project included assisting the alumni to raise money for an educational fund. Our fraternity helped raise money by working with the alumni on the Phonathon. This was a huge success. Our community project was visiting the Preakness Nursing Home. Although we are only required one community service, we enjoyed visiting the Nursing Home so much that we visit the home once every two weeks.

Our third requirement, financial records, has been prosperous for the majority of our existence. Our Treasurer, Bill Borenstein, has kept us well informed on our financial status. As a fraternity we have currently started a sinking fund which all of the brothers are billed

two dollars a man. That account currently has seventy-two dollars in it.

The fourth requirement is to send alumni, other chapters and National Headquarters two newsletters per year. Our Phi Delta Colony Newsletter, the "Pioneer Press", has been distributed twice since our colonization in January 1986. Our Editor, Chris Bulka, is currently working hard to complete a third newsletter.

As President, I emphasize the participation in this fifth requirement, attending the providence conclave. I am proud to state four of our brothers attended the conclave in Washington, D.C. We also sent three representatives to the National Convention in Ann Arbor, Michigan.

Our sixth requirement is currently in the process of establishment. The Prudential Committee and our Scholarship Chairman are setting up scholarship awards as well as a semi-annual academic progress report on each brother. As President I advise all brothers to use the on campus Tutoring Center, here at William Paterson College of New Jersey.

The social aspect of our fraternity continues to grow by the semester. Our social chairman, Stephen Wiatroski, has set many enlightening events which included brother-only-events and mixers. Although social takes "the backseat" most of the time due to our "work before pleasure" motto, I feel our social activities are well planned but not over done.

Our internal activities have included being in good-standing with the Internal Fraternity and Sorority Council, attending bi-weekly meetings as well as other greek functions here at William Paterson College.

Our next requirement, communications with National Headquarters, in my opinion has been successful. We have responded to the special questionaires. We also submitted Pledge Reports, reports of undergraduate membership, carry over pledge reports, publication materials, and address changes relatively on time.

We have also invited Henry Morris, who is in charge of student activities, to our meeting several times. Unfortunately he has not responded. Henry Morris is equivalent to a dean.

Our files include a various amount of objectives and qualities that each new officer can follow without difficulty. These include a job description as well as the various amount of goals set by the officers that currently hold the positions. We feel this is an asset, because it not only helps future officers but it helps the officers that are currently holding the positions.

In conclusion, I feel the Phi Delta Colony is worthy of becoming a chapter of Alpha Sigma Phi Fraternity. We here at William Paterson College

hope that the Grand Council feels the same way in order for us to enter the Mystic Circle. I also would like to take the time on behalf of Colony to thank the Grand Council for its time in considering and evaluating our membership. THANK YOU.
