EPSILON ALPHA CHAPTER CONSTITUTION AND BY-LAWS

MICHIGAN STATE UNIVERSITY

PREAMBLE

In order to provide a medium for the encouragement of high scholastic and social achievements, we establish this chapter of Phi Sigma Phi National Fraternity, Inc.

Founded on brotherhood and dedicated to the concept of mutual understanding and cooperation, we shall stand in opposition to ignorance, bigotry, and provincialism.

Justice, Honor, and Wisdom, the long held ultimate achievements in society, shall be our constant aspirations and hopes, both individually and corporately.

THE CONSTITUTION

(NAME) ARTICLE I

The name of this organization shall be EPSILON ALPHA CHAPTER of Phi Sigma Phi National Fraternity, Inc.

(OFFICERS)

ARTICLE II

- Section 1. There shall be two (2) classifications of elected officers of this chapter. One (1) of these shall to be to conduct official business of the chapter. The other classification of officers shall be Non-Constitutional Officers whose duty it shall be to serve as a subsidiary officers and to carry out specific tasks in promoting the interests of the membership.
- Section 2. The Constitutional Officers listed in the order of their rank shall be the President, Vice-President, Treasurer, Corresponding Secretary, and the Recording Secretary. These five Constitutional Officers shall compose the Executive Board.
- Section 3. The Non-Constitutional Officers shall have no rank among themselves. They shall be the Alumni Secretary, the Athletic Director, the Chaplain, the Historian, the House Manager, the House Manager's Assistant, the New Member Education Chairman, the Assistant New Member Education Chairman, the Publicity Director, the Sergeant-at-Arms, and any other officer's deemed necessary for the efficient operation of the chapter.
- Section 4. The Vice President, New Member Educator, Rush Chairman, Security Chair, and Sergeant at Arms shall compose the Ways and Means Committee
- Section 5. All Constitutional Officers shall serve a one-year term. Non-Constitutional Officer's terms shall be six months to one year in duration.

(Membership)

article iii

- Section 1. The membership of this chapter shall consist of all those duly initiated and approved men who have indicated a willingness and a desire to live in accordance with the principles, purposes, and ideals of this chapter.
- Section 2. No brother who is a member in good standing of this chapter shall be denied the privileges of voting, participation in free debate, or the attending of social events.
- Section 3. No brother of this chapter shall be deprived of the rights of membership for any reason, except he be adjudged guilty of violating the principles, purposes, and ideals of this chapter. This action shall be executed by the chapter assembled or by the executive board acting as an agent of the chapter.

(meetings)

article iv

- Section 1. The regular meetings of this chapter shall be held at least once a week (during the regular academic term) in accordance with a schedule to be announced by the president at the beginning of each semester.
- Section 2. Adjourned meetings or adjourned sessions shall be held when proper provisions are made for them.
- Section 3. Special meetings may be called by the president or by a petition signed by one-third (1/3) of the brothers in good standing of the chapter. All brothers shall receive a written notification of suchspecial meetings stating the time, place, and purpose of such meetings. This notification shall be delivered at least twenty-four (24) hours prior to such meetings.

(finances)

article v

- Section 1. Membership fees as prescribed by the national constitution of phi sigma phi national fraternity shall apply to this chapter.
- Section 2. The active membership shall be empowered to enact by-laws prescribing chapter membership fees, fines, and assessments and shall provide for a special quorum at all meetings where such by-laws are enacted.
- Section 3. The active membership shall be empowered to enact by-laws prescribing associate fees. They shall be prohibited from levying special assessments on new member associates.

(amendments)

article vi

- Section 1. Any amendments to this constitution may be submitted to the membership in writing at any regular meeting of the chapter or at any special meeting called for that purpose.
- Section 2. Amendments to this constitution shall be voted upon no sooner than two (2) meetings after the notice of intention to amend has be introduced.

Section 3. A three-fourths (3/4) vote of a special quorum shall be necessary for the adoption of any amendments to this constitution.

(effective date)

article víi

The effective date of this constitution, the by-laws of the chapter, the standing rules of this chapter, and any amendments thereof shall be immediately upon their adoption, unless otherwise specified. No amendment which would cause any law to be ex post facto shall be adopted by this chapter.

the by-laws

(constitutional officers) by-law 1

The duties of the five (5) constitutional officers shall be the same as those generally understood for each office as prescribed by these by-laws, by the national constitution, by the ritual of this fraternity, and by the officer's handbook of this chapter.

- Section 1. Executive duties of the chapter president shall be classified into two (2) areas: the chapter and the national office.
 - 1. He shall preside over all meetings of the chapter.
 - 2. He shall appoint all committees.
 - 3. He shall keep in touch with all committees and attend committee meetings whenever possible.
 - 4. He shall maintain liaison with the college administration.
 - He shall keep the chapter informed of all the national office notices and information of events of interest.
 - 6. He shall see that all national reports are filled out and submitted to the national office by the treasurer.
 - 7. He shall see that all membership fees are submitted to the national office by the Treasurer.
 - He shall be charged with the protection of the property of the National that is held by the chapter.
 - He shall appoint additional officers deemed necessary to the efficient operation of the chapter.
- Section 2. The Vice President shall be delegated the following powers and responsibilities:
 - He shall act in the capacity of the President in the event of the latter's absence.
 - 2. He shall aid the President whenever and wherever possible.
 - 3. He shall aid the President by working with committees or any other group toward the betterment of the chapter.
 - He shall act as chairman of the Ways and Means Committee.

Section 3. The V) shall be delegated the following powers and responsibilities:

- 1. He shall collect and record all membership fees.
- 2. He shall pay all chapter bills unless otherwise delegated.
- He shall keep proper records of all financial transactions.
- 4. He shall submit figures necessary each month for the Activity Report to the Corresponding Secretary so he can, in turn, submit the report on time to the National Office.
- 5. He shall work with the Corresponding Secretary in sending petitions for membership, ordering jewelry, etc.
- He shall complete the budget form at the beginning of each semester or quarter and submit to the Corresponding Secretary for forwarding to the National Office.
- 7. He shall carry out further duties assigned by the president.

Section 4. The Corresponding Secretary shall be delegated the following powers and responsibilities:

- He shall answer all correspondence not directed to any specific officer in a prompt and thorough manner and shall file carbon copies of same in fraternity files.
- 2. He shall report all changes in officers, committees, and other personnel promptly to the National Office.
- He shall report all items affecting the chapter which may be interest to the National Office.
- We Shall forward all reports to the National Office as requested or required.
- b. He shall assist the Chapter Publicity Director in furnishing news and material for the EQUILATERAL.
- 6. He shall order all jewelry and paraphernalia.
- 7. He shall contact the National for needed information.
- 8. He shall carry out further duties assigned by the president,

Section 5. The Recording Secretary shall be delegated the following powers and responsibilities:

- 1. He shall keep accurate minuets of each meeting.
- He shall keep a list of addresses and activities for each member.
- 3. He shall submit the Membership Report to the Corresponding Secretary for forwarding to the National Office on the proper date.
- He shall act as a custodian of all chapter materials and records.
- 5. He shall carry out further duties assigned by the President.

(NON-CONSTITUTIONAL OFFICERS) BY-LAW II

The duties of the Non-Constitutional Officers shall be the same as those generally understood for each office as prescribed by this By-Law, by the National Constitution, and by the Officer's Handbook of this chapter.

Section 1. The Alumni Secretary shall be delegated the following powers and responsibilities:

- 1. He shall keep and up-to-date copy of all alumni and their addresses.
- 2. He shall send all correspondence to the alumni which is deemed necessary.

- Plan and coordinate homecoming events for the alumni.
- Section 2. It shall be the duty of the Athletic Director to organize and administer the chapter athletic program.
- Section 3. The Chaplain shall be delegated the following powers and responsibilities:
 - He shall give an opening prayer at all chapter meetings.
 - He shall give an opening prayer at any other chapter function where such action would be deemed proper.
- Section 4. The Historian shall be delegated the following powers and responsibilities:
 - 1. He shall act as custodian of the chapter scrapbook.
 - He shall collect all materials deemed important for the future publicity or history of the chapter.
- Section 5. The House Manager shall be delegated the following powers and responsibilities;
 - He shall draw up all house rules and submit them to the active membership for a majority approval.
 - He shall enforce all laws pertaining to the house as passed by the active membership.
 - He shall have the power to levy fines of members not complying with the rules of the house.
 - 4. He shall serve as chairman at all house meetings.
 - He shall keep proper records of all financial transactions.
 - He shall be responsible for the collection of rent and payment of house bills, unless otherwise delegated.
 - Act as a liaison between landlord and house tenants.
 - 7. He shall be responsible for the work of the House Manager's Assistant.
 - He shall be responsible for a monthly report to the chapter President on House Operations.
- Section 6. The House Manager's Assistant shall be delegated the following powers and responsibilities:
 - He shall assist the House Manager whenever and wherever possible.
 - 2. He shall act in the absence of the House Manager.
- Section 7. The New Member Education Chairman shall be delegated the following powers and responsibilities:
 - He shall draw up a tentative New Member Education program and submit it to the Chapter Executive Board four (4) weeks prior to the commencement of the New Member Association for final revision, and to the General Assembly two (2) weeks prior to the commencement of New Member Association for final approval.

- 2. He shall assist with rush and be in charge of New Member Education.
- He shall handle all dealings with the New Member class concerning the New Member Education program.
- 4. Act as a liaison between the associate class and General Assembly,
- 5. Oversee all Associate Class Meetings.
- 6. Serve as a member of Ways and Means Committee.
- Section 8. The New Member Education Assistant shall be delegated the following powers and responsibilities:
 - He shall aid the Education Chairman in drawing up the tentative New Member Program.
 - He shall aid the New Member Education Chairman throughout the rushing and New Member Education periods.
 - He shall act in the absence of the New Member Education Chairman.
- Section 9. The Sergeant-at-Arms shall be delegated the following powers and responsibilities:
 - He shall keep order at all chapter meetings and shall be vested with the authority to levy fines in order to maintain such order.
 - 2. He shall distribute all materials at meetings.
 - 3. He shall call the roll at meetings and shall be vested with the authority to levy fines for unexcused absences or tardiness at meetings.
 - 4. He shall secure the place for meetings.
 - He shall have the power to remove any member form the meeting when ordered to do so.
 - He shall serve as a member of the Ways and Means Committee.
- Section 10. The Brotherhood Chairman shall be delegated the following powers and responsibilities:
 - 1. Organize and Coordinate all brotherhood events, functions and retreats.
 - He shall be responsible for maintaining a brotherly atmosphere between all active members.
- Section 11. The Rush Chairman shall be delegated the following powers and responsibilities:
 - Develop and implement a Rush program in accordance with all Interfraternal Council guidelines.
 - 2. Organize and coordinate a rush program during rush.
 - 3. He shall serve on the Ways and Means Committee.
- Section 12. The Social Chairman shall be delegated the following powers and responsibilities:
 - 1. He shall organize all social functions for the Fraternity.
 - 2. He shall ensure all social events are run according to all Interfraternal Council quidelines.
 - He shall submit all social events to General assembly for approval.
 Under extendating circumstances, he may seek approval from the Executive Board.

(OTHER POSITIONS) BY-LAW III

In addition to Constitutional and Non-Constitutional Officers this chapter shall have the following other positions:

- Section 1. The Advisor shall be elected by the chapter. He shall be delegated the following powers and responsibilities:
 - He shall advise the chapter and aid in deciding policies and practices.
 - 2. He shall attend chapter meetings.
 - 3. He shall act upon the request of the chapter as the chapter's representative to the University administration.
 - He shall become a permanent personnel of the chapter and aid in periods of officer transition.
- Section 2. The first and second Alternate to the National Conclave shall be elected be the active membership to become official delegates to the National Conclave in the event that either or both of the regular official delegates are unable to attend.
- Section 3. The Chapter Photographer shall be appointed by the President. His duties shall be to take pictures at all chapter functions when requested to do so by the Publicity Director or the Social Chairman.
- Section 4. The Parliamentarian shall be appointed by the President without approval of the chapter. His duty shall be to advise the President and the chapter regarding any questions of procedure (Parliamentary).
- Section 5. The President-elect for the ensuring year shall serve as one of the two delegates to the National Conclave; the other delegate shall be elected by the active members. No delegate shall officially represent the chapter unless he is making plans to return to this Michigan State University during the semester immediately following the biennial Conclave.
- Section 6. The Security Chairman shall be appointed by the President without the approval of the chapter. His duties shall consist of maintaining the security of the house for all social events. We shall ensure that any social event is run according to Interfraternal Council guidelines.
- Section 9. The scholarship chair shall be appointed by the President without the approval of the chapter. His duties shall consist of:
 - 1. Keeping accurate academic records of all active members.
 - 2. Updating all scholarship trophies and plaques.
 - 3. Updating and maintaining the chapter scholarship files.
 - 4. Be responsible for maintaining scholastic excellence.
- Section 10. The Athletic Chair shall be appointed by the President without the approval of the chapter. His duties shall consist of:
 - 1. Coordinating all intramural sport teams within the house.
 - 2. Organizing sporting events for the active and associate membership.
- Section 11. The Philanthropy Chairman shall be appointed by the President without the approval of the Chapter. His duties shall consist of:

- Scheduling philanthropic events benefiting the East Lansing community and the national philanthropy.
- 2. Keep accurate records of philanthropy hours earned by active members.

Section 12. Greekweek Chairman

Section 13. The Serenade Chairman shall be appointed by the President without the approval of the chapter. His duties shall consist of:

 He shall plan, organize, and coordinate all associate and active serenades.

Section 14. The Ritual Chairman shall be appointed by the President without the approval of the chapter. His duties shall consist of:

- 1. Organizing all rituals as directed by the New Member Educator.
- He shall be responsible for maintaining all ritual equipment and paraphernalia.

Section 15. The Formal Chairman shall be appointed by the President without the approval of the of the chapter. His duties shall consist of:

- 1. Planning, organizing, and coordinating the chapter formal,
- 2. He shall submit his plans to General Assembly for approval. (NOMINATION BY-LAW IV AND ELECTION OF OFFICERS)

Section 1. Those persons shall be eliqible for office in this chapter who have been brothers in the chapter for a period of not less than ninety (90) days; who will be enrolled at this college for the ensuing year, and who are brothers in good standing with an academic point average as required for graduation.

Section 2. Nominations.

- The nominations shall be made by the Executive Board acting as a Nominating Committee.
- The Nominating Committee shall nominate two (2) candidates for each office.
- 3. No self-nominations shall be accepted. All additional nominations must be submitted to the Corresponding Secretary nine (9) full days before the elections. These nominations must be signed by the person doing the nominating and the person being nominated, and they must state qualifications for the nomination. These qualifications shall be read by the nominee at the next regular business meetings during an allocated time limit of ten (10) minuets.
- 4. The Nominating Committee shall make up the final ballot. No one may appear on the ballot more than three (3) times. In case a person is nominated for more than three (3) offices, he shall choose the three (3) for which he most wishes to run.
- 5. No campaigning of any kind shall be permitted.
- 6. The final report of the Nominating Committee shall be made at the meeting one week prior to elections.

Section 3. Elections.

- 1. Elections shall be by secret ballot.
- No brother shall be elected to more than one (1) office during any one term.
- A majority of votes cast shall constitute an election.
- Section 4. The oath of office for Constitutional Officers shall be administered at the first regular meeting.
- Section 5. The following oath of office, to be administered by the newly elected President at the first regular meeting and shall be taken by the Non-Constitutional Officers:
- "I, do hereby swear that I will abide by the National Constitution of Phi Sigma Phi, Constitution and By-Laws of this chapter, and other rules and regulations governing this chapter in fulfilling the duties of the office which I am about to assume."

(QUORUM)

BY-LAW V

- Section 1. One (1) more than half of the number of active members shall constitute a normal quorum.
- Section 2 A special quorum of two-thirds (2/3) the number of active members shall be necessary to pass any amendment to the Constitution or By-Laws or matters pertaining to the general welfare of the chapter or when the rights of a member will be in any way affected.
- Section 3. A normal quorum for the Executive Board shall be four-fifths (4/5) of the Constitutional Officers.

(COMMITTEES)

BY~LAW VT

- Section 1. The President shall have the power to appoint all standing and temporary committees and to name the chairman of said committees, unless otherwise stipulated.
- Section 2. The Executive board shall be a standing committee of the chapter. The five (5) Constitutional Officers shall compose this committee. The President shall act as chairman. The function of this committee shall be as follows:
 - 1. It shall consider all national reports.
 - It shall act on matters referred to it by the chapter.
 - It shall act on matters referred to it by the President.
 - 4. It shall hold regular meetings at least once each week.
- - 1. Expansion Committee

(MEMBERSHIP) BY-LAW VTI

Membership in this chapter shall be the same as that described in the National Constitution of Phi Sigma Phi National Fraternity, Inc.

(FINANCES)

BY-LAW VIII

- Section 1. Membership fees shall be the same as those described in the National Constitution of Phi Sigma Phi National Fraternity, Inc.
- Section 2. Local membership fees shall be those prescribed by the Executive Board and approved by the membership.
- Section 3. All members shall be the recipients of a fine, not to exceed for an unexcused absence at any business meeting. Only the following shall be classified as excused absences:
 - The membership is attending other meetings in his major subject area.
 - There is illness or death in the member's immediate family.
 - 3. The member is engaged in gainful employment during the meeting.
 - The member is a student teacher unable to attend because of distance;
 - The member is a participant in Varsity or Junior Varsity athletics, Student Council, or other major all-college activities.
 - He is representing the Fraternity in an activity or in conducting business.
- Section 4. Any member who has two (2) unexcused absences during any quarter or three (3) unexcused absences during any semester shall be cast from the fraternity.
- Section 5. All members who shall be unexcused tardy at any business meeting shall be the recipient of a fine not to exceed ______. (The period of tardiness shall begin seven (7) minuets after the meeting is called to order and shall end with adjournment.)
- Section 6. All fines, fees, assessments, etc., shall be paid to the chapter no later than three (3) weeks from the date of their incidence. If such moneys are not 'paid at the end of said three (3) week period, a probationary period of one (1) week shall be in effect. If such moneys are not paid by the end of said probationary period, such cases of delinquencies shall return their badges to the Executive Board which shall hold them for a period of one (1) week before returning them to the National Office and requesting that the delinquent member (s) be stricken from the roll.
- Section 7. The Treasurer shall sign all checks disbursing chapter funds only with the approval of the

President.

(AMENDMENTS)

RX-PWM IX

- Section 1. Amendments to these By-Laws may be proposed in writing by any brother in good standing at any regular business meeting.
- Section 2. Such proposed amendments shall be voted upon at the next scheduled business meeting.
- Section 3. A majority of a special quorum shall be necessary for the adoption of such proposals.

(PARLIAMENTARY AUTHORITY)

BY-LAW X

The rules contained in Robert's Rules of Order, revised, shall govern this chapter and the Executive Board in all cases to which they are applicable, and in which they are not inconsistent to the Constitution, By-Laws, or special rules of order in this chapter.

(EFFECTIVE DATE) BY-LAW XI

These By-Laws shall become effective immediately upon their adoption as provided in By-Law V, Section 2.

(ADDITIONAL REGULATIONS)

BY-LAW XII

Section 1. This chapter shall be given the power to enact such rules and legislation as it may deem fitting and proper for the promotion of the best interests of the chapter.

Section 2. Such rules and legislation shall be classified and codified according to the areas which they effect.

Amendments

By Law 1, Section 2, Rule 4

Vice President shall sit on the social committee. The chairman of the social committee shall be elected for a period of one term by the members of the chapter.

Article III

Section 4

Any M.S.U. student, regardless of residence may be a member. Phi Sigma Phi will no discriminate on the basis of race, creed, ethnic origin, sex age, political persuasion, sexual preference, handicapper status, or marital status. Only M.S.U. students may be members of the M.S.U. Chapter of Phi Sigma Phi.

Section 5

Only members of the M.S.U. Chapter of phi Sigma Phi will be allowed to vote at any meeting. \cdot

Section 6

A committee shall exist that will be composed of the president and chairman of the following committees: New member educator, rush, security, and a person from the membership at large. This committee shall be referred to as the ways and means committee.

EPSILON ALPHA CHAPTER CONSTITUTION AND BY-LAWS

MICHIGAN STATE UNIVERSITY

PREAMBLE

In order to provide a medium for the encouragement of high scholastic and social achievements, we establish this chapter of Phi Sigma Phi National Fraternity, Inc.

Founded on brotherhood and dedicated to the concept of mutual understanding and cooperation, we shall stand in opposition to ignorance, bigotry, and provincialism.

Justice, Honor, and Wisdom, the long held ultimate achievements in society, shall be our constant aspirations and hopes, both individually and corporately.

THE CONSTITUTION

(NAME) ARTICLE I

The name of this organization shall be EPSILON ALPHA CHAPTER of Phi Sigma Phi National Fraternity, Inc.

(OFFICERS)

ARTICLE II

- Section 1. There shall be two (2) classifications of elected officers of this chapter. One (1) of these shall to be to conduct official business of the chapter. The other classification of officers shall be Non-Constitutional Officers whose duty it shall be to serve as a subsidiary officers and to carry out specific tasks in promoting the interests of the membership.
- Section 2. The Constitutional Officers listed in the order of their rank shall be the President, Vice-President, Treasurer, Corresponding Secretary, and the Recording Secretary. These five Constitutional Officers shall compose the Executive Board.
- Section 3. The Non-Constitutional Officers shall have no rank among themselves. They shall be the Alumni Secretary, the Athletic Director, the Chaplain, the Historian, the House Manager, the House Manager's Assistant, the New Member Education Chairman, the Assistant New Member Education Chairman, the Publicity Director, the Sergeant-at-Arms, and any other officer's deemed necessary for the efficient operation of the chapter.
- Section 4. The Vice President, New Member Educator, Rush Chairman, Security Chair, and Sergeant at Arms shall compose the Ways and Means Committee
- Section 5. All Constitutional Officers shall serve a one-year term. Non-Constitutional Officer's terms shall be six months to one year in duration.

(Membership)

article iii

- Section 1. The membership of this chapter shall consist of all those duly initiated and approved men who have indicated a willingness and a desire to live in accordance with the principles, purposes, and ideals of this chapter.
- Section 2. No brother who is a member in good standing of this chapter shall be denied the privileges of voting, participation in free debate, or the attending of social events.
- Section 3. No brother of this chapter shall be deprived of the rights of membership for any reason, except he be adjudged guilty of violating the principles, purposes, and ideals of this chapter. This action shall be executed by the chapter assembled or by the executive board acting as an agent of the chapter.

(meetings)

article iv

- Section 1. The regular meetings of this chapter shall be held at least once a week (during the regular academic term) in accordance with a schedule to be announced by the president at the beginning of each semester.
- Section 2. Adjourned meetings or adjourned sessions shall be held when proper provisions are made for them.
- Section 3. Special meetings may be called by the president or by a petition signed by one-third (1/3) of the brothers in good standing of the chapter. All brothers shall receive a written notification of such special meetings stating the time, place, and purpose of such meetings. This notification shall be delivered at least twenty-four (24) hours prior to such meetings.

(finances)

article v

- Section 1. Membership fees as prescribed by the national constitution of phi sigma phi national fraternity shall apply to this chapter.
- Section 2. The active membership shall be empowered to enact by-laws prescribing chapter membership fees, fines, and assessments and shall provide for a special quorum at all meetings where such by-laws are enacted.
- Section 3. The active membership shall be empowered to enact by-laws prescribing associate fees. They shall be prohibited from levying special assessments on new member associates.

(amendments)

article vi

- Section 1. Any amendments to this constitution may be submitted to the membership in writing at any regular meeting of the chapter or at any special meeting called for that purpose.
- Section 2. Amendments to this constitution shall be voted upon no sooner than two (2) meetings after the notice of intention to amend has be introduced.

Section 3. A three-fourths (3/4) vote of a special quorum shall be necessary for the adoption of any amendments to this constitution.

(effective date)

article vii

The effective date of this constitution, the by-laws of the chapter, the standing rules of this chapter, and any amendments thereof shall be immediately upon their adoption, unless otherwise specified. No amendment which would cause any law to be ex post facto shall be adopted by this chapter.

the by-laws

(constitutional officers) by-law 1

The duties of the five (5) constitutional officers shall be the same as those generally understood for each office as prescribed by these by-laws, by the national constitution, by the ritual of this fraternity, and by the officer's handbook of this chapter.

- Section 1. Executive duties of the chapter president shall be classified into two (2) areas: the chapter and the national office.
 - 1. He shall preside over all meetings of the chapter.
 - 2. He shall appoint all committees.
 - 3. He shall keep in touch with all committees and attend committee meetings whenever possible.
 4. He shall maintain liaison with the college
 - administration.
 - 5. He shall keep the chapter informed of all the national office notices and information of events of interest.
 - 6. He shall see that all national reports arefilled out and submitted to the national office by the treasurer.
 - 7. He shall see that all membership fees are submitted to the national office by the Treasurer.
 - 8. He shall be charged with the protection of the property of the National that is held by the chapter.
 - 9. He shall appoint additional officers deemed necessary to the efficient operation of the chapter.
- Section 2. The Vice President shall be delegated the following powers and responsibilities:
 - 1. He shall act in the capacity of the President in the event of the latter's absence.
 - 2. He shall aid the President whenever and wherever possible.
 - 3. He shall aid the President by working with committees or any other group toward the betterment of the chapter.
 - 4. He shall act as chairman of the Ways and Means Committee.

Section 3. The V) shall be delegated the following powers and responsibilities:

- 1. He shall collect and record all membership fees.
- 2. He shall pay all chapter bills unless otherwise delegated.
- He shall keep proper records of all financial transactions.
- 4. He shall submit figures necessary each month for the Activity Report to the Corresponding Secretary so he can, in turn, submit the report on time to the National Office.
- 5. He shall work with the Corresponding Secretary in sending petitions for membership, ordering jewelry, etc.
- He shall complete the budget form at the beginning of each semester or quarter and submit to the Corresponding Secretary for forwarding to the National Office.
- 7. He shall carry out further duties assigned by the president.

Section 4. The Corresponding Secretary shall be delegated the following powers and responsibilities:

- He shall answer all correspondence not directed to any specific officer in a prompt and thorough manner and shall file carbon copies of same in fraternity files.
- He shall report all changes in officers, committees, and other personnel promptly to the National Office.
- 3. He shall report all items affecting the chapter which may be interest to the National Office.
- He Shall forward all reports to the National Office as requested or required.
- b. He shall assist the Chapter Publicity Director in furnishing news and material for the EQUILATERAL.
- 6. He shall order all jewelry and paraphernalia.
- 7. He shall contact the National for needed information.
- 8. He shall carry out further duties assigned by the president.

Section 5. The Recording Secretary shall be delegated the following powers and responsibilities:

- 1. He shall keep accurate minuets of each meeting.
- He shall keep a list of addresses and activities for each member.
- 3. He shall submit the Membership Report to the Corresponding Secretary for forwarding to the National Office on the proper date.
- He shall act as a custodian of all chapter materials and records.
- 5. He shall carry out further duties assigned by the President.

(NON-CONSTITUTIONAL OFFICERS) BY-LAW II

The duties of the Non-Constitutional Officers shall be the same as those generally understood for each office as prescribed by this By-Law, by the National Constitution, and by the Officer's Handbook of this chapter.

- Section 1. The Alumni Secretary shall be delegated the following powers and responsibilities:
 - 1. He shall keep and up-to-date copy of all alumni and their addresses.
 - 2. He shall send all correspondence to the alumn; which is deemed necessary.

- Plan and coordinate homecoming events for the alumni.
- Section 2. It shall be the duty of the Athletic Director to organize and administer the chapter athletic program.
- Section 3. The Chaplain shall be delegated the following powers and responsibilities:
 - He shall give an opening prayer at all chapter meetings.
 - He shall give an opening prayer at any other chapter function where such action would be deemed proper.
- Section 4. The Historian shall be delegated the following powers and responsibilities:
 - 1. He shall act as custodian of the chapter scrapbook.
 - He shall collect all materials deemed important for the future publicity or history of the chapter.
- Section 5. The House Manager shall be delegated the following powers and responsibilities:
 - He shall draw up all house rules and submit them to the active membership for a majority approval.
 - He shall enforce all laws pertaining to the house as passed by the active membership.
 - He shall have the power to levy fines of members not complying with the rules of the house.
 - 4. He shall serve as chairman at all house meetings.
 - He shall keep proper records of all financial transactions.
 - He shall be responsible for the collection of rent and payment of house bills, unless otherwise delegated.
 - Act as a liaison between landlord and house tenants.
 - 7. He shall be responsible for the work of the House Manager's Assistant.
 - He shall be responsible for a monthly report to the chapter President on House Operations.
- Section 6. The House Manager's Assistant shall be delegated the following powers and responsibilities:
 - He shall assist the House Manager whenever and wherever possible.
 - 2. He shall act in the absence of the House Manager.
- Section 7. The New Member Education Chairman shall be delegated the following powers and responsibilities:
 - 1. He shall draw up a tentative New Member Education program and submit it to the Chapter Executive Board four (4) weeks prior to the commencement of the New Member Association for final revision, and to the General Assembly two (2) weeks prior to the commencement of New Member Association for final approval.

- 2. He shall assist with rush and be in charge of New Member Education.
- 3. He shall handle all dealings with the New Member class concerning the New Member Education program.
- 4. Act as a liaison between the associate class and General Assembly.
- 5. Oversee all Associate Class Meetings.
- 6. Serve as a member of Ways and Means Committee.
- Section 8. The New Member Education Assistant shall be delegated the following powers and responsibilities:
 - He shall aid the Education Chairman in drawing up the tentative New Member Program.
 - He shall aid the New Member Education Chairman throughout the rushing and New Member Education periods.
 - He shall act in the absence of the New Member Education Chairman.
- Section 9. The Sergeant-at-Arms shall be delegated the following powers and responsibilities:
 - He shall keep order at all chapter meetings and shall be vested with the authority to levy fines in order to maintain such order.
 - 2. He shall distribute all materials at meetings.
 - He shall call the roll at meetings and shall be vested with the authority to levy fines for unexcused absences or tardiness at meetings.
 - 4. He shall secure the place for meetings.
 - He shall have the power to remove any member form the meeting when ordered to do so.
 - He shall serve as a member of the Ways and Means Committee.
- Section 10. The Brotherhood Chairman shall be delegated the following powers and responsibilities:
 - 1. Organize and Coordinate all brotherhood events, functions and retreats.
 - 2. He shall be responsible for maintaining a brotherly atmosphere between all active members.
- Section 11. The Rush Chairman shall be delegated the following powers and responsibilities:
 - Develop and implement a Rush program in accordance with all Interfraternal Council quidelines.
 - Organize and coordinate a rush program during rush.
 - 3. He shall serve on the Ways and Means Committee,
- Section 12. The Social Chairman shall be delegated the following powers and responsibilities:
 - 1. He shall organize all social functions for the Fraternity,
 - He shall ensure all social events are run according to all Interfraternal Council guidelines.
 - He shall submit all social events to General assembly for approval.
 Under extenuating circumstances, he may seek approval from the Executive Board.

(OTHER POSITIONS) BY-LAW III

In addition to Constitutional and Non-Constitutional Officers this chapter shall have the following other positions:

- Section 1. The Advisor shall be elected by the chapter. He shall be delegated the following powers and responsibilities:
 - He shall advise the chapter and aid in deciding policies and practices.
 - 2. He shall attend chapter meetings.
 - 3. He shall act upon the request of the chapter as the chapter's representative to the University administration.
 - 4. He shall become a permanent personnel of the chapter and aid in periods of officer transition.
- Section 2. The first and second Alternate to the National Conclave shall be elected be the active membership to become official delegates to the National Conclave in the event that either or both of the regular official delegates are unable to attend.
- Section 3. The Chapter Photographer shall be appointed by the President. His duties shall be to take pictures at all chapter functions when requested to do so by the Publicity Director or the Social Chairman.
- Section 4. The Parliamentarian shall be appointed by the President without approval of the chapter. His duty shall be to advise the President and the chapter regarding any questions of procedure (Parliamentary).
- Section 5. The President-elect for the ensuring year shall serve as one of the two delegates to the National Conclave; the other delegate shall be elected by the active members. No delegate shall officially represent the chapter unless he is making plans to return to this Michigan State University during the semester immediately following the biennial Conclave.
- Section 6. The Security Chairman shall be appointed by the President without the approval of the chapter. His duties shall consist of maintaining the security of the house for all social events. We shall ensure that any social event is run according to Interfraternal Council guidelines.
- Section 9. The scholarship chair shall be appointed by the President without the approval of the chapter. His duties shall consist of:
 - 1. Keeping accurate academic records of all active members.
 - 2. Updating all scholarship trophies and plaques.
 - 3. Updating and maintaining the chapter scholarship files.
 - 4. Be responsible for maintaining scholastic excellence.
- Section 10. The Athletic Chair shall be appointed by the President without the approval of the chapter. His duties shall consist of:
 - 1. Coordinating all intramural sport teams within the house.
 - 2. Organizing sporting events for the active and associate membership.
- Section 11. The Philanthropy Chairman shall be appointed by the President without the approval of the Chapter. His duties shall consist of:

- Scheduling philanthropic events benefiting the East Lansing community and the national philanthropy.
- 2. Keep accurate records of philanthropy hours earned by active members.

Section 12. Greekweek Chairman

Section 13. The Serenade Chairman shall be appointed by the President without the approval of the chapter. His duties shall consist of:

 He shall plan, organize, and coordinate all associate and active serenades.

Section 14. The Ritual Chairman shall be appointed by the President without the approval of the chapter. His duties shall consist of:

- 1. Organizing all rituals as directed by the New Member Educator.
- He shall be responsible for maintaining all ritual equipment and paraphernalia.

Section 15. The Formal Chairman shall be appointed by the President without the approval of the of the chapter. His duties shall consist of:

- 1. Planning, organizing, and coordinating the chapter formal,
- 2. He shall submit his plans to General Assembly for approval. (NOMINATION BY-LAW IV AND ELECTION OF OFFICERS)

Section 1. Those persons shall be eliqible for office in this chapter who have been brothers in the chapter for a period of not less than ninety (90) days; who will be enrolled at this college for the ensuing year, and who are brothers in good standing with an academic point average as required for graduation.

Section 2. Nominations.

- The nominations shall be made by the Executive Board acting as a Nominating Committee.
- The Nominating Committee shall nominate two (2) candidates for each office.
- 3. No self-nominations shall be accepted. All additional nominations must be submitted to the Corresponding Secretary nine (9) full days before the elections. These nominations must be signed by the person doing the nominating and the person being nominated, and they must state qualifications for the nomination. These qualifications shall be read by the nominee at the next regular business meetings during an allocated time limit of ten (10) minuets.
- 4. The Nominating Committee shall make up the final ballot. No one may appear on the ballot more than three (3) times. In case a person is nominated for more than three (3) offices, he shall choose the three (3) for which he most wishes to run.
- 5. No campaigning of any kind shall be permitted.
- The final report of the Nominating Committee shall be made at the meeting one week prior to elections.

Section 3. Elections.

- 1. Elections shall be by secret ballot.
- No brother shall be elected to more than one (1) office during any one term.
- A majority of votes cast shall constitute an election.
- Section 4. The eath of office for Constitutional Officers shall be administered at the first regular meeting.
- Section 5. The following oath of office, to be administered by the newly elected President at the first regular meeting and shall be taken by the Non-Constitutional Officers:
- abide by the National Constitution of Phi Sigma Phi, Constitution and By-Laws of this chapter, and other rules and regulations governing this chapter in fulfilling the duties of the office which I am about to assume."

(QUORUM)

BY-LAW V

- Section 1. One (1) more than half of the number of active members shall constitute a normal quorum.
- Section 2 A special quorum of two-thirds (2/3) the number of active members shall be necessary to pass any amendment to the Constitution or Ey-Laws or matters pertaining to the general welfare of the chapter or when the rights of a member will be in any way affected.
- Section 3. A normal quorum for the Executive Board shall be four-fifths (4/5) of the Constitutional Officers.

(COMMITTEES)

BY-LAW VI

- Section 1. The President shall have the power to appoint all standing and temporary committees and to name the chairman of said committees, unless otherwise stipulated.
- Section 2. The Executive board shall be a standing committee of the Chapter. The five (5) Constitutional Officers shall compose this committee. The President shall act as chairman. The function of this committee shall be as follows:
 - 1. It shall consider all national reports.
 - It shall act on matters referred to it by the chapter.
 - It shall act on matters referred to it by the President.
 - 4. It shall hold regular meetings at least once each week.
- - 1. Expansion Committee

(MEMBERSHIP) BY-LAW VII

Membership in this chapter shall be the same as that described in the National Constitution of Phi Sigma Phi National Fraternity, Inc.

(FINANCES)

BY~LAW VIII

- Section 1. Membership fees shall be the same as those described in the National Constitution of Phi Sigma Phi National Fraternity, Inc.
- Section 2. Local membership fees shall be those prescribed by the Executive Board and approved by the membership.
- Section 3. All members shall be the recipients of a fine, not to exceed _____ for an unexcused absence at any business meeting. Only the following shall be classified as excused absences:
 - 1. The membership is attending other meetings in his major subject area.
 - There is illness or death in the member's immediate family.
 - 3. The member is engaged in gainful employment during the meeting.
 - 4. The member is a student teacher unable to attend because of distance:
 - The member is a participant in Varsity or Junior Varsity athletics, Student Council, or other major all-college activities.
 - He is representing the Fraternity in an activity or in conducting business.
- Section 4. Any member who has two (2) unexcused absences during any quarter or three (3) unexcused absences during any semester shall be cast from the fraternity.
- Section 5. All members who shall be unexcused tardy at any business meeting shall be the recipient of a fine not to exceed ______. (The period of tardiness shall begin seven (7) minuets after the meeting is called to order and shall end with adjournment.)
- Section 6. All fines, fees, assessments, etc., shall be paid to the chapter no later than three (3) weeks from the date of their incidence. If such moneys are not 'paid at the end of said three (3) week period, a probationary period of one (1) week shall be in effect. If such moneys are not paid by the end of said probationary period, such cases of delinquencies shall return their badges to the Executive Board which shall hold them for a period of one (1) week before returning them to the National Office and requesting that the delinquent member (s) be stricken from the roll.
- Section 7. The Treasurer shall sign all checks disbursing chapter funds only with the approval of the

President.

(AMENDMENTS)

RX-FWM IX

- Section 1. Amendments to these By-Laws may be proposed in writing by any brother in good standing at any regular business meeting.
- Section 2. Such proposed amendments shall be voted upon at the next scheduled business meeting.
- Section 3. A majority of a special quorum shall be necessary for the adoption of such proposals.

(PARLIAMENTARY AUTHORITY)

BY-LAW X

The rules contained in Robert's Rules of Order, revised, shall govern this chapter and the Executive Board in all cases to which they are applicable, and in which they are not inconsistent to the Constitution, By-Laws, or special rules of order in this chapter.

(EFFECTIVE DATE) BY-LAW XI

These By-Laws shall become effective immediately upon their adoption as provided in By-Law V, Section 2.

(ADDITIONAL REGULATIONS)

BY-LAW XII

Section 1. This chapter shall be given the power to enact such rules and legislation as it may deem fitting and proper for the promotion of the best interests of the chapter.

Section 2. Such rules and legislation shall be classified and codified according to the areas which they effect.

Amendments

By Law 1, Section 2, Rule 4

Vice President shall sit on the social committee. The chairman of the social committee shall be elected for a period of one term by the members of the chapter.

Article III

Section 4

Any M.S.U. student, regardless of residence may be a member. Phi Sigma Phi will no discriminate on the basis of race, creed, ethnic origin, sex age, political persuasion, sexual preference, handicapper status, or marital status. Only M.S.U. students may be members of the M.S.U. Chapter of Phi Sigma Phi.

Saction 5

Only members of the M.S.U. Chapter of phi Sigma Phi will be allowed to vote at any meeting.

Section 6

A committee shall exist that will be composed of the president and chairman of the following committees: New member educator, rush, security, and a person from the membership at large. This committee shall be referred to as the ways and means committee.

"Michigan State University holds a unique position in the state's educational system. As a respected research and teaching university, it is committed to intellectual leadership, and to excellence in both developing new knowledge and conveying that knowledge to it's students and the public. And as a pioneer land-grant institution, Michigan State University strives to use practical uses for theoretical knowledge, and to speed the diffusion of information to residents of the state, the nation, and the world. world and for individual and group beliefs and traditions; ethically, through sensitivity and faithfulness to examined values; and politically, through the use of reason in affairs of state. There are more than 31,000 undergraduates at Michigan State. Michigan State University provides opportunities for students to learn in both academic and extra-circular arenas. One of the best opportunities for education outside of the formal university is Michigan State University's Greek System. With 32 fraternities and 16 sororities, the Greek system is strong and diverse. A student interested can choose from houses with numbers ranging from twenty to ninety men. Further, many fraternities exist which do not conform to traditional stereotypes. Just as Michigan State University prides itself on diversity of its students, so too do many fraternities. By interacting with the those different, one can learn great amounts about himself.

The Greek system at Michigan State University has traditionally been a strong contributor to local and national philanthropies. Local programs of interest include Into the Streets, Baker Street Exchange, the Kappa Alpha Theta Children's carnival, and many more. While every distinct chapter on campus has an annual philanthropy event, once a year the entire system dedicates a week to Special Olympics. What we call Greek Week is a week-long fund raiser compiled of individual games, group competitions, and an entire day providing a good-spirited competition for members of the Special Olympics. Ticket sales by the system totaled over \$50,000 dollars last year. It's fair to say that each chapter anticipates Greek Week as the pinnacle of the year, both in competition and spirit.

As the community and the university have evolved, so too has the Greek system. Lead by the Interfraternity and Panhallenic councils, the entire system is auditing the manner in which they conduct themselves. Several incidents within the system during the past year have brought such safety issues to the forefront of discussion. Hence, both fraternities and sororities are adapting to the changing tides of legal issues in an effort to protect their security. While in the past hazing and other unacceptable practices were common, current efforts to reform the system are proving successful. Perhaps the strongest example of progress is the Greek system's involvement in Gamma. Gamma's responsibility is to patrol social functions and enforce the rules created by representatives of each chapter. These rules include mandatory safe rides, emergency provisions, guest lists, and prohibition of common sources of alcohol. In this age of uncertainty, such

provisions are necessary to ensure that the Greek System at Michigan State University remains a place where men and women can further their education outside of the classroom.

The main reason for becoming part of this organization was to try and foster a tradition of breaking the typical stereotypes of many of the Greek organizations.

The history of our chapter has ties back to 1910 with Phi Sigma Epsilon. Phi Sigma Epsilon was prospering for many years and then suffered on hard times. In the mid 1980's, after suffering through a difficult time in the Greek system, Phi Sigma Epsilon was approached by Phi Sigma Kappa to discuss the possibility of a merger between the two fraternities. A heated and emotional debate followed at the National Conclave, which in the end resulted in the approval of the merger. Several members of the National Council, as well as members of Alumni Chapters, decided to form a new organization. A long legal battle ensued, which did not end until 1987 when both sides agreed to cease litigation. On July 30, 1988 a new name for the organization, that being Phi Sigma Phi.

This chapter was the first to be colonized by this new organization, led by a transfer student from Eastern Michigan University, John Taylor. The reason for the chapter name of Epsilon Alpha is as follows: Epsilon, signifying our ties back to Phi Sigma Epsilon, and Alpha, signifying this was the first new addition to this new national organization.

This organization has become one of the premier fraternities on this campus. We have succeeded in setting standards in many aspects including, social, philanthropic, and brotherhood. The dedication and diversity of our brotherhood leaves an impression that is virtually impossible to find at other houses. Hopefully, we will not only try to continue to meet our past standards but rather exceed those standards. Our future will not rest on our past accomplishments, but on the accomplishments of those brothers who will follow us.
