ATLANTIC CHRISTIAN COLLEGE

The purchase of Kinsey Seminary for \$25,000 in Wilson by the Disciples of Christ of North Carolina was the beginning of the first church-related college of its kind in the coastal area. One year later Atlantic Christian College was incorporated on May 1, 1902 with fifteen trustees, and opened September 3, 1902 under the presidency of James C. Coggings, A.M., L.L.D. Ten states were represented by 107 students, a capacity enrollment. Included in the constitution of Atlantic Christian is the following: "Its object shall be the dissemination of knowledge, religious, scientific, and practical, to white persons of both sexes, in all branches usually taught in colleges, and such as are necessary to meet the requirements of advancing Christian civilization and enlightenment."

Atlantic Christian College is a co-educational, four-year, liberal arts college striving to add to general cultural education the strength and grace of the Christian tradition. While the necessity and importance of solid intellectual preparation is stressed, its purpose has been to develop also a sense of value, well-rounded character, integrity, and moral worth. The college is church-related and controlled but it is non-sectarian in its policies and administration. It is committed to a view of higher education which balances the emphasis upon vocational aims with an aim that gives a proper stress to the harmonious development of mind, body and spirit and results in a desire to serve the common welfare. It is the aim of the college to develop character through Christian education, to combine with the develop-

ment of the intellectual abilities a growing spiritual insight, to inspire to active service, and thus to have a part in contributing to the world efficient Christian citizens and leaders.

Different arrangements of courses may be made to meet the requirements for pre-professional training for use in Business, Medicine, Law, Dentistry, Nursing, Social Work, the Ministry, Teaching and Science. Two baccalaureate degrees are conferred by the college, the Bachelor of Arts and Bachelor of Science. A diploma in music is granted to a student who completes a major and renders a successful senior recital. Certificates in Stenography, Teaching and Secretarial work are granted in accordance with published regulations of the State.

By Action of the Board of Trustees in 1936, the government of the College is committed to the Co-operative Association of which all the students and faculty are members. The affairs of the association are handled by an executive board. Other campus participation of students include the Student Christian Association, Golden Knot Honor Society, Stage and Script, the Pan-Hellenic Council, The Pine Knot and The Collegiate--student publications, and the mixed chorus. There are eight social sororities and fraternities: Phi Sigma Tau, Sigma Tau Chi, Delta Sigma and Omega Chi as sororities; Sigma Alpha, Phi Kappa Alpha, Phi Delta Gamma, and Sigma Rho Phi as fraternities. The fraternities and sororities are regulated by the Pan-Hellenic Council; which is composed of two members of each Greek letter organization and three faculty advisors.

Since 1902 Atlantic Christian College has made great progress

in building and expanding. In 1925 Christian Churches of North Carolina secured endowment fund of \$300,000, including a gift of \$100,000 was offered by the citizens of Wilson for the erection of a new plant for the college. By 1950 Wilson Gymnasium, Bert Hardy Dining Hall, the heating plant, Howard Chapel and Harper Hall, dormitory for women, were completed. The fall of 1956 brought the opening for use of five new buildings. A new classroom building was designed to accommodate a student body of 1500 along with the new Science building. The classroom and administration buildings are of modern, flexible design. An Alumni Student Center and Infirmary were opened, totalling \$890,000. All of these buildings are complete within themselves, with offices, labs, lounges, classrooms and storage. At present plans call for a new dormitory for boys and a new gymnasium.

Atlantic Christian College is fully accredited by the Southern Association of Colleges and Secondary Schools, the North Carolina College Conference, and is fully approved by the Department of Public Instruction of the State of North Carolina. It is a member of the Association of American Colleges, the North Carolina Council of Church-Related Colleges, the North Carolina Foundation of Church-Related Colleges, the Board of Higher Education of the Disciples of Christ, and Unified Promotion of the Disciples of Christ.

FRATERNITY CONDITIONS OF ATLANTIC CHRISTIAN COLLEGE

Atlantic Christian College has a housing system for its fraternities, and all the rooms are utilized to their fullest extent due to the increasing number of men who wish to live in the houses. Each house has a chapter room and other facilities which are for use by its members.

Every year each house is used for different occasions on our campus such as Homecoming, Rush Week, and different socials. The faculty is welcome at all of these functions.

The Pan-Hellenic Council regulates our fraternity activities. This council is composed of two representatives from each fraternity and sorority. Their functions consist of regulating Rush Week, pledge training and determining who shall receive certain awards for outstanding fraternity work.

Fraternities are made up of approximately 35% of the male student body. These men are very active leaders in sports, Campus Government and social activities. It may also be noted that the fraternities, along with the sororities, have great influence on the campus government.

Fraternities of Atlantic Christian College are very active. Each fraternity has a Spring dance, pledge dance and other activities with its sister sorority each year. We use various locations in Wilson for our dances. Each fraternity participates in the Homecoming Parade by building a float and participating in decorations for each house.

Fraternities are an important part in all the campus activities and undertakings.

HISTORY OF SIGMA ALPHA FRATERNITY

The Greek-Letter Societies of Atlantic Christian College are undoubtedly in the greatest social and economic influence in the student body of the college. The extent to which they provide for the material and social welfare of the student is, perhaps not sufficiently well understood, nor is there generally an appreciation of the extent to which the students have gone in providing for their own needs. It may be general interest, therefore, to present some of the facts concerning one of their societies, with some account of it's establishment and activities.

Sigma Alpha, Local Social Fraternity was founded at Atlantic Christian College during the spring semester of 1925. This was the first social fraternity on our campus. Twelve regular matriculated men students decided to take advantage of a provision made by the college administration where by Greek letter fraternities might be created. It's effort was to revive the national organization of the same name which existed at a majority of the colleges in Virginia and various universities throughout the country.

We feel, in presenting the Sigma Alpha Fraternity to those who do not know them quite as well as they should, much like P. T. Barnum, whose rotund breast surely must have swelled with pride as he read the billboard advertisements of his famous aggregation in which he modestly announced his show as "The Greates Show on Earth," a Galaxy of Scintillating World-Wonders brought from the Four Coners of the Globe at Phenomenal Expense.

There are many annual social functions included in Sigma Alpha's fraternal program. Through the years we have entertained our alumni at Homecoming which is held in November of each year. This event includes a buffet dinner and a dance following. We join with the college in celebrating the Yule season each year before our Christmas holidays. Also in December we honor our new members with a buffet dinner. This follows a two month period of very serious training of the history and traditions of both the college and the fraternity. Our social season is climaxed in late May, on which date our annual spring banquet and dance is held in a ball room of a local hotel. This event has been a tradition of our fraternity since 1925.

At the present time Sigma Alpha Fraternity maintains a well-equipped Fraternity House at 600 West Gold Street, Wilson, North Carolina. A House Committee is responsible for the enforcement of rules and regulations governing the use of the house. Good order is maintained without difficulty.
