THE PENNSYLVANIA HILITARY COLLEGE STORY

A heritage, steered in the best of traditions - yet employing the better of the most modern educational methods - is yours when you matriculate at Pennsylvania Military College.

Chartered since 1343. Pennsylvania Hilitary College has had collegiate powers since 1847. The College traces its origin from two sources, both boys' schools founded in Wilmington, Delaware. The first, begun by John Bullock, a leading Friend, opened in 1321 and became the leading boys' school in the city. In 1846, Samuel Alsop succeeded the founder to the control of the institution and conducted it until 1853, when he transferred, by sale, the equipment and good will to Theodore Hyatt, then the principal of another boys' school. The latter gentleman had previously been in charge of the parochial school of the First Tresbyterian Church of Wilmington. From 1853 to 1859. the school was known as Theodore Hyatt's Select School for Foys. The second, The Wilmington Literary Institute, begun by the Reverend Corry Chambers in 1339, was incorporated by the Delaware Legislature, February 28, 1843. In 1846, under the famed Captain Alden Wartridge, it became a military school, and. in 1847, its charter was amended, changing its name to The American Literary, Scientific and Hillitary Institute and giving it collegiate powers.

In the fall of 1853, military instruction was introduced into the Hyatt School and on February 16, 1859, this school, using the charter of The Wilmington Literary Institute, was incorporated as the Delaware Hilitary Academy, with Theodore Hyatt as Fresident. The trustees of the new institutions,

including the Rev. Mr. Chambers, were essentially those who had incorporated The Wilmington Institute in 1843. On April 19, 1859, the Governor of Delaware, Hon. William Durton, ordered the delivery to the institution of "certain public arms," equipment which consisted of an outfit of rifles and two six-pound field pieces. Six days later, April 25, President Hyatt was appointed aide-de-camp, with the rank of colonel, on the staff of the Governor.

At the opening of the War Between the States, increased facilities for conducting the Academy became necessary. Accordingly, an extensive school property at West Chester, Pa., was leased, and the school was then incorporated in Fennsylvania under an act of Pennsylvania State Legislature, approved April 8. 1862, by Governor Andrew G. Curtin. The new charter invested the Board of Trustees with all the powers and privileges of a military university. It authorized the conferring of scholastic honors and degrees, enjoins the conduct of theoretical and practical military instruction, and empowers the State authorities to supply arms for infantry, artillery, and cavalry drills, together with tents and other camp equipment. following June, the Board of Trustees organized under the corporate title of Pennsylvania Military Academy and elected Colonel Theodore Hyatt president of the institution. first session in Pennsylvania opened September 4, 1862, with all the students residing at the institution.

In December, 1865, the institution changed its location to Chester, occupying, at first, the Crozer Normal School Building.

Two years later a fine tract of land was acquired near the northeastern border of the city, and in June, 1867, the cornerstone of the present main building of the College was laid, the construction being completed in time for the doors to be opened to the incoming corps of cadets on September 3, 1868.

In 1869 the Military Department of the College was accorded Government recognition under an Act of Congress, by the detail of an officer of the United States Army as Professor of Military Science and Tactics, and by the furnishing of equipment and supplies for military instruction and training. This official connection with the Government, which has continued unbroken throughout the years, includes all cadets in its operations, but it has never imposed any obligation of service to the United States, nor does it now impose any other obligation than that of good citizenship.

In order that the name of the institution might indicate without ambiguity that the Legislature had invested the Board of Trustees with collegiate powers and privileges, the Court of Common Pleas of Delaware County, Pennsylvania, on December 12, 1892, changed the corporate title to Pennsylvania Military College.

In the fall of 1913, all qualified students were inducted into the Army but remained in the College under the Students' Army Training Corps. The curriculum and Military Science Program of Pennsylvania Military College were such as to fall naturally into the pattern of the SATC. Likewise, disbandment of the SATC and the return to ROTC following the next Christmas vacation had no serious impact on the institution.

In November, 1934, the College was transferred, largely by gift, from the Hyatt family to the public.

In order to assure the perpetuation of the College beyond their own lives, they took this action, making it a purely non-profit, non-proprietary institution. The Board of Trustees, a self-perpetuation group, controls and operates the College under the College Charter.

In 1942, early in Norld War II, the College adopted a yearround program of acceleration, revising its calendar in April,
1943, to a year of four 12-week terms, corresponding to the
then-proposed Army Specialized Training Program. The next month,
all seniors and juniors were called to active service in the
Enlisted Reserve Corps, leaving the College depleted of students.
However, on 14 June 1943, a Basic Engineering Unit of the Army
Specialized Training Program (ASTP) was activated and continued
to April, 1944. In July, 1944, an Army Specialized Training
Reserve Program was activated. The last ASTRP boys left in May,
1946, overlapping by three months the incoming flood of veterans.

In view of their previous military training and service, veterans were admitted as civilian students, both day and boarding, and the long tradition of Pennsylvania Military College as an exclusively military college with an exclusively boarding Corps of Cadets came to an end.

In 1949, off-campus living privileges for residents of Delaware County, Pennsylvania, were extended to non-veterans on a day-cadet basis. At present, students living within easy commuting distance are enrolled as civilians, regardless of their

military status; and all cadets are again members of the boarding Corps of Cadets.

Prior to World War II, the curriculum at Pennsylvania
Military College had been largely technological and business.

In 1947, academic offerings were expanded and now include programs in Liberal Arts, with majors in English and Political
Science; Science, with majors in Biology and Chemistry; Business
Administration, with majors in Accounting and Economics; and
Engineering, with majors in Civil, Electrical and Mechanical
Engineering. Beginning in the fall of 1948, a program was
offered for Secondary School Teachers' certification.

In 1954, in order to provide a needed community service, an Evening Division was launched and now provides degree programs in Accounting, Engineering and Management.

In 1956, an Industrial Services Center was developed to provide training programs and allied services to our industrial community.

Pennsylvania Military College is a college "on the move". In the past four years, three dormitories have been constructed and a fourth is expected to be completed by February of 1962, housing 300 boarding cadets. Now under construction on our campus is the new Alumni Auditorium. This building which will cost around \$205,000, fully equipped is being built from contributions of the alumni, plus the students who are to be future alumni. Before June, 1962 a new student union building costing over one million dollars to build will be started.

Through the work of Dr. Clarence R. Holl, President of the College, and his staff, 13 acres adjacent to the college grounds have been procured for redevelopment. Houses for Pennsylvania Hilitary College faculty members would be among some of the buildings constructed on this newly obtained land. This 13 acres of land will increase the size of the present campus by fifty percent.

Along with the new face lifting which the Pennsylvania Military College campus is now receiving, the cadets of this institution are to get a new Commandant of Cadets, retired Army Major General, William S. Biddle. General Biddle will be the first Regular Army General in the 141-year history of Pennsylvania Military College to serve as Commandant. The students of the Pennsylvania Military College are looking forward to April 1,1962 when General Biddle will begin his new job.

The future of Pennsylvania Military College looks bright and promising to the total enrollment of 1,061 students (683 in the military and 378 in the non-military programs) and the sixty-two members of the teaching faculty.

This long record of traditional success does much to develop the espirit de corps in the P.M.C. Cadet and a sense of pride in the non-military student which is conducive to the best efforts of both.

THE HISTORY OF OUR COLONY

This group known on the campus of Pennsylvania Hilitary College as a colony of Alpha Sigma Phi emerged as a formal organization on March 13, 1961, with the able assistance of J. Mervin Marris, Office of Admissions at Pennsylvania Military College and Gordon Beauchamp, an accountant with the Comptrollers Office in the city of Chester. Both men are active members of the alumni organization of Pennsylvania Military College and Kappa Sigma Kappa.

From its beginning, Lambda Zeta Rho, as our local fraternity is known, has aspired to belong to an old line national fraternal organization. On April 6, 1961 Lambda Zeta Rho invited Mr. Stephen Purnell Toadvine, Chairman of the Business School at Pennsylvania Military College, to address the membership as to the merits of belonging to Alpha Sigma Phi a social fraternity founded in 1845 of which Mr. Toadvine is an alumnus of the Iota Chapter at Cornell University.

After due consideration the membership unanimously chose Alpha Sigma Phi as the national fraternity that they would aspire to be a member of. Under the able assistance of Mr. Elwood Smith, former Assistant Executive Secretary of Alpha Sigma Phi Fraternity, we began work on this retition.

Our original thirteen brothers, working only with the news of our intentions of becoming a chapter of Alpha Sigma Phi, increased the brotherhood to fifty men. This recruiting program was done without the aid of social functions or promises, other than our intentions of joining Alpha Sigma Phi.

This colony is represented on the Inter-Fraternity Council as it was recognized by the College on April 28, 1961. The brothers also belong to other campus organizations such as the Student Council, various clubs, and is well represented in athletics.

As a colony we established and developed a friendship with the Omicron Chapter of Alpha Sigma Phi at the University of Pennsylvania. Their President, Garry Kallen, had cordially invited our colony to the Penn Chapter House so that we would be able to see the Penn campus and also to instill a lasting friendship between both Chapters.

This colony of Alpha Sigma Phi is unique on the Pennsylvania Military College campus in that our membership is evenly divided between resident and non-resident students. Those resident students are taking a military program which will allow them to receive a commission in the Armed Forces. The non-residents are men of the Delaware Valley Area who commute to and from the college daily.

We feel that becoming a chapter of Alpha Sigma Phi Fraternity will continue to bring the enjoyment and pleasure to each member of this fraternity during their college life and in the future years.

FINANCIAL REPORT

Alpha Sigma Phi Colony was established at Pennsylvania Military College as a permanent organization. Its financial policy has been in keeping with this goal.

Bills have been paid as soon as due. Dues are collected weekly, at a rate of two dollars per week per man. Upon joining this organization, each member's account is debited \$104.00, to be paid by the member no later than March 13, 1962.

The Colony has accounts receivable, by March 13, 1962, of \$1,282.00; collections received totaling \$3,997.45; less

Dear Sirs,

The following is an excerpt from the history of Delta Delta Rho Fraternity which was included in our petition for a charter to Tau Kappa Epsilon in the Spring of 1961. Delta Delta Rho became Theta Lambda Chapter of T.K.E. on April 29, 1961.

Pennsylvania Military College. The first records show that there were twenty-five charter members on November 9, 1951. One year later, twenty-five more men had become brothers of the new fraternity. Since that time the active membership has remained well above the initial number of charter members.

One of the first problems faced by the fraternity was that of obtaining a fraternity house. The old riding hall on the south-east end of the campus was chosen as the future home of Delta Delta Rho. The charter members encountered many difficulti in converting this riding hall into an attractive fraternity house but their efforts, as well as the efforts of the new brothers, resulted in the attractive house still used by the fraternity. The wooden floor was replaced by inlaid linoleum with large red Greek letters on a black background highlighting the center of the floor. A kitchen was built, surrounded by a bar of glass blocks and a brass foot-railing. The sides of the house were covered with knotty-pine paneling and two washrooms were built.

Brothers of Delta Delta Rho have been traditionally known for their resourcefulness and initiative. Even after the house had been completely remodeled, new problems arose regarding maintenance and repairs, and all problems were met by eager and willing brothers. When the roof began to leak, the brothers tarred and papered it; when the plumbing went bad, the brothers re-built the entire system. The pool table, which was purchased through fraternity funds, was badly in need of repair and was refinished with a new felt top and black and white trim by some of the brothers. Other items, such as piano, refrigerator, stove and television set were all procured through the continuing efforts of the brothers.

Delta Delta Rho is an active fraternity, always seeking ways to advance and improve the house. In the last year the brothers have built a ping-pong table, replaced the old ceiling with acoustical tiling and stripping, rewired the electrical

system, repainted the house, and made necessary repairs on the roof. Delta Delta Rho is the first fraternity at Pennsylvania Hilitary College to raise the academic requirements for pledging in order to insure high scholastic achievement in the brother-hood and is constantly striving to better the fraternity, the college, the community and, most of all, the individual man who is a brother of this proud fraternity."

HISTORY OF THETA CHI AT PENNSYLVANIA HILITARY COLLEGE

In 1956 this petition was approved and Pi Mu Chi was installed as Epsilon Camma Chapter of Theta Chi. Since its inception, Theta Chi at Pennsylvania Military College has continued to grow steadily and produce many cadets proficient both militarily and academically. This is attested to by the fact that Theta Chi has produced many Distinguished Military Students, and holds one of the highest cumulative academic averages of any organization on campus.


